NARRATIVE

On June 22nd, 2026, at approximately 0654 hours, I responded to the residence of [REDACTED] in reference to a Disturbance in Progress. The call notes advised [REDACTED] who advised [REDACTED] were actively fighting and the father had a knife. Upon arrival, Deputy Newman was outside with the father, Demarcus Denson. I made contact with the mother inside, Regdrecka Tolbert, who provided the following statement:

Denson came into the bathroom calling her numerous names, whore, bitch, etc. Denson had a knife and began poking her with it. Tolbert stated to Denson he was poking her, he replied he does not care and will "hit her in her shit". The two of them began a verbal argument while Denson poked her with the knife. India Tolbert (DOB 3/27/2015) managed to grab the knife from Denson. Denson began "Bear holding her" and she dropped the knife. Tolbert yelled at the [REDACTED] which [REDACTED] did. Paris Tolbert also witnessed this take place. When observing Tolbert, I observed a small puncture wound on her upper right arm, consistent with her statement. When observing the knife Denson used, I did not observe any blood.

I read Denson his Miranda Warnings, which he agreed to speak with me. Denson advised nothing physical took place and Tolbert is drunk. Denson advised he believes Tolbert gave herself the mark and he never had a knife. When asking why the kids advised they witnessed this, he replied the mother is making the kids to be liars. When asked why dispatch advised they heard the argument, he stated people can say whatever they want.

Due to the children's statement, victim statement, and evidence, I found probable cause for Domestic Violence Battery with a Deadly Weapon.

Denson was placed into Deputy Newman's patrol vehicle and transported to the Indian River County Jail.

NARRATIVE

On June 22nd, 2026, at approximately 1737 hours, IRCSO dispatch [redacted] They stated a physical altercation was occurring at [redacted] between a white female, and a black male. The caller reported a female was having her hair pulled and was trying to get away from the male.

I responded to the residence, where I knocked and began speaking with a female identified as Kylie Williams. A second person came to the door, who was identified as Joshua Williams. It should be noted, these two parties are married for approximately the past 3 years, [redacted] They also match the provided description. Kylie explained a physical altercation happened between her and husband over the dogs. She explained she asked Joshua to put the dogs away, where he did not like her tone. As a result, an argument broke out, where she attempted to walk away. She stated as she walked away, he grabbed her on the shoulders and attempted to pull her back. She explained this happened in the rear of the house in the backyard. I asked to see Kylie's shoulder, which did not have any marks of bruising.

I spoke with deputies who were with Joshua. Joshua advised the couple were just playing a game of tag, and he did not do anything to hurt her. A third adult household member was identified as Norman Northover. I asked Joshua if he witnessed this event. He stated Norman was sleeping and has been for quite some time; therefore, he did not see anything. I asked for permission to go inside the residence to speak with Norman, which Joshua declined. I knocked on Norman's window, where he exited the residence and we began to speak.

I spoke with Norman where he explained he was not sleeping and hear the disturbance. He explained he opened his blinds to his bedroom window, where he observed Joshua pulling Kylie by the back of her shorts. He described it to be a "wedgie." He stated this happened within his line of sight from his bedroom window, which is located on the 3/4 corner of the residence. He explained the couple argue a lot and figured he should check on them, hence how he saw the disturbance.

I returned to speak with Kylie. She explained the incident further. She explained the physical violence began in the backyard and continued to the side of the house. I asked specifically about her pants being pulled, which she confirmed Joshua did this. She explained Joshua did not like when Kylie attempts to walk away from her, and he does this to her often. She demonstrated the grab on me, where she grabbed both of my shoulder as my back was turned to her. She explained this is what Joshua did to her. She then stated he picked her up off the ground by wrapping his arms around her legs from her behind, which hurt her. No visible marks or redness were observed. I asked specifically if Joshua grabbed the back of her pants to restrict her from walking away, which she stated yes. I asked

Kylie overviewed the disturbance. She explained is stated in the living room, where she asked him to feed the dog. She explained she walked into the bedroom after such, where Joshua came into the bedroom, and an argument ensued. She explained she then walked outside to sit in a swing have in yard, which she stated Joshua followed her. She explained she then walked through the gate on the 3/4 corner of the house to get away due to not being confrontational. I asked Kylie if she believed she was free to leave, which she stated her belief if she told Joshua her intent to leave the residence he would have let her. I confirmed however, he did not allow her to walk away from him in the yard, which she confirmed. She further elaborated the pulling by her pants at this point. She stated as she walked out of the aforementioned gate at the 3/4 corner, Joshua pulled her by the rear of her pants, back into the backyard of the residence. I asked Kylie if she believed Joshua's characterization of this being rough-housing, which she kind of. She stated it got to a point where she got annoyed and had to tell him to stop, which he did so.

I returned to speak with Joshua, where at this point, I read him his Miranda rights. He declined to speak with me. Due to my belief probable cause of a domestic violence battery occurring where Kylie had her shoulders grabbed, hair pulled, and pants grabbed where she was forcibly moved to her backyard, I placed Joshua under arrest.

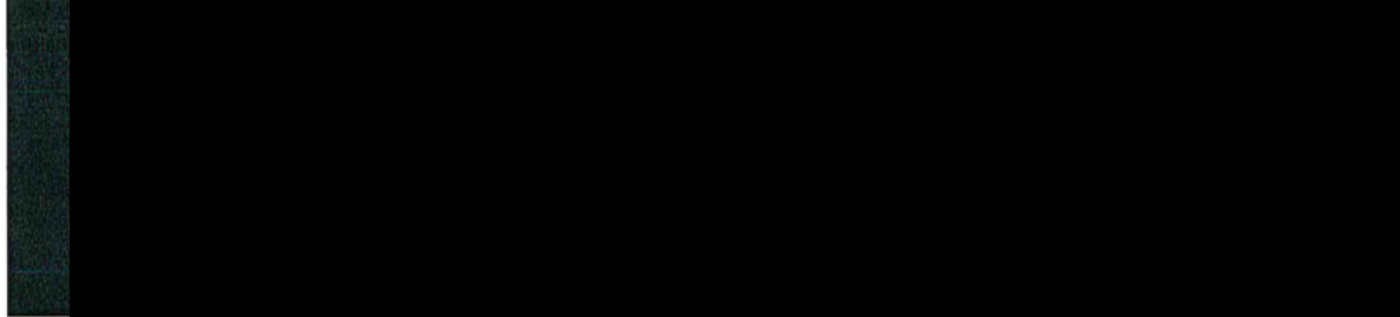

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 06/22/2026 at 17:56 (Specifically include facts constituting cause for arrest.)

On June 22nd 2026 at approximately 1618 hours, I was dispatched to [redacted] in reference to a disturbance.

Upon arrival, I met with the complainant later identified by FL DL as Brandon Thomas Martin. Brandon stated that his wife identified by FL DL as Jennifer Ann Martin and himself were returning from Buffalo Wild Wings in Melbourne after watching a soccer game. While enroute back to their home, a verbal argument began. The argument consisted of Brandon's bank statements reflecting a spending balance of \$4,000 USD. Jennifer confronted Brandon about this transaction and how he should not be spending that much money.

Brandon then stated that a physical fight occurred inside he vehicle. I was able to establish by Brandon that the disturbance occurred within Sebastian's jurisdiction at the intersection of CR512 and Fleming Street. Brandon stated that Jennifer threw his phone towards his stomach area. Also, Brandon stated that Jennifer had struck Brandon on the right side of the head. Upon my observation on Brandon's head, I could observe slight redness by the top of his temple and no redness on his stomach where he advised Jennifer threw the phone. It is to be noted that Brandon and Jennifer are legally married and have been for approximately 4 years.

I began to speak with Jennifer who stated that they were having a verbal argument about Brandon's spending. I asked Jennifer that if at any time the verbal argument became physical to which she advised it did. Jennifer proceeded to explain that it occurred in the car on CR512 while coming home. When confronted about her throwing the phone towards Brandon and hitting him on his head she stated "I 100% did". Also, she proceeded to explain that she could not really remember what had happened but she was the one who "started it".

Based on Jennifer's statements and admission of provoking and hitting Brandon, and also the redness on top of Brandon's right side of his head consistent with a blunt force impact, I find probable cause to arrest Jennifer for FSS: 784.03 Battery (domestic violence) for intentionally striking Brandon against his will. Jennifer was transported to the Indian Rover County Jail without incident.

This case will be cleared via arrest.





The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 06/22/2026, at 18:42 (Specifically include facts constituting cause for arrest.)

On June 22, 2026, at approximately 1842 hours, I responded to [REDACTED] with additional VBPD Officers in reference to an open door at a vacant property.

Upon my arrival, I met Officer Covarrubias (ID 450) on the East side of the property who was in the presence of two males. Ofc. Covarrubias told me that when he arrived on scene the males were inside the residence and exited through the rear sliding glass door, which was open on my arrival. Officer Covarrubias advised me that there have been prior calls regarding trespassing at this location. The property was vacant and under construction at the time, and a neighbor called to report this incident. I observed that there were broken windows on the South and East side of the property.

The males, William Talley and John Boerstler, provided their names and date of birth for identification. Officer Covarrubias asked Talley where his backpack was, and Talley grabbed his gray bag, which was just behind the sliding glass door inside the home. Talley then handed this bag to Officer Covarrubias. Officer Covarrubias asked for consent to search Talley's bag while Officer Wickert (ID 436) was present. Talley provided consent, and Officer Covarrubias began searching through the bag. Vero Beach Communications Center then advised over the radio that Talley had an active warrant for his arrest. I then attempted to interview Talley, separate from Boerstler, regarding this incident. During a post-Miranda interview, Talley stated that he had entered the property, knowing he was not permitted to be there, to find a place to stay for the night. Talley added he entered the property to escape the rain, however, it was not raining at the time. Talley did not state how he entered the property, but as I attempted to inquire further, Talley advised that he did not wish to make any more statements. Talley was then detained in handcuffs, pending confirmation on the arrest warrant. While waiting, Dispatch also informed me that Talley was currently on probation. After receiving confirmation of the warrant, Talley was placed under arrest.

The gray backpack that Talley was in possession of at the time of his arrest had drug paraphernalia stowed inside. I recovered a glass bowl pipe containing burned residue within the bulb, that was concealed in a napkin. Next to the glass pipe was a makeshift pipe constructed using a Sharpie marker with an open end. The makeshift Sharpie pipe also had burnt residue inside. I recognized these two items to be drug paraphernalia, commonly used to smoke narcotics. There also were several tools in Talley's backpack including pliers and a screwdriver.

I then spoke to Boerstler who stated he had arrived within 20 minutes of officers' arrival and had come to the property to see Talley. Boerstler was also in possession of an orange/red multicolored backpack. Boerstler told Officer Covarrubias that the bag was his and granted him permission to search through the backpack. At the beginning of the search, Boerstler grew nervous and claimed that there may be something illegal in the backpack. Inside the backpack I found a wallet containing Boerstler's Florida Identification card. I then retrieved a drawstring Crown Royale bag inside the main compartment of the backpack. This bag contained a glass bowl pipe with burnt residue of a substance, as well as a white powdery substance in the stem. In this same Crown Royale bag, I recovered a plastic bag, tied off with a white powdery substance at the bottom. The substance field tested presumptively positive for methamphetamine. The total package weight with the methamphetamine was approximately 1.5 grams. The backpack also contained several lighters. I placed Boerstler under arrest at this time.

I was later able to locate contact information for the owner of the vacant property, Nick Nico. While talking to the property owner, he told me that there should be no one present on the property, and that he has not granted anyone permission to be there at any time. Nico stated he would like to press charges on anyone present on the vacant property. Nico also stated that when he was last on the property, all doors were locked and secured including the rear sliding glass door. Nico could not confirm if the windows had been damaged prior to today's contact with the two defendants.

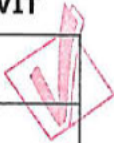

On June 23, 2026 at approximately 0102 hours I responded to Cumberland Farms 1690 US-1 in reference to shoplifting.

Upon arrival, I met with Cumberland employee Kynna Nott (C1) who wanted to report someone that just stole merchandise from the store. C1 described the suspect as a short white female with dark hair and a red shirt. C1 told me that the female entered the store took and two 24oz Black Cherry Twisted Teas from the cooler. The female suspect then left the store, passing all points of sale without paying for the merchandise. Each can was valued at \$3.79, totaling \$7.58 in US currency. I observed two empty spaces on the shelves where the Black Cherry Twisted Teas should have been. C1 mentioned she was certain it was those two cans because she had just organized all the coolers and there should not be any empty spots. C1 added that before the suspect left the store; C1 told the female that she was not permitted to take the drinks and the female exited the store despite the warning.

Cpl. Dominguez (ID 498) searched the area and found a female that matched the provided description. The female identified herself as Jessica McCranie, who was detained at this time. Officers attempted to interview the suspect; however, she wasn't cooperative and would ramble. A show up was conducted with C1. After being read the instructions C1 positively identified McCranie as the suspect by stating "that's definitely her." McCranie was taken into custody, issued a trespass for the location, and transported to the Indian River County Jail.

McCranie was charged under FSS 812.014 for Petit Theft.
