NARRATIVE

On Wednesday October 29 2025 at approximately 0930 hours I responded to Walmart 5555 20th Street Vero Beach Florida in reference to a retail theft. Upon arrival I made contact with Walmart loss prevention Brittany Dowdy who advised the following in substance:
Brittany observed a black male later identified as Montae Burks, select several items off the shelf and place them in a Walmart shopping bag. The male also grabbed a fishing knife and placed it on the bottom of his child's stroller. The male then walked out of the store without making any attempt to pay for the items.
Montae was located in the Walmart parking lot by Deputy Portocarrero with the Walmart bag. Deputy Portocarrero escorted Montae back to the Walmart loss prevention office.
Deputy Portocarrero provided me with the Walmart bag containing several items to include 5 spools of fishing line, 2 Penn reels and a fillet knife. Total of items taken is \$384.64
I read Montae his Miranda rights which he advised he understood and agreed to speak with me. Montae advised he selected the items off the shelf and placed them in a Walmart bag. He then grabbed a fillet knife off the shelf and placed it in the bottom of his child's stroller. Montae then left the store without attempting to pay for the items. Montae informed me he stole the items because someone told him he could steal the items to get food.
Montae was placed under arrest and transported to the Indian River County Sheriff's Office jail.
Montae's child was turned over to her mother.



NARRATIVE

On October 29th, 2025, at approximately 1555 hours, deputies, detectives, and the Aviation Unit from the Indian River County Sheriff's Office were actively searching for Andrew Jones Jr., who had an active felony warrant (2025CF1252). Your affiant possessed intelligence related to a separate investigation (Indian River County Case #2025-700034) indicating that Jones was operating a white Honda Accord bearing Florida tag RQVN81.

Detective L. Bennett observed the vehicle traveling south in the 4200 block of Old Dixie Highway. The Aviation Unit maintained visual surveillance of the vehicle as it traveled from that location to the south side of 1927 19th Street, where it stopped in an alleyway. The Aviation Unit observed Jones exit the vehicle while holding a bag in his right hand and walk toward the southwest corner of the property. Jones was then seen concealing the bag inside a bush before re-entering the Honda Accord.

Detectives Castano and Orehostky conducted a traffic stop at the same location. Due to Jones's criminal history, a vehicle immobilization technique was utilized to safely stop the vehicle. A felony traffic stop was conducted, and Jones was taken into custody without incident.

Sergeant C. Clark searched the area where Jones had been observed concealing an item and located a white plastic bag inside the bush. The bag contained a large clear bag with three smaller clear bags containing a white rock-like substance, two clear bags containing a white powdery substance, several blue pills imprinted "GG258," six white pills imprinted "M365," and a black digital scale with a white residue.

Detective Doval took possession of the evidence and transported it to the Crime Scene Unit. Your affiant met with Jones, who invoked his rights. Detective Doval field-tested and weighed the substances, yielding the following results:

- The white rock-like substance tested positive for cocaine and weighed 79.92 grams.
- The white powdery substance tested positive for cocaine and weighed 82.90 grams.
- The white pills imprinted "M365" were identified via Drugs.com as Hydrocodone.
- The blue pills imprinted "GG258" were identified as Alprazolam.
