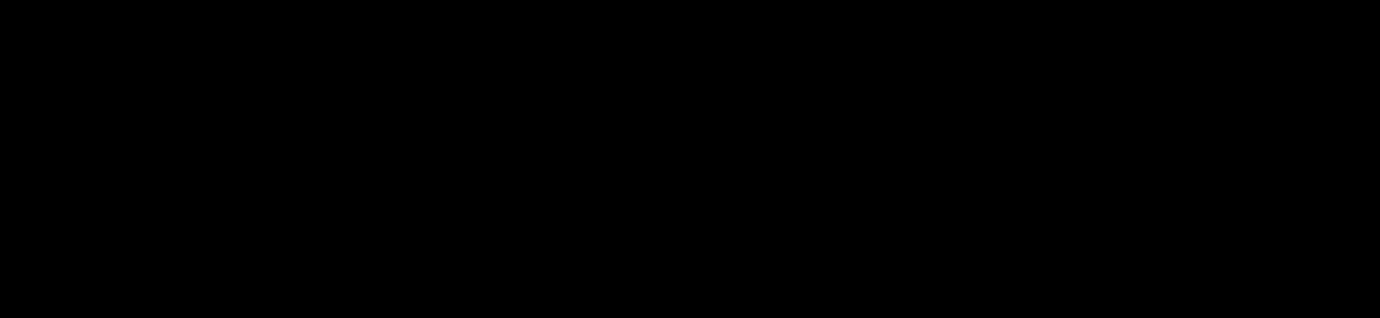

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On April 13, 2026 at approximately 0758 hours, I was dispatched to [REDACTED] reference to a disturbance.

Upon my arrival, I made contact with Jamie Borozny. Borozny stated that on April 12, 2026, at approximately 2130 hours, she arrived to her residence [REDACTED] after being at work. Borozny stated when she entered her home, her boyfriend, Jason Maradiaga was highly intoxicated. Borozny stated a verbal altercation occurred between her and Maradiaga, therefore, she left her residence and stayed overnight at a family members house. Borozny stated she arrived home on today's date at approximately 0750 hours. Borozny stated when she entered her home she observed her couches, dining room table, and end tables in the living room flipped upside down. She observed all of her personal belongings including but not limited to her make up and bathroom items thrown throughout the house. Borozny stated everything on the counters and on the shelves were thrown all over the house. Borozny stated Maradiaga started to yell at her to get out of the house. Borozny stated she immediately exited the residence and contacted the Vero Beach Police Department.

I made contact with Maradiaga. Maradiaga stated he did not wish to talk to me about the items that were destroyed inside of the residence. I observed numerous items spread throughout the house. I observed couches and tables turned upside down. I observed broken glass and other broken items lying throughout the house.

Borozny showed me the end tables that she purchased for \$100, and the damage that was done to the tables due to Maradiaga throwing them down. Borozny stated she wants to press charges.

Maradiaga was placed under arrested at approximately 0831 hours for violation of FSS number 806.13, Criminal Mischief. Maradiaga was transported to the Indian River County jail where he is being held on a \$500 bond.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 04/13/2026, at 21:00 (Specifically include facts constituting cause for arrest.)

On 04/13/2026, at approximately 21:00 hours, VBPD officers responded to the Dollar General store (located at 660 21st Street) in reference to a shoplifting in progress. The store clerk called law enforcement and stated that there was an active disturbance involving the suspect at the store. The last update provided was that the suspect had fled from the store with merchandise.

Upon arrival, I met with the complainant/victim, who is listed as "victim person 2" in this affidavit. The complainant is the assistant manager at the store and will be further referred as "V2". V2 had just returned to the entrance of the store after chasing after the shoplifting suspect. V2 provided me with his account, and he later allowed me to review surveillance footage of the incident. I noted the following:

At approximately 20:55 hours, the suspect entered the front entrance of Dollar General while V2 was up front near the register. V2 described the suspect as a middle-aged black male, last seen wearing light colored shorts and a dark grey sweatshirt. During the review of footage, it appears that the suspect was dropped off near the entrance by a black SUV. I was unable to distinguish the vehicle model, nor the characters on the license plate. The suspect enters the store and greets V2, asking to use the restroom. The male suspect walks to the back of the store and then approaches V2 a second time. The suspect then asked V2 where a specific aisle was located, and V2 directed the suspect to the correct aisle. V2 stated that he grew skeptical of the suspect and remained in the area to monitor him. In the surveillance footage, the suspect is seen concealing a backpack behind his back while waiting for V2 to walk away. The suspect then quickly grabs bottles of body wash and hair products, subsequently stowing the merchandise inside of his backpack. V2 witnessed this and immediately confronted the suspect. V2 told the suspect to stop and to place the items back. The suspect continues grabbing merchandise, and V2 then physically intervenes. The suspect breaks away and sprints to the front door with possession of the merchandise. The suspect manages to exit through the front entrance, still in possession of the merchandise. V2 chased after the suspect as the suspect ran out into the parking lot. V2 told me that the suspect appeared frustrated and made comments suggesting that he was expecting someone to pick him up. With nowhere to go, the suspect then began to throw objects at V2. V2 advised me that the suspect grabbed rocks from the ground and threw these rocks at V2. While I was speaking with V2, I observed that he had an injury to his left hand, consisting of a small laceration that drew blood. V2 advised that he was eventually able to recover the backpack from the defendant that possessed the stolen merchandise. The suspect then continued to run away, and he was last seen by V2 near the plaza by Maryland Fried Chicken and the Red Wok restaurant (in the 700 block of 21st Street).

The last known description and direction of travel was relayed to the officers who were responding to this scene. These additional units searched the area before locating a subject matching the description near 21st Street and 8th Avenue. Officer Thelisme (#435) later briefed me of his account, and he advised me of the following:

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 04/13/2026, at 21:00 (Specifically include facts constituting cause for arrest.)

Upon his arrival, Officer Thelisme began canvassing the area for the suspect. he then observed a black male wearing a dark-colored hoodie and grey shorts near the alleyway by Maryland Fried Chicken and the Red Wok restaurant. Officer Thelisme observed this suspicious male crouching down near the ground amongst other pedestrians who were standing normal. Officer Thelisme then circled around the parking lot and observed the same black male walking westbound in the 700 block of 21st Street. Officer Thelisme noted that the subject appeared paranoid as he would frequently check his surroundings. Officer Thelisme then activated his emergency lights and made contact with the individual, later identified as Tamorrio L. Clark (B/M DOB: 09/20/1980). At the time that he stepped out with Mr. Clark, Officer Thelisme observed that Mr. Clark was sweating profusely and he was visibly agitated. Mr. Clark was very defensive to any questioning regarding where he came from. Officer Thelisme told me that he requested Clark to keep his hands out of his pockets, but Mr. Clark refused and was not compliant. Due to his behavior and refusal to comply with lawful commands, Mr. Clark was then detained by officers. At the time that officers attempted to place Mr. Clark in handcuffs, Officer Thelisme advised me that Mr. Clark would tense up his body. Mr. Clark was eventually restrained and handcuffed.

At this point I was advised by Officer Thelisme over the radio that they possibly located the suspect. V2 agreed to perform a

"show-up" with me to determine if Mr. Clark was the suspect from this incident. I read the show-up instructions to V2, and he expressed that he understood. I then transported V2 to the scene where Mr. Clark was standing with officers.

When I drove by Mr. Clark, V2 uttered: yeah, that's him. V2 then again provided a positive identification by affirming his decision when we were parallel with Mr. Clark. It should be noted that while driving by, I observed that Mr. Clark was pulling away from officers and kept trying to break free. Officer Thelisme later advised me that at the time that we were performing the show-up, Clark became uncooperative with him and the two additional officers present. Mr. Clark refused to comply with the instructions provided by officers on the scene. Additionally, Mr. Clark would intentionally turn away his face and his body to hinder our ability to perform the show-up with the victim. The officers present with Mr. Clark had to restrain him to complete the show-up. While Clark resisted, Officer Thelisme noted that Mr. Clark would yell profanity at officers, stating that he wasn't going to let us complete the show-up.

Along with the positive show-up identification provided by V2, I was also confident that Mr. Clark was the same subject that I later observed during my review of the surveillance footage. Mr. Clark was placed under arrest at 21:23 hours. At the time of his arrest, it was discovered that Mr. Clark had an active warrant out of Indian River County for violation of probation. Mr. Clark was listed on felony probation for Third Degree Grand Theft (reference Indian River County SO case #2024-1130). A hit confirmation for this warrant was received at 22:02 hours.

While at the scene, V2 provided me with a receipt that documented an inventory of the stolen merchandise. The receipt listed four bottles of body wash and two "WAHL" hair clipper kits. The total value of the merchandise was \$104.33 in US Currency after tax. V2 also expressed that he wished to prosecute for the battery, providing his signature on a written statement.

Your affiant conducted a records check on Mr. Clark to see if he had previous convictions involving retail theft. I was unable to locate specific incidents of retail theft, but I observed that Mr. Clark had a conviction for petit theft (first degree) dated from 2024, and a conviction for grand theft (third degree) dated from 2025. Mr. Clark also had 12 felony convictions, including multiple prior offenses involving battery, narcotics, resisting arrest, and other property crimes.

Based on the facts above, Mr. Clark was charged with violation of:

-FSS 812.015(6) Retail Theft (\$100 less than \$750) with resistance to recovery of property by merchant. At the time of the theft, Mr. Clark was confronted by V2, who Mr. Clark had knowledge was an authorized employee of Dollar General. Mr. Clark then resisted and opposed V2's efforts to recover the merchandise, subsequently exiting the store with possession of the merchandise that he failed to provide payment for.

-FSS 784.03 Felony Battery (2nd or subsequent conviction). Mr. Clark struck V2 with a rock, causing injury to V2's hand. Court records show that Mr. Clark has prior convictions for battery/felony battery.

-FSS 843.02 Obstruction. Mr. Clark displayed willful physical resistance to officer's lawful orders and their attempt to restrain him. Mr. Clark intentionally pulled away and resisted officers' commands, with the intent to prevent a show-up and to hinder a lawful investigation.

-FSS 948.06 Violation of Felony Probation (3rd Degree Grand Theft) in reference to Mr. Clark's warrant (IRCSO Case #2024-1130).

Mr. Clark was turned over to the Indian River County Jail for booking and processing.

NARRATIVE

On April 13th, 2026, at approximately 2251 hours, I was dispatched to 36 1st Ct. SW., Vero Beach for a report of a disturbance. It should be noted, this residence is known to the Indian River County Sheriff's Office for frequent calls for service involving the following persons: Summer Johnson and Patsy Moore. Patsy is Summer's grandmother and they reside together at 36 1st Ct. SW and are related by blood.

Upon arrival, I observed through the front living room window, Summer screaming at Patsy who was seated in a recliner. I knocked on the door and Summer answered. We began speaking outside about the particulars of the disturbance. Summer is known to believe members of the Sheriff's Office are out to get her and believes there is a conspiracy between Patsy and law enforcement to get Summer in trouble. She is known to be diagnosed with [REDACTED] Deputy McKay and Deputy R.T. Williams were assisting in the investigation.

Deputy McKay was inside speaking with Patsy. I walked inside to speak with her, where she explained her wishes for Summer to be [REDACTED] While inside, Deputy McKay and I noticed through Summer's slightly ajar bedroom door, what appeared to be marijuana and a marijuana bowl. She was asked about a medical marijuana card, where advised she had an active and current one. Due to this, Deputy McKay to look in her room. Summer did not consent to deputies searching her room.

Summer walked into the residence with the intent to gather her medical marijuana card/identification, where during this process she opened the door to her bedroom and allowed Deputy McKay and I inside the room with her. While she was fanatically looking around her room for identification, I observed a multi-color sharp steak knife on the night stand directly next to her bed. I picked up the knife and placed it in a safe area. Summer began to yell and scream about this along with following me around the room, where I explained this was an officer safety issue.

During the course of running Summer's Florida ID card through Dispatch, Deputy McKay advised he observed what he believed to be a bag of cocaine on Summer's bed in plain view. He illuminated the item with his flashlight, where I observed a small plastic baggie filled with a white crystal-like substance. I immediately grabbed this item, and recognized it to be consistent with methamphetamine. It should be noted, the baggie was placed on top of Summer's bed, next to items such as her planner, cell phone, TV remote, and multiple lights and other personal belongings. The item was in plain view of deputies.

Summer was read her Miranda rights, where she stated she understood them. She explained the methamphetamine was not hers and she could not afford that much. I asked her how much methamphetamine she could afford, and she explained she did not use and offered to take a drug test. She stated she believed the drugs to be placed there by her mother, and housemate, identified as Kerry Moon.

It should be noted, I have personally responded to an overdose with Summer where she was believed to be under the influence of fentanyl (IRCSO Case 2025-82514). Fentanyl was seized from the exact bedroom we were in. It should be noted at the time of this overdose, methamphetamine was also seized from Summer's room along with smoking devices.

I secured the believed to be methamphetamine, brought it to my agency vehicle. I weighed the baggie, which resulted in 2.4 grams and conducted a field test for methamphetamine. This resulted in a positive test. The test

I spoke with Patsy and Kerry Moon (housemate). Kerry explained she had not been in Summer's room for multiple days, and explained she believed her to use methamphetamine. Kerry explained Summer states she has a camera in her room. Summer advised she does not have a camera in her room. Patsy explained she had been in Summer's room earlier; however, it is noteworthy that she is born in 1943 and is not a methamphetamine user. She is Summer's caretaker and allows Summer to live in her home.

Deputy McKay and other deputies on scene spoke with Summer, where she reconfirmed/affirmed that she invited us into her bedroom.

Summer was handcuffed (double locked/checked for fit) and transported to IRCSO Jail.
