### NARRATIVE

On Wednesday, August 27<sup>th</sup>, 2025 at approximately 1421 hours, I responded to 4315 27<sup>th</sup> Avenue in reference to a CSFAX for the Department of Children and Families (DCF).

I made contact with Department of Children and Families (DCF) investigator Gutowski, who provided information regarding an individual named Nathaniel W. Lee, who was reported to be residing with Thomeisha K. Woodson. It is pertinent to note that Woodson has an active injunction issued in the state of Illinois against Lee, which prohibits him from being "within 1,000 feet of her at all times," as mandated by the court order. This injunction is enforceable across all 50 states.

Upon arriving at the residence, I knocked on the door, and Woodson answered, accompanied by her child. We made several attempts to encourage her to step outside and engage in a conversation, but she declined to communicate with law enforcement or DCF representatives. Subsequently, Lee arrived at the scene, at which point we inquired if he was aware of the existing injunction. Initially, he claimed ignorance regarding the injunction; however, he later stated that he was aware of it but had chosen to assist Woodson due to concerns regarding her mental health and her situation with her son. He mentioned that she had been residing with him from August 24, 2025, to August 27, 2025, for approximately three days.

I spoke again to Woodson she advised that Lee and her moved in together about three weeks ago and have been together since. I asked Lee if Woodson pays any bills or provide for the house hold in anyway he advised she has never paid for anything and that she is living here due to him allowing her to. Lee now knowing he could be in trouble by near her he advised he did not want Woodson at the residence any longer. Lee was willing to sign a Transient Occupant Affidavit, as legal occupant of the residence, Lee signed the document stating he did not want her on the property and giving us the authority to remove Woodson from the property. Woodson was asked to leave by law enforcement several time and refused to leave. Woodson was explained that she would go to jail if she did not leave and that she would be trespassing. Woodland was ultimately taken into custody and was transported to the Indian River County Jail.

In conclusion, based on the aforementioned facts, Thomeisha K. Woodson is in violation of FSS 810.08 (trespassing).

### NARRATIVE

On Wednesday, August 27th, 2025, at approximately 2123 hours, I responded to 5655 38th Place, Vero Beach, FL, in reference to a disturbance. (Statements are paraphrased)

While enroute, IRCSO Public Safety Dispatch stated it was regarding an intoxicated male who was waiving around a knife. The male with the knife was later identified as Billy Arriaga.

Upon arrival, Billy was located standing in the roadway in front of the residence. Billy was detained for safety purposes. The above residence is a rooming house, which houses several residents.

I spoke to a resident of the house, named Antonio Saunders, where I gathered him and Billy were involved in a disturbance earlier in the evening. Antonio said Billy had female guests over at the residence, whom he was arguing with. Antonio tried to intervene and keep Billy from arguing with the female guests, which is where Billy and Antonio's disturbance escalated. Antonio began to walk outside of the residence and into the roadway. He began to walk west, where Billy continued to follow him. Antonio looked behind him, and could see Billy armed with a knife in his right hand, with the blade pointed at him. Billy was simultaneously following Antonio, placing him in fear that he would be harmed. When Billy was following Antonio, he was yelling derogatory names at Antonio and yelled "I'm going to fuck you up" several times. Antonio described Bill as being about 15 to 20 feet away from him. He described the knife to be about a foot long with a neon green handle. Antonio said he wanted to pursue charges against Billy for the incident.

Post Miranda, I began to ask Billy about his disturbance with Antonio and he mentioned that there was a disturbance with the two female guests at the house. He said he was afraid of Antonio but denied ever threatening Antonio with a knife but proceeded to say if I he did something then it was in his defense but was unwilling to articulate further.

A neighbor across the street, named William Kendall, had a surveillance video of the disturbance in the street. In the video, I could see Antonio walking westbound in the street. Behind him, I could see Billy follow him and retrieve a knife out of him pants with his right hand and hold it in the manner Antonio described. Antonio then began to walk off further and Billy walked back to the house. The knife was not located. The disturbance occurred on video at 1957 hours.

Based on the evidence presented, I determined there was probable cause to charge Billy with violation of FSS 784.021 Aggravated Assault. Billy was booked in the Indian River County Jail.
