NARRATIVE

On Tuesday, July 1, 2025, at approximately 0010 hours, I was traveling south on U.S. Highway 1, Sebastian, Florida, when I observed a large group of what appeared to be juveniles exit a residential neighborhood and proceed northbound.

I made contact with the group of six individuals at the intersection of Barber Street and U.S. Highway 1. As I spoke with the individuals, I was made aware that they had just left a house party where three of the juveniles stated they had smoked and consumed alcohol. As I continued to speak with the group it was determined there was two minors and four adults, I noticed one of the juveniles, Jase Vaughn (17-years-old), had a protruding can of twisted tea in his right pocket and a strong odor of marijuana was emitting from his person.

Cpl. Moon and I attempted to have both minors, Jase and Mason Moehle contact their guardians to have them picked up; however, as we continued speaking with them the odor of Marijuana continued to get stronger. Cpl. Moon stated that if they were in possession of any narcotics, they needed to hand it over. Jase and Mason both individually reached into their underwear, and removed the following: Jase had a clear plastic bag of Marijuana bud which was weighed on location as (24 Grams) of Marijuana. Mason Removed a clear plastic bag of Marijuana which was weighed as (6 grams) of Marijuana.

Once the bags were handed over both Jase and Mason were placed into custody and a subsequent search revealed both Jase and Mason were also in possession of THC Vape Pens.

Once Jase and Mason were secured into CPL. Moon and my patrol vehicle's, I began speaking with Jasper Lee. Jasper again stated they all reside in Melbourne, Florida and were in the area for a party of which had ended. As I continued to speak with Jasper, I again observed a very strong odor of Marijuana emitting from Jasper's bag. A subsequent search of Jasper's bag revealed three individually packaged bags of a green leafy Marijuana. The three bags were weighed on scene which confirmed the total package weight was 60 Grams of Marijuana.

It should be noted that Jase, Mason, and Jasper do not possess a medical marijuana card, the bags were not in a prescription container.

CPL. Moon transported Jasper to the Indian River County Jail, meanwhile I transported both Jase Vaughn and Mason Moehle for processing.

Due to the facts and Circumstances previously mentioned I find probable cause to charge Jasper with the following:

Count 1: Possession of a Controlled Substance- 60 Grams of Marijuana.

 On 07/01/2025 at 18:23 (Specifically include facts constituting cause for arrest.)

Defendant Rotem E. Elbilila violated Florida State Statue 812.131 Robbery by sudden snatching by snatching Anthony Pappagallo's phone from his hand after pushing him against the car and opening his cash app and sending himself \$130.00 against Pappagallo's wishes and inciting fear into Pappagallo.

Defendant Rotem E. Elbilila violated Florida State Statue 784.03(1)(a) by pushing Anthony Pappagallo into a vehicle and forcing him to give him his cell phone by snatching it out of his hand.

I responded to Mid Florida Bank located at 2800 20th Street in reference to a fraud that occurred. Upon my arrival I made contact with Anthony Pappagallo who stated he was forced to give the locksmith he hired money against his will. Pappagallo stated that around 10 am he hired Rotem E. Elbilila to help him get into his residence as he locked himself out of his home. Elbilila arrived and completed the work. Pappagallo had Elbilila follow him to Mid Florida bank to get \$150 cash for the payment for his service. Pappagallo stated that when he parked, Elbilila parked his vehicle blocking him in the parking space while he went inside. Pappagallo stated when he came out of the bank and gave Elbilila the \$150.00 cash, Elbilila stated that the fee was \$275.00. Pappagallo stated that is not what they agreed upon. Pappagallo stated that Elbilila became aggressive and started yelling to give him the money, and asked if he had cash app. Pappagallo started to take out his phone because he was afraid when Elbilila snatched the phone out of his hand while pushing him in between two parked vehicles and started to cash app himself the \$130.00. Pappagallo showed me the cash app where the line (To:) \$elilocks and wrote on the line (For:) lockout \$130 for you never gave me s. Pappagallo has a disability and remained at the bank after Elilila left however was able to take a picture of the rear of the vehicle and Florida tag bearing KP46IJ. That tag was registered to Rotem E. Elilila.

Pappagallo went inside the bank and told the teller what happened after staying at the bank afraid for a few hours. The bank teller advised Pappagallo to contact the police.

Pappagallo completed a sworn written statement and was sworn and attested to the statement at the scene. Mid Florida bank had security cameras facing the parking lot where I was able to observe on the video Pappagallo walking towards Elbilila attempting to hand him something and then Elbilila push Pappagallo between two cars in the parking lot while blocking him in preventing him from leaving. There was some type of physical altercation between the vehicles however due to the positioning of the camera I was unable to see the extent of the battery past the pushing of Pappagallo between the vehicle.

Pappagallo showed me the cash app of the transaction which photographs were taken on scene and placed into the evidence library.

Elilila was taken was detained on Interstate I-95 by Indian River County Sheriff's Office at 1630 hours after a BOLO was aired of the vehicle.

I read Elilila his miranda rights which he agreed to speak with me regarding the incident. Elbilila stated he did push Pappagallo at the bank because Pappagallo was refusing to pay him the amount he requested and Pappagallo was getting upset. Elbilila stated that he did take Pappagallo's phone because he was taking too long to send him the cash app.

I placed Rotem E. Elilila into custody and transported him to Indian River County Jail without incident.

Cpl J. Brumley (3415) remained with his vehicle on Interstate 95 until CJ towing arrived.

My BWC was active during this entire investigation.
