NARRATIVE

On Thursday March 25th, 2026, at approximately 1017 hours, Corporal Munni and I responded to the 4100 66th Avenue in reference to a LPR hit.

While traveling north bound on 66th avenue, I had a visual on a 2017 white Dodge Durango bearing FL tag#DI45NE traveling West on 41st Street making a left turn onto 66th Avenue heading southbound with extremely dark window tints.

I made a U-turn on 66th Avenue heading southbound catching up to the vehicle conducted a routine traffic stop. Final stop was at the 3500 block of 66th Avenue.

I approached the vehicle, stating the reason for the traffic stop. I asked the driver, later identified as Daija Stroyek, for license, registration, and proof of insurance to which she stated she does not have.

Deputy Whittington was asked to assist due to having a tint meter. Deputy Whittington stated the tint read 5% and the legal limit is 28% placing Daija in violation.

A query was made by Public Safety Dispatch to look up information on Daija Stroyek who was the driver of the vehicle.

Public Safety Dispatch responded advising Daija license is suspended.

Vero Beach Police Detective Jesse Maslan was present and stated that Daija was stopped a couple days prior by Vero Police for not having a valid driver license. Daija stated she was driving to the DMV to get it corrected prior to the stop.

Daija was arrested and placed in wrist restraints for fss 322.34 knowingly driving while license suspended revoked.

Daija vehicle was inventoried, searched and impounded by CJ's Towing with her knowledge.

Daija was transported to the Indian River County Jail for processing.

NARRATIVE

On Thursday, March 26, 2026 at approximately 2044 hours, I was requested to assist with a trespassing call for service. Deputy M. Ciofalo advised the following information:

“On March 26th, 2026, at approximately 2030 hours, I was dispatched to 1565 19th Ave. SW., Vero Beach for a report of a trespassing. The reporting party was identified as Benjamin Schwey. He stated a female was at his residence and refusing to leave. The female was later identified as Amber Raynor. It should be noted, I am familiar with Amber and Benjamin from previous interactions. I have personally arrested Amber on March 11th, 2026, for trespassing and served her with a trespass warning for this address. This is documented in IRC SO Case 2026-26262.

I arrived at the location, where I observed Ambers’ vehicle, identified as a 2007 Nissan Exterra parked southbound on 19th Ave. SW. I am familiar with her car from my prior interaction. I approached the driveway, where I began speaking with Benjamin. He explained Amber was at the residence, was highly intoxicated on alcohol, and was not invited over to the residence. Benjamin is the primary renter of the property and is the issuing party on the TAW from the prior case.

While speaking with Benjamin I observed the Nissan’s engine turn on. I heard a loud engine rev, which sounded like the driver took their foot and pushed the gas pedal to the floor without the vehicle being in park. The vehicle then drove away and turned onto 16th St. SW., where I followed the vehicle to the 1400 block of 21st Ave. SW. Due to the totality of the information gather, along with Benjamin’s statements regarding Amber being intoxicated on alcohol, I conducted a traffic stop. It should be noted, the prior call for service, Amber was intoxicated via alcohol. She was actively attempting to drink more wine during the prior call for service, where I removed the alcohol from her hand because she was belligerent.

I conducted a traffic stop, where I approached the vehicle. I requested Deputy Omari Green to respond to assist. I noted while walking up to the vehicle a strong sweet odor emitting from the vehicle. The odor appeared to be an odor of an alcoholic beverage. I began speaking with the operator, who was identified as Amber. She explained she left Benjamin’s house because she wanted to get her dogs. She explained she knew she had a trespass warning, but appeared to not care about the consequences.

I requested her license, registration, insurance. She struggled to find her license inside her wallet passing it over multiple times, and complaining throughout looking for it. While speaking with her, I noted her to speak with slurred speech, and have glassy eyes. I also noted an odor of an alcoholic beverage to be coming from her persons as she spoke. This grew stronger the more she spoke. She ultimately located her license and handed it over. I then requested her registration, which she attempted to hand me a large stack of documents and told me to look through them. I explained to her this was not my job. She attempted multiple times to have me look through the documents,

where she took deep breaths and exhales out of frustration. During these breaths she blew directly into my face, where the odor of an alcoholic beverage was extremely strong and overwhelming.

I asked her to step out of the vehicle and sit on my push bar, which she did so. Deputy Green arrived on scene and took over the investigation.

While Deputy Green was conducting his DUI investigation, I contacted Benjamin via telephone. He explained he wished to press charges due to Amber being on an alcohol fused bender. He explained this has been an on-going issue and her ex-boyfriend was on a date and not at the residence. I asked if he had video of the interaction which he stated yes. He was provided an Axon link to upload the video, which he did so. He swore via telephone that his statement was true under the pains of perjury.

I reviewed the video upon upload to Evidence.com. I observed the video to be filmed on March 26th, 2026, at 2022 hours. I observed Amber knock on the door to the front residence, where Benjamin opens the door. She asks to see her dogs, which he says "no" and shuts the door. He walks back into his residence. Amber is clearly identifiable, and was wearing the same clothes in the video as she was at the time of the traffic stop (black leggings and black tank top)."

I then began my DUI investigation.

DRIVER OBSERVATIONS

After arriving on the scene, I spoke with Ms. Amber Raynor and immediately I could smell the strong odor of an alcoholic beverage emitting from her breath as she continued to speak, I observed the following:

- Bloodshot eyes
- Watery eyes
- Slurred speech

When asked, Ms. Amber Raynor admitted to drinking earlier in the morning.

Before beginning the exercise, Ms. Amber Raynor was read the Miranda warnings which she stated she understood and agreed to speak to me. I then continued my DUI investigation, and asked if she had any medical problems and she replied that she did not.

HORIZONTAL GAZE NYSTAGMUS EXERCISE

Prior to attempting this exercise, Ms. Amber Raynor indicated she did not have any medical problems that would have prevented her from performing the exercise. It was determined that she was not wearing contacts. Her eyes were checked and they displayed equal tracking and her pupils were equal sizes. Ms. Amber Raynor was instructed to follow the stimulus with her eyes only, keeping her head still. After stating that she understood the instructions, Ms. Amber Raynor attempted this exercise. No resting nystagmus was observed.

The results of this exercise displayed 6 of the 6 possible clues.

- A lack of smooth pursuit in the left eye
- A lack of smooth pursuit in the right eye
- A distinct and sustained nystagmus in the left eye at maximum deviation
- A distinct and sustained nystagmus in the right eye at maximum deviation
- An onset of nystagmus in the left eye prior to 45 degrees.
- An onset of nystagmus in the right eye prior to 45 degrees.

During the exercise, she was unable to maintain her balance and encountered difficulty in following the stimulus without moving her head. Despite multiple instructions to keep her head still, she eventually grasped my forearm and requested that I remain still.

- Does not touch heel-to-toe.
- On the first set of steps, she did not touch heel-to-toe on steps 3, 5, 8 and 9.
- On the second set of steps, she did not touch heel-to-toe on steps 1, 3, 5, 6 and 7.
- Steps off the line.
- On the first set of steps, she stepped off the line on steps 3, 5 and 6.
- On the second set of steps, she stepped off the line on steps 1, 3, 5 and 6.




NARRATIVE

On March 26, 2026 at approximately 22:42 hours, I responded to 5555 20th Street (Walmart), in reference to a shoplifting call for service.

Prior to my arrival, I was informed that a male individual who was earlier identified as David Alex Mohan was back inside the store. David has an active trespass warning against him for this Walmart location (Reference case 2025-132097). David was related to another shoplifting and trespassing call that occurred on 3/25/2026 at this Walmart location (Reference case 2026-32224). There was already probable cause to arrest David for trespassing and for that past shoplifting incident that occurred on 3/25/2026.

Upon my arrival, I called the complainant who was also an asset protection employee, Sara Rene Ingo. I spoke with Sara via telephone to get accurate updates on David's movements and whereabouts while he was inside of the store. Sara stated the male was in isle i8 which was the sporting goods section near the bicycles. I continued to make my way to that area. While approaching the isle that David was in, I observed him in the isle wearing the same attire as seen on CCTV footage reference the (2026-32224) shoplifting incident.

David was seen wearing a black and white pull over sweatshirt, tan camo pants, black shoes, a black hat, along with wearing a new black backpack on his back.

Once I positively identified David as the suspect from the (2026-32224) case, I pulled out my agency issued taser and identified myself as law enforcement to David and commanded him to put his hands where I could see them. David was placed into custody and walked outside to my marked agency issued patrol vehicle.

While outside the store, the new black backpack that David had on and in his possession on his back had a new wrist watch in a case, as well as a cold Dr. Pepper soda beverage concealed inside the backpack. David's person was searched prior to getting into my agency issued patrol vehicle.

Furthermore, David was read his Miranda Warnings and he advised he understood them. Post Miranda, David was cooperative and stated he was inside the Walmart with the intent to steal the backpack, the wrist watch, and the soda. David stated he already had knowledge he was trespassed from the current Walmart location, but disregarded it. I had probable cause to arrest David for this incident as well as the other incident. David stated he steals merchandise from Walmart and sells it on the street for money to buy Narcotics. David stated he will both sell the items and trade the items for his drug of choice, Fentanyl. Post Miranda, David was also questioned about the 2026-32224 incident that occurred on 3/25/2026. David stated he was at Walmart on that date and stole merchandise. David stated he had a cart full of miscellaneous items which totaled \$399.71 and left without paying for them. David stated he has already gotten rid of all the stolen merchandise.

Later on in the investigation, Sara provided me with the following probable cause statement, "I, Sara, Ingo, Asset protection for Walmart, witnessed on CCTV a white male with camo like pants and a hat in shoes on March 26, 2026. I suspected the individual to be David Mohan, as I had seen the previous outfit the day before. I zoomed in on camera and I was able to confirm Mohan's identity. I then called IRC SO to alert them as I exited the office and went onto the floor.

NARRATIVE

On March 26, 2026 at approximately 20:42 hours, I responded to 5555 20th Street (Walmart), in reference to a past shoplifting call for service.

Prior to my arrival, I was informed that a male subject had stolen merchandise the night prior on 03/25/2026.

Upon my arrival, I spoke with Walmart Asset Protection, Sara Rene Ingo. Sara stated there was a white male individual wearing a black shirt, black hat, black shoes, and tan camo pants that had stolen a cart full of merchandise. The male was seen entering the store on 03/25/2026 at 22:42 hours and exiting the store at 23:06 hours. The male exited Walmart through the back Fire exit door without any attempt to pay for the merchandise in the shopping cart. The CCTV footage showed the male exit the through the back door with the shopping cart and take off running Westbound in the parking lot towards Sam's Club.

Sara stated the male has been seen at this Walmart location in the past and stolen from them. Sara stated she and her staff believed the male to be identified as David Alex Mohan from previous interactions. From the clear CCTV footage and the identifying features such as physique, tattoos, and wristbands, it was positively confirmed that the male suspect was indeed David Alex Mohan. Sara stated that David has already been trespassed from this Walmart location. Sara Stated that David had previously been trespassed on December 11, 2025 (Reference case 2025-132097).

Sara stated that David had a shopping cart full of sporting good items. From viewing the CCTV footage and observing David take items, Sara was able to put an item receipt together which showed what David stole. The total loss of merchandise was \$399.71

Sara provided me with the following probable cause statement, "I, Sara, Ingo, Asset protection for Walmart, witnessed CCTV footage for March 25, 2026 of white male wearing a black hat, and a dragon ball z shirt push out a cart full of merchandise through the hardware fire Exit doors. This person's name is believed to be David Mohan, and he can be described as a 26-year-old male, (DOB June 14, 1999), who was previously detained and trespassed from Walmart property. Mohan parked his bike behind the bushes at Sam's Club. He then walks over onto Walmart property and enters through the Grocery doors at 22:42. Mohan starts by grabbing food items from the bakery section, goes over to the drink area and selects multiple items, and then heads into apparel. With continued observation he makes selection in jewelry, head to grocery to select other items, and two items near the deli. Subject continues by making his way through cleaning supplies and then onto the clearance aisle. From what I could see, no items were selected at this time. I then witnessed subject in Sporting Goods at approximately 23:01. Multiple items including knives, two backpack duffels, a camping tool set, and a smiths knife sharpener were selected. Subject then heads into hardware but walks back to our automotive area to grab a Jackery solar generator. At approximately 23:06 the subject bolts out the fire exit door in hardware and runs back to the bushes by Sam's Club. Moments later, Subject then exits the bushes with two large bags (full) on his bike. The total amount of merchandise unrecovered was \$399.71. Walmart wishes to prosecute for this event."

Sara's witness statement was accurate. I viewed clear and precise CCTV footage that showed the incidents take place.

After I left the store, later on into the night Sara from Walmart Asset Protection called law enforcement again

approximately around 22:00 hours to inform us that the male suspect, David Mohan was back inside of the store wearing the same attire as seen from the past CCTV footage on 03/25/2026.

(Reference case 2026-32246), I called the complainant who was also an Asset protection employee, Sara Rene Ingo. I spoke with Sara via telephone to get accurate updates on David's movements and whereabouts while he was inside of the store. Sara stated the male was in isle i8 which was the sporting goods section near the bicycles. I continued to make my way to that area. While approaching the isle that David was in, I observed him in the store wearing the same attire as seen on CCTV footage from the 03/25/2026 shoplifting incident.

David was seen wearing a black and white pull over sweatshirt, tan camo pants, black shoes, a black hat, along with wearing a new black backpack on his back.

Once I positively identified David as the suspect, I pulled out my agency issued taser and identified myself as law enforcement to David and commanded him to put his hands where I could see them. David was placed into custody and walked outside to my marked agency issued patrol vehicle.

While outside the store, the new black backpack that David had on and in his possession on his back had a new wrist watch in a case, as well as a cold Dr. Pepper soda beverage concealed inside the backpack. David's person was searched prior to getting into my agency issued patrol vehicle.

Furthermore, David was read his Miranda Warnings and he advised he understood them. Post Miranda, David was cooperative and stated he was inside the Walmart with the intent to steal the backpack, the wrist watch, and the soda. David stated he already had knowledge he was trespassed from the current Walmart location, but disregarded it. I had probable cause to arrest David for the incident that occurred on 03/25/2026 as well as the other incident (2026-32246).

David stated he steals merchandise from Walmart and sells it on the street for money to buy Narcotics. David stated he will both sell the stolen items and trade the stolen items for his drug of choice, Fentanyl. Post Miranda, David admitted to being inside the Walmart on 03/25/2026 to steal a shopping cart full of merchandise. David stated he had a cart full of miscellaneous items, which totaled \$399.71. David stated he knowingly left the store without paying for them. David stated he has already gotten rid of all the stolen merchandise.

David was transported to the Indian River County Jail.

The stolen merchandise receipt and CCTV footage on a disc was submitted into Crime Scene as Evidence.

This entire interaction was captured on my agency issued Axon body worn camera.
