On May 7, 2024, at approximately 1230 hours, I was in the parking lot of 1808 Wabasso Beach Road, reference a parking violation.

While I was on scene, a woman I later identified by Florida Driver's license as Mary Mongillo, attempted to leave the beach parking lot. While I was watching, Mongillo backed out of the parking space successfully and began to travel forward. There was a large enough space between a properly parked truck and an improperly parked vehicle for Mongillo's vehicle to fit through. Mongillo hit the rear end of the properly parked pick up truck's rear bumper with the side of her vehicle. This all occurred in front of me, I observed her driving.

I finished my initial call for service at the same location, then assisted with the crash investigation in this case. When I spoke with Mongillo, I noticed her eyes were red, watery and glossed over. I could smell the odor of an alcoholic beverage exhaling from Mongillo's breath as I spoke with her. Once Deputy Fraker completed his crash investigation, I explained to Mongillo the crash investigation is over and I would be moving on to a criminal investigation for DUI.

I conducted Horizontal Gaze Nystagmus with Mongillo and observed the following: Mongillo failed to follow my instructions to use her eyes only, moving her head to follow the tip of my pen multiple times, she had a lack of smooth pursuit, and onset of nystagmus prior to 45 degrees. She was also swaying back and forth as she stood there.

I read Mongillo her Miranda Rights, she stated she did not wish to answer questions. I informed her that I would be stating, not questioning, what happened thus far which got us to this point of our investigation. I further reminded her, anything she chooses to say while I explain the process to her, will be used in my investigation. She understood. I asked her if she had any health conditions which would keep her from being able to conduct a series of simple exercises. She stated she has extreme leg pain,

not specifying a medical condition. However, she was able to walk a short way on the beach.

Mongillo stated she would participate in the Standardized Field Sobriety Tests.

I explained and demonstrated the one leg stand. I observed the following: She stood with her feet together and hands behind her back. Which was then corrected. She held her hands out to her sides in an attempt to keep her balance. She counted properly until she put her foot down and stopped counting, stopping the exercise. I told her she could stop.

I then explained and demonstrated the walk and turn: Mongillo attempted to begin the exercise a number of times prior to me telling her to begin and before I was finished explaining or demonstrating the exercise. It took multiple tries to explain and demonstrate the exercise, because each time she would start without being told to do so she would get frustrated, say she can't do it and walk away. She came back to me each time after initially walking away. She stated she understood the instructions. When she performed the exercise, she did not make contact between her heel and toe as she made each step. She used her arms to keep balance. When she finished the first set of 9 steps, she thought she was supposed to take 9 heel to toe steps backwards. I demonstrated how to turn, more than once in order to walk the 2nd set of 9 heel to toe steps. I told her she was not supposed to walk backwards and that she needed to turn how I demonstrated previously. She turned but did not keep her one foot on the line. The next set of steps she took were also not touching heel to toe. She also did not keep her arms at her sides.

Mongillo was placed into custody and transported to the jail.

She provided a sample of her breath at the jail. Resulting in a BAC of .203 and .194.

Mongillo's fiancé stated he's attempted to put her into rehab twice already and that has not been successful.





NARRATIVE

On 05/07/2024 I responded to [REDACTED] in reference to a stolen vehicle call for service.

I spoke with the owner of the vehicle Teresa Morrow, who stated her boyfriend Homer Petty was in possession of her vehicle without permission. Teresa stated she is the registered owner of the vehicle, and that no one has permission to drive the vehicle other than herself. Teresa stated Homer has had her vehicle the past 7 days, and will not return it.

Teresa showed me multiple text messages telling Homer to bring the vehicle back to the campsite. Homer refused to bring the vehicle back, and blocked Teresa's phone number.

I verified with a records check on NCIC/FCIC that Teresa is the sole registered owner of the vehicle.

While at the scene of my investigation, Homer returned to the scene. In attempts to conceal the vehicle, Homer parked the vehicle at the back of the Campground out of Teresa's sight and my sight. Homer additionally concealed the keys to the vehicle, in the on-site laundry mat underneath a pile of clothes.

Post miranda, Homer advised he did have the vehicle for the past 7 days but claimed he had permission. Homer stated he knew that Teresa wanted the vehicle back but did not have gas to bring it back.

Homer was taken into custody without incident.

NARRATIVE

On Tuesday, May 7th, 2024, at 1842 hours, I, Indian River County Sheriff's Office Deputy Ballester, responded to [REDACTED] in Indian River County, in reference to a disturbance call for service.

Upon my arrival at the residence, I made contact with the complainant, Patrick Gregory Soares, who informed me of the following:

On today's date, May 7th, 2024, he was sitting down in the kitchen area having a conversation with his stepson, John Paul Wandell, when his ex-wife, Bobbie L. Di Benedetto, walked into the kitchen and asked him to leave so she could cook in peace. Patrick stated that he wasn't going to move because he was talking to John, at which point Bobbie grabbed the chair where he was sitting and pulled it from underneath, causing him to fall and hit his back.

Patrick informed me that he has seven folding disks due to a car accident he was involved in about three years ago and that Bobbie was aware of it. During my investigation, Patrick was observed limping as he was walking towards law enforcement, and he showed me a medical brace he was wearing on his waist.

Contact was made with John Paul Wandell, who told me the following: John was talking to Patrick when his mother, Bobbie, walked into the kitchen and began to argue about Patrick leaving the kitchen so she could cook in peace. John stated that he observed his mother bending down near Patrick to pull the chair where he was sitting down, causing Patrick to fall to the ground.

I then made contact with Bobbie L. Di Benedetto, who told me the following: Bobbie stated that Patrick and her have been having issues due to him not leaving the house and being a terrible roommate. Bobbie stated that she walked into the kitchen to cook and asked Patrick to leave so she could cook in peace, and Patrick told her that he wasn't going to go anywhere. Bobbie then grabbed the chair he was sitting on and pulled it away, causing Patrick to stumble.

I asked Bobbie why she did that knowing about Patrick's injuries, to which she replied, stating that she did not know that he had surgery on his back but was aware of the car accident and medical procedures Patrick had undergone due to the car accident a couple of years ago.

At the conclusion of my investigation and based on the statements from all parties involved, I charged Bobbie L. Di Benedetto with battery domestic violence consistent with FSS 784.03.1a1. Bobby was then transported to the Indian River County Jail without incident.

I, Officer Ayala, responded to Southeastern Truck & Auto located at 2530 US HWY 1 in reference to a suspicious incident.

Upon arrival, I made contact with Officer Covarrubias who advised he observed a white male subject, later identified as David A Farinella, located inside a vehicle belonging to the auto shop. Officer Covarrubias stated he spoke to the owner of Southeastern Truck & Auto who explained that he stopped by his shop and observed an unknown white male subject playing music inside one of his vehicles. Officer Covarrubias detained the subject and inquired if that was his vehicle to which he stated no and that the vehicle had been unlocked which is how he gained access.

I made contact with owner, Steven Loudermilk, who advised he had stopped by to switch his vehicle out when he noticed an individual on his property and as he got closer, he observed the subject get inside one of the vehicles and close the door behind him and proceed to smoke a cigar. Loudermilk immediately contacted Law Enforcement. Loudermilk advised the vehicle was left unlocked due to a missing key. Loudermilk advised the business was closed and no one had permission to be on the property.

I then made contact with Farinella. I read Farinella his Miranda warning to which he advised he understood, but was not willing to speak to me.

Farinella was placed under arrest for being in violation of FSS 810.08 Trespass and FSS 856.021 Loitering and Prowling.

On 05/07/2024 at 01:01 (Specifically include facts constituting cause for arrest.)

On 05/07/2024 at approximately 0101 hours I was sitting stationary in my marked patrol vehicle, at the 300 block of CR-512 facing east. While monitoring west bound traffic, I observed white Honda 4D bearing FL temporary tag DPV7619 traveling at a high rate of speed. I visually estimated the vehicle's speed to be approximately 80 mph in a posted 35 mph zone. I activated my agency issued radar (Kustom Golden Eagle II S/N XE38932) which displayed a speed of 81 mph for the vehicle. The Doppler tone was consistent with the displayed speed, as such; I conducted a traffic stop of the above vehicle.

The vehicle stopped near the 400 block of CR-512 on the right shoulder of the roadway. I made contact with the driver and sole occupant of the vehicle, identified via Guatemala Passport as Hugo Ruiz Domingo, who was the registered owner of the listed vehicle. While requesting basic documents such as driver's license, registration and vehicle insurance, Hugo stated "he has no license". Due to the language barrier, Officer Venegas #420 was summoned to the scene to translate. Officer Venegas stated Hugo explained he just was involved in a verbal disturbance with his boyfriend, causing him to drive as fast as he was. Hugo stated he resides in Orlando, although drove to Sebastian to visit friends. Hugo admitted he has never had a driver's license issued and knows he is not allowed to drive.

Through the course of the investigation, it was learned Hugo did not possess a valid license which was confirmed via dispatch. Additionally, it was learned Hugo received a criminal citation (A5HELJP) regarding driving without a driver's license on 02/06/2024 from Orlando Police Department with a pending court date of 06/17/2024.

At this time, Hugo was placed under arrest and in mechanical hand restraints. Hugo was transported to Indian River County Jail for processing. Hugo was issued a uniform traffic citation (AIU68UE) for F.S.S. 322.03 (1).
