NARRATIVE

On Tuesday, June 24th, 2026 at approximately 0222 hours, I responded to the 7200 block of State Road 60 to assist Corporal A. Ballester in reference to a possible intoxicated driver. Upon my arrival, Corporal A. Ballester stated the following:

“On June 24th, 2026, at 0222 hours, I responded to the area of 66th Avenue and State Road 60, Vero Beach, Florida, in reference to a reckless driver. While in route, I was advised that the driver of a black Jeep bearing Florida tag HB DL87 was reportedly driving while intoxicated and was heading toward Aspire Apartments, located at 7590 20th Street. I was able to locate the vehicle at the intersection of 66th Avenue and State Road 60. As the vehicle proceeded westbound, I observed it jerk sideways while in motion. As I got closer to the vehicle, I observed it change lanes from the far-right lane to the far-left lane, where I continued to observe the same jerking pattern. I then conducted a traffic stop on the aforementioned vehicle and made contact with the driver and sole occupant, later identified as Christen Ann Leaf. While speaking with Leaf, I observed that her eyes were glassy and droopy. I requested her driver’s license, vehicle registration, and proof of insurance. Leaf stated that she had just picked up her belongings from a friend’s house and was unable to provide any of the documents requested.

I then contacted Deputy O. Green to assist with the investigation.”

Subsequently, I engaged in conversation with Ms. Leaf. During our interaction, a strong odor of an alcoholic beverage was emanating from her breath. It was observed that she had bloodshot and watery eyes, as well as slurred speech. I instructed Ms. Leaf to exit the vehicle; she agreed and proceeded to walk from her vehicle to the front of Corporal A. Ballester’s agency issued Tahoe. After a few seconds, she appeared confused and inquired again about her instructions. As she began to walk, she noticeably stumbled throughout the entire walk to the front bumper. At this point, Ms. Leaf was read her Miranda warnings, which she stated she understood, and she exercised her right to remain silent, refusing to speak to me or any other Deputy on scene. I requested her participation in Field Sobriety Exercises; she declined. I then advised her of the Taylor warnings, explaining that, due to her refusal, a decision would be made based on my observations and the information gathered, potentially resulting in her arrest. Ms. Leaf made a second refusal to participate. She was subsequently restrained and secured into the rear of my patrol vehicle, then transported to the Indian River County Jail.

When I arrived to the jail, Deputy Cazares attempted to administer the states test and it was reported to me that Ms. Leaf refused to provide her breath and after being implied consent she still refused to provide her breath. Based on the clues, all of my observations and statements made by Ms. Leaf, Ms. Leaf was placed under arrest for violating FSS. 316.193 (1)(A) (Driving Under the Influence) and FSS. 316.1939 (1)(E) (Refuse to Submit to BAC Test.

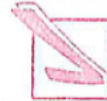

NARRATIVE

On Wednesday June 24, 2026 at approximately 0851 hours, Deputy Fraker and I responded to [REDACTED] in reference to a domestic violence.

While in route to the call dispatch advised the following: mother and father are in a disturbance. Father is trying to fight caller's older brother. Physical and thinks mother is possibly injured. Some sort of arm injury. Male left in a black Chevrolet truck.

Both myself and Deputy Fraker observed a black Chevrolet truck drive past us. Both units then turned around. Deputy Fraker provided the Florida tag QYCC63 which returned to a Melanie Goldie and a Thomas Goldie. Due to the driver being the possible suspect a traffic stop was initiated in the 1100 block of County Road 512. Deputy Fraker made contact with the driver who identified himself with his Florida driver's license. Deputy Fraker explained that the stop was due to a call for service and asked him to step out of the vehicle to which he complied.

I then relocated to the primary address of [REDACTED] where I made contact with Nohelani Goldie (complainant) who advised she heard a verbal argument between her mother (Melanie Goldie) and her father (Thomas Goldie). When she exited her room she observed her mother in the doorway of the garage and kitchen. She observed her father in the garage and appeared to be throwing things towards her mother. She believed her mother was struck by the objects being thrown.

I then made contact with Kalei Goldie (victim) who stated he was in [REDACTED] when he heard a verbal altercation between his mother and father. Upon exiting his room, his father (Thomas) was in the garage throwing things. Due to his mother crying he believed that Thomas struck her. Both he and Thomas got into a verbal altercation inside the garage. Melanie tried to intervene by pushing both apart from each other. The argument still kept on and Thomas punched him in the face with a closed fist however, he was not aware till after due to the adrenaline. His sister Nohelani then said [REDACTED] and Thomas ended up getting into his truck and left the area.

Next contact was made with Melanie Goldie (witness) who stated that a verbal argument occurred when Thomas became upset she did not stand up to the bank when they took all of their money. Melanie explained to Thomas that it was a judgment and there was nothing she could do. Thomas then got loud and both were arguing and she became upset. Due to her crying her kids exited [REDACTED] Thomas then went into the garage and was throwing items around inside the garage. When Kalei went into the garage to confront him he had to flip a wheel barrow out of the way that Thomas flipped towards the kitchen door blocking it. Kalei and Thomas then got into a verbal argument and she tried to stop it by getting between them and pushing them apart. The argument still was going and Thomas ended up punching Kalei in the face. Melanie stated her and Thomas were in a verbal altercation however, nothing physical occurred between them.

I then relocated back to the traffic stop and made contact with Thomas Goldie who was detained. I read Thomas Miranda Warnings and he stated he understood his rights and wished to talk. I asked Thomas what started the argument today and he stated nothing started it today, this incident started yesterday. Today he confronted his wife on why she did not seem to care that all their money was gone. That is when he got upset and went into the garage. Kalei came into the garage and started throwing weights at him however, he was blocking them with his hands.

I asked Thomas why he punched Kalei and he stated he did not touch him. I asked Thomas why Kalei had a red mark on his face and he stated I don't know. Kalei was throwing weights at him. I explained to Thomas that due to there being an injury and witness to this incident he was being placed under arrest for domestic battery. I explained

that there was no security camera's or witnesses that match Thomas's side of the incident.

Based off the information gathered Thomas intentionally and knowingly struck Kalei against his will and was placed under arrest. (F.S.S. 784.03.1A) Due to Thomas being the father of Kalei this act falls under domestic violence.

Thomas was transported to the Indian River County Jail. Once inside the jail booking Deputy Kane went to unlock the handcuffs on Thomas. Thomas then interlocked his fingers preventing Deputy Kane from unlocking and removing the handcuffs. Eventually Thomas complied and the handcuffs were removed.

NARRATIVE

On June 24th, 2026, at approximately 1932 hours, I was stationary in the area of Roseland Road and US Highway 1, Sebastian, Florida.

At that time, I witnessed a red Nissan Titan (bearing FL tag AHBV95) turn eastbound on Roseland Road from US Highway 1. An NCIC/FCIC query revealed Florida tag AHBV95 was not assigned to a vehicle and had been distributed to the tax collector's office. Additionally, the vehicle had dark tint on all passenger windows, as well as, a completely tinted windshield.

I subsequently conducted a traffic stop on the vehicle in Roseland Plaza, located at 13600 US Highway 1, Sebastian. I made contact with the driver, and sole occupant, Mr. Ethan Tinkham. When I requested Mr. Tinkham's driver's license, he stated he only had a Georgia ID card and not a driver's license.

An NCIC/FCIC query of Mr. Tinkham's ID card through Indian River County dispatch revealed Mr. Tinkham did not have a valid driver's license out of Georgia. An NCIC/FCIC query of the Nissan Titan's VIN (VIN #: 1N6AA07A24N532906) also revealed that the vehicle was not registered. The vehicle's window tint was also measured 4%.

During a post-Miranda interview, Mr. Tinkham advised that he placed a random license plate on the vehicle and that he knew the vehicle was not registered.

Mr. Tinkham was placed under arrest for the offenses of driving while suspended (with knowledge), unregistered motor vehicle, and attached tag not assigned. He was placed into handcuffs that were checked for proper fit and double-locked. Mr. Tinkham was transported to the Indian River County Jail, without incident.

Mr. Tinkham was issued three citations for driving while suspended (with knowledge) (citation #: AMOOCTE), unregistered motor vehicle (citation #: AMOOCUE), and attached tag not assigned (citation #: AMOOCVE). He was issued one warning for improper window tint.

NARRATIVE

On 06/24/26 at approximately 2104 hours I responded to 4855 38th Circle in reference to a Disturbance at that location.

Upon my arrival other responding Deputies were already on scene and had separated the parties. I spoke with Tra Derricka Smith. She said she came to the location to speak with her ex-girlfriend Jasmyne Johnson regarding her continued access to Smith's Facebook account. Smith said she was standing in the hallway of the apartment complex speaking with Johnson. She said the conversation was getting heated. Smith said she was trying to get Johnson to go with her to another location so they could speak privately. Smith said Johnson was not willing to leave with her. While the conversation continued Smith said Johnson got angry and told her she was going to Bear spray her. Smith said Johnson then pulled a can of Bear spray out and sprayed her. Smith said she backed up and grabbed for her firearm which was holstered in her waistband. She said she grabbed the firearm but did not draw or point it at anyone. Smith said she covered her face with her shirt and then walked away. Smith said all events occurred while she was standing in the hallway and Johnson was standing in the doorway to the apartment.

Sergeant Le spoke with Johnson while I was speaking with Smith. Johnson told Sergeant Le that Smith arrived at the residence without being invited. She said Johnson came over and was banging on the door Johnson said she answered and confronted Smith. During the course of the conversation Johnson said she exited the apartment. She said Smith came toward her aggressively. Johnson said that was when she Bear sprayed Smith. Johnson said Smith grabbed for the gun, but never produced drew it. She further stated no threats were made by Smith. Johnson said there were multiple witnesses, but no one came forward on scene and wished to give a statement. Additionally, she claimed there was video evidence to support her claims. No video was produced while Deputies were on scene.
