NARRATIVE

On Friday, December 19, 2025, at approximately 1640 hours, I responded to the 1700 block of Indian River Blvd, in reference to a reckless driver, reported by another motorist. The caller reported a white Audi SUV, bearing Florida registration BL51CY, driving north on Highway A1A passing the Seagrove Drive. The caller (Derrik Chapman 619-559-4176) reported the vehicle was all over the roadway and last seen west bound from the 17th Street Causeway in Vero Beach, FL.

I located the vehicle in the northbound turning lane of Indian River Blvd, from the 17th Street Causeway. I followed behind the vehicle northbound on Indian River Blvd with the vehicle traveling in the left inside lane. I observed the vehicle fail to drive in a single lane while other vehicles were traveling on the roadway. The vehicle's left tires would drive over the solid white line separating the median from the roadway. The vehicle almost rear ended a vehicle stopped in traffic and applied the brakes suddenly to avoid a collision. While approaching the intersection of Royal Palm Place and Indian River Blvd, the vehicle jerked suddenly form the inside lane and entered the left turn lane for Royal Palm Place. While the vehicle proceeded west on Royal Palm Place, the vehicle's right tires drove onto the sidewalk. I initiated a traffic stop on the vehicle, which pulled into the driveway of 528 Royal Palm Place.

The vehicle was occupied by (3) young females. I made contact with the driver, who was identified by her Florida driver's license as Gillian Giordano. I asked Gillian to provide her driver's license, registration and proof of insurance. I observed Gillian to have slurred speech and glazed eyes. I noticed the odor of an alcoholic beverage emitting from Gillian's breath, which grew stronger as she spoke. Gillian had difficulty providing the requested information and would hand me the registration and then handed me another registration that she identified as her insurance. Gillian denied consuming any alcohol.

I had Gillian exit the vehicle and walk to the front of my patrol vehicle. I observed Gillian to be unstable on her feet and noticed an orbital sway while she was standing by my vehicle. While away from her vehicle, I again noticed the odor of an alcoholic beverage emitting from her breath.

I asked Gillian if she had any medical conditions and she stated no. I asked if she took any medication and she stated Gillian denied taking any narcotics or any prescription medications. Gillian again denied consuming any alcoholic beverages. I informed Gillian I believed her normal facilities were impaired and asked for her to consent to perform Standardized Field Sobriety Test (SFST). Gillian gave consent and stated she would participate with the exercises.

explained each exercise to Gillian and verified she understood the instructions prior to asking her to begin the exercise.

During the nystagmus test, I observed Gillian to have an orbital sway while standing. During resting nystagmus, I observed equal pupil size, and I observed nystagmus in both eyes. During Horizontal nystagmus, I observed a lack of smooth pursuit and the onset of nystagmus prior to 45 degrees. I observed nystagmus in both pupils while at maximum deviation.

I explained and demonstrated the one-leg-stand test and verified if Gillian understood the instructions prior to asking her to begin the exercise.

Gillian stated she would raise her left foot because she was left-handed. During the exercise Gillian failed to look down at her feet, failed to keep her foot elevated by dropping it to the ground multiple times. Gillian then began to march forward in a

complete disregard of the instructions given and test demonstrated.

I explained and demonstrated the walk and turn test and verified if Gillian understood the instructions prior to asking her to begin the exercise.

Gillian failed to maintain the starting position as instructed. Gillian then failed to walk heel and would raise her arms in an attempt to maintain balance, while stumbling off center during the exercise.

I placed Gillian under arrets for suspicion of DUI. While collecting Gillian's belongings, I asked the other two passengers if they consumed any alcohol to verify if they could drive the vehicle. Both female passengers stated they did and were unable to drive. One of the passengers who was asked to find a shirt that could cover up Gillian's bikini, stated Gillian was drinking Surfside prior to driving the vehicle. The females were instructed to call a friend to drive them and the vehicle, which Gillian agreed to.

A vape pen was located inside Gillian's purse, which was collected and submitted to crime scene for destruction.

Gillian was transported to the Indian River County Jail. While transporting Gillian to the jail, I told her one of her passenger's stated Gillian was drinking vodka seltzer, to which Gillian replied no it was Surfside, which is a drink that contains vodka.

While at the jail, Gillian provided two lawful breath samples, with results of .19 BAC and .20 BAC. Gillian was issued a DUI citation .15 BAC or higher.

This investigation was captured on my agency issued body worn camera.

This case is cleared by arrest.

NARRATIVE

On December 19, 2025, at approximately 2210 hours, I was patrolling the car dealerships, south of US Highway 1 and Oslo Road due to recent auto thefts in the surrounding area. I observed a person in dark clothes pacing at 1075 S. US. Highway 1 in front of the Toyota dealership, behind a bush where the business utilities are located.

It should be noted that at this time the business is closed and its an unusual place for a law-abiding individual to be. I advised Dispatch I would be out with a suspicious person at this location.

As I made contact with a black male wearing dark color shorts and a dark hooded sweatshirt. Upon attempting to interact with the male, he began to act in an erratic manner, backing up as he spoke, stuttering and rephrasing his words in a nervous manner. I asked what he's doing and why he was there, he stated he's just getting the Wi-Fi to make a phone call. With every question asked he took a step back as if he wanted to get away. As I attempted to identify the subject, he stated that his name was Michael Samuel Moore with a date of birth of September, 29 1980. A query was conducted with dispatch and came back to no record of that individual. He was then asked for his social security number which he provided 354-78-8943 which once again comes back with no record found. As I continued to ask questions in efforts to properly identify the subject, he became repetitive with his statements and agitated at my questions. He was later identified as Traivon Littleton by Corporal Moon.

Deputy Scott arrived on scene and assisted with the investigation. While deputy Scott spoke with Littleton, a black phone charger was directly on the ground by a utility meter's electrical outlet. Littleton was asked if it was his charger and he stated yes and that he was just there to charge his phone and get on the Wi-Fi to call for a ride. I explained that Theft utility is a crime and he stated he didn't know.

Deputy Scott then read Littleton his Miranda rights which he waived and agreed to speak with us. Post Miranda, Littleton continued to give the false name of Michael Samuel Moore, date of birth of September 29, 1980 and social security number 354-78-8943. I then asked Littleton to dispel my fears of loitering and prowling. He was asked if he was invited there, or if he had permission to be there, he stated no, he did not have permission to use the utilities to charge his phone, he wasn't there to purchase a vehicle and there were no employees present after business hours. Littleton could not dispel my fears of loitering and prowling specially after concealing his identity and his unusual behavior.

After making all attempt to properly identify Littleton, Deputy Scott asked Corporal Moon if she could assist with her agency issued Rapid ID. Upon Corporal Moons arrival, post Miranda, and after using the Rapid ID device, Littleton was properly identified.

After determining Littleton's identity, it was determined that he gave a false date of birth, and a false social security number as well. I asked him his name, he stated it was his brother. Soon after he admitted to his name, and that he lied and gave false information. Littleton also admitted to using utilities to charge his phone.

Based on the fact listed above, I find probable cause for the following:

NARRATIVE

On Friday, December 20, 2025 at approximately 2120 hours Cpl. J. Lang and I were dispatched to in reference to a trespassing.

Upon arrival we made contact with the victim, Jennifer McBride who advised the following:

Her ex-boyfriend, Joshua Riddlehoover showed up to her residence uninvited and banged on her bedroom window. He stated "You're going" in reference to him wanting Ms. McBride to move out of Vero Beach. She has been having ongoing issues with Mr. Riddlehoover the past couple months. Ms. McBride showed us video footage of the incident and I observed Mr. Riddlehoover banging on Ms. McBride's window. Indian River County Public Safety Dispatch advised me that Mr. Riddlehoover was trespassed from the residence on 3/12/2024 reference case # 2024-28451.

Ms. McBride also mentioned to us how Mr. Riddlehoover has been harassing her with constant calls, voice messages, and text messages. These incidents of communication from Mr. Riddlehoover all came from the same cell phone number (772) 834-6497. This number is the number that Ms. McBride has known Mr. Riddlehoover to use and communicate with him during the whole course of their 7-year relationship. Ms. McBride stated that she has been telling Mr. Riddlehoover since August of this year to stop communicating with her and to leave her alone. Multiple incidents of this request from Ms. McBride to cease communication was observed by myself in text messages between Ms. McBride and Mr. Riddlehoover. Ms. McBride advised that despite this request of no communication, Mr. Riddlehoover continues to call her approximately 20 times a day to which she never answers. While on scene speaking with Ms. McBride, Mr. Riddlehoover called her to which she answered and he questioned her to why she didn't answer the thousand of other calls he attempted to make. After Ms. McBride hung up the phone, Mr. Riddlehoover continued to call back approximately 3 times in rapid succession while we were on scene investigating.

Ms. McBride also advised that Mr. Riddlehoover texted her a written threat to kill her. Ms. McBride showed me the text message coming from the same aforementioned number which stated the following: "Bitch I will kill you". Ms. McBride also showed me similar instances of a threat to kill in one of her voice messages from the aforementioned number to which she knew the voice to be of Mr. Riddlehoover's. The voice message she played out loud to me said the following: "I don't want to have to kill the both of you". This threat was in reference to Mr. Riddlehoovers suspicion of Ms. McBride having another intimate partner. This is evident through other voice messages Ms. McBride played out loud for me which she also recognized to be Mr. Riddlehoover, berating her, calling her a liar, and general frustration about her talking with someone else besides Mr. Riddlehoover. Ms. McBride played 4 voice messages from 12/18, and 2 voice messages from 12/17 all from unknown numbers, but Ms. McBride recognized and knew for certain it was Mr. Riddlehoover speaking on the voice message. While listening to these voice messages I observed dozens of other voice messages left by unknown numbers to which Ms. McBride advised all came from Mr. Riddlehoover.

Ms. McBride also showed us more text messages between her and Mr. Riddlehoover from the same aforementioned number to which the context surrounding this conversation was about an injunction case against Mr. Riddlehoover:

On March, 25th 2025 Mr. Riddlehoover texted Ms. McBride, threatening her to show up to her place of work (Scully-Welsh Cancer Center, 3555 10th Court, Vero Beach) and demand that she be drug tested if she did not get the injunction dropped

immediately. This text was sent from the same aforementioned number by Mr. Riddlehoover to Ms. McBride 2 days prior to when the injunction hearing was to take place. Refence court case number 312024DR000214AXXXVB the hearing happened on March 27th, 2025 to which the injunction ended up getting dismissed. Ms. McBride advised she had the injunction dismissed due to the threats made to her by Mr. Riddlehoover, and that she was in fear that he would get her fired or damage her reputation if she did not get it dropped.

On 12/18/2025, Ms. McBride mentioned how Mr. Riddlehoover stalked her from her place of work (Scully-Welsh Cancer Center, 3555 10th Court, Vero Beach), to the Indian River County Sheriffs Office, and almost all the way home. This accusation made by Ms. McBride was found to be truthful as Real Time Crime Center found traffic camera footage of the incident taking place. Ms. McBride advised that Mr. Riddlehoover showed up to her work in his truck (Black Chevy bearing tag #FNCW70). This truck can be seen on camera following Ms. McBride from her place of work, to the Sheriff's Office, and towards her house. Ms. McBride advised that prior to Mr. Riddlehoover following her, when he showed up to her work, he threatened to ram her with his car if she did not answer his phone calls.

Upon making contact with Mr. Riddlehoover, he was detained and read his Miranda rights. Post-Miranda, Mr. Riddlehoover advised the following:

He admitted to showing up to her house tonight referencing our original call for trespassing, he initially stated that Ms. McBride had been inviting him over but admitted to not being invited over tonight. He admitted to banging on her window and saying "You're going" and leaving after that. Mr. Riddlehoover also admitted to texting Ms. McBride the written threat to kill but defended himself by stating he only did so because she has done the same to her. He stated that the text messages on his phone would prove it, however while scrolling through his conversation with Ms. McBride for approximately 20 minutes we were unable to find any evidence substantiating this claim of his. Mr. Riddlehoover admitted to following her home from work, he stated that he didn't follow her he was just "behind her" and that they were on the phone the whole time.

Based upon the above information, and my investigation along with the evidence from camera footage, text messages, and voicemails. I found probable cause to arrest Mr. Riddlehoover pursuant to the following charges:

- F.S.S 784.048.3[2567] Aggravated Stalking-due to him following her and threatening to ram her vehicle and also making verbal and written threats to kill her.
- F.S.S. 836.10.2a[9471] Written / Electronic Threat to Kill / Bodily Harm to Another-due to him texting her that he would kill her and also leaving a voicemail threatening to kill her.
- F.S.S. 836.05[3104] Extortion or Threats- due to him threatening to damage her reputation or get her fired if she did not drop the injunction.
- F.S.S. 914.22.1a[9355] Tamper Witness to Withhold Testimony / Information of Non-Criminal Proceeding- due to him threatening to damage her reputation or get her fired in order to have her withhold her testimony.

On Saturday, December 20, 2025 at approximately 0020 hours, I was on routine patrol in the area of 1405 Indian River Boulevard, Sebastian, Florida, 32958 (Earls Hideaway) when I observed and heard a disturbance outside the establishment.

Upon contact, with a large group of individuals, I observed a male and female arguing and beginning to get physical and with each other. I ordered the male to move away and come talk to me. The male was later Identified by Florida Driver License, as Tyler Helock. Tyler continued to ignore my commands. Tyler began to aggressively approach me as I continued to tell him to step away and talk with me separate from everyone. Tyler aggressively postured up to me and continued to ignore my commands while yelling loudly. To create distance from Tyler, and due to being the only officer there with a large group of people around me, and with the size of Tyler compared to myself, I pushed him away and accessed my department issued pepper spray. I told Tyler that if he did not comply, he was going to get pepper sprayed. Tyler then walked across the road and told to me come talk to him. As I went to talk with Tyler he began to start yelling again and in an aggressive manner come towards me. At that time, I performed a double leg take down on Tyler in an attempt to get him under control and handcuff him. During this I sustained an injury to my left elbow and right knew that both hit the pavement and ground. As I was attempting to handcuff Tyler, his mother, Mari Helock ran over to me and started yelling and interfering with my attempt to restrain Tyler. At this time Sergeant Melius #208 arrived on scene and was able to remove Mari from the area while I handcuffed Tyler. After the scene was contained and under control, I spoke with several witnesses that were all willing to write statements on the incident that occurred. I spoke with one of the bartenders, Kim, who stated Tyler was trying to fight people inside the bar. Kim stated Tyler was escorted out and began arguing with his mother. (Specifically include facts constituting cause for arrest.)

On December 20th, 2025, at approximately 0757 hours, I responded to 20th Street and US1 in reference to a traffic stop on a reckless vehicle.

The complainant, later identified as Kyla Leverock, advised VBPD dispatch that the suspect vehicle, a black Ford Mustang (bearing Florida tag# RWHU12) was traveling eastbound on SR60, speeding, and the driver appeared to be under the influence. Leverock continued following the vehicle until they approached the 1000 block of SR60.

Ofc. Aguilar was in the area and observed that the Ford Mustang had dark side window covering (later measured at 17%). Ofc. Aguilar observed the Ford continue eastbound on SR60 and that it was having difficulty maintaining its lane of travel. Ofc. Aguilar then conducted a traffic stop on the Ford near the intersection of SR60 and US1. The Ford then turned south on US 1 and drove over the curb/sidewalk and came to a stop.

I then made contact with the single occupant and registered owner of the Ford, Nicholas Schneider who had slurred speech and glossy red eyes. Ofc. Aguilar requested Schneider step out of the vehicle due to safety concerns of reported driving pattern, and to conduct Field Sobriety Exercises, which he agreed. At this time, I conducted a series of Field Sobriety Exercises on the level ground of Sunshine Pharmacy parking lot (1995 US1).

- 1) Horizontal Gaze Nystagmus: Prior to this exercise, I demonstrated and verbally told Schneider the instructions which he advised he understood. Schneider advised he didn't wear glasses, contacts, or have any medical conditions that would prevent him from performing the exercises. Schneider stated he was not diabetic and that he was only prescribed Suboxone. I observed Schneider to have the following:
- -circular sway of his body
- -lack of smooth pursuit

PROBABLE CAUSE STATEMENT

- -hands not remaining by side
- -lost track of stimulus 4+ times
- -onset of nystagmus prior to 45 degrees
- 2) Walk and Turn: Prior to this exercise, I demonstrated and verbally told Schneider the instructions which he advised he understood. I observed Schneider to have the following:
- -stepped off the line
- -arms used to balance/arms out completely
- -failed to maintain balance while listening to instructions
- -took 15 steps down the line
- -only counted 8 steps on return
- -improper turn
- -does not touch heel to toe
- -stepped off line



- 3) One Leg Stand: Prior to this exercise, I demonstrated and verbally told Schneider the instructions which he advised he understood. I observed Schneider to have the following:
- -failed to maintain balance
- -used arms for balance
- -only counted to 10 in 30 seconds
- -Put foot down 2+ times
- -swayed while balancing

Based on the above-mentioned observations, I placed Schneider under arrest for DUI in violation of F.S.S. 316.193(3a) and placed him in the back of my patrol vehicle.

I then inventoried the vehicle with Ofc. Aguilar who discovered a blue lunchbox on the front passenger floorboard. In the side pocket of the lunchbox, a clear baggy containing 9 white rectangular-shaped pills (V/2090 identified through Drugs.com as Alprazolam) and a used syringe containing orange liquid were located.

At this time I found Schneider to also be in violation of F.S.S 893.13(6a) for Posession of a controlled substance. I Mirandized Schneider, who understood and declined to speak with us. Schneider was transported to the Indian River County Jail for booking, No bond.

I then spoke with the complainant, Leverock over the phone who advised me of her observations. Leverock was Southbound on 66th Avenue and 27th Street when she first observed the Mustang. When the Mustang turned eastbound on

SR60, she observed it: swerving between lanes, riding the median, decreased speed to 15mph then accelerated to approximately 60-70mph, and saw the driver leaned against the driver side door with his mouth open, appearing under the influence.

While at the Indian River County Jail, a 20-minute observation period was conducted. Ofc. Aguilar then requested that Schneider provide a sample to determine his breath-alchohol content. Schneider agreed and the following breath results were captured (sample #1, 0.00 and sample #2, 0.00). Scheider then agreed to provide a blood sample which was taken by Sgt. Marcus Robinson of the Indian River Fire Rescue (#25-33955).

Cpl. Chris Beaumont of the Indian River Shores then responded to the Indian River County Jail for a DRE examination and determined that Schneider exhibited signs of being under the influence of CNS depressants. See his case report for further details (2025-12116).

Schneider was then transferred to jail staff without further incident.

Upon my arrival, I located tire marks that indicated that a vehicle lost control and exited the roadway on the north side of 53rd Ave. It appeared that the vehicle impacted a county fire hydrant and light pole as it continued to come to a complete stop. Once at its final rest, it appears that the vehicle then re-entered the and continued to drive west on 58th Ave. While canvassing the area it was discovered from a part of the vehicle that it was from a gray in color Audi.

Later, Dispatch advised that a caller was reporting a very heavily damaged car being parked and left in the parking lot of the Target store near 58th Ave and 20th Street. This parked vehicle was in the direction of where the vehicle that left the scene of the crash was heading. The caller described the driver of the vehicle as a male subject wearing a tan shirt. The vehicle was located by assisting deputies in the Target parking lot, which confirmed that it was a gray in color Audi with heavy front and rear damage bearing FL Tag: RZZB60. A male matching the description of the driver was located in the 2700 block of 58th Ave by Deputy Shultz. Keys to an Audi vehicle was located on the subject's person.

I then, arrived at the location of the subject who identified himself as James F. Chanto DOB: 09/04/2007. I then informed Chanto his Miranda warnings from my agency issued warning card and that I would be completing a criminal investigation. Chanto stated that he understood the rights that I read to him, and he was willing to speak with me at the time. Chanto stated that while driving west on 53rd Street he lost control of his vehicle due to the rear tires being bald. Chanto stated that he did crash and drive away from the scene without notifying law enforcement of the property damage.

Due to the totality of the circumstances, that James F. Chanto admitted to being involved in a crash resulting in damage to property. That he failed to immediately stop his vehicle at the scene of the crash, and failed to fulfill the requirements of FSS 316.062. Chanto was placed under arrest for FSS 316.061 Leaving the scene of an accident with Property damage misdemeanor with a USD \$1000.00 bond and issued citation AHMU22E.



NARRATIVE

On Saturday, December 20, 2025, at approximately 2056 hours, I responded to the 400 block of 66th Avenue, Vero Beach, Florida in reference to an auto accident with unknown injuries.

I arrived at the aforementioned location and observed two vehicles in the middle of the road in a T-bone collision. I made contact with the female driver, of the blue 2023 Chevrolet Colorado, Linda Danesi, who was seated inside of her husband, Joseph Danesi's Chevrolet El Camino on the passenger side.

I asked Joseph if he was involved in the collision or was a witness to the accident to which he stated he was not. Joseph stated it was his wife, Linda who was driving the blue Chevrolet Colorado involved in the accident. I then proceeded to meet with Linda to check the status of her injuries if any, and to inquire what had transpired.

As I began to talk with Linda, Joseph refused to back away as he was standing approximately one foot from me. Every time I asked Linda a question, Joseph would try and speak for her, at which point I requested that he back away to allow me to conduct my investigation.

Joseph stated, "I'm not going anywhere I am going to stand right here as she is my wife." It should be noted that at this point Joseph positioned his body in the passenger side door jam of his El Camino between Linda and I.

I again instructed Joseph to back away to allow me to conduct my investigation, to which he refused. I requested that Linda exit the vehicle and step to the side with me to allow me to speak with her regarding the accident. Linda began to stand up, at which point Joseph intervened telling her to stay where she was, and stated she wasn't going anywhere and neither was he.

Again, I told Joseph to back away as he was interfering with my investigation, and I informed him of the Florida HALO law. Joseph stated, "I know the law, I'm a law-abiding citizen, and I'm not moving."

Due to the fact that Joseph was knowingly, and intentionally interfering with me conducting my lawful duties as a Deputy Sheriff of the Indian River County Sheriff's Office, while conducting a crash investigation, I placed him into handcuffs and escorted him to my agency issued patrol vehicle.

It should be noted I arrived in a marked patrol car with my emergency lights and sirens activated, and was wearing my patrol uniform which clearly identifies me as a Deputy with the Indian River County Sheriff's Office.

Due to the aforementioned facts and circumstances, I find probable cause to charge Joseph Danesi

NARRATIVE

On Saturday, December 20, 2025, at approximately 2231 hours, I was stopped at a red light at 20th Avenue and 20th Street. On my driver side, I observed a gray vehicle that was also stopped at the stop light. As the light turned green, the stop light illuminated the inside of the vehicle that was next to me. I looked over, and through the passenger window, I observed the driver to be wearing a green shirt. I also observed the driver to not be wearing his seatbelt. I conducted a traffic stop in the 3500 block of 20th Street.

I made contact with the driver that identified himself with his Florida ID card as Michael Douglas. I informed Douglas of the reason of the traffic stop. While I was conversing with Douglas, his seatbelt was secured across his chest. Douglas could not locate the registration or insurance for the vehicle. While at the window, I ran the ID card that was given to me by Douglas. Public Safety Dispatch advised that Douglas did not have a Florida Driver's License. Due to this, I requested Douglas to step out of the vehicle. Douglas at first was hesitant but then ultimately he began to step out of the vehicle. As he was stepping out of the vehicle, I observed his right hand go down toward his right hip area. As Douglas stepped out of the vehicle, I observed a plastic bag in his right hand. Due to this, Douglas was forcefully placed into handcuffs. Inside of the clear bag, I observed approximately eight small white pills in the shape of a bar. I believed the pills to be Alprazolam due to my training and experience. A search incident to arrest of Douglas was conducted and nothing else was located.

Inside of the vehicle, Sgt. Hoilett located a green cigarette pack on the passenger seat. Inside of the cigarette pack, Sgt. Hoilett advised he observed a bag and handed the cigarette pack. Inside of the cigarette pack, I located a clear plastic sandwich bag that contained small blue squares that I believed to be pieces of a pill. There was approximately nine of the small squares in the bag. Nothing else was located inside of the vehicle.

I requested Sgt. Hoilett to look up the white pills in the shape of a bar. I observed the imprint of GG249. Through Drugs.com, Sgt. Hoilett verified that the pills located were Alprazolam 2mg, which is a schedule 4 controlled substance under Controlled Substance Act.

I read Douglas his Miranda Warning to which he acknowledged he understood. I informed him for the reason the stop and Douglas kept advising that he had his seatbelt on. I explained in detail on how I observed Douglas's not wearing his seatbelt but Douglas refused to admit that it was not on. I questioned Douglas about the pills that were located in his hands as he was being taken out of the vehicle. I asked Douglas if the pills were Xanax, Douglas advised they were and that he did not have a prescription for them. I asked Douglas about the small blue square pills. Douglas advised that they were also Xanax. Douglas advised that both the white and blue pills were his.

Douglas was transported to the county Jail by D/S Ortega.

After researching Douglas, I learned that his license was revoked on 06/02/2014. Douglas has seven prior DWLS and two prior DUI's.

NARRATIVE

On 12/21/2025, I was dispatched to	in reference to a disturbance. While enroute to the address, Public
Safety Dispatch stated the caller, Lacey Bowdo	in, stated she was choked by her boyfriend, Jason Hall.

Once other deputies and myself arrived, a tactical approach was made to the front of the residence. Jason was found outside attempting to leave on an electric scooter as contact was made. Jason was ordered to get on the ground, and I placed him in mechanical restraints. I escorted Jason to my patrol vehicle, and other deputies stayed with him as I continued my investigation.

Lacey stated Jason and her have been engaged in an intimate relationship for almost two years. Lacey said Jason and her went out and had a good evening. Lacey said while riding back to the residence on Jason's scooter, he lost control in the driveway causing them to crash. Lacey said after the crash, he got angry and punched her in the face several times causing her to fall down. After she fell down, Lacey said Jason applied pressure to her throat choking her. After the incident, Lacey said they went inside her bedroom. Lacey told Jason she was going to call her brother, and Jason choked her again. Lacey stated she attempted to tell Jason she couldn't breathe. Lacey said Jason stated, "good thing it takes two minutes to kill someone." Lacey said while Jason was applying pressure to her throat, she lost consciousness. Lacey said when she woke up, Jason was outside the residence. Lacey stated she went inside her stepfather's room and got the phone to While speaking with Lacey, she had several scratches on her shoulder, which she stated was from the crash. Lacey's face appeared red in color, and she had minor bumps and scratches. Lacey also had a human bitemark on her back the she believed was from Jason. Photographs were taken of Lacey's injuries. Lacey was given a victim's rights brochure. It should be noted a domestic violence packet was not completed, due to their relationship being classified as dating partners who also have never lived together or have any children in common.

I returned to speak with Jason. I read Jason his Miranda Rights off of my Indian River County Sheriff's Office supplied Miranda Rights card. Jason stated he understood his rights, and wished to speak to me. I asked Jason what occurred tonight, and he stated Lacey and him went out drinking. While on the way home via Uber, Jason said they got into an argument. Jason said after the argument Lacey wanted him to leave the property. Jason said he didn't want to leave the property because he had been drinking. I asked Jason if a crash occurred on his scooter. Jason said at approximately 1900 hours Lacey and him were riding around the property when the crash occurred. Jason stated Lacey had abrasion marks on her side probably from the accident, and afterwards is when they went out together. I asked Jason why Lacey has cuts and marks on her face and neck area. Jason was unable to provide me a valid reason why she would. Jason stated at no time in the evening he physically put his hands on Lacey. Jason stated Lacey and him have been in an intimate relationship for nearly two years.

Due to all of the above statements, I had probable cause to believe Jason and Lacey are in an intimate relationship, and Jason knowingly and intentionally against the will of Lacey, impeded the normal breathing or circulation causing Lacey to lose consciousness.

I transported Jason to the Indian River County Jail without incident.

NARRATIVE

On Sunday, December 21, 2025 at approximately 0007 hours, I conducted a traffic enforcement stop on a silver Honda Accord bearing Florida tag "54CHAA" in the 13000 Block of US Highway 1 in Sebastian, Florida.

While on routine patrol, I observed the above vehicle leaving the parking lot of Earl's Hideaway Lounge located at 1405 Indian River Drive in Sebastian, Florida. The vehicle left the parking lot and proceeded North on US Highway 1, accelerating to over 60 miles per hour in a posted 35 mile per hour zone. I activated my in-car radar and adjusted the settings to capture the vehicle in front of me. I visual estimated the vehicles speed to be 68 miles per hour. I captured the vehicle traveling at 70 miles per hour in a posted 45 mile per hour zone.

I observed the vehicle activate its right blinker and continued to travel North. The vehicle then veered off the road crossing over the solid white line and almost crashed into a ditch. The vehicle quickly jerked to the left and continued to travel North, before ultimately turning onto Roseland Road after I activated my emergency lights.

I made contact with the driver, and sole occupant of the vehicle, Mr. Jack Bloom (Arrestee) who I identified by the Florida Driver's license he provided me. While speaking with Mr. Bloom, I immediately smelled the distinct odor of alcohol emitting from his breath. His eyes were watery and glassy, his pupils were dilated and his speech was slurred. He stated "I am just trying to make it home" and 'I am not a bad guy; my dad was a sheriff and my mother was the Clerk of the Court."

Officer C. Hatton (Sebastian Police) arrived on scene and I began a Driving under the Influence investigation. I asked Mr. Bloom how much alcohol he had consumed and he avoided the question for several minutes. He finally stated he had consumed 3 drinks over the course of four hours.

Mr. Bloom stated he had several medical conditions but denied taking any medications. Mr. Bloom further denied any prescription or illegal narcotic usage. When I asked Mr. Bloom if he had consumed any Methamphetamine he stated, "No sir, I'm not doing work, it's a Saturday." When I asked him to clarify, he stated he had a prescription for when he was a kid. But didn't take it on Saturday. When I asked if had taken any other pills tonight, he stated he took ibuprofen and Cymbalta, and when I clarified if he had taken anything else he stated, "To my knowledge? Yes." Mr. Bloom had a difficulty time answering simple questions and provided lots of unnecessary information.

Mr. Bloom stated he is supposed to wear prescription glasses but is "eligible to drive without them." Mr. Bloom blamed his driving pattern on his inability to see.

Once outside his vehicle, I continued to smell the distinct odor of an alcoholic beverage emitting from Mr. Bloom's breath. I explained my concern for his ability to safely operate a motor vehicle and requested he complete Standardized Field Sobriety Exercises (SFSE's), which he agreed.

NARRATIVE (Continuation)

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) Exercise. I explained the exercise to Mr. Bloom who stated he understood the instructions and did not have any questions. I observed Mr. Bloom's pupils were dilated and tracked equally. I observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and an angle of onset prior to 45 degrees at 40 degrees. I did not observe Vertical Gaze Nystagmus (VGN). Mr. Bloom had to be reminded to not move his head and had difficulty following my stimulus.

The second exercise I administered was the Walk and Turn (WAT) exercise. I explained and demonstrated the instructions to Mr. Bloom who stated he understood the instructions and did not have any questions. During the instruction phase of the exercise, Mr. Bloom failed to maintain the starting position as instructed. I instructed Mr. Bloom back into the starting position and he immediately began the exercise. Mr. Bloom took 10 steps before turning and stated "Pivot, Pivot, Pivot" and then immediately asked if he should start walking the other way. Mr. Bloom was unsure of the instructions and asked if that was a trick question. Mr. Bloom stated he did not want to hear the instructions and walked the line before asking a second time, "Do I pivot again?"

I explained and demonstrated the exercise a second time for Mr. Bloom who stated he understood the instructions and did not have any questions. On his second attempt, I observed the following clues of impairment: Mr. Bloom failed to touch heel to toe, raised his arms to balance, and stopped walking to steady. Mr. Bloom stopped counting out loud on his return and did not look down at his feet as he was instructed. Mr. Bloom DID NOT complete this exercise to standard.

The third exercise I administered was the One Leg Stand (OLS) exercise. I explained and demonstrated the exercise to Mr. Bloom who stated he understood the instructions and did not have any questions. Mr. Bloom stated he was going to use his left foot and raised his left foot off the ground. After approximately 11 seconds, Mr. Bloom placed his foot on the ground. During this exercise, I observed the following clues of impairment: Put foot down, used arms for balance and swayed. Mr. Bloom DID NOT complete this exercise to standard.

The fourth exercise I administered was the Modified Romberg balance exercise. I explained the instructions to Mr. Bloom who stated he understood and did not have any questions. Mr. Bloom tilted his head back and began to count out loud. He was reminded to count in his head. Mr. Bloom estimated 30 seconds in the actual time of 49 seconds. While he was counting, I observed Mr. Bloom to have eyelid twitches. And an approximate 2-inch sway while attempting this exercise.

Based on the observed driving pattern, and indicators of impairment, established probable cause and placed Mr. Bloom under arrest for Driving under the Influence. Mr. Bloom was secured in two sets of handcuffs and transported to the Indian River County Jail Complex.

Upon arrival to the Indian River County Jail Complex, Mr. Bloom was requested to provide a sample of his breath

NARRATIVE

On Sunday, December 21, 2025, at approximately 2222 hours, I responded to a reckless driver call at the 4900 block of U.S. Highway 1 traveling Southbound. The caller requested to remain anonymous; however, stated the female driver is her girlfriend whom has been drinking at Rack Em's Bar at Roseland Road and U.S. Highway 1.

The caller stated the female, Kelly Mercer, was driving 90 miles per hour and was rapidly changing lanes. The caller who was still following Kelly in a black Honda Accord, stated they turned west onto Aviation Blvd, then south onto 20th Avenue. As they came to the solid red traffic light at the 2000 block of 20th Street, I was able to obtain visual of both the caller and Kelly's vehicle.

I requested communications ask the caller to pull away allowing me to get behind the vehicle as they turned West onto 20th Street. As I got behind Kelly's vehicle it made a left turn to go south on 21st Avenue before pulling into the residential neighborhood at 1936 21st Avenue.

It should be noted that the vehicle Kelly was a white in color Nissan Murano bearing Florida tag#: 42AXRI, out of Vero Lake Estates, 9045 85th Place, and Kelly's address was out of Fort Pierce, Florida.

Based on the witness statement that the female driver, Kelly, had been consuming alcohol, was driving at a high rate of speed, rapidly changed lanes, and then pulled into a residence which she did not belong a traffic stop was conducted despite no personal observations of her driving pattern, Navarrete v. California.

As I conducted the traffic stop, Kelly was in actual physical control of the motor vehicle which was now parked, and was seated in the driver seat of the vehicle with the vehicle keys in her possession.

As I interacted with Kelly, I observed several physical signs of impairment: A strong odor of an alcoholic beverage, glossywatery eyes, and a heavy slurred speech. Kelly also stated she had consumed a tall Michelob Ultra while out with friends.

I became concerned Kelly was impaired beyond her normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Kelly if she would participate in a series of standardized field sobriety exercises, to which she agreed. I asked Kelly a series of medical questions to ensure she could participate in field sobriety exercises. Kelly stated that she had no physical defects, was not sick or injured, did not have epilepsy or diabetes, did not wear contacts or glasses, and stated she is only diagnosed with

All field sobriety exercises were explained and demonstrated proficiently prior to her beginning each exercise, and I confirmed she understood the instructions prior to the start of each exercise.

The following exercises were performed:

 HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at

maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed. Vertical Gaze Nystagmus was not present. Kelly had to be instructed numerous times to keep her head still and to follow the stimulus with her eyes only, not to try and lead the stimuli, and to keep her hands by her side.

- 2.) WALK AND TURN A straight painted white parking line was used for the exercise. When asked, Kelly agreed with me that the line was straight, flat, and clear of debris. After stating she understood all instructions, Kelly exhibited the following: stopped the exercise, missed heel-to-toe, stepped off the line, and improper turn.
- 3.) ONE LEG STAND Again all instructions and demonstrations were understood prior to the start of this exercise. Kelly chose her right foot for the exercise. Kelly exhibited the following: improper stance, leg was at a 45-degree angle, did not look at her raised foot, stopped counting placing her foot down, and swayed.

Overall, Kelly performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on Sunday, December 21, 2025, Kelly was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond their normal faculties, incapable of operating a vehicle safely.

Kelly was arrested for DUI at 2243 hours, and was advised of the charge. I took Kelly into custody without incident, and transported her to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Solomon advised me that Kelly refused to provide a breath sample.

Based upon my investigation, I charged Kelly with the following:

Count 1: F.S.S. 316.193 (1)(A)- DUI, Misdemeanor. Citation#: AM5WAVE.

Count 2: F.S.S. 316.1939 (1)(E)- Refusal to Submit to Test. Citation#: AM5WAXE.
