Upon arrival, a neighbor stated that the subjects were behind the apartment. At that time I could hear two individuals yelling. As I rounded the corner, I witnessed the subject Paul E. Kelly Jr. fighting with his father Paul Kelly Sr. Paul Jr. was grabbing, pushing and swinging at his father and ultimately struck him in the upper torso. As I went to intervene Paul turned looked directly at me and proceeded to strike me in the face with a closed fist.

On Wednesday, November 12, 2025, at approximately 2000 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Frank Adamski, [REDACTED] Angela Adamski, [REDACTED] [REDACTED] had gone out to dinner earlier in the evening.

Frank explained that during dinner, an argument began when Angela accused him [REDACTED] Frank further stated that [REDACTED] While driving [REDACTED] the argument continued, and Angela became increasingly upset, yelling profanities and calling him derogatory names.

Frank advised that [REDACTED] Angela took his cellphone, entered [REDACTED] through the garage door, and began sending inappropriate text messages to his friends. When Frank attempted to retrieve his phone, Angela struck him twice in the face with an open hand. Frank stated that he did not retaliate or make any physical contact with Angela.

I then made contact with Angela Adamski, who stated that [REDACTED] Frank, had been drinking and became verbally aggressive during an argument. Angela claimed that Frank began calling her names, causing her to fear for her safety. She stated that she ran [REDACTED] for protection and locked the door. Angela alleged that Frank began banging on the bedroom door, which prompted her to call law enforcement.

During my investigation, I observed visible injuries to Frank Adamski, including a swollen area above his left eyebrow, bruising to the left cheek, and a bloody scratch on the right cheek. These injuries were consistent with his account of being struck in the face. Frank also stated there have been prior incidents of domestic violence between him and Angela.

Based on the victim's statement, visible injuries, and the totality of the circumstances, I determined that probable cause exists to believe that Angela Adamski did unlawfully and intentionally touch or strike Frank Adamski against his will, causing bodily harm, in violation of Florida State Statute 784.03(1)(a)(1) – Battery.

Angela Adamski was placed under arrest and transported to the Indian River County Jail for processing without incident.
