NARRATIVE

On November 12, 2025, at approximately 1023 hours, Cpl. Baumann and I were operating stationary radar in the 10000 block of 20th Street, Vero Beach, Florida, 32966, when I observed a blue Volkswagen Tiguan traveling Eastbound on 20th street at 82 miles per hour in a marked 65 mile per hour zone.

I conducted a traffic stop on the vehicle in the 9800 block of 20th street and it came to a stop in the 9400 block of 20th street. Upon conducting an FCIC/NCIC check of the driver, Mr. Joseph Wygant, dispatch notified me he had an active warrant out of Hillsborough County for misdemeanor domestic battery. These injuries were consistent with his account of being struck in the face. Frank also stated there have been prior incidents of domestic violence between him and Angela. Based on the victim's statement, visible injuries, and the totality of the circumstances, I determined that probable cause exists to believe that Angela Adamski did unlawfully and intentionally touch or strike Frank Adamski against his will, causing bodily harm, in violation of Florida State Statute 784.03(1)(a)(1) – Battery.
