NARRATIVE

On Monday, August 31, 2026, at approximately 0221 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of 101st Avenue and County Road 512, Vero Beach, Indian River County, Florida.

While patrolling McDonalds near 108th Avenue and County Road 512, I observed the defendant start his motorcycle and leave the area. He failed to stop prior to leaving the parking lot and failed to stop prior to making the right on red to enter county Road 512. Additionally, the driver, who was operating a motorcycle, was not wearing a helmet or safety glasses.

Prior to the traffic stop, I ran the attached license plate of SAXH88. This tag came back to a blue scooter registered to Mr. Karson Poole.

I conducted a traffic stop and identified the driver, as being Mr. Poole. He identified himself using a New York Identification card. When asked if he had a drivers license, he stated he did not. He only had a ID card out of the state of New York. I also asked if Mr. Poole had a motorcycle endorsement. He stated he did not.

While running Mr. Poole, I asked if the tag on the motorcycle was correct. He stated that it was not. The tag attached belonged to his scooter and that he has a new tag for the motorcycle that he needs to put on as he recently registered the vehicle.

Per FCIC/NCIC, Mr. Poole only has an ID card out of the state of New York. He is classified as "Eligible **Non-Driver ID Only**". No motorcycle endorsement is observed in FCIC/NCIC. [REDACTED]

I advised Mr. Poole of his Miranda Rights. He advised he understood his rights and was willing to speak to me. Mr. Poole admitted that he did not have a license and knew he did not have a license. He does not have a motorcycle endorsement and needs to get one. He advised he is planning on going to the DMV this week, but has not obtained a license at this point. He has lived in the state of Florida for at least one year since moving from New York. Mr. Poole also admitted to placing this tag on the motorcycle, knowing that it did not belong. He advised he has the other tag at his residence and just needs the tools to change it over.

Based on the above statements and evidence, I placed Mr. Poole under arrest for FSS 322.03(1) – No Valid DL – Never Issued, FSS 322.03(5) – No Motorcycle Endorsement, and for FSS 320.261 – Attaching a tag not assigned.

Mr. Poole was transported to the Indian River County Jail without issue.

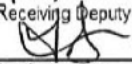

NARRATIVE

On Monday, August 31, 2026 at approximately 2240 hours Sgt. D. Flores observed a Subaru Forester bearing FL tag #81EZZU fail to stop at a steady read light at the intersection of 66th Ave and 20th Street. The vehicle was traveling north bound on 66th Ave and turned west on 20th Street failing to stop at the steady red traffic signal. Upon arrival I spoke with the driver of the vehicle, later identified as Jonathan Hart. While speaking with Jonathan I could smell a strong odor of an alcoholic beverage was emitting from his breath. When asked, Jonathan initially advised he had not one drop of alcohol this evening, later he admitted to drinking, and said he has one standard light beer. Based on my observations and this statement I asked Jonathan to perform standard field sobriety exercises.

Before beginning the exercise, Jonathan advised he had recently [REDACTED] however it did not affect him standing or walking for long periods of time. Jonathan advised he had no history of any other medical condition nor had he been afflicted with a traumatic brain injury.

HORIZONTAL GAZE NYSTAGMUS EXERCISE

Prior to attempting this exercise, Jonathan indicated he did not have any medical problems that would have prevented him from performing the exercise. His eyes were checked and they displayed equal tracking and his pupils were equal sizes. Jonathan was instructed to follow the stimulus with his eyes only, keeping his head still. After stating that he understood the instructions, Jonathan attempted this exercise. No resting nystagmus was observed. During this exercise Jonathan had an orbital sway and could not stand still without swaying.

The results of this exercise displayed 6 of the 6 possible clues.

- A lack of smooth pursuit in the left eye
- A lack of smooth pursuit in the right eye
- A distinct and sustained nystagmus in the left eye at maximum deviation
- A distinct and sustained nystagmus in the right eye at maximum deviation
- Nystagmus onset prior to 45 degrees in the left eye
- Nystagmus onset prior to 45 degrees in the right eye

WALK AND TURN EXERCISE

Prior to attempting this exercise, Jonathan indicated he did not have any medical problems that would have prevented him from performing the exercise. He was instructed to put his left foot on the line and his right foot in front of it with his right heel touching the toe of his left foot. He was instructed to stand in this manner with his hands to his sides until the exercise instructions were completed and the exercise demonstrated. Jonathan was instructed not to begin the exercise until told to start. He was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around. After turning around, he was to take nine steps in a heel-to-toe manner back along the line, in the direction he had come from. Jonathan was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud. After the exercise was demonstrated, Jonathan stated that he understood the instructions and was instructed to begin the exercise.

The results of this exercise displayed 5 of the 8 possible clues:

During the course of the instructional phase of the exercise, Jonathan failed to maintain balance. During the course of the exercise phase, Jonathan failed to take heel-to-toe steps, keep his arms at his side and kept them away from his body to maintain balance, stopped while walking during the turn, and completed an improper turn like I had demonstrated to him.

ONE LEG STAND EXERCISE

Prior to attempting this exercise, Jonathan indicated he did not have any medical problems that would have prevented him from performing the exercise. Jonathan was instructed to stand with his feet together and arms at his sides during the exercise. Jonathan was asked not to begin the exercise until instructed. He was instructed to raise the leg of his choice by approximately 6 inches off the ground. While holding that position, he was to keep his leg straight and count out loud in the following manner, one thousand one (one thousand one, one thousand two, one thousand three, ...) and so forth until instructed to stop (after 30 seconds). The exercise was demonstrated to Jonathan to which he stated he understood.

After he indicated understanding the instructions, Jonathan attempted the exercise and raised his right leg and was wearing sneakers.

The result of this exercise displayed 3 of the 4 possible clues:

- Swayed while balancing during the exercise
- Used arms for balance
- Put foot down multiple times during the course of the exercise

It should be noted that during the course of this exercise, Jonathan lost his balance a multitude of times and had to use his own vehicle to stop himself from falling onto the ground.

Based on my observations, Jonathan Hart was arrested and was transported to the Indian River County Jail.

Upon arriving to the jail, Jonathan was handed over to jail staff where they administered the states test. Jail staff advised the following results: Sample 1 at 2349 hours yielded 0.172 g/210L of breath and sample 2 at 2352 hours yielded 0.174 g/210L of breath which was consistent with his level of impairment.

Due to the listed facts above, I charged defendant Jonathan Hart with F.S.S. 316.193.4 – DUI BREATH ALCOHOL 0.15 OR MORE PER 210 L.

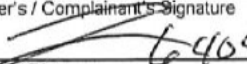
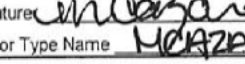
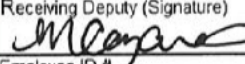
Upon positive confirmation, Chelsea was placed into custody and put into the back of my patrol vehicle.

NARRATIVE

On Tuesday, September 1, 2026, at approximately 0100 hours, Deputy Yerian, Corporal Thomas, Deputy Lopez Acosta, and I were on a directed patrol in the 4300 block of 27th avenue, Vero Beach, FL.

While on the directed patrol a male later identified as Kyle Arturo Green was observed in a vacant lot located at 4346 27th avenue passed out in a lawn chair in an unusual position. We approached him to make sure he was not having a medical emergency. We were able to wake him up and while talking to him his speech was slow and slurred, his movements were slowed and lethargic.

He started stretching for an extended period of time, we asked for consent to search him and he agreed. When he stood up, I observed where he was sitting in the lawn chair a small baggie containing a light in color crystal like substance that through my training and experience appeared to consistent with narcotic use. I pointed it out to Deputy Yerian, he and Mr. Green both looked at it. It was next to where his left pocket was in the chair. Deputy Yerian and I grabbed his wrists and went to detain him in handcuffs. As soon as I pulled my handcuffs out Mr. Green pulled away and tried to run away but ran where Corporal Thomas and Deputy Lopez Acosta were standing. He was lowered to the ground where he was taken into custody without further incident.

Mr. Green was escorted to my patrol car where I field tested the substance that showed a presumptive positive for methylenedioxymethamphetamine (MDMA). I advised Mr. Green of his constitutional right via a Miranda warning; He admitted that the baggie contained MDMA. He also admitted that he and a friend were using, but did not want to say who the friend was. I asked if the baggie was his and he said no, yet he knew what was in the baggie. I asked why he tried to run and he stated he didn't want to go back to jail.

Based on the above Mr. Green was knowingly in actual or constructive possession of 3, 4-METHYLENEDIOXYMETHAMPHETAMINE, a substance classified within Schedule I, Florida Statute 893.03(1), commonly known as ECSTACY and/or MDMA, a controlled substance, contrary to Florida Statute 893.13(6)(a). (3 DEG FEL) (LEVEL 3)

Mr. Green did resist, obstruct or oppose a law enforcement officer of the Indian River County Sheriff's office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD)
