


On _____, at _____ (Specifically include facts constituting cause for arrest.)

On Monday June 9, 2025, Officer Brandes advised he would be standing by to serve a warrant at 338 Fordham Street. The warrant was for an individual, Antonio Martinez-Vega for violation of probation stemming from a DUI charge. Officer Brandes advised Antonio did not have a valid license either.

Prior to my arrival, Officer Brandes advised he observed Antonio get into the driver's seat of a white Jeep (FL tag Z817VR). He observed Antonio back out of the driveway, head north on Fordham Street and then east on Main Street. Officer Brandes advised he confirmed all of above information and initiated a traffic stop on the Jeep in the 100 block of Main Street. Officer Brandes made contact with Antonio, who knew he had a warrant out for his arrest and that his license was not valid. He advised Antonio knew we were going to serve the warrant so he was going to try and get breakfast.

Officer Brandes advised he ordered Antonio out of the Jeep and placed him into handcuff, which were double locked and checked for fit.

Dispatch confirmed Antonio's license was suspended as of 4/16/25 for failure to complete substance abuse program. Dispatch also confirmed the warrant (202401587) was still active and there was no bond.

The Jeep was left in the parking lot of 1295 Main Street per Antonio's request and the owner was notified.

Antonio was placed under arrest DWLSR with knowledge and the warrant, he was transported to jail without incident. Case closed by arrest.



At that time, I witnessed a black Lincoln SUV (bearing FL tag KX683) parked at a fuel pump at the 7-11 located at 7400 20th Street. A male, that I identified as the registered owner via DAVID as Mr. Anthony Ritaldato, was seated in the driver's seat. An NCIC/FCIC query revealed Mr. Ritaldato had a suspended license. I also witnessed another male, later identified as Mr. Daniel Wolff via his Florida-issued driver's license, was also walking around the vehicle and speaking with Mr. Ritaldato.

I then left the area and returned a few minutes later and witnessed the black Lincoln SUV traveling southbound on 74th Avenue from 20th Street. I subsequently conducted a traffic stop on the vehicle in the 1800 block of 74th Avenue for improper tail lights, improper tint, as well as, the registered owner not having a valid driver's license. I then made contact with the driver, Mr. Wolff, front seat passenger, Ms. Jessica Meyers, and passenger-side backseat passenger, Mr. Ritaldato.

As I was conducting my traffic stop, K9 Deputy Mangel, ID# 5949, responded to the scene. At that time, her K9 partner, Tuko, conducted a free-air sniff of the vehicle, and Deputy Mangel advised there was a positive alert. During a search of the vehicle, a glass pipe with residue was located in the driver's door pocket. Another glass pipe with residue was located wrapped in a paper bag in a compartment where the radio was missing from. Additionally, I located a black satchel bag on the floorboard behind the driver's seat. Inside the bag was a third glass pipe with residue and a plastic baggie with a white, rock-like substance. Based on my training and experience, I knew the glass pipes to be utilized in the consumption of illegal narcotics. Based on my training and experience, I also believed the white, rock-like substance to be "crack" cocaine. The suspected "crack" cocaine weighed approximately 0.93 grams and also field-tested positive for the presence of cocaine.

Mr. Ritaldato, Mr. Wolff, and Ms. Meyers were subsequently detained. During a post-Miranda interview, Ms. Meyers advised that she does not use drugs and the black satchel bag belongs to Mr. Wolff. Mr. Ritaldato stated satchel bag was not his and he did not know who it belonged to. Mr. Wolff was also read his Miranda Rights and initially stated the black bag was not his.

Ms. Meyers was released from the scene.
