NARRATIVE

On May 5th, 2026, at approximately 0957 hours, I responded to the Indian River County Jail (4055 41st Avenue) in reference to a Battery on a Correction's Deputy.

Upon my arrival, I met with Dep. J. Green who had the video footage of the incident pulled up on a work computer. I observed the following:

The suspect, Antonio Mojica, was standing on the stairs in [REDACTED] another inmate was waiting to exit the block while mopping. When the door was opened, Mojica adjusts his pants and began to pace back and forth in front of the door. Mojica turns towards the door and looks at Dep. J. Torres. Mojica lifts his hands towards Dep. Torres while closing the distance between them and pushed on her upper body. Dep. Torres then began to attempt to detain Mojica, assisting him to the ground. Other deputies arrived to assist in detaining Mojica.

I spoke with Dep. Torres who stated the following:

Dep. Torres observed Mojica coming towards the door multiple times. Dep. Torres asked if he was okay, Mojica stated yes. At this point, Mojica turned around and shoved Dep. Torres. At this point, Dep. Torres assisted Mojica to the ground to detain him.

Based on the video and statement, Antonio Mojica is being charged with:

Battery on a Law Enforcement Deputy.

NARRATIVE

On May 6, 2026 I responded to a disturbance at 1155 35th Lane Cleveland Clinic. On arrival I met with deputy Eric Gruber who was already on scene. He told me that a patient had hit a Dr while in an exam room. I met with Dr Vincent Haddad the victim who is employed at Cleveland Clinic as a medical provider. He told me that he was attending to John Jukich the defendant. The Dr told me that the defendant was upset about the medical evolution. John then struck the Dr 2 times in the lower leg with force. The Dr then stated John stood up and was in his face in aggressive posture. John stated he didn't hit the Dr and understood he couldn't touch the Dr in a violent manner.

John also preventing the Dr from seeking safety by freely exiting the room.

I placed John under arrest and transported to the county jail.

NARRATIVE

On 05/06/2026 at approximately 1050 hours, I Deputy Austin Binner responded to a CFS Fax a [redacted] involving the neglect of [redacted] by [redacted] (Arlicia Ryan). Due to both victims in this case being [redacted]

Upon arrival, I made contact with DCF case workers to conduct their follow up investigation in reference to [redacted] living conditions at the residence. As we approached the residence, I observed Arlicia sitting by the front porch with both [redacted]. Additionally, I observed Arlicia's mother Cassandra Jones sitting in a vehicle in the drive way at the location as well. As verbal communication was made, Arlicia was argumentative and visibly upset that myself and DCF case workers were at the location in reference to [redacted]. Arlicia advised that she did not want to speak with either law enforcement or DCF case workers. Arlicia stated multiple times that she did not wish to speak with us, and that the [redacted] do not live at the location. Arlicia was unable to list where she and [redacted] reside other than the dispatched address.

Cassandra stated the she would cooperate to the DCF investigation. Cassandra advised that Arlicia and [redacted] have resided at [redacted]. Cassandra stated Arlicia is unemployed, and stays home with the [redacted]. Cassandra advised she has attempted to get Arlicia and [redacted] to stay in better conditions, but has not been successful. Cassandra advised that there is a rodent problem within the residence, and that there are rodents actively living in the residence. Cassandra consented to show the living condition that [redacted] currently [redacted]. As Cassandra walked us through the residence, I observed the following, and documented all findings on my agency issued body worn camera.

As I was granted consent to walk through the common areas of the residence, the odor of animal feces omitted from the residence. There were piles of trash, and miscellaneous objects within the house that would be a danger to [redacted]. The flooring within the house was vinyl laminate, and had black residue film across it showing that is hasn't been cleaned for an extended time. The walls at the residence had excessive signs of water damage. Multiple spots in the residence at paint peeling from the drywall, staining from water damage. Other walls within the residence had the drywall removed exposing concrete that had mold residue on it. The ceiling of the residence had insulation exposed from the attic in numerous areas.

The kitchen, hallway, and bathroom flooring had standing pools of water. The standing water is due to a leaking toilet that is in the shared bathroom in the main hallway. Cassandra advised due to the toilet leaking, and not actively working a bucket of water is used to flush the toilet. It shall be noted the water that is used to fill the bucket is from a broken water pipe in the shared bathroom. While being shown the bathroom I observed approximately a foot or more of a dark colored mold growing on the tile in the shower/tub.

While in the kitchen, I observed pools of standing water. There was water damage to the bottom of the cabinetry. The fridge had multiple items of food that had mold growth, and deemed to be unsafe to consume. While on scene, I only observed a singular bed at the residence, and a singular [redacted] to sleep in.

Due to my above-described observations of the living conditions of the residence, I placed Arlicia into Custody. Prior to

NARRATIVE

On Wednesday, 05/06/2026, at approximately 2103, I was dispatched to 9th street southwest and 106th avenue south west, Vero Beach, Florida 32966, in reference to a suspicious incident involving an older model lifted white pickup truck.

The incident was reported by an on-duty Florida Fish and Wildlife (FWC) Officer. The FWC Officer advised me that he saw a white pick-up truck and dark colored pick-up truck turn off all their lights when he was attempting to turn around to talk to them. The FWC Officer also stated that he last saw the trucks go east-bound on 9th street south west.

I was in the area of 90th avenue south west and 9th street south west when I observed two pick-up trucks matching the description going east bound on 9th street south west. I informed Deputy Magill who was able to get behind the vehicles. Deputy Magill went around a gray Ford pick-up truck to conduct a traffic stop on the White pick-up truck. I then got behind the Gray Ford F-250 bearing Florida tag 24DNMV and observed the license plate decal was expired as of 12/2025, building probable cause for a violation of F.S.S 320.07.3(A) – Expired tag less than 6 months. I conducted a traffic stop on the vehicle based on this violation at 5800 9th street south west.

I made contact with the driver, Michael Alan Sullivan Jr (identified by his Florida's driver's license), and observed a AR15 style rifle with a magazine loaded, as-well as a Winchester rifle in the back seat within reach of Sullivan. I asked Sullivan if he had any other firearms in the vehicle, which he stated there was a handgun within his reach in the center consol. I requested for an additional deputy and had Sullivan step out of the vehicle for my safety. I conducted a query into Sullivan's driver's license and vehicle information while Deputy Magill walked up to the vehicle. While querying Sullivan's information I was informed by Deputy Magill that he observed a white substance, which based on his experience, education and training he believed to be cocaine, in plain view on the driver's seat. Sullivan was detained while further investigation was conducted into the substance. Deputy Magill informed me that the substance tested positive for cocaine, see Deputy Magill's supplement for more information.

I informed Sullivan of his Miranda rights which he acknowledged he understood and voluntarily waived to speak with me. I informed Sullivan that the substance that was located in his vehicle tested positive for cocaine and asked him how often does he use cocaine, which he replied "not much at all". I then asked Sullivan when was the last time he used any narcotic, which he replied that he wasn't sure and it had been a couple of days. When asked Sullivan stated the only drugs he uses is cocaine.

At the time of this investigation, Sullivan was the only person inside of the vehicle with direct access and reach of where the cocaine was located, on the driver's seat. While having possession of cocaine, Sullivan had 3 loaded firearms within direct access to him, which all firearms had one bullet loaded in the
