#### NARRATIVE

On Tuesday, 2/11/2025, at approximately 1304 hours I responded to the Indian River County Jail, in reference to a disturbance.

I made contact with jail staff who showed me security video of the incident. In the video I observed a subject, later identified as the victim, Delbert Brunson, laying in his bunk. Another male, later identified as Antonio Woods, exits one cell and then enters the victim's. Woods then began to punch the victim repeatedly.

I then made contact with the victim who advised me of the following. He was at lunch when Woods approached him. Woods was upset with him because he owed Woods some butter. He then went back to his cell after lunch and laid in his bed. While he was laying in his bed, Woods entered his cell and punched him multiple times. I asked the victim if he had any injuries to which he showed me a knot on the left side of his head from being punched. The victim advised that Woods continually punched him for approximately two minutes before jail staff came in and removed Woods.

I then met with the suspect, Antonio Woods. I read Woods his Miranda Rights to which he advised he understood. Woods advised he did not wish to speak with me. I advised Woods he was under arrest for battery.

#### NARRATIVE

On Tuesday, February 11, 2025, at approximately 1800 hours I Deputy Martin was conducting routine patrol in the 6600 of 20th Street. While stopped at a solid red light I observed a black in color Honda Civic complete a U-turn from the westbound turn lanes after a solid red light was present for east and west traffic.

I then, initiated a traffic stop on the black in color Honda Civic bearing FL/Tag: CL91CU in the 6300 block of 20th Street for violation of FSS 316.074(1) Fail to obey traffic control device (Signal-Red light). The vehicle then came to a stop at the 63rd CT and 20th Street, where I could see that it was being driven by a Hispanic male. Upon making contact with the male; later identified as Samuel L. Vargas, I could see he was visibly upset and he informed me that he did not have a valid drivers license. Vargas then handed me a Florida ID card after request. I then queried Vargas ID card and found it was revoked on 03/27/2024 for driving while license revoked.

I then, placed Vargas under arrest for FSS 322.24(2)(A) Knowingly DWLSR misdemeanor with a \$500 bond. While searching the black in color Honda Civic after arrest, a metal lunch box was located sitting on the front passenger seat. Upon opening the lunch box, a glass pipe with a bulb at one end with burnt residue as located with a small plastic baggie with 3 and ½ bars of Alprazolam, and a baggie of loose-leaf marijuana; later weighing a 5.13g. I then read Vargas his Miranda warnings from my agency issued warning card. Vargas stated that he understood his rights and was willing to speak with me. When asked about the vehicle and the contents found Vargas informed me that there was a black container with weed inside of it; the loose marijuana was weighed later totaling at 25.91g. A small baggie containing 1.03g of methamphetamine was later found inside of the lunchbox and tested positive for methamphetamine by a field test kit. When asked about the lunch box Vargas stated that it belonged to a guy named Jessie, who he gave a ride to earlier that day. Vargas stated that he was unaware of the contents of the metal box.

Due to the totality of the circumstances, that Samuel L. Vargas knowingly and intentionally operated a motor vehicle on the roadway while his license was revoked. That Vargas was in possession of a controlled substance that was readily accessible to him. The total marijuana weight being 31.04g, and in possession of Alprazolam and methamphetamine. Vargas was placed under arrest for FSS 322.24(2)(A) Knowingly DWLSR misdemeanor with a \$500 bond, FSS 819.13(6)(a) Possession of marijuana over 20g felony with a no bond status, and FSS 819.13 Possession of a Controlled substance felony with a no bond status for both the Alprazolam and Methamphetamine.

#### NARRATIVE

On Tuesday, February 11, 2025, at approximately 1423 hours, during routine patrol in the 6800 block of 20th Street, Vero Beach, Florida, I observed a yellow Chevrolet Camaro, bearing Florida tag #RBQP62, with very dark tint. At the same time my Axon Fleet 3 camera alerted me that the vehicle owner had a suspended license and the vehicle tag was expired.

Due to the alert, I ran the tag through my eCite computer program. eCite confirmed that the tag indeed was expired and the vehicle owner, Solon Dalma Ferdinand, had a suspended license. eCite provides its information through DAVID. I looked at the photograph provided for the registered owner's Florida Issue Driver's license, and initiated a traffic stop on the vehicle by turning on my overhead emergency lights and sirens.

Upon contact with the driver, I immediately identified him as the registered owner. I advised Solon the reasons I stopped him and requested his license, insurance and registration. Solon appeared nervous as he spoke to me and reached into the glove box. Solon took out his insurance card and an old registration. The registration matched the vehicle but the tag was different. I again asked Solon for his license and he began fumbling around with his wallet. Solon looked in every compartment of his wallet and could not find his driver's license. I asked Solon if he had a valid license and affirmed, he did. During Solon's search in his wallet, I was able to see he possessed a Florida issued Identification Card. I asked him for the ID and noticed it had expired several years prior.

Using Solon's ID, I ran him through NCIC and DAVID and further confirmed his invalid driving status. Solon was listed as a habitual traffic offender on September 24, 2024. Additionally, Solon had five previous DWLS listed on his DAVID profile. The most current suspension was on September 24, 2024 which coincides with his habitual traffic offender status.

Due to the discovery, I read Solon his Miranda Warnings of constitutional rights from a prepared card. Solon confirmed understanding his rights and agreed to speak to me. Solon stated that he did not know his driver's license was suspended. I confirmed if the address listed on DAVID was the current address for him on September 4, 2024. The day FLDHSMV would have notified him of his suspension and status. Solon did confirm living and receiving mail on that day and address. Solon then advised he has been stopped by other law enforcement agencies after the September date. Solon specified that he was stopped by the Palm Bay Police Department on either December 24 or 25, 2024. At the time of the stop PBPD did not ask him for his driver's license and according to Solon was only given a verbal warning for faulty tag lights. Upon further inquiry Solon advised that he was on a payment plan for a citation he received. A Brevard County Clerks search on "BECA", revealed that the original citation #AK17JIE was the one he was speaking about. The site provided a copy of the citation and it was for FSS 322.34.1 DWLS unknowingly operating a vehicle while DL is suspended. Even though Solon admits to continually paying this fine, he believed his driving privileges were reinstated. Solon went on to explain that he even went to DHSMV to have his privileges reinstated. A further inquiry into his license transactions showed no such transaction has been made under his name or license number. Solon remained adamant to not knowing his license was suspended, even when presented with all the above-mentioned facts.

#### NARRATIVE (Continuation)

During the investigation, I was able to see that Solon's vehicle had a seize tag order. With my experience and training, I was able to determined that order could be put in place due to not having proper insurance on the vehicle. I looked at the toll-free number (1-800-344-2150) provided on the insurance card Solon handed me and called it. I spoke with a customer service representative provided them with the policy number. The representative confirmed Solon's name was in fact on the policy, that it was no longer active since March of 2024, and has failed to make a payment on it since March of 2024.

I walked over to Solon, confirmed that this was his insurance card, that this was his current insurance company, and the policy was active. He affirmed it was. I then inquired when was the last payment he made on it. Solon advised that he paid the insurance bill "last month".

Solon was also found to be in violation of traffic infractions. Expired tag, which expired on January 23, 2025 and improper window tint that measured at 3% using a certified department issued tint meter. Both the driver side and passenger side violated the established percentage stated in Florida State Statue 316.2953 (28%).

Due to Solon's post Miranda statements about his insurance, I determined I had enough probable cause to take him into custody for violating Florida State Statue 324.221.2 Failure of owner/operator to maintain required insurance citation #AKFRVXE. Solon was further cited for FSS 322.34.1 DWLS unknowingly operating a vehicle while DL is suspended citation #AKFRVVE, FSS 320.07.3a Expired tag less than 6 months citation #AKFRVWE, and FSS 316.2953 Sunscreen material below 28% citation #AKFRVYE.

Solon was transported to the Indian River County Jail, where he was charged/cited and turned over to jail staff for further processing.

Solon's vehicle was towed by CJ's towing and taken to their lot. Solon was advised of the tow and the location of the vehicle.

Florida tag #RBQP62 was seized and returned to FLDHSMV.
