On Thursday, August 21, 2025, at approximately 0138 hours, I was conducting traffic enforcement at the 300 block of 27th Avenue SW, Vero Beach, Florida, when I observed a red in color Ford F-150 travelling Northbound without the headlights, or taillights activated.

I initiated a traffic stop on the vehicle at the 200 block of 27th Avenue SW, before the vehicle came to a final stop near the 450 block of 27th Avenue. After the vehicle came to a stop, I made contact with the driver, Colin Knight, who stated they were headed to Pompano, Florida to visit a friend and he must have forgotten to put the lights to vehicle on automatic.

It should be noted as I was speaking with Colin, I observed multiple butane lights, and burnt aluminum foil sitting on top of the vehicle entertainment center. Due to my training and experience, I recognized the aforementioned items to utilized during the use of narcotics.

Due to the fact that the items were in plain view, I instructed Colin, and the female passenger, Alexis Perna, to exit the vehicle to conduct a probable cause search of the vehicle. A subsequent search of the passenger side of the vehicle revealed multiple small plastic bags, a bag of hypodermic needles, and multiple butane lighters. Due to the large quantity of drug paraphernalia located in Alexis's area of direct possession she was detained and was placed into Deputy Montgomery's agency issued Patrol Vehicle.

I advised both Colin and Alexis of the Miranda Right's at which point both individually stated they were willing to speak with me regarding the recovered items. As I spoke with Alexis, I noticed a small crystal-like substance on her right leg as she was seated in the rear passenger side of Deputy Montgomery's agency issued patrol vehicle.

An agency issued narcotics field test for Methamphetamine, and Fentanyl were utilized of the substance, which yielded a positive result for both test kits. I again spoke with Alexis who stated, "look at me do I look like I use narcotics," and stated it must have gotten on her pants when her and Colin removed the center console from the vehicle earlier in the day.

Deputy Neill who was assisting in the search of the vehicle approached me, and stated a drug ledger was located inside of the black purse which had Alexis' wallet and driver's license inside of it. The ledger had the inscription Alexis & Colin written on the first page followed by a list of names, loan amount, and weight conversions written on the following pages. Further speaking Alexis, she stated she was concealing more Paraphernalia inside of her waist, along with "Meth."

Alexis was allowed to retrieve the items, at which point, she handed me two small bags containing a white crystal substance, and a glass pipe with burnt residue and char boy which is utilized to smoke narcotics. A field test kit was utilized which tested positive for Fentanyl.

Due to the fact that Alexis was in direct possession of field test positive Fentanyl and Methamphetamine, as well as drug paraphernalia she was placed into custody under the following charges:

On August 21, 2025, at approximately 1040 hours, I assisted Officer Antosia in a shoplifting at Publix located at 9621 US Hwy

Upon arrival, I made contact with Officer Antosia, who stated that he was waiting on a call from Brooke, the store manager, regarding an individual who might have possibly concealed some unpaid merchandise. Officer Antosia and I made contact with the individual identified as Clayton Lapatte. Clayton was detained for further investigation regarding the items in the cart. Clayton produced a receipt for some items. There was clothing merchandise that was not on the receipt.

Officer Antosia went into the store to review some video footage. Officer Buffington and Officer Pittman also arrived on scene, which gave me a chance to watch the footage with Officer Antosia.

In the video, I observed the male, Clayton, walking the clothing aisle in the store. After some time, he made a selection of some packaged clothing. Brooke changes the view to the self-checkout camera, where Clayton scans some of the food items, then skips scanning two pieces of packaged clothing. He then places the third packaged clothing item in his backpack without scanning it. The other two skipped scanned items are placed in a Publix plastic bag. Clayton walks out of the establishment with the cart and unpaid items. Clayton passes all the points of sales without making an effort to pay for what he took.

I returned to the outside of the store, where I read Clayton his Miranda Rights, to which he voiced his understanding. I asked Clayton if he had concealed a piece of packaged clothing, to which he denied. I assured him that I had seen the video of him placing the item in his bag; Clayton again denied his actions.

Clayton was placed in mechanical restraints, double-locked, and searched before being placed in the back of my patrol unit.


Clayton was charged with petit theft, FSS 812.014.

On 8/21/25, at approximately 1422 hours, 1 Ofc. Kriegner responded to 1400 27th Street (Up Center) in reference to a disturbance.

Upon arriving on scene, I made contact with Melissa Brown (V1) who informed me she was shopping inside the UP Center when she observed her belongings (wallet, eye glasses, and cell phone with an estimated value of \$100) were missing from inside the shopping cart. V1 advised she used her husband's cell phone to attempt to locate her own cell phone. V1 was able to track the cell phone to a location that was southwest of the Up Center. V1 stated she observed a female (later identified as Amanda Perez, A1) holding her glasses and "flipping" through other belongings. V1 advised she attempted to confront A1 and retrieve her belongings she saw A1 in possession of. When V1 advised A1 to return the stolen items, A1 handed V1 her cell phone and left the area, heading southbound, on foot. Once I arrived on scene, I observed several different personal items sprawled across the ground where V1 stated the grey backpack (containing personal items to include a cell phone, Air pods, and a wallet containing V2's Florida Driver's License, all belonging to V2, with a total estimated value of \$385) was emptied. I observed a pink wallet, a cell phone, and a pair of Air pods, to be among the items on the ground, that did not belong to either female on scene. A1 was asked about the backpack; however, denied ownership. A1 was seen by V1 and W1 with the grey backpack containing the stolen items, in her possession prior to abandoning it.

I spoke with another individual on scene, Jahson Cummings (W1), who provided a written witness statement, stating he left the Up Center and observed V1's car "pull up" to A1 and heard V1 tell A1 "give me back my stuff". A1 kept walking away from V1, when V1 followed her, exited the vehicle, and state to A1 "give me my phone". A1 gave V1 the phone back and W1 stated he went up to A1, grabbed the backpack she was carrying (a grey backpack), and told her to "take it off". A1 removed the backpack from her person and V1 began to empty the contents of the bag, looking for her stolen belongings.

A drive-by show-up was conducted and both V1 and W1 positively identified A1; V1 stated, "Yup that's her".

A1 was placed under arrest for FSS 812.014 Petit Theft and FSS 817.5685 Unlawful possession of the personal identification information of another person.

When asked to identify herself, A1 refused and began attempting to physically remove herself from officer custody. A1 was also charged with FSS 843.02 Resisting officer without violence to his or her person.

A1 was then transported to the Indian River County Jail to be held for a bond of \$1500.

While at the jail, A1 was positively identified, and stated she wanted to "kill" the nurse that was attempting to assess her wellbeing. I was advised by Ofc. Marty, that a report was made at the Up Center, regarding a stolen duffle bag containing personal items including cell phone and a set of Air pods with a total estimated value of \$385 (reference Case#2025001612). The victim (Dawn Drilling, V2) provided a written statement of Ofc. Marty. The items that were found in A1's possession were positively identified as belonging to V2.

A1 was subsequently charged with 2 counts of FSS 812.014 Petit Theft and is to be held at the Indian River County Jail with a bond total of \$2000.
