On Monday, August 17th 2026 at approximately 1944hrs, I Deputy Finkle was dispatched to 1060 US Highway 1, Lot 59 for threats of suicide.

Public Safety Dispatch received a call from a female, later identified as Shelby Newman (N408-839-30000-0) advising that a Mark Damon had sent her a photo to her phone that showed him with a black in color shotgun in his mouth and was threatening suicide.

As Deputies arrived on location and began setting up a perimeter, I was able to contact Ms. Newman via cell phone (941-932-0902). She affirmed to me that Mr. Damon had sent her that photo this evening and that the firearm seen in the photograph was her 12-gauge tactical shotgun that she had hidden inside the RV.

I was informed that Mr. Damon had an out of County, non-extraditable warrant and was a convicted felon, who is currently on probation. Utilizing Law Enforcement resources, Deputies were able to make contact with Mr. Damon who surrendered peacefully without resistance. Once he was detained, I informed him of his Constitutional rights and read him Miranda.

Upon Mr. Damon stating he understood his rights, I asked him if he in-fact sent the photograph with a black in color tactical shotgun in his mouth to Ms. Newman to which he affirmed. I then asked how he came into possession of the firearm to which he advised it was hidden under the bed. He stated he did not load it and has never shot a firearm before.

Inside the RV, a black in color tactical 12 gauge shotgun was located and seized by Deputies who will be petitioning for a search warrant.

I took Mr. Damon into custody based on the probable cause obtained for:

790.23.1a[2674]- Possess weapon by convicted Felon

I transported him to the Indian River County Jail where he was turned over to Jail staff without issue. Upon looking through his Criminal History, I located numerous felony convictions to include, but not limited to:

Wakulla County Sheriffs Office- Missile into dwelling Veh Building or Aircraft

St. Lucie County Sheriffs Office- Engage Contracting Busn W/O Certif prior to Conv

NARRATIVE

On Monday, August 17, 2026 at approximately 1812 hours I was dispatched to [REDACTED] in reference to a domestic disturbance.

Upon arrival, I made contact with the victim, [REDACTED] who advised the following in summary:

He and [REDACTED] Rouslande Milien [REDACTED]
[REDACTED] Today, Rouslande was off at an unknown address drinking with her friends and continued to come back to the aforementioned address. Rouslande continued to leave the residence, however she promptly returned to the house and started screaming at [REDACTED] about the location of her phone [REDACTED] was afraid the screaming match would quickly turn physical and attempted to go to his truck and leave the residence. While walking to his truck, Rouslande came up to him and pulled him down to the ground by his shirt [REDACTED] continued to get into his truck bearing [REDACTED] and Rouslande jumped into his truck bed, to hit his back windshield. She continued to get down from the truck bed, open his car door and attempt to remove him from the vehicle and take his keys out of the ignition.

A resident of the household, Sameriza Green advised the following about his recollection:

He was inside of the residence for the beginning of the incident, but went outside when he heard the screaming outside. He did not see Rouslande pull [REDACTED] to the ground, however he did see her get into the back of [REDACTED] truck bed and bang on the back windshield. He did not recall seeing Rouslande go to the driver side portion of the vehicle and gain access to stop [REDACTED] from leaving.

Rouslande advised the following in summary:

She returned to [REDACTED] after drinking with her friends at another residence when she got into a disturbance with [REDACTED] She did not recall shoving [REDACTED] to the ground outside of the residence. She did however admit to gaining access to the driver side door of his truck when he attempted to leave in attempt to stop him from leaving. In this attempt to stop him, she also attempted to take his keys out of the vehicle. Due to her levels of intoxication on scene, it was difficult obtaining a coherent and logical timeline from her.

While en route to the Indian River County Jail, Rouslande was able to maneuver out of her seatbelt and continued to hit her head against the cage in the back seat of my patrol vehicle. I immediately stopped my vehicle in the safest spot in the intersection of 1st place and Old Dixie Highway. I contacted [REDACTED] to be in route with a wrap to immobilize Rouslande from further hitting her head on the cage. When I opened the back door of my vehicle, Rouslande immediately got out of the car and rammed her body into mine. I pinned her into the door frame, issuing verbal command to stop to which she refused. Rouslande continued to open her mouth and begin motioning to bite me. Following this action, I forced Rouslande to the ground and continued to issue commands to stop, which she refused. While on the ground, I put my knee on her back in attempt to immobilize her, she responded to this by maneuvering her head to the right and biting my right ankle. While [REDACTED] was assisting with putting Rouslande inside of the wrap device, she kicked [REDACTED] while [REDACTED] was putting her legs inside of the device and attempted to bite [REDACTED] while putting on the upper half of the device, however was not successful with the bite. While on the ground, Rouslande grabbed the handheld portion of my radio and ripped it off
