NARRATIVE

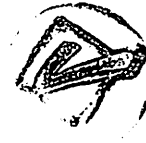
On October 17th, 2024, at approximately 0433 hours, I responded to 4490 U.S. Highway 1 Cumberland Farm, in reference to a trespass in progress.

Upon my arrival, I spoke with Cumberland Manager Martin C. LaChance, who stated that Lena A. Boothe was at the location Panhandling. LaChance stated that Boothe had been previously trespassed and would like her arrested; he also provided video footage of Boothe trespassing.

I located Boothe on the west side of the property and made contact with her. I read Boothe's Miranda rights from my agency-issued Miranda card. Boothe understood her rights and agreed to speak with me. Boothe stated that she walked across the premises to ask a friend for a few dollars and that she was aware that she had been trespassing from the location previously. A query with the Indian River County Public Safety Dispatch revealed a trespass warning previously issued to Boothe, reference case # 2020-195220.

I then placed Boothe under arrest for violating F.S.S. 810.08 (2)(a) trespass of a structure or conveyance. Boothe was placed in the back of my patrol vehicle and transported to the Indian River County Jail without incident.

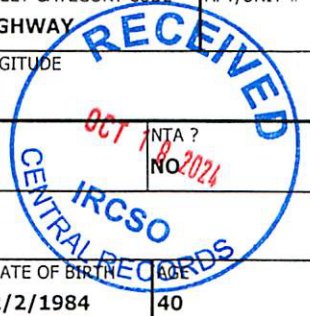
