NARRATIVE

On June 16, 2026, at approximately 2109 hours, I responded to the Indian River County Jail 4055 41st Avenue, Vero Beach, Florida, in reference to a disturbance between inmates.

Upon my arrival, I made contact with Lieutenant Loiseau, he informed me of two inmates, latter identified as Glenn Brown and Ricardo Barrera, who were involved in a physical disturbance. I was shown the video footage of the incident. I observed Barrera sitting at a table while Brown was by his cell door. They appeared to be in a verbal dispute which led to Brown leaving his cell door and striking Barrera multiple times. Barrera can be seen falling to the ground and stumbling to get back up. Brown returned to his cell door as Barrera gathers his bearings and slowly walks back to his cell.

I then made contact with Brown. I read Brown his Miranda right which he understood and immediately invoked his right to remain silent.

I then made my way to Cleveland Clinic Medical Center's Emergency room, where Barrera was being treated for his injuries. Upon my arrival, I made contact with Barrera, read hi his Miranda rights, which he understood, and also decided to invoke his rights.

I then spoke to the nurse who treated Barrera. She stated that he suffered multiple lacerations to his bottom lip. On laceration through the front of his slip and out the back requiring internal stitches. There was also a laceration to his outer bottom lip that also required stitches.

Based on the video footage and Barrera's injuries, I find probable cause to charge Glenn Brown with:

1. F.S.S. 784.082.1 Aggravated battery on person detained in prison or jail facility.





NARRATIVE

On June 16, 2026, at 19:33 hours, I Deputy D. Coon #6379 responded to McDonalds fast-food restaurant at 5875 20th St in Indian River County in reference to a Disturbance call. Dispatch was informed by an anonymous customer that a 1-on-1 fight had just occurred inside the restaurant.

Upon arrival, I was flagged down by the two apparent combatants. I first met with Jaemiesha Johnson. Jaemiesha is the victim, and she swore verbally to the following statement in summary:

Jaemiesha entered McDonald's minutes before our arrival. She stated that she wanted to charge her phone, but she was sternly addressed by the management and informed that she could only remain for thirty minutes. Jaemiesha appeared unkempt and homeless. She was also rolling a large suitcase with several bags tethered to it. Jaemiesha protested staff's remark and insisted that she was ordering food through the McDonald's mobile application on her cellphone. Since her cellphone battery was completely depleted, this complicated the matter and a dramatic verbal exchange ensued with staff. This apparently caught the attention of another patron, Ivan Jermaine Patterson Jr. Jaemiesha and Ivan are complete strangers, and both arrived at McDonald's separately. However, Ivan interjected and began to scold Jaemiesha for her demeanor against McDonald's staff. Ivan grew increasingly aggressive and began to invade her personal space. Ivan taunted Jaemiesha by pointing his finger in her face, nearly touching it. Jaemiesha told Ivan that he was not involved and warned him of McDonald's security cameras. Ivan persisted. Jaemiesha ultimately responded by slapping Ivan's hand away from her face. Ivan responded by reaching out and striking her on the right side of her neck/face. Jaemiesha described the strike as more of an open-hand push to her face, not a punch. I observed no injuries, and Jaemiesha did not request medical attention. Jaemiesha wished to pursue charges against Ivan.

I then interviewed Ivan. Ivan acknowledged being homeless and a complete stranger to Jaemiesha. He overheard Jaemiesha's yelling and dramatic exchange with McDonald's

staff. Ivan felt compelled to intervene. I asked Ivan bluntly why he became involved. He replied, "She was disturbing the peace!" Ivan addressed Jaemiesha about her antics. She rudely replied and began to snap her fingers at Ivan, "like a peasant". This angered Ivan. He admitted to invading Jaemiesha's personal space and pointing his finger in close proximity to her face. Jaemiesha then slapped his hand away from her face. Ivan denied striking Jaemiesha. I asked him if McDonald's security camera footage would show otherwise. Ivan replied, "Yeah, probably...me pushing her." Ivan then explained that he pushed Jaemiesha because she continued to snap at him as if he were a peasant. I observed no injuries, and Ivan did not request medical attention.

I then reviewed McDonalds security camera footage, which had no audio. The overhead-angled camera shows the cash-register counter where customers place orders. Jaemiesha can be seen manipulating her cellphone and speaking out loud. At 19:28 hours Ivan comes into the frame and engages with Jaemiesha. She promptly walks away from him, and then she returns to the register. Approximately one minute later, Ivan reapproaches her. Jaemiesha appears disinterested about engaging with Ivan, but the two eventually square off face-to-face. At 19:30 hours, Ivan's antics appear to intensify as he steps closer to Jaemiesha. He appears agitated. At 19:30:25 hours, Ivan briskly lunges forward and cocks his right fist back an aggressive taunting motion. He does not strike, but he moves closer and repeatedly points his right index finger in Jaemiesha's face. With Ivan's hand/finger nearly touching Jaemiesha's face, she responds by using her right hand to slap Ivan's right hand away. Ivan responds by deliberately using his left hand to strike Jaemiesha on the right side of her neck and face. Both continue to argue, and Ivan continues to invade Jaemiesha's personal space with finger pointing to her face. Ivan was clearly the persistent aggressor and never appeared to be in a defensive posture or manner. Staff and customers then appear to break up the standoff.

Based on my investigation, it was determined that a battery had occurred. There was probable cause that Ivan deliberately and unlawfully struck Jaemiesha against her will. This attack was not provoked, and Jaemiesha appeared to disengage multiple times. I

NARRATIVE

On June 16, 2026, at approximately 2151 hours, I was traveling east on 9th Street SW, and observed a white Jeep bearing Florida tag AW97TW. A query of the Florida tag revealed the registered owner, Krista Reese, did not possess a valid Florida driver's license.

I conducted a traffic stop on the aforementioned vehicle at US Highway 1 and 9th Street SW, Vero Beach, Florida. I made contact with the driver, Krista, and informed her the reason for the traffic stop.

I asked the passenger's, Fred Thomas and Jeffery Beam for their identification, to see if either possessed a valid Florida driver's license to operate the vehicle. I later discovered neither man possessed a valid driver's license.

While conducting NCIC/FCIC queries of the occupants, K9 Deputy Williams arrived on scene. I asked K9 Deputy Williams to conduct a free air sniff of the vehicle with his K9 partner "Remi." K9 Deputy Williams informed me his K9 partner "Remi" alerted to the vehicle for odors he is trained to detect. See K9 Deputy Williams case supplement for his involvement in this investigation.

During the search of the vehicle, several used syringes and glass smoking pipes with residue were located.

I requested Jefferey to the front of my vehicle and conducted a search of his person, then placed him in handcuff restraints and sat him on the curb.

I requested Fred to the front of the vehicle and conducted a search of his person, removing several items from his pockets, to include a black marker, and a pack of cigarettes. I placed him on the curb next to Jeffrey and began testing a substance that was located in a black bag with the aforementioned drug paraphernalia that was located by Jeffrey.

After testing the substance with negative results, I went to inspect the items that I removed from Fred's pockets. I opened the pack of cigarette's and discovered several little clear baggies, that are consistent with the sale of illegal controlled substances. I began to inspect the black marker I removed from Fred's pocket. I discovered the marker was hollow, and contained two (2) baggies with a white powdery substance, and one (1) baggy with a green leafy substance.

I conducted field test on the white powdery substance with an agency cocaine test kit and received a positive result. I field weighed the two (2) baggies, which weighed two (2) grams.

All items of evidence were later placed into evidence at crime scene.

Fred was secured into handcuff restraints, checked for proper fit and placed in the rear of a patrol car.

Krista was able to get a family member to come to the scene to drive her car. Jeffrey was taken out of handcuff restraints.

Krista was given a verbal warning for driving while license suspended, her and Jeffrey were released from the scene.

Fred was transported to the county jail without incident, and charged accordingly.

This investigation was captured on my body worn camera.

This investigation is cleared by arrest.
