NARRATIVE

On 06/23/2026 at approximately 1311 hours, I Deputy Austin Binner responded to the area of 9th St SW and S US 1, in reference to a criminal mischief.

Prior to my arrival, I was notified by Indian River County Emergency Dispatch that a Dark Blue Ford F150 Lighting had front end damage caused by a white male who had thrown his skateboard into moving traffic on S US 1. The alleged suspect given to Indian River County Emergency Dispatch was described as a white male wearing a maroon-colored shirt. The suspect was last observed travelling South on S US 1 near 12th St SW. Deputy Colby Ortega responded to the area prior to me and recalls the following:

"I drove down 12th Street Southwest but did not locate the suspect. As I began driving down 11th Lane Southwest, I observed a white male, later identified as Michael Storm, walking and holding a skateboard. I activated my agency issued marked patrol vehicle's emergency lights and told Michael to stop and he looked back at me and yelled "shave your beard".

I immediately exited my vehicle and Michael stopped walking. As I walked up to Michael, he spontaneously uttered he was walking on the sidewalk and saw a truck driving in the bicycle lane so he held out his skateboard to "establish the bike lane"

D/S A. Binner later arrived on scene and assumed the investigation. D/S A. Binner later said to detain Michael, so he was placed into handcuffs. I then verbally advised Michael his Miranda Rights, which he understood and waived. Post Miranda, Michael stated the following verbally:

Michael was walking on the sidewalk of U.S 1 and saw a man honk his horn at a female driver numerous times. Michael walked over to the man's truck and "touched" the truck so the man would stop. Michael then saw another truck driving and infringing on the bicycle lane, so he stuck out his arm while holding the skateboard. I asked Michael why he would hold out the skateboard and he said law enforcement does not do their job, so he wanted to make sure no one was struck by a car even though no one was riding a bicycle in the bicycle lane."

As I arrived on scene I observed Deputy Ortega speaking with Michael Storm near the intersection of 11th Lane SW and S US 1. As I approached Deputy Ortega and Michael, I heard Michael spontaneously utter while he was walking on the sidewalk parallel with S US 1, he had held out his skateboard to "establish the bike lane" due to motorists driving close to it. While Deputy Ortega continued to speak with Michael, I was approached by the victim, Terence Schlitt. As I approached to speak with Terence, he informed me that Michael was the individual who damaged his Dark Blue F-150 Lighting.

I had requested Terence to relocate to his vehicle that was located at 1189 S US 1. Terence's vehicle displayed FL Tag C89WJ, and a record check indicated he is the registered owner of the vehicle.

Terence recalls the incident as follows:

NARRATIVE (Continuation)

While travelling South on S US 1 a white male carrying a skateboard randomly threw the skateboard at his truck. Terence recalls the incident occurring in front of Kia (1105 S US 1) Terence stated "he" (looking in the direction of Michael and pointing at him) threw the skateboard at his truck and had crossed S US 1 towards 12th Street SW. Terence advised the damage done to his pick-up truck was the front passenger headlight (estimation of \$2,000) and the front passenger side quarter panel (estimation of \$3,000). Terence advised his estimation of the damage total is approximately \$5,000.00 and was quoted by an unidentified college of his via telephone. Terence advised he wished to prosecute. Terence informed me that an employee at Kia stated he witnessed the incident occur.

Contact was made with the Kia employee who identify as Jared Gonzalez. Jared recalls the incident as follows:

While I was standing outside in the parking lot near the entrance of the Kia dealership, I observed a white male walking Southbound throw his skateboard into oncoming traffic. The skateboard struck a Dark Blue F-150 Lightning breaking the headlight. I observed the skateboard bounce off of the truck and land near the white male. The male then crossed S US 1 onto the East side of the roadway and continue to walk South.

While on scene, I observed Michael's skateboard had newly chipped wood to the deck of the skateboard. With damage consistent with it being thrown at oncoming traffic. It shall be noted that the skateboard was made out of wood, hard plastic, and metal. If this object were to be thrown at an occupied moving vehicle it would have the potential, to cause great bodily harm or death to an individual occupying the vehicle.

Due to the above statements from all involved parties, I concluded Michael Storm is in violation of the following.

1 CT FSS 806.13.1b3 Criminal Mischief of \$1,000 or more (No BOND)

1 CT FSS 790.19 Throwing Deadly Missile into Vehicle (No BOND)

NARRATIVE

On Tuesday, June 23, 2026 at 4:34 PM, myself and additional deputies responded to the 7Eleven located at 8530 US Highway 1, Sebastian, FL in reference to a disturbance requiring EMS.

Prior to arrival, Indian River County Sheriff's Office Public Safety Dispatch advised there was a physical disturbance involving a hammer taking place between two females in the parking lot of 7Eleven at pump 15 near a Dodge Challenger. The female victim later identified as, Sally Janette Berry, was struck with the hammer and was now bleeding about the face and neck from the hammer strike. Berry stated the disturbance was involving her daughter, later identified as Heather Lynn Wilson.

Corporal Trevor Kramer arrived on scene prior to my arrival. Corporal Kramer would later describe the following:

"Upon Arrival Heather was standing next to her vehicle at the gas pumps. I exited my patrol vehicle when she started yelling at me that I was not a real cop. As I approached Heather, a citizen shouted to me from the other side of the parking lot, that she was the one who hit her mother with a hammer. Heather then tried to get into the gray Dodge Challenger she was standing beside. I attempted to stop her from fleeing the scene. As I went to grab her arm to pull her away from the vehicle, she began to actively and physically pull away from me. Heather was escorted to the ground, still pulling away from me and refusing to comply with lawful commands. I attempted to detain her with physical hand restraints, she began to grab and scratch my hands, she also grabbed at my arms and was trying to dig her nails into my skin. Heather then kicked me in the legs attempting to defeat my attempts to detain her. Heather was then was placed into physical hand restraints and placed into a patrol vehicle."

Upon my arrival, I observed Corporal Kramer on the ground attempting to restrain Heather. Heather was physically using her body to pull and push away from Corporal Kramer. I went to aid in restraining Heather as she continued to use her body movements to resist us placing her into custody. Heather was then placed into mechanical hand restraints. Heather was later transported by Corporal Kramer to the Indian River County Sheriff's Office Jail for booking.

Corporal Kramer would also later observe in plain view of the passenger side floorboard of the Challenger, a hammer with a small amount of blood on it.

Contact was then made with Sally. I first observed Sally to have injuries to the left side of her face and neck area. The injuries consisted bruising to her bruising to her left eye orbital, scratches to her left cheek where blood had surfaced and bruising to the left side of her neck. Sally also had a bite mark on her back which was red a bruised.

Sally was later transported to Orlando Health Sebastian River Hospital Emergency Department treated for her injuries and discharged.

Sally stated she and her daughter, Heather were traveling in Heather's Dodge Challenger to a cellular store in Brevard County. Heather was driving, while Sally sat in the front passenger seat. Sally said when they entered back into Indian River County, Heather began to argue with her. Sally said Heather has been recently dealing with identity theft, believing her ex-husband was behind it. Heather then began to accuse Sally of being a part of the identity theft. Heather then picked up a large metal construction hammer and began threatening to hit her with the hammer if she did not tell Heather her involvement. Sally continuously denied any involvement at which time Heather struck her in the face with the hammer.

After being struck with the hammer, [REDACTED] Heather recognized this and


While searching Mr. Lee, I discovered a small amount of marijuana in his possession. The marijuana was placed in to crime scene for destruction.


