NARRATIVE

On Wednesday, July 23, 2025, at approximately 1400 hours, I responded to [REDACTED] in reference to a call for service. Upon arrival, I made contact with Samantha Vargas, who advised the following:

Samantha stated that her and her husband, Samuel Vargas, were involved in a domestic disturbance on July 21st, 2025 (ref 2025-76959). Samantha stated that Samuel was released from jail the following day with a condition of his release to refrain from any contact with her. Samantha stated that since Samuel's release, she has received several text messages from Samuel's phone (772-634-5249). Samantha stated that she and Samuel share a phone carrier under her name and the number that was used has been his since it was activated approximately a year prior with no other person having access to the phone. Samantha provided me with her phone to observe the text messages.

I observed Samantha's phone messages for a person she saved as "husband with two hearts", a long list of twenty or so messages with no response from Samantha. The messages start out "Everything ok?" "U ok" then later escalating to "Pussy", a middle finger emoji, "The fucking sitting there ignore me and being scared like a little bitch that you are", "Your'e a pussy ass hoe bitch cuz you fucking made me lose every fucking thing and now its your", "Be ready" and so on.

Samantha stated that she has gps tracking on Samuel's phone and advised that he has been moving around today due to his landscaping job. She advised that he was currently at 1136 34th Street SW. Deputy Saint Eloi responded to the address and made contact with Samuel. Post Miranda, Samuel sated to Deputy Saint Eloi that he was aware of the no contact order from the judge and he only sent one message after his release to Samantha. Samuel provided his phone to D/S Saint Eloi however the messages to Samantha's phone were deleted.

I verified the conditions of Samuel's release to contain the stipulation to refrain from any contact with the victim, Samantha Vargas through our domestic violence unit.

Samuel was arrested and transported to the Indian River County jail.

Based on the escalation of the text messages so soon after the release of Samuel, I believe the victim to be in great risk of serious bodily harm upon his release and request he be held without bond until the case is resolved.

Your affiant along with Officer Farquharson (451) arrived around 4271 25th Avenue to make contact with Michael Slaughter Jr. regarding a warrant in hand. The Indian River County Sheriff's office was notified and responded to the scene due to being in the county's jurisdiction. Upon making contact with Slaughter, he was advised of the warrant and read his Miranda rights. At this time, Slaughter attempted to run while hand cuffed and was taken to the ground by myself along with deputies on scene. At this time, Slaughter was placed in the back of my agency vehicle and was turned over to me from the Sheriff's office.

Slaughter was placed under arrest for Indian River County warrant #2025cf854 for 3 felony counts. The first count is F.S.S. 782.071 Vehicular homicide, the second is F.S.S. 316.027(2)(C) Leaving the scene of a crash involving death, and the final count is 322.34(6)(b).

Slaughter was transported to the Vero Beach Police department where he requested to speak to your affiant as well as Ofc. Farquharson. Slaughter was later transported to the Indian River County jail where he is currently being held on a 1.75 million dollar bond. 



NARRATIVE

On Wednesday, July 23, 2025, at approximately 1946 hours, I, Deputy M. Neill #6317 responded to 1165 12TH Court Southwest, Vero Beach, Indian River County, Florida, 32962 in reference to a disturbance.

The Indian River County Communications Center received two 911 calls in regards to Mr. Pitts. One caller advised that Mr. Pitts was threatening to "shoot everyone in the neighborhood if cops come near him". An additional victim called and reported that Mr. Pitts exposed himself to her to the 911 dispatcher.

Upon Sgt. Thimmers arrival, he observed Mr. Pitts sitting on his pouch. As Sgt. Thimmer approached on foot, Mr. Pitts made threats to Sgt. Thimmer saying "Ive got something for you". Based on the multiple callers identifying the subject and making claims of a crime occurring, Sgt. Thimmer had reasonable suspicion to detain Mr. Pitts. Mr. Pitts got up as Sgt. Thimmer approached. Sgt. Thimmer ordered Mr. Pitts to stop, and not go inside of his residence. Mr. Pitts ignored these commands and went inside his residence after being advised not to. Mr. Pitts went inside and refused to exit for approximately twenty five minutes.

I made contact with Ms. Theresa Jackson who provided the following sworn statement: Mr. Julio Pitts become verbally loud and aggressive when he is intoxicated. Every day, Mr. Pitts causes a disturbance with everyone around him, for no apparent reason. Mr. Pitts will yell at everyone he can see, including random cars as they drive by his residence. These types of occurrences have been occurring constantly, to the point where Ms. Jackson does not feel safe with Mr. Pitts and is disturbed by him causing a disturbance so often. Mr. Pitts disrupts the public morals, and affects the peace and quiet of his neighbors by his loud screaming and yelling. Multiple videos were provided to law enforcement of Mr. Pitts yelling at neighbors and causing a disturbance, for no apparent reason.

Another witness confirmed the disturbance which was caused by Mr. Pitts and also advised it constantly disrupts his peach and quiet.

I also made contact with Ms. Sarah Emard, who provided the following sworn statement: Ms. Edmard, who lives one street to the east, but still can observe Mr. Pitts front yard from her back fence. Mr. Pitts was yelling and screaming, causing a disturbance so loud she could hear it from her residence. From her yard, she yelled at Mr. Pitts to be quiet. Mr. Pitts became irate over this, turned around and then exposed his buttocks at her. He then turned around, pulled his pants down further, grabbed his penis and started to shake it at her. All of this was done from his driveway, approximately 10 feet away from the public street.

Ms. Helen Jordan was present with Ms. Emard when this happened. She provided a sworn statement which was consistent with Ms. Emard. She too observed Mr. Pitts pull down his pants, expose his buttock, then turn around and expose his penis while making a jerking motion.

Law enforcement was able to get Mr. Pitts to exit his residence. After exiting his residence, Mr. Pitts was taken in to custody. He was advised of his Miranda Rights. After being advised of his rights, Mr. Pitts stated that all of his neighbors are jealous of him, and cause disturbances with him. He did confirm he made a jerking motion with his hand around his penis at one of the victims, but did not expose himself. Mr. Pitts did appear to be under the





NARRATIVE

On July 23, 2025, at approximately 2116 hours, I arrived at [REDACTED] in reference to a criminal mischief. Upon my arrival, contact was made with Julius Baker, who advised the following verbally:

Julius has had issues with [REDACTED] Enrique Birks, regarding their properties. On this night, sometime after 2000 hours, Julius was in his home and he heard something hit the dining room window. When Julius checked, he found the window and window screen were damaged and there was a rock on the ground outside next to the window. Julius said the window [REDACTED] thought he may have thrown it, so Julius went to the back of his property to see if he could see if another rock would be thrown. A little while later, Julius saw Enrique walk to the back of his property and watched him throw a rock towards Julius' window. Julius then heard the sound of glass break. Julius said he could positively identify Enrique because there was a gap in the fence where Enrique was standing and Julius could see that Enrique threw the rock. When Julius went back to his home, he found a bigger rock on the ground next to the same dining room window and the window and screen were more damaged. Julius advised the window was valued at approximately \$300.00 and he desired prosecution.

I viewed Julius' dining room window and could clearly see two rocks on the ground just outside of the home. I also observed his window to be heavily damaged and his screen outside the window was damaged.

I then contacted Enrique. Enrique was verbally advised his Miranda Rights, which he said he understood and waived. Post Miranda, Enrique advised the following verbally:

Enrique said he never threw a rock at Julius' window. Enrique claimed someone threw rocks at his home, but there was no evidence of this and he claimed they were dirt rocks that disintegrated upon impact. Enrique allowed me to go to the back yard where he was seen throwing the rock and I noticed numerous cameras around Enrique's property.

I asked Enrique if I could check the video footage he had and he agreed. Enrique's wife (unknown name or anything else because she would not cooperate with providing information) unlocked her phone, pulled up their surveillance cameras and allowed me to view their cameras. Upon viewing the cameras, I observed Enrique walk outside his home to the area Julius claimed he saw him and around the time Julius had called the Sheriff's Office, and I clearly observed Enrique throwing a rock in the direction of Julius' home.

Based on the information above, I found probable cause Enrique was in violation of F.S.S 806.13; criminal mischief under \$1,000.00. Enrique was subsequently arrested and was transported to the Indian River County Sheriff's Office.
