PROBABLE CAUSE STATEMENT

I responded to a disturbance between two males at 925 Bougainvillea Lane (Grind and Grape).

Upon arrival, I made contact with the victim outside of the above mentioned establishment. The victim stated that he had been in an altercation with his boyfriend of six months. The victim stated they do not reside together. The victim's boyfriend/defendant was identified as Michael Reyes (W/M DOB: 12/18/2001).

The victim stated that the defendant became upset when he attempted to take a picture with the victim. The victim stated that he did not notice the defendant trying to take a picture and that's what started the altercation. The victim then stated that the defendant will get aggressive when he consumes alcohol and stated that there has been history of unreported domestic violence issues between them. The victim stated that due to the defendant's behavior, he did not want to leave with him. The victim stated that the defendant proceeded to get into the passenger front seat of his (victim's) vehicle (VA tag #: UHD1576) and refused to exit the vehicle.

The victim completed a witness statement which stated the following: "Michael was acting irrationally and refused to exit my vehicle. He yelled, threw water at me, and punched me in my left upper arm. Witnesses called the police."

The victim provided me with video footage of the incident. In the video, the defendant is seen in the front passenger seat, reaching for a white water bottle and opening the lid. In the video, the victim told the defendant not to pour the water inside of his vehicle. The defendant told the victim "So lets leave..you already know the deal." The defendant then removes the lid from the water bottle and pours the water onto the front drivers seat with his left hand and then grabs the lid with his right hand. The defendant shakes the lid with the straw attached towards the victim, splashing water on the victim. The victim then tells the defendant that he is being recorded and the defendant responded with "you act like I give a fuck. I don't care."

In the video, the defendant then retrieved the straw that detached from the lid (from the ground) but remained in the front passenger seat. The defendant then told the victim "So what are you gonna do? Are you gonna listen? I'm giving you three seconds or I'm gonna do it...and you know I will." The defendant then began to count down and grabbed the water bottle again. The defendant is seen pouring water on the steering wheel and stated "I don't need you recording..I'll admit that I did it." The defendant kept the water bottle in his hand and then lifting the bottle up in a motion that displayed he was going to throw it to the victim and stated "I will break your phone."

In the video, the defendant placed the water bottle down in the cup holder of the center console and exited the vehicle. The defendant aggressively walked towards the victim and the victim is heard saying "stay away" and then a second time saying "stay away from me" in a frightened loud tone. At that time, the defendant is seen slightly but aggressively jogging towards the victim, making unwanted contact. In the video, the defendant is seen with both hands curled in a fist and in a fighting stance. In the video, the victim's watch is on the ground and damaged. The defendant then walked back to the victim's vehicle and sat in the front passenger seat again.

The victim did not have visible injuries at that time and refused medical attention. It should be noted that the victim repeatedly stated that he was afraid of the defendant possibly retaliating. The victim stated that he previously tried to end the relationship but the defendant vandalized his property and threatened to damage his vehicle. The victim also stated that there has been previous incidents where the defendant has called the victim over 100 times in a short time span, has threatened to exploit him on social media to family and friends, and stated the defendant has previously battered him. The victim stated that none of these incidents have been previously reported to law enforcement but he no longer wishes to have any contact with the defendant.

Based on the foregoing, the defendant (Michael Reyes) was placed under arrest for Dating Violence - Battery (Domestic Violence) in violation of F.S.S. 784.03(1A1).

The defendant was read his Miranda Warning to which he stated he understood and agreed to speak with me. The defendant stated he's been in an intimate relationship with the victim for six months but they do not reside together. The defendant stated he was upset because he did not want to be at the bar (925 Bougainvillea Ln) and wanted to go home. The defendant stated that the victim did not want to go home which made him upset. The defendant admitted to pouring water and hitting the victim.

The defendant was transported to the Indian River County Jail for booking and processing and to be held on NO BOND.

A domestic violence packet was completed and a victim's rights brochure was provided to the victim.

On July 7, 2025, at approximately 2200 hours, I was assigned to the Sex Offender/Predator Tracking Detective for the Indian River County Sheriff's Office.

During this time, I was conducting due address verifications for registered sex offenders in Indian River County. The suspect, David Shields, is a qualifying sex offender registered in Indian River County under Florida Statute 943.0435. Shields is also a transient offender who has reported a transient address of 8909 20th Street (TA Truck Stop). I have been unable to locate Shields at his transient address since taking over the position in April of 2025. According to the Sex Offender/Predator database (SOPS), he has reported living at the above transient address since December 19, 2025. Shields has a phone number he is required to report however, I had been unable to reach him by phone after numerous attempts. Shields has been reporting to the Indian River County Sheriff's Office every thirty days as required by a transient offender and informing the Indian River County Sheriff's Office that he still resides at 8909 20th Street. All registrations are documented and recorded. It should be noted that since Shields added the above transient address, he has never been verified at the address.

Upon review of vehicles, he is required to register, I noticed that he possesses a red 2002 Hyundai Sonata bearing Florida license plate Z2XYF however, I noticed that the vehicle is registered to his father, Richard Shields. His father has a listed address of 713 Carnation Drive in Sebastian, Florida 32958. I responded to that address in an attempt to locate Shields however, I received no answer at the door. Through the front window, I could see movement of what appeared to be a male subject walking through the north end of the home however, no one would answer the door. I walked to the east side of the home and noticed a television on. I knocked on the window and a female, later identified as Lisa Shields, finally came to the door. As I met her at the front door, I noticed, David Shields with her attempting to conceal himself from my view.

Lisa answered the door who stated that it was just she and her father living at the home. I then told her that I knew David Shields was home and that he needs to come to the door. Shields finally came to the door and agreed to speak with me. Shields initially told me that he had only been there "for a day or two." Through further interview, Shields admitted to living there since he was released from prison in December of 2024. The residence was never reported by Shields as a permanent address. I asked him why he failed to report the address to the Indian River County Sheriff's Office which is required by law, and he stated that the "address is too close to a charter school" and he had already been denied moving to the residence. I asked Shields why he had been lying to the Indian River County Sheriff's Office during registrations and he stated that he needed to stay at the home to take care of his 94-year-old father. I placed Shields into custody following my interview.

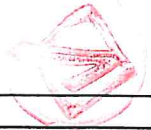



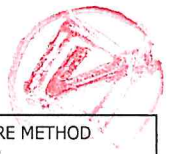

On July 8, 2025, at approximately 00:45 AM, I, Officer S. Gonzalez (Unit #471), responded to a domestic disturbance at [REDACTED]
 [REDACTED] This was my second response to the residence involving the same individuals.

INITIAL RESPONSE AND DE-ESCALATION

Approximately fifteen minutes prior to this incident, I responded to the same address regarding a verbal disturbance between the parties involved. During that initial visit (CFS No.: 070725-111), I determined the disturbance was verbal in nature and directly attributable to the Defendant's intoxication. I spoke with the Defendant, encouraging her to cease drinking and go to bed. I specifically warned her that any escalation of her behavior could result in her arrest. The Defendant assured me she would comply.

SECOND RESPONSE - ALLEGATION OF BATTERY & ARREST

Upon my second arrival, I made contact with the Victim, who provided a sworn statement, which was recorded on my body-worn camera.

The Victim alleged that the Defendant continued arguing, escalated her behavior, and pushed her into the bedroom door as she attempted to close it. The Victim expressed her intent to press charges.

I then interviewed the Defendant, who initially admitted to pushing the Victim but immediately recanted, claiming no memory of the event. While speaking with the Defendant, I observed signs of intoxication, including a strong odor of alcohol on her breath, red and glassy eyes, slow and confused speech, and unsteadiness on her feet. No injuries were reported or observed on either party.

Based on my investigation and totality of the foregoing, I placed the Defendant under arrest and informed her accordingly.

The incident occurred within the City of Vero Beach, Indian River County, Florida.

The Defendant was transported to the Indian River County Jail without incident where she was turned over to Corrections Personnel for processing and booking.

My body-worn camera video was uploaded to a secure server.
