#### NARRATIVE

On 07/12/2024 at approximately 2125 hours, I responded to 8800 20th St in reference to a Traffic Stop.

Upon arrival, I made contact with Sergeant Hoilett who was dealing with an uncooperative driver later identified as Aquaevious Harvey by his FL ID Card. Harvey advised Sergeant Hoilett that he knew he did not have a valid license to be driving upon initial contact.

I handcuffed Aquaevious and placed him in the back of my patrol vehicle. Sergeant Hoilett observed a green leafy substance sitting in plain view and removed the glass container containing the green leafy substance. As Sergeant Hoilett approached the passenger to address her, Sergeant Hoilett and I observed a clear baggy containing a white rock-like substance consistent with crack cocaine. I removed the front female passenger and rear passenger from the vehicle and searched their person.

Upon searching the vehicle a second clear baggy containing the same substance was located on the passenger side floorboard near the first baggy. Both substances were field-weighed at 3.3g with the clear baggies and field-tested positive for Cocaine. All parties advised the narcotics did not belong to them. The Narcotics were placed into evidence and submitted for latent print testing.

Aquaevious was charged and cited for Knowingly operating a motor vehicle with a suspended license, and turned over to the county jail without further incident.

#### NARRATIVE

On Friday, July 12th, 2024 at 2122 hours, I was stationary at the 2400 block of 45th Street when I observed a silver Toyota sedan bearing Florida tag# 27AQMH failing to yield to the crosswalk and stop prior to the limit line while exiting from the MLK Plaza, which is located at 2416 45th Street. I activated my emergency lights and conducted a traffic stop on the vehicle at the 4500 block of 27th Avenue.

Upon my approach of the vehicle, I made contact with the driver, who was identified as Coleerriya Rodgers, and the front passenger, identified as Dexture Jackson. While I returned back to my vehicle to conduct a query of Rodgers's driving history, K9 Deputy Le responded to the scene and advised he detected the odor of marijuana emitting from within the vehicle. Loose leaf marijuana residue was then observed all over Jackson's t-shirt and the seat he was sitting on. Jackson stated that it was only grass and not marijuana. Both subjects stated they did not possess a valid medical marijuana card.

Due to the previously mentioned, a search of the vehicle was conducted. Throughout the search of the vehicle, I located a blue Nautica bag underneath the front passenger which contained a loaded black Taurus .22 caliber handgun, and two sealed baggies containing a green leafy substance. Through previous training and experience, I was able to identify the green leafy substance as marijuana. I also located \$168 dollars in cash split into different denominations. Due to previous training and experience, I know that individuals involved in drug sales are known to carry bills of different denominations for the easier exchange of narcotics and cash. The small single baggies of marijuana were also packaged in a manner that is consistent with drug sales. It is also known to me that individuals involved in the sale of narcotics are known to possess firearms.

Due to the above-mentioned, I placed Jackson in handcuffs and in the back of my marked patrol vehicle. I advised Jackson of his Miranda warnings, which he acknowledged and continued to speak with me. Post Miranda, Jackson denied having the intent to sell the marijuana and stated it was not his. Jackson stated he did not know the bag was underneath the seat.

It should be noted that there were no wrapping papers for the marijuana that indicated any signs of personal use.

Due to the above-mentioned, I criminally charged Jackson with the following charges:

893.13.1a With Intent to Sell, Manufacture, Distribute deliver schedule I or II controlled substance.

The two baggies of marijuana were weighed to be 24.2 grams.

The green leafy substance was then tested using my agency issued field test kits which positively resulted for the presence of marijuana.

Jackson was transported to the Indian River County Jail without further incident

While on scene, I separated both Brandon and Salamasina to get each individual's statement. Deputy M. Hatton arrived on scene to assist in the investigation, therefore Deputy Hatton questioned Brandon separately while I questioned Salamasina.

Salamasina was crying and distraught and stated that the injuries that Brandon succumbed was a direct result from her actions during an argument. Salamasina stated that they both had been drinking alcohol and ended up getting into an argument over the kids while they were in their bedroom. Salamasina advised that during the argument she grabbed his arm firmly, which caused the bruising and torn skin on Brandon's arm.

Deputy Hatton informed me on Brandon's statement and advised that Brandon stated that Salamasina would not leave him alone and he tried to separate himself from the confrontation but was unable to because of Salamasina getting aggressive and physical. Brandon also advised that he had been drinking alcohol and this physical dispute occurred in their back bedroom.

Salamasina and Brandon Material Content of Aleia J. Straub who is a 3-year-old female and Malcolm T. Straub who is a 5-month-old male. Salamasina stated that their children were inside the residence while the dispute occurred, but they did not witness it.

From the investigation conducted, I found probable cause for Battery/Domestic violence. Brandon showed recent injuries on his arm and Salamasina admitted to causing the injuries.

#### NARRATIVE

On Saturday, July 13th, 2024, at 1909 hours I was stationary at the 4000 block of 45th Street when I observed a gray Land Rover bearing Florida tag# 17DHJD run the stop sign while exiting 41st Avenue onto 45<sup>th</sup> Street. I turned around and activated my emergency lights, conducting a traffic stop on the vehicle at the 4600 block of 40th Avenue. It should be noted that the lights of my vehicle were activated at the 4500 block of 40th Avenue and the driver did not stop until making a right turn onto 46 Street and 40th Avenue.

Upon approach of the vehicle, I made contact with the driver and sole occupant, identified as Melissa Miller. Throughout my interaction with Miller, she began to display several signs of nervous behavior such as shaking her hands and demeanor. Due to the previously mentioned, I requested Miller to step out of the vehicle. I then asked Miller if she would consent to a search of her person and vehicle, which she granted.

While interacting with Miller, Deputy Crawford advised me he located a clear plastic container which contained a clear plastic straw with a white powdery residue within. Deputy Crawford further advised there was more white powdery residue within the plastic container. Due to previous training and experience, I identified the clear plastic straw as an instrument to consume narcotics. Due to the previously mentioned, Miller was placed in handcuffs.

Miller then openly stated she had four Xanax pills inside her bra. Miller stated she did not have a prescription for the Xanax.

Vero PD Officer Hogue responded to the scene and retrieved the four Xanax pills from within Millers' bra.

Deputy Consalo then advised he located a blue pill that was cut in half inside Millers' purse. The Xanax pills were consistent with the blue pill found inside Millers' purse. I conducted a query through drugs.com, where I was able to identify the blue pills as Xanax. Xanax is a Schedule 4 controlled substance according to the Controlled Substance Act and is only able to be obtained through a prescription.

I proceeded to advise Miller of her Miranda warnings, in which she acknowledged and continued to speak with me. Post Miranda, Miller stated she has been using the plastic straw to snort suboxone for the past two weeks. Miller stated she uses Xanax to treat her addiction to kratom and receives it through her friend's prescription.

Due to the above-mentioned, I criminally charged Miller with the following charges:

F.S.S 893.13(6)A Possession of a Controlled Substance without prescription

F.S.S 893.147.1b Drug Paraphernalia

Miller was transported to the Indian River County Jail without further incident.

#### NARRATIVE

On 07/15/2024, at approximately 0057 hours, while at the intersection of Oslo Road and 20<sup>th</sup> Avenue Southwest, I<sup>\*</sup> observed a white Ford Ranger bearing Florida tag (CE41KV), traveling northbound.

When the vehicle passed my location, I observed Joseph Acquaviva, sitting in the driver's seat wearing a red shirt. I confirmed that the driver was Joseph, by illuminating the cab of the vehicle with my patrol vehicle's spot light. It should be noted, that I have had numerous previous contacts with Joseph, in a law enforcement capacity and knew that his Florida license has been suspended since 11/18/1981. The most recent contact I had with Joseph, was on 06/29/2024, due to a traffic stop I attempted on the above mention vehicle with Joseph being the driver and he failed to stop for law enforcement with continuous lights and sirens. In reference to the incident, it is currently pending warrant approval from the State Attorney's Office, please see Indian River County Sheriff Office report (2024-70450).

I conducted a traffic stop on the vehicle along the 800 block of 20<sup>th</sup> Avenue.

Upon making contact with Joseph, he immediately stated that he currently did not have a valid Florida license. I was advised on scene by 911 dispatch, that they confirmed Joseph's license was still suspended.

Post Miranda Warnings, Joseph admitted that he should not be operating a motor vehicle, due to not having a valid license.

Joseph was transported to the Indian River County Jail for processing.

Corporal Hatton answered the phone once and identified himself as law enforcement. Holloman was irate shouting profanities and threatening him to put Megan on the phone. I asked Megan if she could identify who the male on the cell phone was and she confirmed that it was Holloman and he was utilizing the 772-501-7864 cell phone number. I answered Megan's cell phone when Holloman called again and I identified myself as law enforcement. Holloman continued to be aggressive shouting profanities and was warned to stop calling. After being warned he continued to be verbally aggressive and would not stop calling and texting Holloman.

Megan stated that Holloman destroyed a chicken cage that was behind her residence during this incident however she declined to pursue any criminal mischief charges because Holloman purchased the items for her. Megan stated that she was in fear for her life and believes that Holloman would harm her. Megan advised that the threats were made because she told Holloman that she did not want to meet with him tonight due to having her children and that he has a history of becoming violent with her.

Holloman on July 14<sup>th</sup>, 2024 between 09:24PM and 11:41PM, sent text messages to Megan threatening to kill her, her mother, and to drive by and shoot up her residence. Holloman sent several messages stating that she would be dead. Holloman sent all of these messages from the phone number 772-501-7864. This phone number was identified as Holloman's by the victim. Holloman was also voice identified during this investigation when he called her cell phone numerous times during the investigation by Megan. A records check also verified that this phone number is listed as Holloman's contact number from previous investigations.

I issued a BOLO for Holloman. Holloman was located and taken into custody by Deputy Barrientos at 2416 45<sup>th</sup> Street. Deputy Barrientos provided the following statement:

"On Sunday, July 14th, 2024 at 2347 hours, I responded to the MLK Plaza, which is located at 2416 45th Street in reference to a domestic disturbance. #### NARRATIVE

On July 14th, 2024, at approximately 2213 hours, I responded to 1999 9th Street SW, Vero Beach, Florida, BP Gas Station, in reference to a disturbance.

Upon my arrival, I observed an adult female standing at the west entrance of the property on 20th Avenue, screaming at the top of her lungs. It should be noted that this was occurring at a business that was open to the public. There were also patrons present in the parking lot and her behavior was causing a disturbance to the public. I then made contact with the female who identified herself as Kristin Phillips. Kristin was attempting to articulate what occurred but was hyperventilating and was not able to clearly articulate what occurred. It was my observation that Kristin was intoxicated because she was sweating and I smelled the odor of alcohol coming off of her person.

I then went inside of the business to speak with the other parties involved. I then made contact with the store clerk, a black female who identified herself as Unique Reio. Unique advised that a white female with a hat came into the store and began to harass the customers. She stated that she would ask the customers questions like, "what are you doing here?". She also described her as being belligerent. Unique then stated that the female got into her face. She stated that she then advised the female that she was refusing to serve her and that she needed to leave the business. The female then walked outside.

I then made contact with an adult female who identified herself as Amanda Cadwallader. Amanda advised that the female began to call her a "fat bitch". Amanda then stated that she believed that the female struck her in the face while motioning is though she struck her with her hand. Amanda then advised that after that occurred, she struck the woman back so that she can get away from her.

I then observed video. I observed that at 2207 hours, the female who identified herself as Kristin Phillips and matched her description was walking around in the store. She then began speaking to a male and female who were standing by the cash register. Amanda then walked up to Kristin and began to talk to her. I then observed Kristin headbutt Amanda in the head. Amanda then struck Kristin in the face with her right hand. It should be noted that this video did not have audio attached to it.

I was then showed me a video of Kristin and Amanda of the events following the physical altercation. I heard Kristin state that she pushed her head into Amanda's head because she was in her face. Kristin after Amanda walked away, Kristin followed her around the store, yelling expletives at her.

Amanda advised that she wished to pursue charges for Battery.

Due to the surrounding circumstances, probable cause was established that Kristin Phillips was in violation of FSS 784.03 Simple Battery and FSS 856.011 Disorderly Intoxication. While attempting to detain Kristin in reference to her charges, she made her arms tense and was not immediately following lawful commands to place her hands behind her back. Probable cause was then established that Kristin Phillips was in violation of FSS 843.02 Resisting Arrest Without Violence.

A FCIC/NCIC inquiry of Kristin revealed that she had an active warrant out of Indian River County.

On July 14, 2024 at approximately 19:43 hours, I responded to service.

Upon my arrival, I spoke with the complainant Ralph Anthony Diprimio JR, who stated that **Constitution** Samantha Rae Anderson started to get physical with him as well as began throwing items throughout the residence and destroyed Ralph's property inside. Ralph showed me recent bruises and red markings on the right side of his neck, and stated that the injuries were from the dispute that occurred inside the residence. Ralph stated that Samantha caused the injuries. Ralph advised that Samantha choked him and punched him on the left side of his face under his chin. Ralph showed visible injuries and markings on his neck, but I was unable to see any markings or injuries on his chin. Ralph refused medical treatment.

While on scene, I separated both Ralph and Samantha to get each individual's statement. Sergeant D. Hoilett arrived on scene to assist in the investigation, therefore Sergeant Hoilett stayed with Ralph at the end of the driveway, while I questioned Samantha.

Samantha was crying and distraught and stated that the injuries that Brandon succumbed was a direct result from her actions during "rough sex" in the bedroom. Samantha stated that the items which were broken in the bedroom were also from them having sex and knocking things out of place.

Sergeant Hoilett informed me that Ralph stated he had no sexual interaction with Samantha at all. Ralph stated that Samantha grabbed his neck with both hands and began to choke him, and advised while this was happening, he could not breathe at the time. Ralph advised that Samantha would not leave him alone and he tried to separate himself from the confrontation but was unable to because of Samantha getting aggressive and physical.

While inside the residence, Ralph advised that Samantha grabbed his lamp from the nightstand and began smashing it multiple times. Ralph advised throughout this altercation; Samantha kicked his bedroom door shut which resulted in the door cracking and becoming inoperable. Ralph also informed me that Samantha had a large mouth full of water and spit it all over his person while inside the bedroom. Ralph showed me a half empty water bottle inside the bedroom and advised that it was the one Samantha used to throw water on him. Ralph showed me wet bedroom sheets that were in his hamper from the incident.

From the investigation conducted, I found probable cause for Battery/Domestic violence. Ralph showed recent injuries on his neck and Samantha admitted to causing the injuries.

Samantha was placed into custody, and while she was in handcuffs she began to tense up and try and pull away. Samantha was informed to stop resisting but became difficult while walking to my agency patrol vehicle.

#### NARRATIVE

On Sunday, July 14, 2024, at approximately 1540 hours, I responded to in reference to a disturbance in progress.

A complainant called in on stating they were fighting with someone and a knife was involved.

Upon arrival, contact was made with juvenile female, Arianna Solomon. Arianna advised Emili De Rosa, pulled a knife on her and threatened to stab her. I was advised the argument started after her mother located a knife in the garbage after the sisters were cleaning. Arianna stated her mother pulled the knife from the garbage and said, "I should stab you". Arianna stated her mother had the knife pointed at her and her sister, Alyssia Solomon, while in close proximity to them. Arianna stated she grabbed her mother's wrist, which caused her to drop the knife. Once the knife was dropped. a physical altercation took place with Arianna and her mother, Emili. Arianna did not remember how she struck her mother, but remembers that she did out of fear for her and her sister's safety.

Contact was then made with the mother, Emili, who was not initially cooperative with law enforcement. Emili stated she did not need us, and that she was just discipling her disrespectful kids. I advised Emili that we were called for a disturbance and needed to check on everyone. Emili stated her and her daughter, Arianna were involved in a verbal argument, when Arianna kicked her in her stomach. Emili advised me she is 8 weeks pregnant, and that none of her kids know she is pregnant.

While talking with Emili, she realized she was bleeding from her vagina. EMS was called to the scene and she was transported to Cleveland Clinic Indian River Hospital as a precaution, due to her pregnancy.

Contact was made with juvenile Audrina Solomon, who stated she witnessed holding a knife at Arianna, and threatening harm. Audrina stated the argument started after her sister, Arianna was cleaning, and threw away belongings. Audrina said Arianna grabbed her mom's wrist in attempt to keep the knife away from her. Audrina stated a physical altercation occurred, and Arianna ran to her room. Arianna stated her mother then grabbed a frying pan and began beating on Arianna's door. Audrina stated this is

Also on scene was Rickie Solomon, who is the but wanted no part of the investigation, and did not want law enforcement inside the home. Due to this, only Arianna and Audrina (the oldest sisters) were interviewed.

I responded to Cleveland Clinic Indian River Hospital, and mirandized Emily De Rosa.

De Rosa stated, she never had a knife and her kids set her up. De Rosa stated her kids are disrespectful.

Once released from the hospital, Emili was arrested and transported to the Indian River County Jail for Aggravated Assault with a Deadly Weapon.

#### NARRATIVE

On Saturday, July 13th, 2024 at 0003 hours, I was traveling Westbound on 45th Street when I observed a black Jeep SUV bearing Florida tag# BY25ER driving at a high rate of speed, failing to maintain its lane. I turned around and activated my emergency lights, conducting a traffic stop at the 3800 block of 45th Street.

Upon approach of the vehicle, I made contact with the driver and sole occupant, identified as Randolph Beasley. Beasley stated he was attempting to grab his cigarettes while driving, which caused him to fail to maintain his lane. Throughout my interaction with Beasley, I asked him to step out of the vehicle. I then asked Beasley if he would consent to a search of his person and his vehicle, which he granted.

I then located a clear glass pipe with burnt residue in the pocket of Beasleys jacket. Due to previous training and experience, I identified the pipe as an instrument to consume narcotics. Upon locating the aforementioned pipe, Beasley openly identified the pipe as his stem, which is a common phrase used to identify the glass pipe as an instrument to consume narcotics. I proceeded to place Beasley in handcuffs and advised him of his Miranda warnings, which he acknowledged, declining to speak with me any further.

Throughout the search of the vehicle, Beasley openly stated he smokes crack because it is the best drug in the world while interacting with Deputy Crawford.

Due to the above-mentioned, I criminally charged Beasley with the following charges:

Beasley was transported to the Indian River County Jail without further incident.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

Committed the offense of DUI in that the Defendant was:

- Driving or in actual physical control of a motor vehicle upon a public road/ highway within this state;
- Under the influence of alcoholic beverages;
- Affected to the extent that the person's normal faculties were Impaired.

On 07/12/24 I, Ofcr. S. Gonzalez (471) was stationary at the Riomar Drive beach access entrance over-looking the stop sign the intersection at southbound Ocean Drive and Riomar Drive.

At approximately 2139 hrs., I observed the Defendant's vehicle approach the stop sign and go past the stop sign and stop bar without stopping.

As the Defendant went by me, I pulled out onto the road and pulled up behind him. I then initiated a traffic stop by activating the emergency lights on my fully marked police vehicle, however, the Defendant continued south on Ocean Drive approximately 100 yrds. turning right onto Sandfly Lane and coming to a stop.

I exited my vehicle and approached the Defendant's vehicle on the driver side and made observed that there were a total of three occupants in the vehicle. Upon arriving at the driver door, I made contact with the Defendant and could immediately detect the odor of alcoholic beverage emanating from from within the vehicle.

I asked the Defendant for his drivers license and vehicle registration which he provided. I then confirmed with the Defendant that the information on the license and vehicle registration were current and correct.

I then asked the Defendant if he knew why he had been stopped. The Defendant acknowledged having failed to stop at the stop sign and further informed me that he had recently received a warning for the same offense in his neighborhood.

I then asked the Defendant as to his whereabouts prior to the stop. The Defendant informed me that he had been at Waldo's for dinner. When asked if he'd been drinking stating that he and his passengers had all been drinking.

During my contact with the Defendant, I noted that his eyes were red and glassy as well as the moderate odor of an alcoholic beverage emanating from the Defendant's breath as he spoke.

I then retreated to my vehicle to conduct a license and registration check after which I returned to the Defendant's vehicle and made contact with him once again and, having a reasonable suspicion that the Defendant might be impaired, I asked him to exit his vehicle which he did freely.

Once out of the vehicle, based on I informed the Defendant that I wanted to check him for impairment.

I asked the Defendant how much he'd had to drink. The Defendant stated that he had consumed three (3) 12 ounce beers with the last one having been consumed just prior to him leaving the restraint.

I asked the Defendant if he was taking and prescription or other medication to which the Defendant stated that he was not. I then asked the Defendant if he had any injuries, illnesses or disabilities to which the Defendant again said he did not.

I then administered Field Sobriety Exercises (FSE's)

The area was well lit and the ground was level and free of debris. An approximately 12 ft. length of masking tape was used for the walk and turn.

HGN (Horizontal Gaze Nystagmus)

The instructions were explained to the Defendant who stated that he understood them.

- Noticeable sway;
- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes).

ONE LEG STAND (OLS) The instructions were explained to the Defendant who stated that he understood them.

- Noticeable sway;
- Right leg up;
- Failed to look at foot during exercise as instructed.

WALK AND TURN (WAT) The instructions were explained to the Defendant who stated that he understood them.

Noticeable sway during instruction phase;

Based on the foregoing, I placed the Defendant under arrest for DUI and informed him accordingly. The Defendant was searched prior to being placed in the back of my vehicle. The money located in his front left pocket was turned over to the Defendant's wife. A receipt for the Grind and Grape was located his right front pocket for \$42.00.

The Defendant was transported to the Indian River County Jail for the administration of a breath test and booking. While en route to the jail the Defendant moved towards his left and positioned himself behind me where I could not see him. When I asked the Defendant to move back, he slide to the middle and sat sideways. When I asked him to move back to where he was and sit straight, he refused. Concerned he might hurt himself against the partition, I stopped at the intersection of westbound Barber Bridge and Indian River Boulevard, exited and opened the backdoor to get the Defendant to move back over and sit straight to which the Defendant eventually complied.

I the requested that the Defendant submit to a test of his breath for the purpose of determining the alcoholic content of his breath. The Defendant refuse but after being read implied consent, the Defendant agreed to a test of his breath and provided a first sample of .072. While providing the second sample, the Defendant stopped and started his as he blew into the mouth piece providing an insufficient sample and stated that he might have COVID before finally providing a sufficient sample of .070.

The Defendant was then turned over to corrections personnel for processing and booking.

The foregoing occurred within the City of Vero Beach, Indian River County, Florida.

The stop and breath test were recoded with the use of my body-worn camera which was uploaded to a secure server.

The Defendant was issued UTC no.: AJH0H4E for the stop sign violation and UTC no.: AJH0H5E for DUI.

- Driving or in actual physical control of a motor vehicle upon a public road/ highway within this state;
- Under the influence of alcoholic beverages;
- Affected to the extent that the person's normal faculties were impaired; and
- Determined to have a breath-alcohol level of 0.08 or more grams of alcohol per 210 liters of breath To wit the Defendant provided samples of .240 & .250, respectively

On 07/13/24 I, Ofcr. S. Gonzalez (471), responded to the 900 block of eastbound 20th Street a/k/a/ S.R. 60, which is a one way eastbound traffic only roadway, at the request of Ofcr. H. Hogue (468).

Upon arrival, Ofcr. Hogue informed me that she was eastbound on 20th street in the curb lane when she observed the Defendant's vehicle traveling westbound on said road.

Ofcr. Hogue then informed me that upon stopping and making contact with the driver whom she identified by his Virginia drivers license as JOHN DOUGLAS COCHRAN ("Defendant").

In addition, Ofcr. Hogue stated that she observed that his eyes were red, glassy and sleepy in appearance and that she could detect the odor of an alcoholic beverage emanating from the driver.

I then made contact with the Defendant whom I observed to be seated in the driver's seat behind the steering wheel. The vehicle was running and in park.

Upon making contact with the Defendant, I could detect the odor of an alcoholic beverage emanating from within the vehicle.

I observed that the Defendant's eyes were red and glassy and had a sleepy appearance.

I asked the Defendant to exit the vehicle so that I may speak with him and he agreed and exited his vehicle freely and willingly.

Once out of the vehicle the Defendant kept putting his hands in his pockets so I asked him if had anything in his pockets I should worry about like a pocket knife to which he stated "Nah, nothing weaponized". I then asked the Defendant to step over on to the sidewalk so we could talk.

Once on the sidewalk, I asked the Defendant where he'd been coming from "home phone" when I asked him again, the Defendant repeated "home phone C2968 that's where my parents are".

I an attempt to clarify where the was coming from, I asked the Defendant again and he then explained that he was taking his friend "Emily" home. The passenger was identified as Emily M. Collina Magana.

Ultimately, the Defendant stated that he'd been at the Boiler which is a bar located on the beach at 3400 Ocean Drive in the City of Vero Beach, Florida. The Defendant stated that he'd been "hanging out" with some friends.

When I asked the Defendant if he'd had any cocktails, he stated that he'd "had a couple" and then stated that he'd had two (2) or three (3).

I then asked the Defendant if he was taking any prescription medication, he stated that he was not.

I asked the Defendant if he had injuries, illnesses and/or disabilities to which the Defendant stated that he did not but had a **second state of the Defendant stated that he did not have trouble walking or standing** and did not require the use of a cane or crutches and walked unassisted.

During this time, I noted that the Defendant's speech was at times slurred and confused, with improper word usage. Also, I noted that the Defendant's balance seemed poor and his displayed some sway when he stood.

I then informed the Defendant that based on Ofcr. Hogue's observations as well as my own, I had a serious concern and suspicion that he was impaired would be asking him to perform Field Sobriety Exercises ("FSE's") in order to give him an opportunity to dispel that concern.

Before beginning the FSE's I asked the Defendant if he had any problems with his eyes to which he replied "not knowingly".

I then administered Field Sobriety Exercises ("FSE's")

The area was well lit and the ground was level and free of debris. An approximately 12 ft. length of masking tape was used for the walk and turn.
