**NARRATIVE**

On Wednesday, April 1<sup>st</sup>, 2026, at approximately 1005 hours, I responded to Wawa, 4495 US Highway 1, Vero Beach, FL, for a shoplifting call. (Statements are paraphrased)

Upon arrival, I spoke to the manager, named Anthony Warusso. I gathered from Anthony that a white male with a long sleeve button down shirt, a hat, shorts, and a backpack entered the store at 0950 hours. At about 0955, he grabs at least one bottle of Sutter Home wine and soon after conceals himself in the bathroom of the store. That bottle of wine is valued at \$12.49. At about 0958 hours, he exits the store through the back door. Anthony believed the stolen wine was concealed inside his backpack. At the point the suspect left, he disregarded all points of sale and made no effort to pay. Anthony showed me the respective surveillance footage and I was able to get a good photograph of the suspect.

Corporal Martin was in the area searching for the suspect and located him near the 3200 block of 45<sup>th</sup> Street. Prior to my arrival, Corporal Martin conducted a post Miranda interview. In their interview, the suspect, who was later identified as David Parker, confessed to Corporal Martin that he stole the missing wine. I arrived and asked David why he stole the wine and he said because he is homeless and planned on selling it.

Searching his backpack incident to arrest and for the wine he told Corporal Martin was in the backpack, Corporal Martin located an additional bottle of wine. That bottle of wine was also a Sutter Home brand. He also had in his possession a fountain drink from Wawa which costs \$2.49.

Upon running a criminal history on David, it showed he has two prior convictions for theft. The first, he was adjudicated guilty on 1/26/2010 for Misdemeanor Retail Theft in Horry County, SC, and the next he was adjudicated guilty on 1/26/2018 for Grand Theft in Duval County, FL.

Also, while running David on IRCSO Pubic Safety Dispatch, they informed me he had an active warrant out of Indian River County for Violation of Felony Probation (Docket #212025CF000700AXXXVB)

David was transported to the Indian River County Jail and charged with FSS 812.014 Felony Petit Theft and FSS 848.06 Violation of Felony Probation.

**NARRATIVE**

On Wednesday, April 1<sup>st</sup>, 2026, at approximately 1703 hours, I was dispatched to the area of 12<sup>th</sup> Street and 58<sup>th</sup> Avenue, in reference to a disturbance call for service. Upon arrival to the area of college lane and 58<sup>th</sup> Avenue, I observed a blue Mitsubishi SUV (FL/ tag FVFG07) and a black Chevy Traverse (FI/ PLC2V) following each other north bound. The black Chevy Traverse was following closely behind the blue Mitsubishi. I observed the black Chevy Traverse to have a damaged to the windshield. Both vehicles I observed matched the description given by IRCSO public safety dispatch.

I activated my lights and sirens in attempts to stop both vehicles, both vehicles yielded to my lights and sirens in the south parking lot of 5755 20<sup>th</sup> Street.

I made contact with the occupants of the blue Mitsubishi who were identified by Florida drivers license as Aaron Thomas, a white male born April 1<sup>st</sup>, 1995 (front passenger) and Ava Jones, a white female born May 17<sup>th</sup>, 2001 (driver). Aaron was very heightened and yelling. Aaron and Ava advised they were in a disturbance and a male punched Aaron in the face but were not able to recall the location of where it occurred. Aaron further advised he was threatened with a gun. When asked how he was threatened, he advised the male passenger in the black Chevy traverse pulled up his shirt displaying a black firearm.

The occupants of the black Chevy traverse were identified as Savannah Martinez (driver) and Curtis Headdy (front seat passenger). Martinez and Headdy advised the following in substance; they were traveling behind a lifted gray pickup truck and observed a white male throw a drink from the passenger seat of the blue Mitsubishi into gray pickup truck. The Mitsubishi then fled northbound after throwing the drink. Martinez then attempted to follow the blue Mitsubishi in attempts to get the tag number. They caught up to the vehicle at a red light. While behind the vehicle at the red light, a white male exited the passenger seat who was identified as Aaron and approached Headdy. Headdy advised he gave the verbal commands to Aaron to not approach him but he continued. Headdy punched the male one in the face in attempts to protect his significant other and his family. Headdy and his significant other were able to get away from the suspect and met up with the driver of the gray pickup truck, who was identified as Krystal Campbell. Martinez advised while speaking with Campbell she observed a white male hanging out the passenger window with red hair of the same blue Mitsubishi SUV. She further advised she saw the male throw a candle into her vehicle through the driver side window. The candle landed up on her dash board cracking the front windshield and also damaging the top of the dashboard.

I questioned Headdy in regards to the firearm and he advised the firearm was secured on the front glove compartment. Headdy advised when Aaron approached his vehicle containing his family, he gave him a verbal command that he was armed and to stop approaching. Headdy advised he never possessed the firearm and it stayed in the glove compartment the entire time. He and Martinez gave consent for me to retrieve the firearm for officer safety purposes. While retrieving the firearm I observed it to be pink in color and a Ruger 380 caliber and not match the description Aaron provided.

Based on Aaron alleging that Headdy committed a crime and Headdy advising Aaron committed crime, I advised both of their Miranda Warnings to which they all verbally stated they understood.

received a call from Krystal Campbell who advised she was the other victim involved in this call. Krystal responded to the scene and I observed her Gray Ford F150 (FL/ R4GQH) pickup truck to have an unknown liquid spread throughout the interior of the vehicle. Krystal further advised while on the side of the road collecting the suspect vehicle information from Martinez and Headdy, she was standing on the passenger side of the Chevy traverse. She advised unknown objective flew into Martinez's vehicle, cracking the windshield. Seconds after she saw the blue Mitsubishi and the white male hanging out the passenger side of the vehicle.


