NARRATIVE

On Wednesday, December 10, 2025 at approximately 2117 hours, I conducted a traffic enforcement stop in the 1500 block of US Highway 1 in Sebastian, Florida.

I observed a white Ford F150 (FL/2WRY) fail to stop before the stop bar at Indian River Drive and Main Street and again at the traffic light at Main Street and US Highway 1. As I got behind the vehicle it signaled to make a U-turn and made an abrupt turn into the parking lot of a closed business.

I made contact with the driver and sole occupant of the vehicle, Mr. terry Peek, who I identified by the Florida driver's license he presented me. While speaking with Terry, I could smell the distinct odor of alcohol emitting from his breath. Terry had a delayed response when I requested his license and information. His movements were slow and unsure. Terry speech was slurred and his eyes were watery and glassy.

I asked Terry to exit his vehicle and when he did, he exited slowly and stumbled as he walked towards my patrol car. Terry stated he was coming from "Tiki" where he consumed three (3) alcoholic beverages. While speaking with terry, I continued to smell the distinct odor of an alcoholic beverage emitting from his breath. Based on all the above observations, I requested Terry complete Standard Field Sobriety Exercises (SFSE's) to determine his ability to safely operate a motor vehicle to which Terry agreed.

I began by questioning Terry about his medical history. Terry regularly sees his doctor and his last visit was approximately 3 weeks ago. Terry is Diagnosed with [REDACTED] which he stated he took today. Terry stated he has had no major surgeries or other medical conditions which would limit his ability to complete the SFSE's.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise: I explained the exercise to Terry who stated he understood the instructions. Terry did not have Resting Nystagmus and I observed Terry's pupils were of approximate equal size and tracked simultaneously. I observed Lack of Smooth Pursuit, Distinct and sustained Nystagmus at Maximum Deviation, and an Angle of Onset of approximately thirty-five (35) degrees. Terry did not have Vertical Gaze Nystagmus (VGN). Terry had to be reminded to not move his head and had difficulty tracking my stimulus.

I then administered the Walk and Turn (WAT) exercise. I explained and demonstrated the exercise to Terry who stated he understood the instructions and did not have any questions. Terry had difficulty maintaining the starting position as instructed and began before being instructed to do so. Terry removed his shoes and made multiple attempts to begin this exercise. Terry raised his arms for balance, stopped walking to steady, made an improper turn and completed an improper number of steps. Terry did not complete this exercise to standard and stopped several times to "prepare and stretch" for this exercise. During this exercise, terry made a comment and stated "I couldn't do this if I was sober!"

I then administered the One Leg Stand (OLS) exercise. I explained and demonstrated the exercise for Terry who

stated he understood the instructions and did not have any questions. Terry asked me to repeat the instructions. Terry again made several attempts before attempting this exercise. Terry counted to approximately eight (8) seconds in the thirty (30) second time period. Terry had an approximately 1 inch orbital sway, out his foot down and used his arms to balance during this exercise. Terry had to be reminded to look at his foot and count aloud. Terry did not complete this exercise to standard.

I then administered the Modified Romberg Balance (MRB) exercise. I explained the instructions and demonstrated the exercise to Terry who stated he understood the instructions. Terry closed his eyes and tilted his head back counting to twenty-three (23) in the allotted thirty (30) seconds.

Based on the above indicators of impairment, Terry was placed under arrest for Driving Under the Influence.

During a probable cause search of his vehicle, Deputy D. Olson (6315) located several bottles of alcohol, including two (2) bottles of Bacardi rum.

I advised Terry of his rights in accordance with Miranda v. Arizona which he stated he understood and agreed to speak with me. Terry stated he consumed three rum drinks while at "Tiki." He stated he felt safe to drive and was driving to his girlfriend's house before he was stopped. On a scale from 0-10, Terry stated he felt his impairment level was a "1." Terry's attitude was carefree and goofy during this investigation, often laughing and making jokes.

Terry was transported to the Indian River County Jail Complex where he provided the following samples of his breath: 0.182 g/210L and 0.178 g/210L.

Terry was ultimately charged with Driving under the influence with a BrAC above 0.15% and held on a total bond of \$1,000.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On 12/11/2025 , at 00:54 (Specifically include facts constituting cause for arrest.)

On December 10, 2025, at approximately 1946 hours, I responded to 1201 Main Street, in reference to a Police Service.

Upon arrival, I made contact with the complainant/victim, Jamie N. Nero, who stated that her husband, Edmond V. Nero, started yelling at her about [REDACTED] chores not being completed. Jamie stated that as she was walking away from the altercation through the garage, Edmond grabbed her from behind by her shirt, which caused her to fall in a supine position on the driveway. Jamie stated that when she fell on the concrete driveway, Edmond then dragged her across the driveway and back into the garage. Jamie stated that she threw an item at Edmond, and Edmond threw an item back at her, hitting her left earlobe. Jamie stated that the residence cameras did not capture the incident, but the cameras were able to record the audio of the incident. Jamie stated that Edmond is the only person to have access to the residence's cameras. Jamie stated that she had screen-recorded the audio of the incident, and when she proceeded to show me the video, she discovered that Edmond had erased the original copy of the footage via the Ring app on her phone. When Jamie was asked about her husband's whereabouts, she stated that the ring camera informed her that his truck was back in the driveway.

Corporal McElvy discovered scratches on Jamie's back that appeared to be caused by three fingernails, which were approximately 2-2 inches in length. Each scratch started consistent with finger lengths from the rear, as they were deeper in the top and lighter as they went down Jamie's back. Corporal McElvy then took photographs of the injuries. Corporal McElvy also discovered marks consistent with falling to her left knee during the altercation. Jamie had white concrete residue on her black leggings in the left knee area, and Jamie had consistent redness and bruising on the same left knee under the leggings.

Upon arrival at [REDACTED] I made contact with Edmond, who stated that the altercation that occurred between him and Jamie was only verbal. Officer Keiser read Edmond his Miranda rights, and Edmond proceeded to invoke his privilege to remain silent. Edmond was placed in mechanical restraints, which were double-locked and checked for proper fit. Edmond was arrested and placed in my patrol to be transported to the Indian River County Jail.

Coprol McElvy questioned Edmond's Mother, who stated that Edmond is the only person with access to the cameras.

Jamie was issued and signed for a copy of the DV legal rights and remedies packet.

A copy of the DV packet and arrest affidavit was submitted with this report.

As this incident may have occurred in the presence of a minor, a DCF referral was made online as required by law.





All Vape's had imprinted on the package the marijuana leaf and some contained the California warning.


I then read Donovan his Miranda Warnings which he verbally stated he understood. He then wished to invoke them.

Based on the facts above Donovan was placed under arrest and issued a citation for Possession of a Controlled Substance (#AM2N6UE).




On Thursday, December 12th, 2025 at 2340 hours, I conducted a traffic stop on a White Toyota as it failed to come to a complete stop leaving the BP gas station located at 1999 9th Street SW, Vero Beach, Indian River County, Florida.

While in the area of the above-mentioned BP gas station, I observed a vehicle leaving the parking lot. The vehicle left the parking lot, failing to come to a stop prior to entering the roadway, disobeying the marked stop sign present.

I conducted a traffic stop and the vehicle came to a stop near 10th Court SW and 9th Street SW. During the traffic stop, I made contact with the driver, Ms. Rachel Torresson. While speaking to her I could smell the odor of burnt marijuana emitting from the vehicle. Additionally, I observed what appeared to be bits and pieces of loose-leaf marijuana near the shifter, commonly referred to as "Marijuana Shake".

Once another unit arrived, I made contact with Ms. Torresson. I asked her when the last time she had smoked marijuana in the vehicle. Ms. Torresson advised she recently smoked marijuana approximately one hour earlier.

During a search of her person, Ms. Torresson had a small blue metal container, that I know is commonly used to house narcotics. Within the container was 2.5 Amphetamine and Dextroamphetamine 20mg pills, and 5 Clonazepam 0.5mg pills. While being placed in to handcuff restraints, Ms. Torresson stated the names of the narcotics and advised that she had a prescription for them.

During a search of the vehicle, I located 11 Tramadol pills located in the center area of the vehicle, near the shifter.

All narcotics were verified by Drugs.com.

I advised Ms. Torresson of her Miranda Rights. She advised she understood her rights and was willing to speak to me. Ms. Torresson advised that she has a prescription for Adderall (Amphetamine and Dextroamphetamine) and for the Clonazepam. She was not able to provide any proof of the prescription at the time and advised she normally carries the narcotics like this to avoid them being damaged by the sun or heat as she would leave them in the vehicle. Ms. Torresson advised the Tramadol pills were in her possession, as they used to be her fathers. She was moving them today in her vehicle and forgot they were in her vehicle.

Upon being informed that Ms. Torresson was going to be placed under arrest, she was provided an opportunity to turn over any other narcotics prior to going to the jail. Ms. Torresson advised she had more Clonazepam pills in her bra, that she was concealing. These pills were identified as the same pills from earlier.

All narcotics located today were either located in a metal container or a plastic bag. There were no prescription containers located within the vehicle.

Based on the above information, I believe there is probable cause to arrest Ms. Rachel Torresson for three counts of
