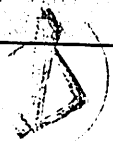

NARRATIVE

On April 17, 2024, at approximately 0028 hours, I responded to the area of 1225 16th Avenue SW in reference to a possible vehicle burglary. Prior to my arrival, HAWK arrived on scene and observed a white sedan in the area of 13th Street SW and 17th Avenue SW with a subject standing outside. HAWK continued to observe the vehicle drive north on 17th Avenue SW. As the vehicle approached 11th Street SW, the vehicle stopped and HAWKED observe the driver exit the front Driver's side and walk to the front passenger side. Prior to the vehicle stopping, HAWK observed the vehicle to have no rear tail lights on. The front passenger also exited the vehicle and entered the driver's seat. The vehicle then turned west on 11th Street SW where a traffic stop was conducted. The vehicle was identified as a white in color BMW sedan (FL Tag: AP94LN).

Contact was made with the driver, who was identified as Amanda Commisso and the passenger, who switched from the driver's seat as Kevin Rosa. There was no one else in the vehicle at this time. While Deputies spoke with Kevin and Amanda, I responded to 1225 16th Avenue SW and made contact with the original complainant.

Upon my arrival at 1225 16th Avenue SW, I spoke with Ical Reddie, who lives at 1216 16th Avenue SW. Ical advised he was sitting in front of his residence when he saw an unknown white male walk into the driveway of 1225 16th Avenue SW and look into and pull on the door handle of a vehicle. Ical said the male then walked away, and later returned to the same address and pulled on the door handle again. Ical said the male left the area again and walked south towards 13th Street SW where he got into a white vehicle.

Ical advised he would not be able to identify the subject if he saw him again.

I then walked into the driveway and observed a blue, Kia Sedan (FL Tag: CI5030) in the driveway. It should be noted that the vehicle was covered in dust and I did not observe any finger prints on the door handles. It did not appear that the vehicle had been entered. I attempted to make contact with the resident of 1225 16th Avenue with no results.

I then responded to the intersection of 11th Street SW and 17th Avenue SW where I made contact with Kevin Rosa. Kevin was checked through DAVID where I was notified that his Driver's License was cancelled indefinitely on 08/24/22.

Based on HAWKS observation OF Kevin in the Driver's seat, Kevin Rosa, did drive a motor vehicle upon a highway in the State of Florida during a time period when his/her driver's license had been cancelled, suspended, or revoked. I placed Kevin under arrest and transported him to the Indian River County Jail. He was issued a Florida Uniform Traffic Citation (AIHALAE) for

NARRATIVE

On April 17, 2024, at approximately 2208 hours, I responded to the [redacted] in reference to a disturbance.

Upon my arrival, I spoke with the complainant, Manager Jessica Monsalve, who stated she heard a verbal dispute that took place in apartment [redacted] where she knew Blaze Howe and Marielena Diles resided. Jessica provided me with a written statement that stated the following: "I was called to come to room [redacted] because guest was fighting its not the first time. When I walked up, she was pushing and pulling his shirt, she was yelling saying he hit her they both are drunk. She hit him with her right hand in the chest and face, he did push her. I told him she needed to go. The room is under his name. I called the cops as well. This goes on every other day."

I then made contact with Deputy M. Davis, who had a male detained in his patrol vehicle, who was identified as Blaze Auburn Howe. Blaze was read his Miranda Rights and advised he understood. Blaze was advising Law Enforcement that his girlfriend, Marielena T Diles had attacked him while he was walking back up to his apartment, stating he believes she was upset because he had been drinking. Blaze stated that Marielena is [redacted]. Blaze advised that Marielena had hit him in the face during the altercation. Using my flashlight to look at the area where he advised he had been hit, I was unable to see any visible injuries. Blaze denied medical attention.

I then spoke with Marielena who was standing on the balcony outside of their room. Marielena was read her Miranda Rights and advised she understood them. Marielena stated that Blaze entered the apartment, after having been outside drinking, and had a mood change. She stated they began arguing, and he began poking her in the forehead with his finger. She stated he then shoved her onto the bed, where he began striking her in the head. She stated he brandished a small taser from his pocket and began making threats to shock her, knowing that she was [redacted]. Marielena stated that Blaze had her pinned down on the bed and she was unable to escape. Marielena stated during the altercation, she had a friend in Massachusetts on the phone who was listening that attempted to record the incident. Deputy B. Nunley was able to listen to the audio footage, captured on body worn camera, in which he could hear the male subject aggressively confronting Marielena about taking his cigarettes. A female was also heard saying "stop hitting me". I examined Marielena's head using my flashlight, where I noticed an abrasion the left side of her forehead, as well as redness on the back left side of the head.

From the investigation and injuries found on Marielena, I found Blaze to be the primary aggressor.

Blaze was transferred to my patrol vehicle and advised he was under arrest for battery/Domestic Violence.

Blaze was transported to the Indian River County Jail without incident.

NARRATIVE

Upon arrival, I made contact with the offender, Jordyn Alicea-Velez, who advised the following: She has been involved in a romantic relationship with the victim, Shawn Carney, for at least a year before they broke up yesterday, April 15th. Although they have been romantically involved for the last 3 years. The last year of their relationship has been consistent with no break-ups and was sexual in nature. Shortly before deputies' arrival to the residence, she had been in a verbal altercation with Shawn. Jordyn proceeded to state that the verbal altercation turned physical when she shoved him backwards with both of her hands, palms facing towards Shawn.

After gathering Jordyn's statement, I spoke with Shawn who advised the following: Shawn had been in a consistent romantic relationship with Jordyn for the last three years and their relationship was sexual in nature. Today, while engaged in a verbal argument with Jordyn, she pushed him backwards. As Shawn fell backwards Jordyn attempted to grab Shawn by his shirt collar, incidentally hitting him in the jaw with her fists.

Both victim and suspect advised that they have been in a continuous relationship for the last 3 years which was sexual in nature.

Based on statements provided, Jordyn Alicea-Velez, was placed under arrest for battery (dating violence) when she actually and intentionally struck Shawn by shoving him down. Alicea-Velez was transported to Indian River County Jail.

NARRATIVE

On April 16th, 2024 at approximately 1731 hours, I responded to Burlington Coat Factory located at 5950 20th Street, Vero Beach, in reference to 2 males taking items from a retail store. Upon arrival, Deputies along with myself waited outside the store with loss prevention. Loss prevention advised he was watching two males, one wearing a gray shirt and one wearing a black shirt taking items off the racks, removing the security control tags, and placing them into a suit case. Loss prevention stated that the male in the gray shirt was using a magnet to remove inventory control tags from the items. The first male wearing a gray shirt, later identified by his Florida ID card as Alonso Nelson (Defendant), walked out the front doors of the store. Deputies intercepted him in the parking lot. Alonso began to pull his arms away from deputies as they were attempting to place him into handcuffs. Alonso was instructed not to resist and was taken to the ground and placed into handcuffs. Upon searching Alonso, a small gray piece of metal with several magnets was found on his person. This device was used to defeat the electronic security control tags on the clothing items. The second male, wearing a black shirt, later identified by his Florida ID card as Adrian Rey Hernandez (Co-Defendant) exited the front door of the store with a large blue suitcase, passing all points of sale without attempting to pay for the suit case or items inside. Upon sight of uniformed Deputies outside the store Adrian immediately started running. Deputies gave several commands to stop or he would be tased. Corporal Robinson deployed two probes from his taser 10 achieving neuromuscular incapacitation. Adrian was immediately placed into handcuffs. A criminal history search was conducted on Adrian, which showed he is on felony probation for petit theft and resist officer without violence. Based on statements from the witness, video evidence, and evidence collected on scene Alonso is being charged with grand theft, possession of cocaine, resisting officer without violence, and violation of probation.
