On Wednesday September 24th, 2025 at approximately 0556 hours, Corporal R. Thomas and I responded to in reference to an unknown call.

As we approached the residence, Anthony Lamar Judon walked towards Corporal R. Thomas and me. He stated that he was stabbed by "Mario Clark", who is also known by his legal name, Tamorrio Lildale Clark, the suspect. Anthony's left hand was wrapped in a black shirt, and he advised that he was stopping the bleeding. Anthony advised that he and Tamorrio "had beef a while back," and around 0500 to 0556 hours, they were involved in a verbal dispute that escalated into a physical altercation. Anthony advised that, during that altercation, he was stabbed with a knife by Tamorrio in the hand and forehead. While speaking with Anthony, I examined the three lacerations located on the backside of his left hand. The lacerations were consistent with a blade leaving a slice marking, and the blood on the wound appeared to be fresh. I also observed dried blood on Anthony's forehead with a red wound in the shape of a dot, which appeared to be leaking before my arrival. Anthony was able to identify Tamorrio due to them being acquainted for several years as family friends.

Anthony advised that Tamorrio may live with his mom, located at 4715 34th Avenue. Deputies responded to the home and located Tamorrio. I arrived on scene at 4715 34th Avenue, where I met Tamorrio. Before speaking to him about the facts of the case, I read him his Miranda rights, which he stated that he understood and agreed to discuss the case with me. Tamorrio's first words were "I ain't stab nobody," denying that he stabbed anyone. Tamorrio denied being in the area between last night and this morning, and getting into an altercation with Anthony. Later in the investigation, Tamorrio admitted he and Anthony were in a physical altercation and that he was in the area at the time, but denies stabbing him.

Based on the statements made above and evidence Tamorrio is in violation of F.S.S. 784.045 1a1 Aggravated Battery with a Deadly Weapon.

Tamorrio was taken into custody and was transported to the Indian River County Jail.

NARRATIVE

On September 24th, 2025, at approximately 1904 hours, I responded to the area of 1400 20th Avenue SW, Vero Beach, Florida, in reference to a crash.

Upon arrival, Deputy Gadacz, ID# 6337, and I made contact with Mr. William Adams, who advised he had been in a traffic crash at 14th Street SW and 20th Avenue SW. He stated a male, later identified as Mr. Clifton Rafford, was driving a black Nissan sedan (bearing FL DU71KP) that struck the rear of his van. He stated Mr. Rafford then exited the vehicle and began arguing with him and his son, so his son

Deputy Gadacz and I then made contact with Mr. Rafford in the rear of Indian River County Fire Rescue (IRCFR), Rescue 4. While Deputy Gadacz spoke with Mr. Rafford, I observed that Mr. Rafford had watery eyes, constricted pupils, appeared "on the nod," had droopy eyelids, and had trouble concentrating. Based on my training and experience, I believed Mr. Rafford to be under the influence of an unknown substance.

After Deputy Gadacz completed his crash investigation, we began traveling to Cleveland Clinic Indian River Hospital to speak with Mr. Rafford in reference to a DUI investigation. While en route, IRCFR Rescue 4 requested law enforcement respond to them. We then made contact with Rescue 4 in the area of 400 20th Avenue. The paramedics on board stated they instructed Mr. Rafford numerous times that he could not use his vape in the ambulance and he became irate and began ripping out his IV's and 12-lead monitor connections and stated he was going to jump out of the back of the ambulance.

I then made contact with Mr. Rafford who was continuing to act irate. Due to his actions and demeanor, he was detained and handcuffed to the stretcher in the ambulance. As I was attempting to place him in handcuffs, Mr. Rafford began yelling at Deputy Gadacz (who was approximately 3 feet away) stating he would slit his throat and was going to spit in his face. I subsequently rode in the back of the ambulance due to Mr. Rafford's behavior and actions.

While en route to Cleveland Clinic Indian River Hospital, Mr. Rafford scooted down in the stretcher and stuck his leg out and intentionally struck me in the left knee with his left boot. He then began yelling expletives and stating he was going to spit in my face, as well.

After arriving at Cleveland Clinic Indian River Hospital, I advised Mr. Rafford he was placed under arrest. Detective McKenzie, ID# 5920, was working an off-duty detail and was attempting to help me place Mr. Rafford in a hospital bed. Mr. Rafford then began yelling at Detective McKenzie and told him he was going to slit his throat, as well. He also stated he wanted to fight Detective McKenzie. Detective McKenzie also searched Mr. Rafford's person, but did not locate any additional items.

Later, Lieutenant Jaworski, ID# 2287, and I were escorting Mr. Rafford to conduct additional hospital testing. Hospital staff stated Mr. Rafford needed to have the handcuffs removed and he needed to move to another bed. At that time, Mr. Rafford became belligerent again and began yelling and balled his fists up and lunged at Lieutenant Jaworski. Mr. Rafford was then redirected to the hospital bed.

Additionally, while Mr. Rafford was laying in bed, he spontaneously uttered, "let me sober up and go home."

NARRATIVE (Continuation)

After being medically cleared, Mr. Rafford was searched again prior to being placed inside my patrol vehicle. At that time, Lieutenant Jaworski located a red box cutter in Mr. Rafford's pocket that wasn't there previously. This knife provided more validity to Mr. Rafford's threats to cut Deputy Gadacz and Detective McKenzie's throats.

Mr. Rafford was transported to the Indian River County Jail, without incident. After arriving at the jail, Mr. Rafford was seated in the general seating area in booking. Mr. Rafford began acting belligerent and irate again. At that time, Lieutenant Vecchione, ID# 5319, began speaking with Mr. Rafford. Mr. Rafford then stood up, balled his fists up, and lunged at Lieutenant Vecchione. He was then redirected to the ground and placed in a restraint chair.

Booking staff then requested Mr. Rafford provide a breath sample, to which he did so. Mr. Rafford provided breath samples of 0.00 and 0.00. I subsequently requested Mr. Rafford provide a urine, however, he stated no. I read Mr. Rafford Implied Consent and he still stated no.

Mr. Rafford was issued two citations for DUI (citation #: AJ8SYHE) and careless driving (citation #: A66AVSE).

It should be noted, during our investigation, a female, identified as Ms. Kristy Bird also stated she witnessed Mr. Rafford exit the black Nissan, then throw something in the shallow ditch adjacent to where Mr. Rafford's vehicle was. Deputy Ciofalo, ID# 6321, then located three empty Suboxone wrappers in the area Ms. Bird witnessed Mr. Rafford throw the items.

Another male, identified as Mr. Matthew Mccanna, also stated his exterior video surveillance captured the incident, as well. After reviewing the video, Mr. Rafford's black Nissan is seen striking Mr. Adams' van. Mr. Rafford is subsequently observed exiting the driver's seat while his vehicle is in the intersection. He then walks over to Mr. Adams and the two are seen arguing. Mr. Rafford is then seen looking inside his vehicle and then walks to the shallow ditch alongside his vehicle where the three empty Suboxone wrappers were located.

NARRATIVE

On September 25, 2025 at approximately 22:02 hours, I responded to 2046 39th Avenue, in reference to a past physical disturbance call for service.

Upon my arrival, I spoke with Vero Beach Police on scene and they advised there was a physical disturbance that occurred, but it happened at another address in the County's jurisdiction. The victim was on the stretcher and being seen by Fire Rescue medical personnel at the time of my arrival.

The victim was later identified as Nichole T. Lightfoot. Once stabilized in the ambulance, Nichole was looked over for any signs of injury on her person. Nichole had red scratch marks on the left side of her neck and a small bloody cut on her left hand.

Nichole was transported to Cleveland Clinic by Indian River County Fire Rescue for her injuries. The investigation continued while at the hospital.

Nichole stated that the physical altercation occurred at back to the residence around 6:00 PM. Nichole stated when she arrived back to the residence she observed her husband, Cole Daniel Lightfoot inside of the residence. Nichole advised while at the residence with Cole, she asked to see his cellphone and when doing so she saw a Tinder Dating app notification on his phone. Nichole stated after she saw the notification, an altercation occurred and Cole became verbally and physically violent. Nichole stated that Cole put his two hands around her neck tightly and started to choke her. Nichole also advised Cole had kicked her in the middle of her back.

According to Nichole's statement, Cole knowingly and intentionally impeded the normal breathing by choking her neck with his bare hands. Nichole was extremely distraught while on scene, Nichole stated that Cole continued to put his hands around her neck aggressively and tight. From Nichole's statement it was evident that such behavior could have created a risk of great bodily harm if Cole had continued to act in such a manner.

Nichole stated after the altercation she left the residence to go to a meeting. Nichole stated she arrived back to the residence approximately around 8:15PM. Nichole stated when she arrived back to the residence after her meeting, Cole was there and started to get physical again. Nichole stated that Cole was upset and shoved her aggressively out of the doorway while trying to leave the residence. Nichole then later called law enforcement to report the incidents.

Nichole stated after the second altercation, she left to go to her friend's house located at 2046 39th Avenue Vero Beach, Fl 32960 and that is when she called law enforcement.

Assisting deputies arrived on scene to the residence where the altercation occurred, but were unsuccessful in finding Cole as he and his vehicle were no longer on scene. Nichole stated that Cole frequents hotels in the area and she gave law enforcement the description of his vehicle.

Nichole stated that his personal vehicle is a white GMC pickup truck with a custom wrap on it that states his business name. Nichole stated that the truck had a trailer attached to it.

While searching for the vehicle, the truck and trailer were later located at 9350 19 th Lane (Hampton Inn Vero Beach Hotel).
While at the hotel, we located Cole's room and took him into custody with no issue. Cole was transported outside and set into my marked agency issued patrol vehicle. Cole was read his Miranda Warnings and he advised he understood them.
Cole stated that he was involved in a verbal altercation with Nichole, but never physically put his hands on her. Cole stated that Nichole was irate and being physical towards him and he tried to separate himself from the situation. Cole stated he tried to leave the residence and Nichole placed herself in front of him and would not move. Cole stated he put his hands out to create separation as he did not want the situation to escalate. Cole stated he did not choke or kick Nichole.
Nichole and Cole both had different statements.
