NARRATIVE

On Friday, April 26, 2024, at approximately 0034 hours, I responded to [REDACTED] in reference to a battery domestic violence.

Upon my arrival, I made contact with Mr. Michael Ross (Victim), who advised the following in substance: He was at his residence with his girlfriend, Ms. Latoya Ruffin (Arrestee), when she ran out of "Molly". They then began arguing, because he refused to buy her more, and she struck him in the face, with a closed fist. The strike caused Mr. Ross' bottom tooth to be knocked out of his mouth. She then grabbed at him and scratched him with her finger nails. He continuously pulled away from her in an attempt to flee, but she continued to attack him. He then [REDACTED] for help and she stopped attacking him. She then walked northbound on 25th Avenue, [REDACTED]. Mr. Ross advised he never shoved or struck her and he just attempted to flee. He confirmed they were in an intimate relationship for over a year and they resided together as if a family. While speaking with Mr. Ross, I observed the following injuries: multiple scratches on the left side of his neck, which were still bleeding, a missing tooth on the bottom row, and cuts on his left leg, which were also still bleeding.

I then made contact with Ms. Ruffin, who advised the following in substance: She was in an argument with Mr. Ross over buying groceries, when he began shoving her repeatedly. She then grabbed him and wrapped him in a bearhug, preventing him from shoving her. She then let him go and he punched her in her left eye. She then began punching him in the face and scratching him with her fingernails. She could not remember where she scratched him or what happened after she struck him in the face. She was then informed he was [REDACTED] so she left and walked northbound on 25th Avenue. She advised she has been in an on and off intimate relationship with Mr. Ross for two years and they reside together as if a family. While speaking with Ms. Ruffin, I observed no marks or injuries on her person.

Due to the statements made by both parties and the injuries being consistent with Ms. Ruffin being the predominant aggressor, she was arrested for battery domestic violence and transported to the Indian River County Jail.

This investigation was captured on my department issued body worn camera.



NARRATIVE

On Thursday, April 25, 2024, at 0817 hours, I observed Detravenous T. Gordon driving a white Jeep Cherokee. I knew Gordon had a suspended Florida Driver's License, so I conducted a traffic stop on Gordon, who was the vehicle's only occupant.

As I exited my patrol vehicle with my agency lights activated, I observed Gordon reclining the driver seat back and beginning to slide to the rear seat of the SUV while holding a bundle of US Currency in his hand. Gordon was given verbal commands to stop moving and place his hands up where they could be seen, but he refused to comply. Gordon was eventually removed from the vehicle and placed into custody. Based on Gordon's movements I believed he may have had a weapon so I conducted a protective sweep of his immediate area.

During the my sweep I located Gordon's FL identification card in his wallet on the front driver's side door panel. Gordon's information was run through dispatch, which verified he did not have a valid Florida driver's license. A black box was also located on the floorboard next to Gordon's black slides, which contained 22 1x1 zip-lock baggies containing crack cocaine individually packaged between the weights of .25g - .40g. There were also three 1x1 zip-lock baggies containing white powder fentanyl individually packaged weighing approximately .22g a piece. There was also a clear plastic bag containing a large crack cocaine rock. There were also numerous empty 1x1 zip-lock baggies within the black box. I also located marijuana (17.8 grams) in the center console next to a scale that had marijuana residue and a white powdery substance on it, matching the color and texture of the fentanyl/cocaine located in the black box. I also located 180 20 dollar bills (\$3,600.00) in US Currency.

The crack cocaine and fentanyl were field tested, testing positive for the presence of cocaine and fentanyl. Gordon also stated that his FL Drivers License was suspended during his arrest.

NARRATIVE

On Thursday, April 25, 2024, between the hours of 0212 hours and 0322 hours, I, Indian River County Sheriff's Office Deputy Ballester, responded to [REDACTED] regarding several noise disturbance calls for service.

Let it be known that this was the fourth time law enforcement responded to the same residence regarding the same loud music complaints. Please reference cases 2024-45395, 2024-45391, and 2024-45387, and Deputy Hatton case supplement for further information.

During my call for service response to [REDACTED] (2024-45387) at 0212 hours. Myself and Deputy Hatton made contact with the homeowner, Isabel Rodriguez, and his nephew, Rolando P. Rodriguez, who were standing next to several vehicles while playing music. They stated that they were just drinking and hanging out outside the house. I informed them of the loud music complaint and requested that they lower the music, to which they complied. Law enforcement then left the area without taking further action.

During my response to 295 20th Avenue (2024-45391) at 0239 hours, I once again made contact with Isabel Rodriguez and his nephew, Rolando P. Rodriguez. Upon arrival, I was able to hear music playing at a low volume. I then informed them that we had received another loud music complaint and requested that they bring the volume down a little more, to which they complied. I then left the area without taking further action.

At 0322 hours, I responded to [REDACTED] regarding another loud music call for service. Upon arrival, Deputy Hatton made contact with the complainant, Jeffrey Paul Hyle, who resides at [REDACTED] from Isabel Rodrigues residence. Jeffrey informed my partner that he had video footage of his neighbors playing the music louder every time law enforcement left the area. Deputy Morgan recorded the video and uploaded it to evidence.com.

I then approached Isabel Rodriguez's residence, where I observed him and Rolando P. Rodriguez standing outside in the driveway. There was no music playing at the time. As I approached the residence, I observed a white pickup truck with dark tinted windows, the driver door wide open, and the vehicle turned on. I then approached the truck through a narrow path due to it being parked too close to another pickup truck. Once I confirmed there was nobody inside the vehicle, I turned around and observed Rolando standing right behind me, really close to my firearm. Deputy Hatton ordered Rolando to back away. Rolando then put his hands up in the air and stood still, stating multiple times that he was on his property. I gave several commands to Rollando to move away so that I could leave the area, but Rolando refused to obey my commands by standing still, not moving, and stating, "No, I'm on my private property." I then placed Rolando in handcuffs and escorted him to my patrol car without issue.

Due to the above, I charged Rollando with resisting without violence, which is consistent with FSS. 843.02 and a violation of county ordinance section 974.04. Rollando was transported to the Indian River County Jail without further incident.
