NARRATIVE

On Thursday, April 25, 2024, at 0817 hours, I observed Detravious T. Gordon driving a white Jeep Cherokee. I knew Gordon had a suspended Florida Driver's License, so I conducted a traffic stop on Gordon, who was the vehicle's only occupant.

As I exited my patrol vehicle with my agency lights activated, I observed Gordon reclining the driver seat back and beginning to slide to the rear seat of the SUV while holding a bundle of US Currency in his hand. Gordon was given verbal commands to stop moving and place his hands up where they could be seen, but he refused to comply. Gordon was eventually removed from the vehicle and placed into custody. Based on Gordon's movements I belived he may have had a weapon so I conducted a protective sweep of his immediate area.

During the my sweep I located Gordon's FL identification card in his wallet on the front driver's side door panel. Gordon's information was run through dispatch, which verified he did not have a valid Florida driver's license. A black box was also located on the floorboard next to Gordon's black slides, which contained 22 1x1 zip-lock baggies containing crack cocaine individually packaged between the weights of .25g - .40g. There were also three 1x1 zip-lock baggies containing white powder fentanyl individually packaged weighing approximately .22g a piece. There was also a clear plastic bag containing a large crack cocaine rock. There were also numerous empty 1x1 zip-lock baggies within the black box. I also located marijuana (17.8 grams) in the center console next to a scale that had marijuana residue and a white powdery substance on it, matching the color and texture of the fentanyl/cocaine located in the black box. I also located 180 20 dollar bills (\$3,600.00) in US Currency.

The crack cocaine and fentanyl were field tested, testing positive for the presence of cocaine and fentanyl. Gordon also stated that his FL Drivers License was suspended during his arrest.

The total weight of the crack cocaine was 13.02 grams, and 0.67 grams of fentanyl.
