Arrest Affidavit Report

NARRATIVE

On 07/21/2025 at approximately 0344 hours, I responded to 4055 41st Ave (County Jail) in reference to a disturbance.

Upon arrival, I made contact with Corrections Sergeant Cuevas who advised there was a physical disturbance that occurred earlier in the night at approximately 0248 hours in the Jail Kitchen, involving two inmate workers.

Sergeant Cuevas provided CCTV footage which revealed Emmett Lane (suspect) having a dialogue with Michael Podway (victim) another inmate working in the kitchen with him. A short time later, video reveals Emmett poking Michael's face using his right hand.

I made contact with Michael, he advised that the disagreement both subjects were involved in was in reference to how he was stacking the bread on a metal tray, he advised Emmett poked his eye with his finger as he walked away. I did not observe any redness or obvious marks on Michael's face. Michael advised he wanted to pursue prosecution.

I then made contact with Emmett to collect his statement. I advised Emmett this was a non-custodial interview and he could walk away at any point that he may desire. Emmett advised he understood and stated he wanted to provide his statement. Emmett stated he got into an argument with Michael about how he was organizing the bread on a metal tray. Michael advised Emmett shoulder checked him and putting his finger in his face was only way to avoid conflict and advise him that he would defend himself.

Based on the totality of the circumstances, I determined Emmett to be the primary aggressor and there was probable cause for Battery by detained person.

Emmett continues to be incarcerated at the Indian River County Jail.

NARRATIVE

On Monday July 21st, 2025 at approximately 1249 hours, I responded to 4055 41st Street, Indian River County Sheriff's Office, in reference to a Harassment. Upon my arrival I spoke with Michael Peruta and Danielle Wynkoop they provided the following statements.

During a recent discussion with Michael, he provided information regarding his interactions with defendant Sara E. Goodnow. Michael indicated that both he and Sara were members of a Facebook group titled "Vero Beach Neighborhood." He reported that Sara had been posting false information concerning allegations of sexual abuse and asserting that he is a registered sex offender.

Despite initial attempts to restrict her access to the Facebook group, Sara continued to seek alternative means to contact Michael through various social media platforms, including Google reviews, comments on his YouTube channel, and multiple email accounts. On another occasion, Michael mentioned that he shopped at Publix, located at 4145 Ninth Street SW, Vero Beach. Subsequently, Sara posted a photograph of the front of the store on Facebook, with the caption, "We're looking for you," and further mentioned, "Trying to make myself more noticeable," in reference to Michael's unrelated post featuring himself and his daughter. Additionally, Sara had her husband to reach out to Michael on her behalf as another method of contact. Michael expressed his reluctance to engage with Sara, yet she consistently found ways to reach him. He conveyed his concerns regarding the possibility that Sara may exacerbate the situation and potentially harm him or his family. Michael has reported experiencing heightened anxiety as a result of this interaction, resulting in significant emotional distress.

In a subsequent conversation with Danielle, posts on Facebook and sent Danielle multiple back-to-back direct messages, requesting approval for a post intended for the Vero Beach Neighborhood group. After blocking Sara on Facebook, Danielle received emails from Sara's account containing disparaging remarks about her and requests for further contact. Additionally, Sara submitted four negative Google reviews that adversely affected Danielle's business. In her efforts to communicate with Danielle, Sara also discovered and utilized Danielle's personal YouTube account. Danielle has expressed her concerns regarding the potential repercussions of this situation, fearing that if it continues, Sara may cause harm to her business, family, and emotional well-being.

It should be known that I have had encounters with Sara Goodnow in a law enforcement capacity and was able positively identify her from a photo shown by the victims.

I then responded to 1385 21st Street SW Vero Beach, Sara's home, to conduct an interview. Sara was read her Miranda right, she stated she understood them and agreed to speak with me on scene. Asked Sara about the allegations made above and she denies that she did not do the things they have said about her.

NARRATIVE

On Monday, July 21, 2025 at approximately 1409 hours I conducted a traffic stop on a dark four door sedan which I was previously informed by Detective Bennett (ID# 6232) that he had a reason for an investigative stop on the vehicle.

I was further informed the vehicle may contain a wanted subject, Ms. Latoya Bennefield (DOB: 05/29/1981).

Prior to this traffic stop I surveilled the vehicle while it was stationary within Taylor Pointe apartment complex. I approached the occupants attempting to locate Ms. Bennefield under deceptive pretenses asking if they had seen anyone near by screaming. While in close proximity with the vehicle and its' occupants, I observed the strong odor of freshly burnt cannabis; in addition I observed two individuals actively smoking which had walked away from the vehicle.

I parked my vehicle on 49th street waiting for the vehicle to pass by my location so I could conduct a traffic stop with the intent of locating Ms. Bennefield.

While stationary, I conducted an FCIC/NCIC query of the vehicle bearing Florida license plate DP95WN, where I noted neither registered owner possessed a valid Florida Driver's License.

I observed the vehicle travel Eastbound on 49th Street; where I then followed behind it. As the vehicle passed my location where I observed numerous people within the vehicle.

I initiated a traffic stop in the area of 5300 Old Dixie Hwy, upon approaching the vehicle I noted the strong odor of freshly burnt cannabis as the window rolled down. Immediately upon approaching the vehicle I observed a female sitting on the lap of the front passenger seat occupant without a seat belt.

I observed numerous ash trays within the vehicle. I ordered all occupants out of the vehicle to begin my investigation; where I immediately recognized the wanted subject, Ms. Latoya Bennefield. Ms. Bennefield failed to provide her last name upon demand. She was subsequently detained in handcuffs.

I confirmed through dispatch Ms. Bennefield was still actively wanted by St. Lucie County under the following warrant / case number:

Several occupants of the vehicle confirmed my suspicion, confirming they had finished smoking marijuana recently when I previously observed them.

NARRATIVE

On July 21st, 2025, at 2351 hours, I responded to Sonata, 2425 20th Street, in reference to a past disturbance. Upon my arrival, I made contact with Samantha Vargas, who stated she was involved in a physical altercation with her estranged husband, an hour and a half prior. Samantha stated once she got off work, her estranged husband, Samuel Vargas, came and picked her up from the aforementioned address, and brought her to 810 8th Street Lot #73, where they parked in the roadway and engaged in a verbal altercation reference their failing marriage. Samantha stated during the argument, Samuel became irate and grabbed her neck, by placing his hand around her throat. Samantha stated he did not block her airway or interrupt her breathing, but stated he grabbed her hard enough to cause physical pain. I observed Samantha's neck and was unable to locate any signs of injury due to the time delay and how flushed she was from crying.

I then traveled to 810 8th Street Lot #73, where I observed a male subject standing on his steps outside 810 8th St #16. The male subject pointed to Samuel and stated "that's the guy you're looking for." I questioned the male subject and asked how he knew I was looking for Samuel and he stated Samuel told him what he did to his wife. I then approached Samuel observed him to be crying, sitting in a lawn chair, listening to IRCSO 911 livestream. I asked Samuel why he was crying and he said it was because he did something he shouldn't have done. I then read Samuel his Miranda Rights, too which he replied by stating he understood his rights and wished to speak with me. Post Miranda, Samuel advised once he picked up Samantha from work, he brought her to the aforementioned address where they engaged in a verbal argument inside her car. Samuel stated he became upset from something Samantha stated and he responded by grabbing her by the throat. Samuel stated he did not choke her but he knew he should not have put his hands on her. I then detained Samuel without incident and transported him to the Indian River County Jail.

NARRATIVE

On 07/22/2025, at approximately 0251 hours, I responded to 1180 U.S. Highway 1, in reference to an intoxicated subject.

Prior to my arrival, 911 dispatch advised that they received a call-in reference to a highly intoxicated white male subject that entered the store. When the subject left the store, he moved his vehicle bearing Florida tag (BG47AG), out of a parking spot and parked his vehicle at one of the gas pumps.

Upon my arrival, I located the above mention vehicle parked at one of the gas pumps running with its headlights on. When I approached the driver's door, I observed a white male subject, sitting in the driver's seat eating. While observing the subject eating, I noticed that a large portion of the food was dripping onto his shirt and pants, due to noticed several food spots scattered all over his clothing.

When the subject opened the driver's side door, immediately smelled the strong odor of an alcoholic beverage emitting from inside. As the driver was providing me with his license, I noticed that his movements were very slow. While the subject, removed his vehicle registration, he held onto to it in his right hand for approximately 1 minute, after I asked for it. At the time, I was able to identified the subject as Jayden Hernandez-Mahoney, from his Florida license. When Jayden made direct eye contact with me, I noticed that both of his eyes were glassy and watery.

During a brief conversation, Jayden denied consuming any alcoholic beverages this evening. When Jayden spoke, I was able to smell the very heavy odor of an alcoholic beverage emitting from his person.

Next, I informed Jayden that I would be conducting a D.U.I investigation, which he stated that he understood.

During the Horizontal Gaze Nystagmus Exercise, Jayden showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. During vertical gaze nystagmus, I observed that both eyes voluntary moved upward. Due to standing directly in front of Jayden, I continued to smell the strong odor of an alcoholic beverage emitting from his body.

During the Walk and Turn Exercise, Jayden took a total of 10 steps, that were not heal to toe or straight in a line, after being instructed to conduct to 9. When Jayden conducted the turn to start the second phase of the exercise, both of Jayden's feet were observed stepping off of the line. During the second portion, Jayden reached step 7 and loss his balance, with both of his feet stepping off of the line.
