NARRATIVE

On Friday, May 16, 2025 at approximately 1237 hours I responded to 5800 20th Street (Target) in reference to a shoplifting.

While in route I was advised by dispatch that the suspect involved in the shoplifting is described as a black male wearing a black shirt and black shorts and left the scene towards the Ryanwood shopping plaza.

Upon my arrival I made contact with Hayden Davies the Asset Protection agent for the target location who advised that a black male subject exited the store with two bottles of laundry detergent passing all points of sales without paying for the items.

Hayden and I reviewed the in-store surveillance video of the incident and I observed a black male later identified as Ronald Callies enter the store at approximately 1213 hours, walked to the detergent aisle and selected two bottles of "Tide" detergent and placed the items into a dark colored backpack. Ronald then walked to the main aisle of the store and walked past all points of sales exiting the store at 1222 hours. Hayden further advised that he recognized Ronald from a previous retail theft Case # 2025-21572 where Ronald exited the store prior to being identified.

Hayden described the items as a white bottle of "Tide" detergent valued at \$27.49 and an orange bottle of "Tide" detergent valued at \$27.49 for a total value of \$54.98.

While reviewing the surveillance video it could be seen that Ronald was not wearing black shorts but was wearing Camouflage shorts.

I was contacted via my handheld radio and was advised by Lieutenant Knott that he was out with a male subject at the Bank of America in the Ryanwood Shopping Plaza. I described the male subject as a black male wearing a black shirt, camouflage shorts a khaki hat and black shoes. Knott advised that he is with the male matching the description. Knott advised that he was at the Bank of America (5780 20th Street) on the east side of the building.

I escorted Hayden to the rear seat of my patrol vehicle and transported Hayden to the male suspect and conducted a show up. Upon my arrival Hayden positively identified the male suspect as the suspect who stole the two bottles of laundry detergent from the Target location. I transported Hayden back to the Target location.

I returned to the Bank of America location and placed Ronald into the rear seat of my patrol vehicle. I read Ronald his Miranda Warning from a preprinted agency issued card. Ronald advised that he understood his rights and advised that he was homeless and the he is on hard times and needed to take care of somethings.

A search of the two black packs in Ronald's possession yielded two-bottles of green laundry detergent and the two bottles (1-white and 1-orange) of laundry detergent stolen from Target.

The bottles of detergent were returned to Target and photographed. Ronald advised that the two green bottles of laundry detergent belonged to his friend who is not at the location. The backpacks were placed into evidence with case number.

Hayden advised that Target would like to have Ronald Trespassed from the property.

NARRATIVE

On May 16, 2025, at approximately 1900 hours, I was dispatched to Wawa, located at 4495 US Highway 1, Vero Beach, Florida, in reference to an Extremely Intoxicated male, wearing tan pants and tan shirt, stumbling around the aforementioned location.

While enroute to the Wawa, the complainant told dispatch, that the male was entering into a gold Cadillac SUV.

I entered into the Wawa parking lot, and observed a Wawa employee pointing towards the Cadillac SUV, as it drove past me. I turned around and got behind the Cadillac SUV on Old Dixie Highway as it approached the red light at 45th Street, Vero Beach, Florida. I immediately observed the vehicle swerve over the white solid line on the right side of the road on Old Dixie Highway. When the vehicle approached the red light, it passed the clearly marked stop bar [F.S.S 316.123(2)(a)], and pulled into the crosswalk, completely blocking the aforementioned crosswalk [F.S.S 316.1945(1)(a)(4)]. At the red light the Cadillac inched forward, and as the red light turned green, the Cadillac failed to yield for oncoming traffic as it made a left hand turn onto 45th Street, cutting off a vehicle that had the right away [F.S.S 316.155]. As the Cadillac cut the vehicle off with the right away, it almost drove off the road. After observing all the above traffic infractions, I initiated a traffic stop on the Cadillac bearing Florida tag DL35QZ.

The Cadillac pulled into the gas station parking lot, located at 2416 45th Street, Vero Beach, Florida. I made contact with the driver, Kevin Yearby, on the passenger side of the vehicle. I noticed Kevin's eyes were blood shot and watery, as I requested his required documents. Kevin was not responding to me, so I approached the driver's side of the vehicle, where Deputy Lowell was located. I asked Kevin, again for his required documents, When I got closer to the driver's side window, I could smell an alcoholic beverage emanating from Kevin's breath as he spoke to me, while speaking with Kevin, I noticed his slow motion and slurred speech. Kevin handed his registration, and insurance. I asked Kevin for his Florida drivers license, he advised he handed it to me. I informed Kevin he did not, and requested it again. Kevin became uncooperative, so Deputy Lowell and I removed Kevin from the vehicle.

I conducted an NCIC/FCIC query of Kevin, when I was complete with the query, I requested Kevin submit to the field sobriety exercises, he verbally stated that he would. Prior to beginning the exercises Kevin stated that he does not have any physical defects. I asked Kevin if he wore glasses or contacts, he informed me he does not.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN). I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

During his first attempt I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and Nystagmus prior to 45 degrees almost instantly. I observed vertical gaze Nystagmus in both eyes. Kevin had to be reminded to follow the stimulus, with his eyes, and eyes only, several times.

It should be noted, as I explained the exercise to Kevin, and made him place his feet together, he swayed to the point where he had to separate his feet, to keep from falling.

The second exercise I began to demonstrate and explain was the Walk and Turn exercise, during this portion, Kevin began to become augmentative. I asked Kevin if he wished to continue the exercises, which he advised he

did not. Due to Kevin refusing the remainder of the exercises, Deputy Lowell and I began to take Kevin into custody, Kevin began to resist our attempts by pulling away and being argumentative. Kevin was eventually secured into handcuff restraints, checked for proper fit, and placed in the rear of my patrol vehicle.

It should also be noted, due to Kevin's level of intoxication, he had urinated on himself.

Based upon the totality of the evidence Kevin was taken into custody for violation of FSS 316.193(1) DUI. While enroute to the Indian River County Jail, I advised Kevin of his Miranda Warnings from my agency issued Miranda Card. Kevin was transported to the Indian River County Jail for booking.

At the county jail Kevin provided a lawful breath sample to Deputy Rodriguez ID# 5661. His first breath sample was 0.305 and his second breath sample was 0.297. Due to Kevin's level of intoxication, I had to take him to Cleveland Clinic for a medical clearance.

At Cleveland Clinic, Kevin admitted to drinking, but wanted me to release him because he was not hurting anyone. Kevin asked about his property, several times, and I informed him it was at the jail. Kevin asked why his property was at the jail, and I explained to Kevin, that he was so intoxicated, that during the booking process, he was refused entry to the jail, and required a medical clearance.

NARRATIVE

On May 17, 2025, at approximately 0320 hours, I observed a red Dodge pick-up bearing Florida tag HNBU95, depart Players Pool Lounge, located at 4066 Old Dixie Highway, Vero Beach, Florida, without any tail lights on.

After observing violation of Florida State Statute 316.221, I followed the vehicle west on 41st Street, where my in-car Stalker radar, was able to capture the vehicle doing 44 mph in a posted 35 mph zone. I initiated a traffic stop, just prior to the intersection at, 41st Street and 28th Avenue, Vero Beach, Florida, by activate my overhead lights.

The aforementioned vehicle made a right hand turn onto 28th Avenue, accelerated away from me, north on 28th Avenue, slowed and made a righthand turn onto 42nd Street, accelerated away and proceeded east to 27th Avenue. At the intersection of 42nd Street, and 27th Avenue, when the vehicle failed to stop, I activated my siren, at which point the vehicle made a left hand turn onto 27th Avenue, proceeded north, accelerating away from me again. At the intersection of 27th Avenue and 42nd Place, the vehicle made a left hand turn and proceeded west on 42nd Place. The vehicle came to a final stop at the intersection of 42nd Place and 28th Avenue.

I ordered the driver, later identified as, Eddie Eliacin (previously known as Eddie Levi Mitchner), out of the vehicle. I instructed Eddie to walk back towards me, where I placed him in handcuff restraints, then placed him in the back of my patrol car. The other two occupants, later identified as, Terry Craig, and Michael Slaughter, where taken out of the vehicle and placed into handcuff restraints by Deputies on scene.

When Terry was asked by Deputies if he had anything illegal on him, he informed Deputies that he had a small amount of marijuana in his pocket. I seized the marijuana for destruction, based on the fact Terry did not have a medical marijuana card.

At the conclusion of the traffic stop, Terry and Michael were released from the scene, and the vehicle was towed by Mikes Wrecker.

Based on the fact, after I initiated the traffic stop on the red Dodge bearing Florida tag HNBU95, that Eddie was operating, made 4 turns, accelerated away from me, and traveled approximately one-half mile before coming to a stop. I charged Eddie with FLEE/ ELUDE OFFICER IN MARKED PATROL VEHICLE/ LIGHTS & SIREN ACTIVE, Violation of Florida State Statute 316.1935(2).

Committed the offense of DUI in that the Defendant was:

- Driving or in actual physical control of a motor vehicle upon a public road/ highway within this state;
- Under the influence of alcoholic beverages;
- Affected to the extent that the person's normal faculties were impaired; and
- Determined to have a breath-alcohol level of 0.08 or more grams of alcohol per 210 liters of breath To wit the Defendant provided samples of .206 & .207, respectively.

On 05/17/25 I, Ofcr. S. Gonzalez (471) responded to the 2600 block of 12th Avenue at the request of K-9 Ofcr. J. Doty (434).

Upon arrival I met with Ofcr. Doty who informed me that he conducted an investigatory stop on the Defendant in connection with a disturbance call where the Defendant was alleged to have been trying to force his way into the complainant's residence.

By way of background, the Complainant, was blocking him with hand.

Ofcr. Doty informed me activated his lights for the traffic stop at or about the intersection of 12th Avenue and 26th Street and the Defendant had a delayed response reacting and coming to a complete stop.

Ofcr. Doty further informed me that upon making contact with the Defendant he could detect an odor of an alcoholic beverage coming from the Defendant's breath as he spoke, that his eyes were red and glassy and that his speech was slurred. Also, Ofcr. Doty found that the Defendant had an insulated tumbler in the center console which contained an alcoholic beverage.

Based on the foreging, Ofcr. Doty had reasonable suspicion to believe that the Defendant might be impaired and requested that I conduct a DUI investigation.

Upon making contact with the Defendant, I could immediately detect a strong odor of an alcoholic beverage coming from within the vehicle and I noted that his eyes were red and glassy.

I spoke with the Defendant about his whereabouts and activities and he stated that he had been out fishing but had not caught anything.

During this interaction, I noted a strong odor of alcohol emanating from the Defendant's breath as he spoke and that his speech was slurred.

I subsequently asked the Defendant to exit his vehicle so that I could speak with him further. The Defendant carefully exited his vehicle and did so freely and willingly.

Once out of the vehicle, I informed the Defendant that Ofcr. Doty made some observations that gave him cause for concern that he might be impaired and that I had made similar observations and therefore would give him the opportunity to dispel our concerns by performing sobriety exercises ("FSE's").

While speaking with the Defendant, he appeared unsteady on his feet and was fidgety & nervous.

I asked the Defendant if he took any medications and informed me that he took blood pressure medication.

When asked how much [alcohol] he had to drink, the Defendant stated that he'd only had two (2) beers.

When asked if he had any injuries, illnesses or disabilities, the Defendant informed me that had and stated that he had undiagnosed issues with his hips but was vague about that nature of the issues with his hips. However, the Defendant informed me that me that he did not have any diagnosed injuries or disabilities from his hips and no trouble standing or walking and did not required the use of canes or crutches to walk or stand.

I then administered Field Sobriety Exercises ("FSE's")

The area was well lit and the ground was level and free of debris. An approximately 12 ft. length of masking tape was used for the walk and turn.

- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes).
 - * While administering HGN, the exercised had to be restarted multiple times as the Defendant would fail to follow the stimulus as instructed and/or would focus on something other than the stimulus.

ONE LEG STAND (OLS) The instructions were explained and exercised partially demonstrated to the Defendant who stated that he understood them.

- Noticeable sway;
- Right leg up;
- Failed to Raise leg or perform exercise as instructed.
- Put foot down 3x at the count of 3
- Switched feet and raised his LEFT foot
- Put right foot down on count 7
- Difficulty maintaining balance throughout exercise.

WALK AND TURN (WAT) The instructions were explained and exercised partially demonstrated to the Defendant who stated that he understood them.

- Noticeable sway during instruction phase;
- Unable to maintain balance and stepped off the line during instruction Phase multiple times;
- Missed heel-to-toe throughout the exercise;
- Stepped off line multiple time outbound;
- Too many steps outbound (13)
- Improper turn (turned other than as instructed);
- Began counting return steps at "9" and took too many steps on return as well.

Based on the foregoing, I gave the Defendant an opportunity to be truthful about how much [alcohol] he had consumed to which the Defendant stated that he had consumed "6 or 7 beers".

Based on the totality of the foregoing, I placed the Defendant under arrest for DUI and informed him accordingly.

The Defendant was transported to the Indian River County Jail for the administration of a breath test and booking.

After a 20-minute observation period, the Defendant was asked to submit to a test of his breath for the purpose of determining the alcoholic content of his breath.

The Defendant initially refused and was read Implied Consent after which he subsequently agreed to submit to a test of his breath.

The Defendant provided two samples of .206 & .207 respectively

The Defendant was then turned over to the custody and control of corrections personnel.

The foregoing violation occurred within the City of Vero Beach, Indian River County, Florida.

The stop and subsequent DUI investigation was recorded with the use of my body-worn and in-car video camera as well as that of Ofcr. Doty all of which was subsequently uploaded to a secure server.

NARRATIVE

On May 17th, 2025, at 2153 hours, I was patrolling southbound on 4th Street and US Highway 1 in Vero Beach, Florida, when I observed a white Dodge Ram bearing Florida tag # QRSQ71 traveling southbound on US 1 in the outside speeding away from all other vehicles and swerving in and out of the right shoulder several times. I was able to pace the vehicle going 75mph in a posted 45mph zone.

I then conducted a traffic stop on the aforementioned vehicle and came to a final stop at the Vatland dealership. I made a driver-side approach and made contact with the driver and sole occupant of the vehicle, Dustin Duane Nobles.

I asked Nobles to provide the proper documentation for the vehicle. Nobles was able to provide his driver's license but was searching in his center console for a longer time than usual for his insurance and registration. I asked Nobles if there were any firearms in the vehicle, to which he stated, "Yes," and that it was located between the driver's seat and center console. I then asked Nobles to stop digging around the center console and to step out of the vehicle. When Nobles stepped out, I observed him having difficulties standing still as he was swaying to his left.

As I interacted with Nobles, I observed several physical signs of impairment. Noble's eyes were bloodshot and glassy. His speech was slightly slurred. Nobles had difficulty maintaining balance. Nobles also appeared to have difficulties concentrating, as I had to ask him several times to remove his hands out of his pockets.

I became concerned the defendant was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Nobles if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked him a series of medical questions to ensure he could participate in field sobriety exercises. Nobles stated that he has no physical defects, was not sick or injured, and was willing to participate.

All field sobriety exercises were explained and demonstrated proficiently prior to Nobles beginning each exercise, and I confirmed he understood the instructions prior to the start of each exercise.

The following exercises were performed:

- 1. HORIZONTAL GAZE NYSTAGMUS No resting nystagmus was observed. Equal pupil size was observed in both eyes. Nobles had difficulties tracking with his eyes only as he used his head to track and looked down a few times. Distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior to 45 degrees was observed at an estimated 30-degree angle. Vertical gaze nystagmus was also observed.
- 2. WALK AND TURN—A straight line at the entrance of the dealership was used for this exercise. Nobles stated he understood this exercise and had no questions on it. During the first nine, Nobles walked three steps, stopped, and spontaneously stated that he had been drinking and that I could do whatever I needed to do. Nobles proceeded to place his hands behind his back as if he was surrendering himself to be placed under arrest. I then asked Nobles if he was refusing to perform these field sobriety exercises. Nobles stated that he had no problem

continuing. Nobles then took nine steps with no issues that I observed. After taking the turn. Nobles missed heel-to-toe steps four and five and used his arms to balance.

- 3. ONE LEG STAND—Noble wore his shoes for this exercise and raised his left foot. He continued to lower his feet and use his arms to balance. Noble was also observed placing his foot down several times. He was only able to count to 11 seconds before placing his foot down.
- 4. FINGER TO NOSE—Noble was instructed on how to perform this exercise, which he understood and had no questions about. When instructed to touch his nose with his left finger, Nobles touched the bridge of his nose. When he was instructed to touch his nose with his right finger. Nobles touched the right side of his nose and not the tip. Nobles continued this process in the following order: left, right, right, left.

Overall, Nobles performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on May 17th, 2025, the defendant was in actual control of a motor vehicle while under the influence of alcoholic beverages and/or a chemical or controlled substance and was impaired beyond his normal faculties, incapable of operating a vehicle safely.

The defendant was arrested for DUI at 2209 hours and was advised of the charge. I took the defendant into custody without incident and advised him of his Miranda rights, to which he stated he understood and agreed to speak with me. Nobles informed me that he arrived at Post and Vine at approximately 1900 to 2000 hours and remained there until he was pulled over. Nobles also informed me that he had 4-5 beers and mixed them with a shot of Jameson whiskey. Nobles was then transported to the Indian River County Jail without incident.

After I arrived at the jail, the corrections deputy advised me that the defendant agreed to provide a breath sample. At the conclusion of the test, the breath sample showed the subject had a breath alcohol concentration (BrAC) of .276 grams per 210 liters of breath and .273 grams per 210 liters of breath.

At the conclusion of this investigation. Dustin Duane Nobles was charged with of FSS 316.193—Driving Under the Influence.

NARRATIVE

On 05/18/2025, at approximately 0126 hours, I responded to the 5300 block of Old Dixie Highway to assist Deputy Shaw with a traffic stop.

Deputy Shaw stated while sitting along the 3300 block of 45th Street, he observed a silver suv bearing Florida tag (UX15B), 43rd Avenue traveling at a high rate of speed, weaving from left to right. When the vehicle, approached the intersection of 43rd Avenue and 49th Street, the vehicle failed to stop for a steady red light and continue traveling north bound. The vehicle was then observed running a steady red light at the intersection of 43rd Avenue and 53rd Street. While continuing following behind the vehicle, Deputy Shaw continued to observe that the vehicle was severely weaving from left to right, within its lane.

When Deputy Shaw made contact with the driver Brandon Deaquino, he noticed that both of his eyes were glossily and noticed that his movements were very slow, when Deaquino was providing him with his driver's license.

Next, I made contact with Deaquino, who at the time was standing at the front of Deputy Shaw's patrol vehicle. While observing Deaquino, he was standing up right and I noticed that his body was swaying from left to right and I could smell the strong odor of an alcoholic beverage emitting from his breath. When Deaquino made direct eye contact with me, I noticed that both of his eyes were glassy and watery. Deaqunio then stated, that the reason why he was speeding and running red lights is that his vehicle was just shot at by an unknown subject along the 3300 block of 45th Street. It should be noted, that Deputy Shaw was sitting along the road at the time of the incident and did not hear any gun shots.

Throughout my brief conversation with Deaqunio, I noticed that his words were very slurred and slow. I also noticed a large amount of salvia, would periodically drool out of his mouth while he talked.

At the time, Informed Deaguino that I would be conducting a DUI investigation (SFST'S) which he agreed to perform.

During the Horizontal Gaze Nystagmus Exercise, Deaquino showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. During vertical gaze nystagmus, I observed that both eyes voluntary moved upward. Due to standing directly in front of Deaquino, I continued to smell the strong odor of an alcoholic beverage emitting from his body.

During the demonstration and instructional phase of the Walk and Turn Exercise, Deaquino started the exercise, prior to being instructed to start by taking three steps, that were not heal to toe or straight in a line. For the first phase, Deaquino took a total of 30 steps, that were not heal to toe or straight in a line. While conducting the turn to conduct to start the second portion, both of his feet stepped off of the line and he lost his balance. During the second portion, Deaquino took a total of 28 steps, that were not heal to toe or straight in a line. Deaquino was instructed prior to performing the exercise, to conduct a total of 9 steps, for both portions.

During the One-Leg Stand Exercise, Deaquino's body was observed swaying from left to right and he was unable to complete the exercise, due to him not being able to maintain his balance.

The following exercise I explained and demonstrated was the finger to nose. After explaining and demonstrating the exercise, Deaquino stated that he understood the instructions.
Left-used center pad of finger to touch above the bridge of nose. Had to be instructed to remove finger.
Right- used center pad of finger to touch above the left nostril. Had to be instructed to remove finger.
Left — used center pad of finger to touch center of nose. Had to be instructed to remove finger.
Right- used center pad of finger to touch right nostril. Had to be instructed to remove finger.
Right- used center pad of finger to touch bridge of nose. Had to be instructed to remove finger.
Left- used center pad of finger to touch above right nostril of nose. Had to be instructed to remove finger.
Throughout the exercise, I noticed that Deaquino's body would periodically sway from front to back.
While placing Deaquino into handcuffs, he informed me that he left his at his residence unattended, due to him only going a few blocks away to visit a friend. Deputy Shaw responded to Deaquino's residence and located unattended alone in the home sleeping. Deputy Shaw made with the Florida Department of Children and Family's (DCF) informing them of the incident as well as the child's grandmother who arrived to the residence and took custody of the child.
At the jail, Deputy Rodriguez requested Deaquino to submit to a lawful test of his breath for the purpose of determining its alcohol content. Deaquino refused to provide a breath sample. After being read implied consent, Deaquino still refused to provide a breath sample.

NARRATIVE

NARRATIVE

On Monday, May 19th, 2025 at 0122 hours, I responded to McDonalds, located at 9495 108th Avenue, in reference to a trespassing incident. Prior to arrival, Public Safety Dispatch advised the complainant stated a black male subject, who was later identified as Gregory Brown, was inside the establishment causing a disturbance. Public Safety Dispatch further advised the Brown was asked to leave several times by the manager however he refused to leave.

Upon arrival, I made contact with the complainant, identified as Tabitha Lydick. Lydick stated that she attended to Brown when he initially entered the establishment. Lydick stated that Brown attempted to purchase a sweet tea because his sugar was low however his debit card declined five times. Lydick stated she gave Brown the sweet tea for free to assist him with his troubles. Lydick stated Brown came back to the establishment twenty minutes later to order food inside the establishment. While Lydick was attending to Brown, he became verbally aggressive and stated he was upset with her attitude when she previously attended to him.

Lydick and her manager, identified as Alba Aparicio, proceeded to tell Brown to leave the establishment several times however he would not. Lydick stated Brown continued to stay inside the establishment when she called Law Enforcement. Lydick advised she wished to pursue charges against Brown for trespassing.

I then made contact with Aparicio and another employee, identified as Ashley Wilson. Both subjects stated they instructed Brown to leave the establishment however he did not listen and continued to argue with them.

I then made contact with Brown who was standing outside the front door of the establishment. Brown openly stated he was upset with employees because they did not want to give him his food until Law Enforcement arrived. I proceeded to place Brown in handcuffs and in the back of my marked patrol vehicle.

Due to the above mentioned, I criminally charged Brown with the following charges:

F.S.S 810.08(2)(A) Trespassing on property

Brown was transported to the Indian River County Jail without further incident.
