NARRATIVE

On 01/13/2025 at 2003 hours, I, Deputy Austin Binner, responded to a domestic disturbance, located at [REDACTED]. The incident involved Tracy A Pyke and her husband Ronald J Pyke. Both parties stated they live at the location, and are currently married.

Upon arrival, I made contact with Tracy at the front porch on the West side of the residence. Tracy was outside by herself sitting in a chair. During the initial contact with Tracy her physical appearance showed that she had been recently crying, and she was soft spoken.

Tracy stated she and her husband Ronald Pyke, are in the process of divorcing each other. Tracy advised she and Ronald have continuously been verbally arguing in relation of each of their daughters, which has no relevance in regard to this investigation. Both parties stated they do not share children together, and no one else resides at the location.

Tracy stated on 01/13/2025 she and Ronald continue to verbally argue in regard to both of their daughters. Tracy stated the incident occurred on the front porch, where I made contact with Tracy. Tracy stated during the verbal altercation, Ronald was sitting in a chair, and she was standing in front of Ronald. Tracy stated she continued to argue with Ronald pointing her finger in his direction, while standing close to him while he sat. Tracy visually motioned as an example of what had occurred, by raising her left hand displaying that she was going to slap Ronald. Tracy stated after pointing at Ronald she slapped the right side of his face. Tracy advised Ronald pushed her away from him once he was slapped while sitting. Tracy stated she did not fall when Ronald pushed her. Tracy advised Ronald then slapped her, and walked inside the house. Tracy stated both parties threatened to call law enforcement to respond, and Tracy stated she eventually called for law enforcement to respond.

Ronald advised he and Tracy were having a continuous argument in regard to their daughters. Ronald stated on 01/13/2025 the argument continued on the front porch at their residence. Ronald stated during the verbal argument, he sat in a chair while Tracy stood in front of where he sat, yelling and pointing at him. Ronald stated profanities were said of each other's daughters, and Tracy had slapped him in the face with her left hand, striking the right side of Ronald's face. Ronald advised in self-defense he had pushed Tracy to get away from her, and he had retreated into the residence.

At the scene, Ronald had a visible red mark on the right side of his face concurrent with both parties' statements. Tracy had no visible markings on her face to signify that Ronald had slapped her. I determined Tracy is the primary aggressor in this investigation. Tracy was taken into custody without incident and transported to Indian River County Jail for the following charge.

**NARRATIVE**

On January 13th, 2024, at approximately 2252 hours, I observed a black Harley-Davidson motorcycle bearing NY tag 514BD2 travelling Southbound on U.S. Hwy 1. Due to the tag on the vehicle having no operable white light illuminating it pursuant to F.S.S. 316.221(2), I conducted a stop on the motorcycle.

Upon approach to the motorcycle, I made contact with Brian Schroeder. As I began to question Brian, I asked if there was anything illegal on his person to which he stated no. Brian began to change his statement when I asked what I would find if I did find illegal narcotics, to which he became more open to the questioning and advised he had a pipe on his person and a baggie of methamphetamine.

Upon a probable cause search of Brian's person, I located a small, clear plastic baggie with a white crystalline substance inside of it in the right front pocket of his jeans. This substance would field test positive for methamphetamine.

Due to Brian possessing the methamphetamine on his person, probable cause was found for F.S.S. 893.13, possession of a controlled substance.






On 01/13/2025 at 1956 hours, I, Ofc. Kuehn, responded to \_\_\_\_\_ in reference to a disturbance. Vero Beach Police Telecommunications advised a male could be heard in the background screaming at a female and the caller advised the male hit her mother. Upon arrival, I along with other responding Officer's, approached the aforementioned residence and I could clearly hear from outside what appeared to be a verbal altercation coming from inside. Due to the caller informing dispatch that a physical altercation had occurred, the front door to the residence was opened at which time, I observed a Hispanic male being restrained by two females. The Hispanic male who was later identified as Sergio Armando Ramirez Lopez (DOB: 11/18/1986) was order to exit the residence and detained into handcuffs.

It should be noted that I responded to this location earlier tonight. On 01/13/2025 at 1850 hours (CFS# 011325-78), I responded to the same location \_\_\_\_\_. According to Vero Beach Police Telecommunications, a female was on the phone and then hung up, upon call back the phone was answered but nobody could be heard talking, then a female voice possibly a child stated "come right now, male hurting mom." Upon arrival to the aforementioned residence, I made contact with a Kaylanie Ramirez (DOB: 11/29/2010), her sister Isabella Ramirez (DOB:11/18/2008) and their mother Jacquelyn Ramirez (DOB: 05/05/1986) along with the father Sergio Ramirez. Once on scene, after speaking with juvenile's "KR" and "IR" it was determined that a verbal altercation had occurred between Jacquelyn and there father Sergio. On scene, I was shown a video recored on a cell phone of Sergio standing inside the front entrance to the residence yelling at Jacquelyn who was outside. In the video, Sergio accuses Jacquelyn of having an affair. In the video, Sergio is seen several times making the statement that if Jacquelyn enters the residence he will go to prison. After speaking with all parties involved it was determined no criminal activity occurred and both Jacquelyn and Sergio were told to separate for the night.

It should be noted that Sergio Armando Ramirez Lopez and Jacquelyn Lori Ramirez are married and have three children in common.

The first call for service was cleared at 1945 hours on 01/13/2025 and approximately ten minutes later at 1956 hours, I received the second call for service at the same location.

On scene, after Sergio was detained, I made contact with Jacquelyn. According to Jacquelyn after the police left the residence for the first call for service, she was inside the residence cleaning up after her youngest daughter. Jacquelyn stated while cleaning up she was approached by Sergio who attempted to instigate another verbal argument. Jacquelyn stated she attempted to remove herself from the argument by backing away however Sergio continued to advance on her and eventually backed her into a wall. Jacquelyn informed me that while Sergio was standing within an arms length of her he made the statement of "I could smash your face." Jacquelyn stated she was not fearful that Sergio would act on his threat.

After speaking with Jacquelyn, I made contact with her daughter "KR." "KR" informed me that she witnessed the altercation between her mother Jacquelyn and her father Sergio. While speaking with "KR" she informed me that she witnessed her father kick her mother and that the altercation was recorded on video. Upon viewing the video, I observe Jacquelyn who appears to be seated on a couch, Sergio is standing in front of her while being restrained by his daughters "KR" and "IR." In the video, I observed Sergio kick Jacquelyn several times, striking her in the upper shin or thigh area.

I also spoke with "IR" who gave a similar account of what occurred as her sister "KR."

After speaking with "IR" I made contact with Jacquelyn again. While speaking with Jacquelyn she informed me that Sergio was kicking at her however she did not believe she was kicked.

After speaking with Jacquelyn and her daughters, I made contact with Sergio and informed him he was under arrest for Battery (Domestic Violence) in violation of F.S.S 784.03(1a1).

This incident was captured on body worn camera and later downloaded into a secure file at the Vero Beach Police Department.

On 01/13/2025, at 11:35 hours, I was sitting stationary at the light located at 10th Avenue and 21st Street. As the light cycled to green, I observed a black Lexus SUV (FL tag #HYZI75) travel through the intersection at a speed that was well below the speed limit. I observed that the Lexus was traveling so slow that it hindered the flow of southbound traffic attempting to go through the intersection. The vehicle then conducted a slow right hand turn into the Citgo gas station (located at 1005 21st Street). As the vehicle entered the parking lot, I observed that the vehicle had an expired registration dated from April of 2024.

I circled around and conducted a traffic stop on the aforementioned vehicle. I then made contact with the sole occupant, Stacey Whitfield. Mrs. Whitfield was sitting behind the steering wheel as her car was idling in front of the gas station. I observed that Mrs. Whitfield had bloodshot, glassy eyes, and I could smell a strong odor of an alcoholic beverage emanating from her person. In plain view from the driver's side window, I observed a large box of "Natural Light" beer in the front passenger compartment. Several of the beer cans were opened and discarded within the immediate reach of Mrs. Whitfield. I informed Mrs. Whitfield the reasons for my stop and I requested for her to provide me with her documentation. While speaking with Mrs. Whitfield, I noted that her speech was mumbled and that she would slur her words.

I had suspicion that Mrs. Whitfield was under the influence of alcohol and I requested that she step out of her vehicle to speak with me. When Mrs. Whitfield exited her vehicle, I observed that she had to support herself by holding onto the side of her car. I walked Mrs. Whitfield to the front of my agency vehicle and attempted to assess her eyes. While speaking to Mrs. Whitfield, I could still smell a moderate odor of an alcoholic beverage emanating from her person as she stood a few feet away.

I attempted to assess Mrs. Whitfield's eyes but she repeatedly failed to follow my instructions. Mrs. Whitfield would not maintain focus on my finger as I attempted to check her eyes. Mrs. Whitfield would repeatedly follow with her head, and would even stop performing the exercise entirely. My suspicion increased and I subsequently read Mrs. Whitfield her Miranda warning off an agency issued card. Post Miranda, Mrs. Whitfield advised me that she understood her rights and spoke with me.

Mrs. Whitfield claimed that she did not recently consume any alcohol. I informed Mrs. Whitfield that I had suspicion that she was under the influence of alcohol and that I would be conducting an investigation. I then requested Mrs. Whitfield to perform standardized field sobriety tests to determine if she could safely operate a motor vehicle. Mrs. Whitfield agreed. Mrs. Whitfield advised me that she did not have any medical conditions [REDACTED] I advised the defendant that she would attempt the exercises to the best of her abilities and I would document the information she provided me.

I then explained and demonstrated each exercise individually before having Mrs. Whitfield perform them. I additionally had Mrs. Whitfield acknowledge that she understood each exercise before having her perform them. I observed the following:

**Horizontal Gaze Nystagmus:**

- Resting nystagmus was not present and Mrs. Whitfield's pupils were equal size
- I did observe the lack of smooth pursuit in both eyes.
- Mrs. Whitfield repeatedly failed to follow instructions and I could not have her maintain eye positioning to observe distinct and sustained nystagmus at maximum deviation.
- Mrs. Whitfield followed with her head.
- The onset of nystagmus prior to 45 degrees was observed.

**Walk and Turn:**

- Mrs. Whitfield repeatedly failed to follow instructions.
- Mrs. Whitfield attempted to start the exercise before being instructed to do so multiple times.
- Mrs. Whitfield did not maintain the starting position.
- Mrs. Whitfield did not touch her heel to her toes on any of her steps.
- Mrs. Whitfield stepped off the line multiple times.
- Mrs. Whitfield did not count her steps aloud as she performed the exercise.
- Mrs. Whitfield conducted nine steps forward, an improper turn, and then exceeded nine steps on the way back.
- Mrs. Whitfield used her arms for balance.

**One Leg Stand:**

- Mrs. Whitfield repeatedly failed to follow instructions.
- Mrs. Whitfield attempted to start the exercise before being instructed to do so multiple times.
- Mrs. Whitfield could not maintain her foot in an elevated position.
- Mrs. Whitfield failed to count aloud while performing the exercise.
- Mrs. Whitfield failed to maintain her balance and repeatedly returned her foot onto the ground.
- Mrs. Whitfield switched her elevated foot back and forth between her left and right leg.

The entirety of the exercises were captured on my body worn camera.
