The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On 07/15/2025 at 14:53 (Specifically include facts constituting cause for arrest.)

Defendant Donovan Fitzgerald Lucas violated Florida State Statute 812.014(2)(e) by knowingly and intentionally passing the point of sale without purchasing \$225.89 worth of groceries from Walmart located at 1750 US Hwy 1, Vero Beach, Florida 32960 at 8:45pm on July 14, 2025 and returning to the store on July 15, 2025 and attempting to walk past the point of sale again with more items until met by the police. He permanently deprived Walmart of those items.

On July 15, 2025 I responded to a call at the Neighborhood Walmart located at 1750 US Highway 1, Vero Beach, Florida 32960 in reference to a male and female currently in the store shoplifting again, attempting to walk past the point of sale with items not purchased until met by Police. The male and female were there the night before and were observed on the Walmart security camera's taking \$225.89 worth of groceries at 8:45pm. The Loss Prevention officer Carlos Molina was notified of the theft when he arrived at work this morning by the overnight technician. As Molina was reviewing the footage he was alerted to see the couple again in the store shopping. Molina provided footage of Donovan Fitzgerald Lucas walking past the point of sale with a cart of groceries after using his Walmart shop and go application on his phone. Molina explained to me when using that app, it alerts you in real time that the transaction went through and you may now exit the store and provides a receipt. Lucas did not receive that message nor the receipt and proceeded to exit the store with the items.

I read Donovan Lucas his miranda rights which he waived and stated he would speak with me. Lucas stated that he did use his Snap and Go app however the transaction did not go through. Lucas stated that he did walk out of the store with the items, however did not tell his wife that was with him that the purchase was not successful. Lucas stated he did not want to tell her because he was embarrassed.

Loss Prevention Officer Carlos Molina provided a receipt of the items that were taken and a disk of the footage of the theft.

Donavan Fitzgerald Lucas was taken into custody, patted down and searched, and placed into the rear of my patrol car. Lucas was transported to the Indian River County Jail without incident.

Loss Prevention Carlos Molina provided a sworn written statement.

A trespass warning was issued to Donovan Fitzgerald Lucas and his wife Monica K Barton for one year.

My BWC was active during this entire investigation.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On 07/15/2025, at 13:41 (Specifically include facts constituting cause for arrest.)

On July 15th, 2025, at approximately 1329 hours, I observed a white male on a bicycle who I recognized as Dustin Greer, traveling eastbound in the 700 block of Sebastian Boulevard. I had knowledge of Dustin having an active Civil Order for Arrest warrant in reference to Failure to Pay Child Support (WARRANT #20131507, BOND \$1,500) which was confirmed by Sebastian Communications. I followed the male and made contact with him at the intersection of Georgia Boulevard and south Wimbrow Drive.


I approached Dustin and asked him if he would speak to me, to which he stopped his bike and spoke with me. Upon confirming his identity, by asking if his name was Dustin Greer which he stated it was, he was immediately placed into mechanical restraints. Dustin was ultimately placed under arrest upon receiving confirmation of the warrant.
