NARRATIVE

On July 11<sup>th</sup>, 2024, at approximately 2300 hours, while stationary at the 1800 block of US Highway 1 SW facing south, I observed a black SUV traveling at a high rate of speed northbound. I estimated the vehicle to have been traveling at 70MPH and activated my Stalker 2x radar. The radar gave me a reading of 71MPH with a clear and concise Doppler tone. The posted speed limit was 50 MPH.

I followed the black Ford SUV which had Florida tag DH70 and conducted a traffic stop at the 400 block 9<sup>th</sup> Street SW. Upon making contact with the vehicle, the driver provided me with a Florida driver's license identifying herself as Brianna Duffy. As I spoke to Duffy, I smelled the odor of marijuana emanating from inside of the vehicle. I asked the Duffy and her passenger if there was anything illegal in the vehicle. The passenger stated he had marijuana in his backpack. I asked Duffy and the passenger if they had a medical marijuana card. Both stated no.

Upon searching the vehicle, I located a black Adidas backpack on the driver's seat. This backpack was the same one I observed Duffy sitting next to while she was in the driver's seat. Inside the backpack, I located one sublingual film of Suboxone. Suboxone is a schedule three controlled substance. There was also a plastic bag containing less than twenty grams of marijuana in the same backpack.

I read Duffy Miranda Warnings which she verbally stated she understood. Post Miranda, Duffy stated the Adidas backpack belonged to her. Duffy admitted to having possession of the Suboxone which she said belonged to a friend of hers. Duffy admitted to not having a prescription for the Suboxone.

During the time of this arrest, Duffy was under Florida probation supervised release for Aggravated Child Abuse.

NARRATIVE

On the evening of 07/11/24, I responded to 13527 US 1 in reference to a suspicious incident. While traveling to the location, dispatch advised of a subject passed out behind the wheel of a vehicle in the parking lot. I then called the complainant on the phone who advised she had seen the vehicle in the parking lot, with the engine running and the sole occupant a male passed out in the driver's seat. She told me she was unsure of how long the subject had been there but she had not seen him move.

Upon my arrival to the location, I observed a red in color four door sedan in the parking lot with the headlights on. As I got closer to the vehicle, I observed a white male in the driver's seat and he appeared to be "passed out" or asleep. The vehicle was not properly parked and was halfway out of the parking stall and the engine was running. Prior to making contact with the driver, I placed my agency issued stop-sticks in front of the vehicle for safety purposes in case the subject attempted to flee upon my waking him. Once the stop-sticks were deployed, I made my way to the driver's door where the window was down, I could smell the strong odor of an alcoholic beverage emitting from within the vehicle. I was able to safely reach in the vehicle and turn the engine off without the subject stirring. I then shook him and called out to him at which time he woke up. When the subject later identified as Troy Depalmenary woke up he looked at me and said "oh shit!" He immediately reached to the center console cup holder area and grabbed and open Yuengling beer can and attempted to hide it from me. The beer still had condensation on the exterior. I asked Troy for his driver's license and he stated he did not have one. I asked if it was suspended or if he had ever had one issued. He stated he never had one. I asked him if he had a state issued identification card and he stated yes. He continued to search the passenger seat, center console, and the Burger King bag. While he was doing this, I observed a small black credit card holder in the passenger seat with a green bank card clearly visible. Troy reached passed this hold several times. I asked him what he was looking for and he said his wallet, so I pointed it out to him in the passenger seat. He retrieved the wallet and attempted to hand me a bank card instead of his ID. I told him I needed the ID and not the bank card and he was finally able to give it to me. I asked him how much he had to drink and he stated just one and pointed back to the open beer can. While I spoke with Troy his speech was mumbled and slightly slurred. His eyes were red, glassy, and bloodshot.

I asked Troy to exit the vehicle and once he was outside the vehicle, I was able to get closer and observed the strong odor of an alcoholic beverage emitting from his person and breath as he spoke. I asked him if he would be willing to perform a series of Standardized Field Sobriety Exercises to which he stated "I'm good." I asked him if that meant he would or would not perform the exercises, and he stated he would not pass them due to being tired. I continued to speak with Troy about the circumstances in which I had made contact with him as well as my observations, and again asked him if he would be willing to perform the series of Standardized Field Sobriety Exercises, I was requesting. He stated no, I will not pass them. He also made the spontaneous utterance of "I know I fucked up."

Based upon my observations, I placed Troy under arrest for DUI. He was transported to the Indian River County Jail for processing. Once at the jail he was met by Corrections Deputy N. Rentas who requested him to submit to a chemical breath test to determine its alcohol content. Troy submitted to the test and the results were .153, .176, and .155% BrAC. He was further processed and held in lieu of a \$1,000 bond.

NARRATIVE

On 07/10/24, I responded to 555 4th Street, Woodlawn Mobile Home Park, in reference to a disturbance. Dispatch stated that the caller was at the clubhouse and that another resident, Joshua Henkel, had tried to hit him with his car.

Upon my arrival, I made contact with Daniel Proper (maintenance manager) at the clubhouse, and he advised me of the following: He was at the clubhouse/pool around 9:45 PM, waiting to lock it up at 10:00 PM. While waiting, a resident known to him as Josh asked him why he was sitting alone. He stated that he told Joshua he was waiting until 10:00 PM to lock up the gates. Once he advised Joshua of this, Joshua became irate and told him that he does not control him and that he will come to the clubhouse when he wants. Daniel stated that there were cameras there now and that Joshua would get banned from the clubhouse for violating the rules. He stated that Joshua continued being irate with him, so he walked out front to call the property manager, Cumi Newhouse. While out front, Joshua exited the clubhouse, walked to his vehicle, and, as he was getting in his car, stated, "Better get out of the middle of the fuckin' road or I'm going to run your ass over." Daniel was standing approximately five parking spots away when Joshua made this statement. Joshua then entered his vehicle, backed out of the spot, and put it in drive, accelerating towards Daniel's position and coming within approximately six feet of him. Daniel stated he was in fear for his life, and you can see him on camera running out of the way to avoid being struck by the vehicle. Joshua came to a stop, and as Daniel ran around towards the back of the vehicle to get the tag, Joshua exited his vehicle, then got back in his vehicle, and left the clubhouse.

I then reviewed the video, which depicted the above incident. The video also had audio, which I could hear the statement Joshua made to Daniel about running him over. It should be noted that the direction Joshua drove was directly towards Daniel, where he was standing. Also, the direction he drove was not on the street but through parking lanes which led up to a mulch bed with a flagpole, multiple concrete planters, and a metal bench.

I spoke with Cumi Newhouse (property manager), who advised me of the following: She received a call from Daniel in regards to Joshua Henkel being at the clubhouse/pool and causing an issue. She stated that Daniel advised her that Joshua tried to run him over. Cumi advised that she received a call from Joshua at 10:19 PM asking her if the cops were called, and she told him "yes" because he tried to run Daniel over. Joshua advised her that he just did a 3-point turn and did not try to run him over. Cumi then disconnected with Joshua upon my arrival.

Deputies attempted to make contact with Joshua at his residence but were met with negative results. I attempted to call Joshua but was also met with negative results.

On 07/11/24, I responded back to Joshua's residence and was able to make contact with him. I asked him to explain the incident that occurred at the clubhouse last night, and he stated the following: He went to the clubhouse for a quick dip in the pool, and while he was there, he came into contact with the maintenance manager (Daniel Proper). He stated that he got into an argument with the manager over being told that the pool was closing. Joshua stated that he then exited the property, had a friend from Pointe West come pick him up,
