NARRATIVE

On Monday, June 1, 2026, at approximately 1939 hours, I, Deputy M. Neill #6317 responded to the intersection of 13th Street SW and 43rd Avenue SW, Vero Beach, Indian River County, Florida.

At the time, Deputy Edgar was attempting to located Mr. Roger Lopez as he was the suspect in a Assault – Domestic Violence case, which he was investigating under case number 2026-57994. The victim in this case alleged that Mr. Lopez threatened her and acted as if he was going to punch her.

Utilizing FLOCK, I observed that Mr. Lopez's registered vehicle, a 2015 Volkswagen GTI, bearing Florida tag PXUX29, last hit FLOCK at 43rd Avenue at the St. Lucie County / Indian River County Line at 1811 hours going northbound. I originally searched around the Publix shopping center at 43rd Avenue SW and Oslo Road, but was not able to locate Mr. Lopez. Later, Deputy Edgar notified me that he had received information that Mr. Lopez had broken down somewhere on 43rd Avenue SW.

I responded down 43rd Avenue SW until I approached 13th Street SW. This is where I met a construction area with three very large "Road Closed" signs. A black Volkswagen GTI was sitting on the other side of the signs.

As Deputy Edgar and I approached the vehicle, Mr. Lopez exited the vehicle from the driver's side door. While he was exiting, he was unsteady on his feet and used the vehicle for balance.

When asked what he was doing in the construction area, Mr. Lopez stated that he was having vehicle troubles due to his vehicle overheating. I walked around Mr. Lopez's vehicle. He had a flat front left tire, and leaked all of the oil out of his engine.

Deputy Edgar questioned Mr. Lopez about his investigation. While doing so, I walked the immediate area around Mr. Lopez's vehicle. While doing so, I could see that Mr. Lopez was traveling northbound on 43rd Avenue SW. There was a ten-foot section that was milled up, so there was a 4-inch difference between the roadway and the milled-out section. Mr. Lopez drove over the section which resulted in the roadway disabling his vehicle. There was an oil trail as well engine pieces between the milled out roadway and his vehicle.

Once Deputy Edgar was done questioning Mr. Lopez about his case, I started a crash investigation. Mr. Lopez stated that he was on 58th Avenue SW traveling northbound at 30MPH when he went around the road closed sign, because he always takes this roadway home. He ended up hitting that milled out part of the roadway which resulted in a flat tire. Mr. Lopez had already called a tow truck which had arrived just after we arrived on scene.

While speaking to Mr. Lopez, he had the odor of an alcoholic beverage emitting from his breath, he was slurring his speech, making incomplete sentences, remained unsteady on his feet, used his vehicle for balance, had a poor dexterity using his phone, had mood swings while speaking to him, and appeared to have a wet mark on the front and back of his pants consistent with someone urinating themselves.

NARRATIVE (Continuation)

Once the crash investigation was complete, I advised Mr. Lopez that the criminal investigation for DUI was now commencing. Mr. Lopez became argumentative on scene, and started to yell and scream at deputies. Mr. Lopez was advised of his Miranda Rights. He denied wanting to speak to us without a lawyer present. I then requested that Mr. Lopez perform Standardized Field Sobriety Exercises (SFSE's). Mr. Lopez refused. I advised Mr. Lopez that his refusal to perform SFSE's could be used against him in court. He responded to my statement with stating he would not provide an answer as if he understood or not. I then asked him again if he was willing to perform SFSE's. He responded back with stating no.

I placed Mr. Lopez under arrest for DUI. He was secured in handcuffs which were checked for proper fit and double locked.

At the time of this incident, the Indian River County Intoxilyzer's were down and unavailable. This was due to an IT issue where they would not transmit data out. I called a couple of other agencies to see if they were available with either a Mobile Intoxilyzer or one at the station. Neither FWC or Palm Bay PD had one available. Prior to calling more agencies, I asked Mr. Lopez if he would be willing to submit to a lawful test of his breath. He refused. He was advised of Implied Consent. After being advised of Implied Consent, he stated "Suspend that shit", referring to his license.

Mr. Lopez was transported to the Indian River County Jail for booking.

Per DAVID, Mr. Lopez has a prior DUI from 2006, out of Brevard County. He was issued citation 8196XAD. He was also issued a Refusal to Submit to Breath/urine/Blood on the same case, reference the same citation number.

Based on the above information, I believe there is probable cause to arrest Mr. Roger Lopez for Driving Under the Influence, pursuant to FSS 316.193.1a, and for Refusing to submit to a lawful test of his Breath/Urine/Blood 2nd Offense, pursuant to FS 316.1939.

NARRATIVE

On June 01, 2026, at 19:46 hours, I Deputy D. Coon #6379 responded to 545 21st Ave at Indian River County in reference to a Disturbance call. The complainant, Kyle John Simons, was initially outside on 22nd Ave when he heard a loud skirmish nearby. He walked closer to the source and observed a male throwing chairs on the back patio of a home on 21st Ave. The hysterical male was involved in a heated argument with at least one female subject. Kyle added that he could hear female prompting the male to "Leave!" Kyle directed responding deputies to that home.



Upon arrival 545 21st Ave, I met with Azpen Erin Marie Murray. Azpen is the victim, and she swore verbally to the following in statement in summary:

Azpen is a [REDACTED] resident, who is vacationing in Vero Beach with her family and friends. Her boyfriend, Damian Ray King, was present. They have been dating for approximately five years and have a 3-year-old child (Camden Aaron King) in common. Also vacationing with the family is Azpen's friend, Comasia Anjali Blue. The group had rented the 21st Ave home for approximately one week and were planning to return to North Carolina tomorrow. Damien had been drinking this afternoon. A family argument erupted on the back patio, and it dramatically escalated. Damian began throwing patio chairs and pushing the patio table in a drunken tantrum. Azpen argued in return and remembers throwing objects in protest of Damian's antics. Azpen had a half-dollar-sized scalp hematoma on her left temple, just beside her left eye. The area was reddened and slightly puffy. Her left, pearl earring was also missing. Deputies also noticed that Azpen had red blotches across her front neck area, with a small scratch on the front-left neck area. I photographed her injuries. Azpen declined medical attention, and she stated that she did not recall exactly how her injuries occurred. Azpen denied striking Damian with any chair/objects or touching him in anyway. Furthermore, Azpen stated that Damian did not directly strike her with any chair/object or strike/kick/push her in any way. Azpen informed deputies that she is fourteen weeks pregnant, and she and Damian (together) have already seen a physician for her prenatal care. She stated that she does not want to press charges against Damian.

I then interviewed Azpen's friend, Comasia Anjali Blue. Comasia swore verbally to the following statement in summary:

Comasia accompanied the family to Vero Beach for vacation as Azpen mentioned. Comasia was inside the living room and with 3-year-old Camden Aaron King. Comasia acknowledged the Damian had been inebriated and apparently became upset about family business. An argument then erupted between the parents on the back patio. Comasia opened the sliding glass door and exited, but her attention was divided between the quarreling couple and their 3-year-old child. Comasia observed Damian throwing a patio chair towards the pool and in the direction of Azpen. Comasia also observed Azpen throwing a smaller object in protest. Comasia did not see either parent strike one another. Comasia did not become physically involved in the quarrel and suffered no injuries.

I then attempted to interview Damian Ray King. Damian was extremely intoxicated and could not focus on my direct line of questioning. He was crying and intermittently emotional. At one point, Damian grew frustrated with the interview and punched the concrete floor. He acknowledged his long-term relationship with Azpen and their child in common. Additionally, Damian informed me that Azpen is pregnant with his child; he said he has accompanied her on a related visit to her doctor. Damian denied throwing any chairs/objects and added that Azpen also did not throw any chairs/objects. No violence occurred between them. He could not explain how Azpen developed a distinct hematoma to her left temple. I photographed his face/hands/torso, but I did not observe any injuries or trauma. Damian declined medical attention.

Based on my investigation, it was determined that domestic violence had occurred. Accounts from witnesses and the injuries sustained indicate that Damian Ray King was the primary aggressor against his pregnant common-law wife. There is probable cause that Damian unlawfully committed Aggravated Battery (domestic violence on pregnant

NARRATIVE

On June 1st, 2026, at approximately 2332 hours, I was stationary in the area of 11000 US Highway 1, Sebastian, Florida.

At that time, I witnessed a silver Honda Civic (bearing FL tag 39ETEQ) traveling southbound on US Highway 1 at a high rate of speed - I visually estimated the vehicle to be traveling 70 miles an hour in a 50 mile an hour zone. Utilizing my Stalker DSR 2X radar (S/N: DF002876), it displayed a speed of 73 miles an hour, and emitted a tone consistent with that speed.

As I attempted to catch up to the Honda Civic, it quickly turned right into the plaza at 10725 US Highway 1, Sebastian. I subsequently conducted a traffic stop on the vehicle in that area. I then made contact with the driver, and sole occupant, Ms. Rachel Baker, who I identified by her Florida-issued driver's license. While speaking with Ms. Baker, she had slurred speech and glassy, watery eyes. Ms. Baker stated she was headed to a friend's house in Vero Beach.

Based on my observations, I requested Ms. Baker perform Standardized Field Sobriety Exercises (SFSE's), and Ms. Baker stated she would perform them. During the medical questionnaire, Ms. Baker stated she is prescribed [REDACTED] and a [REDACTED]. She explained that she took the [REDACTED] the day before, and she took the [REDACTED] however, she could not advise when she took it.

The first exercise was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions for the exercise, and Ms. Baker stated she understood. During the exercise, Ms. Baker had a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. Additionally, Ms. Baker had to be reminded multiple times not to move her head and to follow directions.

The next exercise, was the Walk and Turn (WAT) exercise. As I explained the instructions for the exercise, Ms. Baker was unable to keep her balance. After finishing the instructions, and demonstrating the exercise, Ms. Baker stated she understood the exercise and did not have any questions. During the exercise, Ms. Baker stepped off line, took the wrong number of steps, missed heel-to-toe, and made an improper turn.

The third exercise was the One Leg Stand (OLS) exercise. I explained the instructions and demonstrated it for Ms. Baker. She stated she understood and did not have any questions. During the exercise, Ms. Baker put her foot down numerous times and almost fell over. Additionally, she changed what foot she was using.

The fourth exercise was the Modified Romberg Balance exercise. I explained the instructions for Ms. Baker and she stated she understood and did not have any questions. During the exercise, Ms. Baker was swaying and estimated 30 seconds had elapsed after approximately 101 seconds.

Based on my observations, Ms. Baker was placed under arrest for the offense of DUI. She was placed into handcuffs that were checked for proper fit and double-locked. After being placed in my patrol car and seatbelted, Ms. Baker began banging the back window area. At that time, it was discovered Ms. Baker removed her seatbelt and her handcuffs. She was subsequently re-secured.
