NARRATIVE

On July 25th, 2024, at approximately 0109 hours, I was patrolling the neighborhood, Paradise Park. While driving past the residence of 8637 22nd Street, I observed a blue in color Nissan sedan, bearing Florida license plate, QTHB35, with the rear passenger door wide open.

I notified dispatch of the open door. Due to car burglaries rising in the area, I approached in attempt to find out why the door was opened. As I approached the driver side of the vehicle, I observed a white female slumped over in the back seat. I began to knock on the window with my flashlight in attempt to wake her up. The female did not move, which in turn, I knocked harder. The female still did not respond, so I approached the passenger side of the vehicle. I had to shake the female to gain her attention. I advised the female it was the sheriff's office. The female began to wake up. The female was able to tell me her name, Michele, but did not know where she was. The female stated she did not want rescue to make sure she was okay. I asked the female if this was her vehicle, at first she stated yes. I asked the female if she took anything today, she stated no. I asked the female if there was anything illegal in the vehicle, she stated no. The female then stated this was not her vehicle.

While speaking with the female, she attempted to conceal a small purse underneath her. The female then reached towards a bag, which is when I told her not to reach for anything. I asked the female if there was anything in the bags, she replied no. The female advised I could search the backpack, but the small purse was not hers. I had the female exit the vehicle and the female consented to a search of her person. Once the female was searched, the registered owner exited the residence, which is when she consented to a search of the area where the female was sitting. While searching the area, I opened the small purse she was earlier trying to conceal. Inside the purse was a Florida driver's license with the name Michele Imbro, with the photograph matching the female, multiple cards with the name Michele Imbro, and two bags with clear crystal rock like substance, which I know to be Methamphetamine.

Due to what was found inside the purse, Imbro was placed into handcuffs and secured in my patrol vehicle. I read Imbro her Miranda Warnings, to which she advised she understood and wished to speak with me. Imbro provided the following statement:

Imbro was only sleeping inside the vehicle. When spoke to about the purse, she advised it was her chain purse. I asked Imbro what the narcotics will test positive for, she advised Methamphetamine. Imbro went back and forth of the chain purse being hers, but when advised all of her cards and ID have her name on it, she did claim it. Imbro even asked about her boyfriend, Jimmy, when she also had his CashApp card in the purse.

I spoke with the registered owner again, Amanda Foley, who advised she does not know Michele well, but they have been trying to wake her up, but they were unsuccessful. Amanda did advise she had permission to be inside her vehicle.

I field tested the clear crystal rock like substance for Methamphetamine, which both bags tested positive for. The bags weighed to be 4.38 grams.

I transported Imbro to the Indian River County Jail for Possession of a Controlled Substance. Imbro received citation number AJ5SFNE for Possession of a Controlled Substance.

This incident was captured on my agency Axon body camera.

NARRATIVE

On July 24th, 2024, at approximately 1634 hours I responded to [REDACTED] in reference to a residential burglary.

Upon arrival, I spoke with one of the victims [REDACTED] Crystal Decker, who advised the following paraphrased: She was in her bathroom when a male she identified as Tamorrio Clark tried entering through her back window by breaking it. I observed glass break in the bathtub as if it was broken in from the outside.

The male then made his way to the front door of the residence where he forced entry into the home and began banging on the bathroom door. According to Crystal, Tamorrio would state, "Bitch, I'm gonna kill you" as he banged on the door. When she threatened to call 911, the male fled. Crystal further advised that Tamorrio was there to find "Lisa," who he believes is having an affair with Andrew.

The owner of the home, Andrew Coffee, would corroborate the fact that his window and door were both broken and that he saw the male he identified as Tamorrio Clark.

Due to both witness statements corroborating the physical evidence at the scene, Tamorrio forcing entry into the residence in two different manners, and the threats to kill while he banged on the door placing Crystal in well-founded fear, probable cause was found for F.S.S. 810.02(2)(a), Burglary with Assault.

Tamorrio was placed into my custody and transported to the Indian River County Jail.

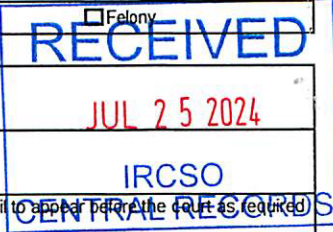

On 07/24/24 I, Ofcr. S. Gonzalez (471), responded to the McDonalds located at 1925 U.S.-1 in the City of Vero Beach, Indian River County, Florida in response to a request for assistance with a possibly impaired driver.

Upon arrival, I observed that the McDonalds appeared to have been closed for business in that the exterior lights were all off. I also observed a white Jeep in the drive through stopped half-way between the drive-thru payment and pick-up windows.

My supervisor informed me that the driver and sole occupant of the vehicle was asleep and that the vehicle was running when initial contact had been made.

I then made contact with Ofcr. W. Brumley (482) who was at the driver side door.

Upon making contact with Ofcr. Brumley, I noted that there was a white make seated in the driver seat behind the steering wheel and he appeared to be asleep or passed out. Also, I note that there was a strong odor of an alcoholic beverage emanating from within the vehicle.

As I looked into the car, Ofcr. Brumley pointed out that there was a "Four Loco" alcoholic beverage in the center console and two empty Four Loco cans in the back seat.

I then observed for myself an unopened Four Loco can in the center console as well as two empty Four Loco cans in the rear pocket of the passenger seat.

I later identified the driver of the vehicle by his Florida license as Bryson Andrew Lasky ("Defendant").

Ofcr. Brumly and I made several attempts to wake but to no avail. The Defendant was initially unresponsive but eventually started to become more responsive as my attempts to rouse him became more rigorous.

The Defendant at one point came to and started honking the car horn before reaching for the gear shift lever in an attempt to what appeared like he was trying to place the car in gear. At which point I was able to get the Defendant to exit the vehicle.

Once out of the vehicle, the Defendant appeared unsteady on his feet and disoriented.

I noted that the Defendant's eyes were red and glassy and sleepy or drowsy in appearance. In addition, I could detect a very strong odor of an alcoholic beverage emanating from the Defendant.

Once out of the vehicle, I directed the Defendant to the rear of the vehicle where I spoke with him as Ofcr. Brumley stood nearby.

During my conversation, I asked the Defendant if he knew where he was to which the Defendant stated that he was in Fort Pierce. I also asked him if he knew what time it was to which he stated that he did not know.

I then asked the Defendant if he would be surprised to know that he was not in Fort Pierce but in Vero Beach to which he stated that he was surprised and had a look of bewilderment when I told him.

When I asked the Defendant where he thought he was in Vero Beach, the Defendant stated Burger King.

PROBABLE CAUSE STATEMENT

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

When I told him he wasn't at Burger King, the Defendant name several fast food restaurants including Wendy's. I subsequently told the Defendant he was at McDonalds.

During the entirety of my conversation, the Defendant appeared unsteady on his feet, his speech was slow and he further appeared confused and disoriented.

Based on the foregoing, I informed the Defendant that based on my observations, I had a concern that he might be impaired and wanted to give him the opportunity to dispel that concern by performing Field Sobriety Exercised ("FSE's").

Before beginning, I confirmed with the Defendant that he did not have any injuries, illnesses or disabilities and was not taking any prescription medication. However, the Defendant stated that he had "an in-grown toe" for about a year; however, I further confirmed that he did not use a cane or crutches as a result.

I then administered Field Sobriety Exercises ("FSE's")

The area was well lit and the ground was level and free of debris. An approximately 10 ft. length of masking tape was used for the walk and turn.

HGN (Horizontal Gaze Nystagmus)

The instructions were explained to the Defendant who stated that he understood them.

- Noticeable back & forth sway;
- Unsteadiness;
- Eyes red and glassy/watery;
- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes).

ONE LEG STAND (OLS) The instructions were explained to the Defendant who stated that he understood them.

- Noticeable sway during instruction phase;
- Left leg up
- Unable to maintain balance;
- Raised arms from his sides greater than 6 inches for balance;
- Failed to raise leg as instructed;
- Failed to count aloud as instructed;
- Hopped and lost balance.

WALK AND TURN (WAT) The instructions were explained to the Defendant who stated that he understood them.

- Noticeable sway during instruction phase;
- Stepped off line during instruction phase while exercise demonstration;
- Missed heel-to-toe throughout the entire exercise;
- Stepped off line on step 7 outbound;
- Stumble on step 7 to 8 outbound;
- Missed heal-to-toe and stumbled on step 8;
- Too many steps (10) outbound;
- Improper turn (turned other than as instructed);
- Stumbled and missed heal-to-toe on steps 1 through 6 (return);
- Stepped off / walked next to line 7 through 10;
- Too many steps (10) on return.

Based on the foregoing, I placed the Defendant under arrest for DUI and informed him accordingly.

The Defendant was transported to the Indian River County Jail for the administration of a breath test and booking.

On 7/24/2024, I was wearing full Sebastian Police Road Patrol attire driving a marked SPD Patrol vehicle when I responded to assist another officer at 1405 Indian River Drive (Earl's Hideaway) in reference to several heavily intoxicated subjects. On my arrival, I made contact with Corporal Singh who advised the male (Defendant) Carmino Giannone became highly agitated from simply his presence and approached him in an aggressive manner but since calmed down. A short while later while trying to figure out a ride away from the bar, Giannone apologized to Corporal Singh for his conduct. It should be noted, Giannone is approximately 6'1" and 280 pounds.

Both Giannone and Giannone's mother were present and heavily intoxicated. Giannone had a strong odor of alcoholic beverage emitting from his breath as he spoke and had slurred speech. While the two were waiting for their ride, Giannone's mother fell over several times into the bushes due to her heavy intoxication. Giannone initially grabbed hold of his mother's arm in an attempt to escort her to a chair inside the establishment however the doors were closed and it was unsuccessful. Giannone's mother was placed in a seated position on a pylon by him in the same spot she was previously falling over into the bushes. Giannone's mother attempted to stand up which cause Giannone to now visibly become more agitated. Giannone put his hand on his mother's upper chest and pushed her onto the pylon telling her to "Sit the fuck down". Giannone's mother moved his hand away and attempted to stand up again which he responded by placing his hand on the base of her neck and once yelling, telling her to "Sit the fuck down".

At this point it was apparent Giannone was becoming increasingly more aggressive towards his mother which caused law enforcement officers to tell him to get his hands off of her. Giannone responded with stating something to the effect of "This is my mother". I told Giannone "We were done" referring to the situation at hand of him being aggressive towards his mother. Giannone then turned his whole body redirecting his attention and aggression towards me and began to advance towards me. Giannone stated to me "Are you going to lock me the fuck up?" while taking a bladed stance. Giannone then "Puffed" his chest forward towards me taking an obvious fighting stance. Giannone was advised to cease his aggression towards me. Giannone responded by raising his shoulders which simultaneously raised his hands yelling "Well what's up then?", in an obvious attempt to try to engage law enforcement in a physical altercation. Based on Giannone's actions previously mentioned with him standing between 7-10 feet away from me, it created a well-founded fear that a physical altercation was about to be initiated by Giannone.

Giannone was placed in mechanical hand restraints which were locked and checked for proper fit and placed under arrest for the charge of Assault on a Law Enforcement Officer. Giannone was transported to the IRC Jail where he was left in their care and custody.
