NARRATIVE

On October 20, 2025 at approximately 0934 hours, I responded to a shoplifting at Wawa located at 4495 US Highway 1.

Dispatch advised the manager Richard Faxon was calling about a Black male with a bald head last seen wearing a white shirt and dark pants riding a bicycle came into the store and stole a case of Coca-Cola then left without paying for the item. Dispatched stated the male was last seen heading westbound on 45th Street then south on 26th Avenue.

I began searching the area of 2600 block of 45th Street, at approximately 0937 hours, I observed a black male riding a bicycle in the area of 4300 block of 27th Avenue. The male later identified as Rayon T. Snyder, was wearing a white t-shirt, black pants he also had a bald head and a beard, and on his bicycle was a black grocery bag with something inside. I stepped out with Mr. Snyder, and asked him where he was coming from. Mr. Snyder told me he was coming from a local food truck over on 25th Ave, I asked if he had been to Wawa this morning, he advised he was there a little bit ago. I then detained Mr. Snyder in physical hand restraints (handcuffs) and ensured fit and double lock. Upon running Mr. Snyder through dispatch, it was learned that he was issued a trespass warning for Wawa located at 4495 US Highway 1. Case # 2024-00056455.

I read Mr. Snyder Miranda warning, to which he waived his rights and agreed to speak with me. I asked when he was at Wawa, he stated just a few minutes ago, when asked what he got there he stated he got a coffee. I questioned him about the item reported stolen was a case of Coke, he said that he did take it but he didn't steal it. He claimed he put it in the bushes, when asked what bushes he changed his story and said he put it in the trash. I asked what trash can, and he said the dumpster behind the church located at 2485 45th Street. The bag on Mr. Snyder's bicycle was brought up and he stated we could search the bag, he said it was just toilet paper. Upon searching the bag, an unopened 4 count pack of toilet paper was recovered. I asked Mr. Snyder why he was at Wawa when he had been trespassed, he stated he thought it had expired.

I then contacted Deputy Montgomery, who was with the manager of Wawa, Richard Faxon. Deputy Montgomery stated based on the video footage, Mr. Snyder entered the store at approximately 0926 hours, grabbed a 4 pack of toilet paper and a case of Coca-Cola and then proceeded to leave out of the back entrance of the store without paying for the items. Mr. Snyder got onto his bicycle and left westbound on 45th Street. Deputy Montgomery conducted a show up with Mr. Faxon, who positively identified Mr. Snyder as the same subject who stole the items from the store.

I then conducted a search incident to arrest of Mr. Snyder where I asked if he had anything that harm me during the search. Mr. Snyder advised he had a glass pipe in his zipper pocket. I located a small glass pipe with burnt choirboy inside it, in his right zipper pocket of his pants. While continuing to search his person, a small clear baggie with white powder inside fell to the ground from his right pants pocket. In Mr. Snyder's left pants pocket, I found a small metal rod with a sharp point on it. Based on my training knowledge and experience I know this to be a push rod or a cleaning rod for a pipe. I asked Mr. Snyder if that what he used it for and he stated "yes."

Mr. Snyder was then placed into my patrol vehicle, before transporting Mr. Snyder to the jail I conducted a field test of the white powdery substance found on his person. The substance field test presumptive for Cocaine and Molly. When asked

NARRATIVE

On Monday, October 20, 2025 at approximately 1358 hours, I responded to the Indian River Mall located at 6200 20th Street, Vero Beach, FL, in reference to a retail theft in progress.

Prior to arrival, dispatch advised that the suspect was a white female wearing all black clothing with red hair. As I arrived, dispatch further informed that the female was heading toward exit #4 of the mall. I parked my patrol vehicle near the entrance and began walking inside. Upon entering the main hallway, I observed a white male, later identified as Mark William Douglas, on the phone while following a female matching the suspect's description. I advised dispatch of my observation and began running to catch up to them. The female appeared to be attempting to get away, and I loudly commanded her to stop. She looked back at me but continued walking away. I gave another verbal command for her to stop, which she again ignored.

At this time, Deputy Baumann arrived on scene, and together we pursued the female, continuing to issue commands to stop. Once we caught up to the female, later identified as Melissa Marie Vasquez, she was taken into custody and escorted to my patrol vehicle.

Once secured, I conducted a search incident to arrest of Melissa's belongings. During the search, I located several jewelry items including rings, earrings, and necklaces. I turned the items over to Deputy Baumann and he later responded to the victim's location to confirm ownership. See Deputy Baumann's supplemental report for additional details.

During a further search of Melissa's purse, I located a small jeweler's baggie containing a white powdery substance and a blue pen tube that was hollowed out with white residue inside. Due to this discovery, Deputy Baumann read Melissa her Miranda warnings, which she acknowledged understanding and agreed to speak with us. When asked about the substance, Melissa stated that it was possibly Fentanyl.

Following her post-Miranda statement, I field-tested the substance using a department-issued test kit. The test produced a positive result for Fentanyl, indicated by the clear liquid turning orange upon contact. A photograph of the Fentanyl and the positive test result was taken and uploaded to the Axon evidence site via the Axon Capture app.

While waiting for Deputy Baumann to confirm ownership of the recovered items, I observed that Melissa appeared incoherent and repeatedly went in and out of consciousness. I attempted to ask her questions, but she was unable to respond coherently and continued to nod off.

After a short time, Deputy Baumann advised that Mark confirmed the jewelry items belonged to his store, Rock of Ages, and that he wished to prosecute. He valued the items at approximately \$86.

On Monday, October 20, 2025, at approximately 1908 hours, I, Deputy M. Neill #6317 responded to the Publix located at 810 S US Highway 1. Vero Beach, Indian River County, Florida, in reference to a violation of pretrial release which was occurring at

Upon my arrival I made contact with Mr. Zebair Hussain at Publix. He stated he was kicked out of his residence by his family so that his brother, Mr. Hamad Hussain could return to the residence. Due to the previous history of violence and Zebair being afraid of Hamad, he left. After realizing that he should not have to give up his residence, he called law enforcement today, so that the issue could be resolved.

Upon looking up court records, Hamad was arrested on 10/10/2025 by Deputy Ciofalo for Battery - Domestic Violence under case number 2025-00109431. Under court case number 312025MM001722AXXXVB, he was issued a bond by Judge Stone at Initial Appearance. During the initial appearance, Judge Stone issued conditions of bond upon his release. Hamad was not to have any with contact the victim and not be within 500 feet of the victim's residence, even if the victim and defendant share the residence. Hamad was issued a one time stand by to gather belongings. From my knowledge, that stand by has never been used.

I responded to the residence. As other deputies knocked on the front door, Hamad was seen sitting in the living room area talking with other family. Hamad walked out of the residence where he was secured in handcuff restraints and placed under arrest for the violation of pretrial release.

Hamad was advised of his Miranda Rights. He advised he understood his rights but was not willing to speak to me.

Based on the above evidence, I believe there is probable cause to arrest Hamad Hussain for the offense of Violation of Pre-Trial Release, pursuant to FSS 903.047.1.

NARRATIVE

On October 20th, 2025, at approximately 2059 hours, I responded to the intersection of 5th Street and 27th Avenue Southwest, Vero Beach, Florida, in reference to a disturbance.

Upon arrival, I observed a white female, known to me as Effie Brown from previous calls for service, sitting on the sidewalk in front of the Skate Factory, located at 485 27th Avenue Southwest. Effie was visibly upset and crying. I also observed a white male, known to me as David Brown from previous calls for service, standing within the wooded area at the southwest corner of the intersection. Due to my interactions with both individuals in the past. I know them to be husband and wife.

As I exited my patrol vehicle, I instructed David to stay where he was. David replied, "Why? I didn't do anything," while crying. I gave him another lawful order to remain in place until my backup arrived. As I turned away to speak with Effie, David left the area.

While on scene, a gray SUV arrived, occupied by Wyatt Hargraves and Hailey Johnston, who advised that they were traveling northbound through the intersection when they observed Effie and David physically fighting in the middle of the roadway. The altercation caused northbound traffic to stop completely which caused them

Both witnesses stated they observed Effie striking David in the face and pushing him, while David appeared to be pushing Effie away in response. When asked if the subjects were striking each other with open or closed fists, the witnesses stated that Effie was using her hands to hit David, while David was pushing her face away.

I then made contact with Effie and advised her of her Miranda rights, which she stated she understood and waived. Effie stated that she did not recall hitting David, but claimed she was trying to get away from him because she had seen David's mother driving westbound on 27th Avenue Southwest, who currently has custody of Effie's children. Effie's statements were disorganized and out of chronological order, and she appeared emotionally unstable. As a result, I was unable to obtain a clear and detailed account of the incident.

During my contact with Effie, I did not observe any visible injuries on her person.

With the assistance of other deputies in the area, David was located a couple of streets south of the original scene. Upon contact, I advised David of his Miranda rights, which he stated he understood and waived.

David stated that he and Effie were involved in a verbal argument because Effie saw his mother driving in the area, which caused her to become angry and belligerent. The argument reportedly began at the Salvation Army, located at 2655 27th Avenue Southwest, and continued to the intersection of 5th Street, where Effie stood in the middle of the roadway yelling at him.

David further stated that Effie was shining a small flashlight in his face while in the roadway. He told her multiple times to move out of the road for safety reasons. When she refused and continued flashing the light in his face, David walked into the roadway to physically guide her out. David stated that Effie then began hitting him multiple

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 10/20/2025 23:25 On (Specifically include facts constituting cause for arrest.)

On October 20th, 2025, at approximately 2218 hours, 1, Ofc. 2. Dominguez (VBPD #490) responded to 1055 20th Street (Vero Beach Police Department), in reference to a disturbance.

Upon arrival, I met with the complainant, Linda Scaccio, on the front steps of the Vero Beach Police Department. Immediately I observed her clothes, arm, and face stained with blood and asked Scaccio what happened. Scaccio advised that she had been "head butted" by her boyfriend, Charles Krerowicz. Scaccio elaborated, saying they were laying on the sidewalk of the 2001 building (2001 9th Ave) when Krerowicz intentionally hit her with his head "headbutted", striking her in the nose which caused severe bleeding. Scaccio later advised she thought her nose was broken. EMS was contacted and transported Scaccio (Run #28279) to Cleveland Clinic Indian River Hospital.

I then arrived at the 2001 building at approximately 2237 hours, to speak with Krerowicz. Due to Krerowicz being detained, and no longer free to leave, he was read his miranda warning from a prepared card which he stated he understood and waived. During my post-miranda interview, Krerowicz advised he and Scaccio were eating on the sidewalk of the 2001 building when they accidentally collided heads. While on scene, I observed many droplets and smears of blood, consistent with Scaccio's injury. Krerowicz also advised that they've been in a dating relationship for past 6-7 years.

At the conclusion of my interview, Krerowicz was asked if he had any injuries or needed medical services, but declined.

Upon reviewing Krerowicz criminal history, it shows a prior conviction for battery on 12/20/2012 (312012MM002478A). Based on this information, Krerowicz was placed under arrest in violation of (F.S.S 784.03) felony battery with a prior conviction/domestic violence.

Once placed under arrest, Krerowicz was transported to the Indian River County Jail for booking and processing, no bond.

Due to Krerowicz and Scaccio's dating relationship, she was issued a domestic violence rights and remodies packet. A domestic violence lethality assesment was also completed, and she advised she is in a potentially lethal situation،

This incident was captured on my department issued Body-Worn Camera (BWC), and photographs of the incident were later downloaded to Evidence Library.

NARRATIVE

On Monday, October 20, 2025 at approximately 2228 hours, I conducted a traffic stop in the area of US Highway 1 and Jackson Street in Sebastian, Florida in reference to a reckless driver.

While conducting stationary traffic enforcement near the 1600 block of US Highway 1, I observed a vehicle leave the parking lot of a business on the West side of US Highway 1 and travel northbound in the southbound lanes of travel, causing another vehicle to maneuver around it and attempting to alert the driver by flashing its high beams.

I immediately attempted to catch up to the vehicle which was a blue Ford F150 bearing Georgia tag "RWB5235." The vehicle corrected into the proper lanes of travel at Jackson Street and US Highway 1. I activated my emergency lights and the vehicle immediately yielded.

I made contact with the driver and sole occupant of the vehicle, Mr. Caine Sinclair (Arrestee) who I identified by his Georgia driver's license. I immediately noticed his eyes were watery and glassy and could smell the distinct odor of an alcoholic beverage emitting from his breath as he spoke.

I requested his insurance and registration, which he displayed extreme difficulty in locating. Mr. Sinclair became emotional and started to cry while I was speaking to him. Mr. Sinclair let his foot of the brake and his vehicle rolled forward. Mr. Sinclair put his vehicle in park, turned his vehicle off and handed me the keys to his truck.

I explained to Mr. Sinclair my concerns for his ability to safely operate a motor vehicle based upon the above indicators of impairment and requested he complete Standard Field Sobriety Exercises (SFSE's). Mr. Sinclair agreed and was asked to exit his vehicle.

I began asking Mr. Sinclair about his medical history. He stated he medication prescribed for his condition, but had not taken his medication today. Mr. Sinclair also disclosed a history of Mr. Sinclair denied consuming any alcohol since approximately noon while at Capt. Hiram's resort. While outside the vehicle, I continued to smell the distinct odor of an alcoholic beverage emitting from his breath.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions to Mr. Sinclair who stated he understood the instructions. I observed Mr. Sinclair's pupils were of equal size and tracked equally. I did not observe resting nystagmus. I observed Lack of Smooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation and an Immediate Angle of Onset in both eyes. I did not observe Vertical Gaze Nystagmus (VGN). During this exercise, Mr. Sinclair had an approximate 2-inch orbital sway and had to be reminded not to move his head.

The second exercise I administered was the Walk and Turn (WAT) exercise. I explained and

demonstrated the exercise to Mr. Sinclair who stated he understood the instructions. Mr. Sinclair was unable to maintain the starting position, did not touch heel to toe on multiple steps (half steps), completed and incorrect number of steps and improper turn. Mr. Sinclair did not complete this exercise to standard.

The third exercise I administered was the One Leg Stand (OLS) Exercise. I explained and demonstrated the exercise to Mr. Sinclair who stated he understood the instructions. Mr. Sinclair lifted his right foot off the ground for approximately six (6) seconds before placing it on the ground. I observed Mr. Sinclair Place his foot on the ground, use his arms for balance, Sway and Hop while completing this exercise. Mr. Sinclair did not complete this exercise to standard.

The fourth exercise I administered was the Modified Romberg Balance (MRB) exercise. I explained and demonstrated the exercise to Mr. Sinclair who stated he understood the instructions. Mr. Sinclair counted to fifty-five (55) seconds, which is outside the allotted five (5) second variance of thirty (30) seconds. Mr. Sinclair also had an approximately 2-inch orbital sway while completing this exercise.

Based on the above indicators of impairment, Mr. Sinclair was placed under arrest for Driving Under the Influence (DUI). Mr. Sinclair was secured in mechanical restraints and secured in the rear seat of my patrol vehicle.

An inventory search of Mr. Sinclair's vehicle was conducted prior to tow. During this inventory, I observed multiple open containers of alcohol in the vehicle.

Mr. Sinclair was transported to the Indian River County Jail Complex (IRCJC) without further incident. Upon arrival to the IRCJC, Deputy J. Hiss (5370) initiated a twenty (20) minute observation period at 2338 hours and requested Mr. Sinclair provide a sample of his breath to determine its alcohol content. Mr. Sinclair agreed and provided the following samples of his breath: 0.285 g/210L and 0.277 g/210L.

Mr. Sinclair was ultimately charged with DUI w/ BrAC above 0.15 (AM5W7TE) (FSS 316.193(4)) and held on a total bond of \$1,000.00.

Mr. Sinclair was issued the following civil citations: Possession of Open container – Driver (AM2NJGE) and driving on wrong side of divided highway (AM2NHJE).
