


## Arrest Affidavit Report

### NARRATIVE

On Wednesday, April 23rd, 2025 at 2151 hours, I responded to the area of 11555 US Highway 1 in reference to a reckless driving incident. Prior to arrival, Public Safety Dispatch advised the complainant, identified as Richard Ferretti, stated he observed a vehicle traveling Northbound in the Southbound lanes of travel on US Highway 1 from the 11600 block. Ferretti was able to provide specific details of the vehicle, identifying it as a gray jeep bearing Florida tag# Y65REG. Ferretti advised Public Safety Dispatch he was following behind the aforementioned vehicle until Law Enforcement arrived on scene. Ferretti observed the vehicle park at 11335 US Highway 1.

Upon arrival, I made contact with Ferretti who directed me towards the area where the vehicle was parked. I observed the gray 2018 Jeep bearing Florida tag# Y65REG, which was the same description provided by Ferretti. I then observed a white female, who was later identified as Dana Davis, step out of the drivers seat of the vehicle and walk towards me. Throughout my interaction with Davis, I detected the strong odor of alcohol emitting from her breath as she spoke. I also observed Davis to have red watery, glossy eyes and slurred speech. I then asked Davis if she had consumed any alcoholic beverages throughout the evening, in which she stated she consumed a total of two beers and was coming back home from work. Due to my observations, I asked Davis if she would submit to Standardized Field Sobriety Exercises (SFSEs), in which she stated yes.

Prior to conducting the Standardized Field Sobriety Exercises (SFSEs), it should be noted I still detected the strong odor of alcohol emitting from Davis' breath as she spoke.

The first exercise I explained was the Horizontal Gaze Nystagmus (HGN) exercise. It should be noted I was not able to conduct this exercise due to Davis' inability to follow the instructions. Davis' had to be told several times to stop moving her head and follow with her eyes only however she would not.

The second exercise I explained and demonstrated was the Walk and Turn exercise. Davis attempted to begin the exercise prior to being instructed to do so. Davis struggled to maintain her balance and stay heel-to-toe throughout the exercise. Davis failed to keep her arms down to her sides. Davis took more than the instructed nine steps before having to turn around. Davis did not complete this exercise as instructed.

The third exercise I explained and demonstrated was the One Leg Stand exercise. Davis failed to count out loud in the instructed manner. Davis failed to maintain her arms at her sides as instructed. Davis placed her foot down at nine seconds without being instructed to do so.

The last exercise I explained and demonstrated was the finger-to-nose exercise. Davis failed to touch the tip of her nose throughout the whole exercise. Davis did not go back to the starting position as instructed once she touched her nose.

Based upon the totality of the evidence, Davis was taken into custody for violation of FSS 316.193(1) DUI. I then placed Davis in handcuffs and in the back of my marked patrol vehicle.

A search of Davis' vehicle was conducted, in which I located two sealed bud light beer bottles inside her purse, which were cold to the touch.

Davis was transported to the Indian River County Jail without further incident.

At the Jail, Corrections Deputy Cazares requested Davis to provide a lawful breath sample and she refused. Davis

NARRATIVE

On April 23, 2025, I responded to a hit and run accident that was dispatched occurring at 37<sup>th</sup> Street and Indian River Blvd. IRCSO Dispatch advised that the suspect vehicle a dark gray Toyota Camry (bearing Florida License CJ7 1V1) left the scene, traveling southbound on Indian River Blvd. I observed the aforementioned vehicle drive past my vehicle at the 800 block of Indian River Blvd. I then initiated a traffic stop at the 600 Block of Indian River Blvd on the Camry. The driver (later identified as Maxwell Pierce) immediately pulled over, prior to me turning on emergency lights and sirens.

Upon making contact with Pierce, he advised the following;

Pierce stated he just was involved in a traffic accident and rear ended the other vehicle. Pierce stated he and the other driver began to argue. Pierce stated the other driver told Pierce she was on the phone [REDACTED] Pierce claimed he was trying to tell the other driver to move vehicle off the roadway. Pierce stated he told the "old lady driver" to follow him. Pierce then said he continued to drive southbound, believing the other driver was behind him. Pierce said once he saw my patrol vehicle, he immediately pulled over. (It should be noted Pierce drove 30 blocks before pulling over and/or Pierce recognizing that the other driver was no longer behind him)

D/S Adam Brady made contact with other driver of vehicle, Karrie Lee Spooner who advised the following;

Spooner was driving eastbound on 37 th Street, approaching a red light at Indian River Blvd. Spooner told D/S Brady, a dark Toyota Camry rear ended her vehicle and the driver left the scene without identifying himself. D/S Brady said Spooner took photos of the driver (later identified as Maxwell Pierce) and the vehicle. D/S Brady advised Spooner had minimal bumper damage to her silver BMW (Bearing Florida License 2NJY LFE). Spooner did not claim any injuries related to the traffic accident.

I did observe the minor front bumper damage to the vehicle Pierce was driving. Pierce stated the vehicle did not belong to him, but could not provide information related to the owner of the vehicle. Pierce advised he lives in Mesa Arizona and had a document that showed a temporary driver license. It should be noted that Pierce had a previous Florida Driver's License, that was suspended on 06/03/2024. Pierce stated he was not injured.

I then placed Pierce into custody for leaving the scene of an accident with property damage FSS 316.061 (1) traffic citation number AKFSASE and driving with a license from another state when Florida license is suspended FSS 322.30(1) traffic citation number AKFSATE.

Pierce was later transported to IRCSO Main Jail.

### NARRATIVE

On Wednesday, April 23, 2025, I served Abraham Josue Mendez with Saint Lucie County warrant number 202556000803 for the following offense:




The residence is a group home that houses people with disabilities with (24) hour staff care. On arrival, I made contact with the victim [REDACTED] identified as Stephon Peters [REDACTED] and is [REDACTED]

[REDACTED] Stephon asked one of the residents to place his cup back on the counter when he was finished using it and was met with a verbally aggressive response of expletives. The resident was identified as Sophea Choun who has a disability but does not have a continuing care provider to verify his actual diagnosis. Sophea has bouts of aggression daily and has been the subject [REDACTED] that resulted in no continuing care plan. Staff was advised that Sophea had no need to [REDACTED]

Sophea then entered the room of another resident to obtain a laptop computer that he was previous allowed to use but did not have permission this time. Stephon instructed Sophea to leave the residents room and tried to close the door. Sophea became angry and rushed Stephon in a threatening manner. Stephon tried to back away from Sophea but was unable as Sophea became physical with him and began scratching at his face. Stephon suffered multiple small lacerations to his left cheek that appeared fresh and still bleeding.

Sophea stated to me that he did not intend to hurt Stephon however he was angry and did not like the staff member. Sophea does appear to understand right from wrong however is unable to control his outburst.

Based on the totality, I found Sophea in violation of FSS 784.03 battery touch or strike.

It is requested that Sophea be placed into mental health court for assignment of a continued plan for care as his current standing in the group home is not safe for the staff.

I transported Sophea to the Indian River County Sheriffs Office without further incident.



Upon arrival, we located the Defendant who was lying on the ground in a sleeping bag next to the dumpster next to the business.

Ofcr. Hernandez and I made contact with the Defendant, I then remained with the Defendant while Ofcr. Hernandez attempt to make contact with the complainant.

While with the Defendant, I asked him for an identification card. The Defendant stated that he did not have one because he had lost it. I followed up by asking the Defendant if he was telling me that he had no identification whatsoever to which the Defendant affirmed that he did not.

I then asked the Defendant for his name and date of birth. The Defendant stated that his name was "MARIO TORRES" and that his date of birth was "12/27/80".

I radioed the name and date of birth the Defendant provided me to dispatch to conduct a records check. A short time later, dispatch asked to clarify if the Defendant from Florida or out of state as there was no record found for the name and date of birth provided.

As an alternative to his name and date of birth, I then asked the Defendant if he knew if social security number to which he stated that he did not. I then asked the Defendant if he was front Florid or somewhere else [out of state] to which the Defendant stated that he was from Florida.

Based on my experience, I suspected that the Defendant was concealing his true identity as often times a no record query result is the result of a false name and/or date of birth.

I then informed the Defendant that we were getting no records back for the name and date of birth he had provided.

I asked the Defendant if his name was in fact "Mario Torres" and if his date of birth was "12/27/80" to which the Defendant asserted that that was his name and date of birth.

In an effort to give the Defendant an opportunity to be truthful about his identity, I advised the Defendant that I was going to give him an opportunity to be truthful about his identity but that if he continued to lie to me about his identity, he would be charge accordingly; however, the Defendant maintained and re-asserted that his name was "MARIO TORRES" born on 12/27/80.

I then asked the Defendant to stand up in order that I may pat him down for weapons.

As I was patting the Defendant front-left pocket, I felt was a small, flat square object(s) similar to the size and shape of an identification card.

I asked the Defendant to show me the contents of his pocket and when he did I observed a picture of him on what appeared to be an identification card amongst what appeared to be some business card.

When I demanded to see the identity card, the Defendant tried to put it back in his pocket and would not show it to me asserting that they were weapons.

I then secured the Defendant and retrieved the a Florida Department of Corrections identification card with the Defendant's picture on it and which listed his true identity as "ELISME J. LIMA" with the same 12/27/08 date of birth.

Based on the foregoing, I subsequently placed the Defendant under arrest and informed him accordingly.

Subsequently, while assisting Ofcr. Hernandez in searching the Defendant's belongings for contraband and prohibited items, I located a clear plastic bag in the Defendant's suitcase containing a green leafy substance which based on my training and experience I recognized and determined to be cannabis.

I then used a field test kit which yielded a presumptive positive result of cannabis. I then turned over the cannabis to Ofcr. Hernandez to be placed into property and evidence at the Vero Beach Police Department.

The Defendant then asked to speak with me and upon doing so, the Defendant acknowledged that he had lied to me and did so because he didn't want to show me his prison identification card.

As to the cannabis, the Defendant was vehement that it wasn't good cannabis.

The foregoing occurred within the City of Vero Beach, Indian River County, Florida and was recorded with the use of body-worn and in-car cameras which were subsequently uploaded to a secure server.

The Defendant was then transported to the Indian River County jail without incident for processing and booking.



On 4/23/2025 at 1153 hours, I responded to [REDACTED] in reference to a trespassing. The caller, Jennifer Diroma, stated a male named Gilberto Garza was at the front door knocking on it. Diroma advised he was already trespassed from the property.

Prior to my arrival, I confirmed through Sebastian Dispatch he was trespassed the previous night, 4/22/2025 (SPD Case#25-0697).

Upon my arrival, I made contact with Garza, who was standing at the front door, under the curtilage of the front door area to the home. Garza was detained and read his Miranda Warning which he stated he understood. Garza waived his rights and elected to provide a statement. Garza confirmed he knew he was trespassed from the property and confirmed he knew to call law enforcement prior to his arrival to remove his belongings. Garza stated he did not know the phone number to call the police department. (Garza was later found to have the trespass warning in his pocket)

I then made contact with Diroma who was inside the residence with her children. Diroma stated she received calls and texts from Garza while he was walking back from Best Western. Diroma stated Garza was transported to Best Western last night after he was trespassed. Diroma stated she did not invite Garza back to the property. Diroma completed a sworn written statement. Diroma stated she wished to pursue charges for trespassing.

I find probable cause to charge Garza with one count of F.S.S. 810.08 (2)(b) Trespass in an Occupied Structure.

Garza was subsequently transported to the Indian River County Jail where he was left in their custody.
