NARRATIVE

On May 20, 2025, at approximately 09:05hrs I responded to a motor vehicle accident at the intersection of 4^{th} Street and Old Dixie Highway involving a red Ford Mustang and a gray Toyota Tacoma.

Upon arrival, I first made contact with the driver of the Tacoma, who stated he was struck by the Mustang. The driver of the Tacoma stated he believed the driver of the Mustang was intoxicated. I then walked over to the Mustang, where the driver was standing outside of the vehicle. As I approached the driver, identified as Fernando Gudino Martinez, appeared to have unsteadiness on his feet and glassy eyes. As I began speaking with Fernando, he appeared to have slurred speech, and I detected the odor of alcoholic beverages emanating from his breath. Fernando stated he had been driving south on Old Dixie Highway, where the other involved motorist had stopped in front of him for a red traffic light. Fernando stated he struck the small trailer being pulled by the other motorist before pulling off the roadway on 4th Street.

While speaking with Fernando, who was still standing on the sidewalk near his vehicle, he continually began swaying back and forth, almost falling backwards several times. I instructed Fernando to sit on the sidewalk next to his vehicle, and helped him to a seated position. I completed my crash investigation, and informed Fernando that I would now be conducting a DUI investigation. I asked Fernando how much he had to drink. He informed me that he had drank tequila the night before, and estimated he stopped drinking around 21:00hrs.

I assisted Fernando to his feet, and faced him away from the sun. I instructed Fernando to stand with his feet together, and arms down by his sides. I instructed Fernando to follow the tip of my finger using only his eyes, keeping his head still. I detected lack of smooth pursuit in both eyes, nystagmus in both eyes, and onset prior to 45 degrees.

I asked Fernando if he had anything preventing him from performing any balance exercises. Fernando stated he had an injured knee from a previous accident, but stated he still wished to attempt the field exercises. Utilizing the straight flat surface of the sidewalk, I began giving verbal instructions and demonstrations for the walk-and-turn. I instructed Fernando to stand with his left foot in front of his right foot, and hold the position to await further directions. Fernando attempted to correctly position his feet, however continually began weaving, having to use his feet to maintain balance. After several failed attempts, I advised Fernando we would attempt the one-leg stand.

I instructed Fernando to again stand with his feet side by side, with his arms down to his side. As Fernando was attempting to reposition his feet, he began taking several small steps backward, seemingly in an effort to regain his balance. I offered Fernando several attempts to stand in the directed starting position, but he kept saying he was nervous, and continued losing his balance, requiring him to walk backwards.

At this time, I instructed Fernando to place his hands behind his back, where he was placed in handcuffs. I advised Fernando that he was being placed under arrest for DUI. Fernando was placed in the backseat of my patrol vehicle and transported to the Indian River County Jail without incident.

While at the jail, Fernando was taken into the DUI test site, where he was asked by Corrections Deputies to submit to an evidentiary test of his breath. Fernando submitted to the tests, which showed a result of .33 and .31 BAC. At the request of

Callahan advised that Mr. Marlow had spontaneously stated, "Yes, I punched him. Yes, I punched him," when questioned about the incident. Mr. Marlow stated that he was standing in the alleyway behind Kwik Stop (1852 20th Street) when he approached a female coworker regarding a job-related matter. Brumley made contact with the complainant, later identified as Joshua C. Smith, who provided a sworn written statement. Mr. Smith stated that he was in the alleyway of Kwik Stop watching a YouTube video with a female, later identified as Dawn Duane, who is a coworker of Mr. Marlow. Mr. Smith stated that Mr. Marlow approached Ms. Duane in an aggressive manner, appearing upset because she had sent him home earlier that day for wearing headphones while at work. Mr. Smith advised that he stepped between the two in an attempt to de-escalate the situation, at which point Mr. Marlow struck him on the right side of the neck with a left-handed punch Ms. Duane corroborated Mr. Smith's statement. Based on the totality of statements, including Mr. Marlow's spontaneous admission and corroborating witness accounts, probable cause existed to arrest Mr. Marlow for Battery, in violation of F.S.S. 784.03(1)(a)1. Mr. Marlow was placed under arrest and transported to the Indian River County Jail for booking. This incident was captured on BWC.

(Specifically include facts constituting cause for arrest.)

On May 20, 2025, at approximately 1538 hours, I, Officer Marty, responded to 3850 16th Street (Rosewood Elementary), in reference to a possible intoxicated white male in the car loop line of the school.

At approximately 1545 hours, I made contact with SRO (School Resource Officer) Slattery. SRO Slattery advised that a school employee contacted him in regards to a parent sleeping in the driver seat of a grey 4D SUV. The school employee stated she knocked several times on the window of the vehicle, but the white male did not wake up. SRO Slattery was able to wake up the white male who was later identified as William James Esterline. Esterline stated he was there to pick up his son. (It should be noted this is the time during school release and there were several children in the area being released from school.) SRO Slattery asked Esterline if he knew where he was. Esterline stated, "Yes." SRO Slattery asked Esterline where was he, and Esterline again stated, "Yes." SRO Slattery stated Esterline had a strong odor of an alcoholic beverage coming from his person and was swaying back and forth. SRO Slattery advised Esterline attempted to pull his pants down due to yelling, "I have to pee." SRO Slattery was able to stop Esterline from urinating in front of several children.

I then made contact with Esterline. I observed him in the driver's seat of a 4D grey Nissan, bearing a Florida tag AZ48VF. The vehicle was still turned on in the middle of the car loop of the school. I immediately advised Esterline to turn off the vehicle and to step outside. Esterline stepped outside of the vehicle and while doing so he almost fell several times. Esterline had red glossy eyes, a strong odor of an alcoholic beverage emitting from his person, and could barely stand on his own. I asked Esterline if he had any alcoholic beverages today he stated, "Yes, I had a lot." I then told Esterline I do not think he is able to operate a vehicle safely and asked if he would be willing to perform standard field sobriety exercises. Esterline stated he was willing to perform the tasks.

I first asked Esterline if he had any problems with his balance he stated no. I asked if he has any problems with his eyesight preventing him from seeing the line at his feet, he stated no. I asked if he has any problems with his feet or legs causing him any difficulty to walk, he stated no.

Esterline performed the following tasks:

Horizontal Gaze Nystagmus- Esterline was instructed numerous times to follow the tip of my pen with his eyes and his eyes only. Esterline could not follow the tip of my pen without moving his entire head. While at a 45 degree angle Esterline had nystagmus to both his left and right eye.

Walk And Turn- Esterline was unable to put his left foot on the line and then his right foot in front of it with his heel touching his left toe. I demonstrated several times; Esterline stated he understood the instructions but was off balance and unable to stand in that position. I instructed Esterline to take nine heel-to-toe steps, and also demonstrated what was expected to be done. Esterline was unable to walk and was unable to count to nine; Esterline started with the number ten even after repeating the instructions to him numerous times.

One-Leg Stand- After I demonstrated the One-Leg Stand task, Esterline stated he understood the instructions. Esterline was unable to lift his left or right foot off the ground without falling over. After Esterline attempted several times we stopped the task due to the safety of Esterline.

Finger To Nose- Esterline stated he understood the instructions after I explained and demonstrated them to him. Two times Esterline used his right finger to touch his nose when I instructed him to use his left finger. Each time Esterline failed to touch his nose and instead touched his closed eyes. Esterline did not leave his head tiled back even after being reminded several times to keep his head tilted back.

Esterline could not keep his hands to his side during any of the tasks. He started each task before I instructed him to. I explained several times the instruction to each tasks and Esterline still did not accurately perform any of the tasks.

At approxiamtely 1606 hours, I placed Esterline under arrest for violation of Florida statute number 316.193, DUI.

I transported Esterline to the Indian River County Jail. At approximately 1630 hours, I began Esterline's 20 minute observation period. At approximately 1701 hours, Esterline refused to perform a breath test. Esterline was read the State of Florida Department of Highway Safety & Motor Vehicles Affidavit of Refusal to Submit to Breath test (Implied Consent), and Esterline still refused to provide a breath sample.

It should be noted that the VBPD Communication department researched Esterline's records and found that on January 30, 2018, Esterline required a interlock device, however, it did not show that he has a criminal history.

Esterline was issued a criminal DUI citation, AFVKJEE.

NARRATIVE ***

On Tuesday, May 20th, 2025 at approximately 2350 hours, I, Deputy Sheriff Ramiro Doval was stationary conducting speed enforcement on Interstate 95 (State Road 9) at mile marker 143 on northbound traffic, when I observed a black SUV traveling at a high rate of speed. I visually estimated the vehicle to be traveling at a speed of 90-mph in a 70-mph zone. I activated my dual stalker radar serial #DB017965, and got a reading of 91 mph in the target window of my radar.

I was able to safely enter the interstate from the median and closed the distance on the vehicle, eventually conducting a traffic stop at mile marker 146 northbound, the vehicle was a black Audi Sport Utility Vehicle, bearing Florida tag #RPVZ49.

As I began to make an approach on the vehicle through the passenger side, I could smell a strong odor of marijuana from the vehicle. The driver only rolled the window down halfway and I advised him the reasoning for the traffic stop, he stated he understood. I then advised him if he could roll the window down the rest of the way, which he did. It should be noted, the driver, later identified as Christopher Kinigopoulo was very nervous and would not look at me when speaking to me and appeared to be fidgety and could not keep still.

I then asked Christopher if he had any illegal narcotics in the vehicle, Christopher then moved a jacket from the passenger seat and I observed 5 clear glass containers of a yellowish-brown substance consistent in appearance and odor with THC concentrate (commonly known as marijuana wax).

I asked Christopher if he had a marijuana card, at first, he stated no. I then asked him a short time later he stated yes. Christophers name and information was given to IRCSO dispatch to check if he had an active medical marijuana card, which he did not and did not have any open orders and was expired. Christophers driver's license was also suspended and had outstanding warrants from Broward County.

I did read Christopher Miranda warning from a departmental business card, Christopher stated he would speak to me. Christopher advised he picked up the marijuana wax from a friend in Miami and was transporting it to Orlando to a certain individual. Christopher advised he only does this when he needs the money.

The marijuana wax was collected and weighed in its clear glass containers, and later field-tested positive for THC. The containers weight are as follows;

- 1.) 112.55g
- 2.) 120.34g
- 3.) 119.22g
- 4.) 119.87g
- 5.) 115.76g

Total weight of the marijuana wax (cannabinoid), 587.74 grams.

NARRATIVE

On 05-21-2025 at approximately 0057 hours, I, Deputy Mindy Mangel #5949, was on assigned patrol in Indian River County, Florida when I observed a 2024 black Honda Civic, bearing Florida License Plate 47DTYR, positioned in the northbound lane of 58th Avenue but had come to a stop beyond the stop bar, obstructing the eastbound lane of State Road 60. This posed a hazard for vehicles traveling eastbound on State Road 60 approaching 58th Avenue.

When the traffic light turned green, I observed the Honda turn west onto 20th Street at a high rate of speed. As it made the turn, the vehicle entered the right lane, then abruptly swerved into the center lane before jerking back into the right lane. Several deputies were conducting a traffic stop on the right shoulder of the roadway at the time. The driver of the Honda failed to slow down or move over for law enforcement vehicles, as required by Florida's Move Over Law.

I initiated a traffic stop and approached on the passenger side of the car. As soon as the driver, later identified to be Kristen Zagami (DOB: 02-27-2001), put the window down, I immediately detected the strong odor of an unknown alcoholic beverage emanating from the vehicle. I observed her eyes to be bloodshot, watery and glassy and her speech was slurred. I asked Ms. Zagami for her driver's license and she looked at me with a blank stare. I had to ask her several times for her driver's license.

I asked Ms. Zagami to exit her vehicle and she complied. While walking to the front of my patrol car, I observed Ms. Zagami to be unsteady on her feet. While talking to Ms. Zagami outside and away from her car, I detected the strong odor of an unknown alcoholic beverage coming from her breath. Ms. Zagami agreed to participate in voluntary Standardized Field Sobriety Tests (SFST). Before beginning the tests, I asked Ms. Zagami if she had any medical or physical problems that would prevent her from walking in a straight line or standing on one foot. Ms. Zagami told me that she did not.

Each test was explained and demonstrated to Ms. Zagami and I confirmed that she understood each one prior to beginning the tests. The tests were conducted on the roadway. The surface was flat and the markings in the road were visible.

During Horizontal Gaze Nystagmus, I observed equal tracking, equal pupil size, and no resting Nystagmus. I observed a lack of smooth pursuit in both eyes, I observed distinct and sustained Nystagmus at maximum deviation in both eyes and I observed onset of Nystagmus prior to 45 degrees in both eyes. Ms. Zagami had a visible sway from front to back and side to side during the test.

During the Walk and Turn, I explained and demonstrated the test and Ms. Zagami said that she understood. Ms. Zagami was unable to hold the starting position and stepped out of it multiple times. During the first series of steps, Ms. Zagami took the correct (9) number of steps. She missed heel to toe on the 2nd and 3rd set and counted incorrectly. The turn was performed correctly. During the seconds series of steps, Ms. Zagami took the correct (9) number of steps. During the entire test, Ms. Zagami took slow deliberate steps as if she were walking on a tight rope.

During the One Leg Stand, Ms. Zagami chose to raise her right foot. She put her foot down and lost her balance multiple times during the test.

During the Finger to Nose, I explained and demonstrated the test and Ms. Zagami said that she understood. The sequence for the task was left, right, left, right, left.

Left: Ms. Zagami touched her upper lip with the pad of her finger.

Right: Ms. Zagami touched the top of her nose with the pad of her finger.

Ms. Zagami had a visible sway from side to side and front to back during the test. I observed her to have eyelid tremors and body tremors. She used the pad of her finger and not the tip as instructed and searched for her nose the entire time.

During the Modified Romberg, Ms. Zagami estimated the passage of 30 seconds at an actual elapsed time of 44 seconds. When I asked Ms. Zagami what she counted to, she told me 15 seconds even though the instructions were to count to 30 seconds.

During my entire interaction with Ms. Zagami she exhibited an orbital sway of approximately 2 inches. I observed leg and eyelid tremors. She had to have instructions repeated to her multiple times.

Ms. Zagami did not complete roadsides satisfactorily. I placed her under arrest for violation of FSS 316.193(1) DUI.
