NARRATIVE

On April 24, 2024, at approximately 1206 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with the victim, Lisa A. Stroyek, who advised that she got into a verbal altercation with Kolby A. Schweiger but then turned physical. Stroyek advised that Schweiger became agitated and aggressive towards her because she was occupying a male's vehicle with whom Schweiger happens to be interested.

Stroyek advised that Schweiger threatened to fight her multiple times, but Stroyek stated that she would not. Stroyek advised that when she began walking off the property from the disturbance, Schweiger spit on her. Stroyek stated that she immediately left the property and contacted law enforcement using a neighbor's phone.

Stroyek pointed to the spit on the back of her head, where I observed an approximate quarter-size amount of saliva. She advised that she was tired of being bullied by Schweiger and wanted to press charges. I photographed the saliva via Axon Capture for evidentiary purposes.

When I arrived on the scene, I observed Schweiger walk briskly from a shed-like home where she spoke with a female bystander to a camp-style setup on the same property where several people were sitting. Schweiger refused to get up from the chair and speak with me alone. I asked Schweiger about the details of the dispute, and Schweiger advised that Stroyek was lying and that no one spit on her.

Responding deputies heard a female bystander blurt out that Stroyek deserved more than being spit on, contradicting Schweiger's statement.

Based on the statements provided, Schweiger was arrested and transported to the Indian River County Jail without incident for the following charge:

NARRATIVE

On Monday, April 22, 2024, at approximately 1500 hours, I responded to 13407 US Highway 1 in reference to a suspicious person. Upon arrival, I made contact with the complainant, Bill Nixon who advised that the same subject from an earlier call for service (2024-44214) had returned to the location and was sitting on a bench on the south end of the plaza.

I responded to the area and made contact with the suspect, Joseph Camarda who was sitting on a bench in front of Publix on the aforementioned property. Camarda refused to identify himself however I was familiar with a him due to a previous call for service. I asked Camarda why he returned to the location after I verbally warned him that he was trespassing earlier in the day and could not be on the property unless he was conducting business. He said that Smith was not allowed to be on the property and that she had active warrants. Dolbashian further explained that Smith had been causing disturbances with the other tenant in apartment D and the police were recently looking for her.



On April 22nd, 2024, at approximately 1837 hours, I was dispatched to the area of 697 Caravan Ter in reference to a reckless driver. While en-route, dispatch advised the caller stated a gold Ford F-150 pickup truck was speeding up and down the road, leaving skid marks on the street.

Officer Buffington arrived to the intersection of Laconia St and Periwinkle Dr, where he was flagged down by bystanders. Officer Buffington was informed the same truck in question ran over a stop sign at this intersection and left the scene. Upon my arrival on scene, I observed the stop sign to be damaged and on the ground. The witnesses on scene stated the truck was last seen going northbound on Laconia St. The witness's advised the driver of the truck was a white male with brown hair that was approximately 30 years old.

Officer Martinez was traveling on Barber St, when he observed a truck matching that description driving recklessly. Officer Martinez conducted a traffic stop on the vehicle at the intersection of Barber St and Rolling Hill Dr and immediately detained the individual. It should be noted, upon making contact with him officers on scene confirmed the male matched the description provided by witnesses and the truck had front end damage consistent with hitting a pole. I responded to this location and stood by until Officer Buffington was done with his crash investigation. The male was identified by his Arizona DL as Daniel Taylor. Officer Buffington responded to this location and read Daniel his Miranda Rights to which he agreed to speak to him. It should be noted; while Officer Buffington was speaking with Daniel I observed Daniel's eyes to be glassy. Daniel was speech very slurred and was hard to understand while speaking with Officer Buffington. I also was able to smell the odor of alcoholic beverage emanating from Daniel as he spoke. Officer Buffington's investigation concluded Daniel struck the stop sign, which caused approximately \$250 in damage and failed to stay on scene. As soon as Officer Buffington completed his crash investigation, I advised Daniel that I was now going to be conducting a criminal DUI investigation.

Daniel was transported to the Indian River County Jail without incident. Once at the jail, I asked Daniel if he was willing to preform field sobriety exercises, to which he agreed to. The first exercise was Horizontal Gaze Nystagmus. During this exercise, I observed the following: Daniel was not able to follow the instrument with his eyes. I observed a lack of smooth pursuit in both eyes. Daniel had nystagmus in both eyes at maximum deviation. I also observed onset nystagmus prior to 45 degrees in both of Daniel's eyes.

The next exercise was the Walk and Turn exercise. I explained to Daniel the starting position. Daniel was unable to stay in the starting position, and had to be reminded to stay in this position until told otherwise. Daniel's hands were not all the way down to his side as instructed to do so. Upon advising Daniel to begin the exercise, he took 9 steps which were not all heel to toe. Upon reaching his 9th step, Daniel failed to turn around in the manner that he was instructed and demonstrated to. Daniel took approximately 11 steps back and failed to count them out loud.

The final exercise was the One Leg Stand. I explained to Daniel the starting position for this exercise. Once in this position, I explained and demonstrated the exercise for Daniel. Upon telling Daniel to begin, Daniel raised his leg and failed to look at his toes. Daniel also failed to count, and instead was making eye contact with me. Daniel was also unable to leave his hands down by his side.

Daniel agreed to blow once completing the exercises. Upon doing so, both samples came out as .159 BAC.

Due to the above facts, Daniel was charged with FSS 316.061 LEAVING THE SCENE OF ACCIDENT W PROP DAMAGE and FSS 316.193 (1) DUI.
