




On Sunday, March 29th, 2026, at approximately 2356 hours, I, Deputy M. Neill #6317 conducted a traffic stop near 4th Street and Old Dixie Highway, Vero Beach, Indian River County, Florida.

I conducted a traffic stop near the above intersection in reference to a vehicle driving upon the roadway without any rear lights on at night.

Without activating my emergency lights, the vehicle pulled in to the closed gas station located on the southeast side of the intersection. I then activated my emergency lights to conduct the traffic stop.

Upon speaking to the driver, who was later identified as Mr. Christopher Reeves, I asked to see his license. Mr. Reeves stated that he did not have a license. I asked if it was suspended. He stated that he believed it was not valid for child support. Mr. Reeves then provided me with his Florida ID card.

During the traffic stop, Deputy McKay and his canine partner conducted a free air sniff on the vehicle. His canine partner provided a positive alert for the presence of narcotics within the vehicle.

During a probable cause search of the vehicle, I located a glass pipe with a white powdery substance underneath the driver's seat of the vehicle. Sgt. Thimmer located another broken glass pipe with a powder substance within it. Deputy McKay located a silver rod on the passenger side that had a white residue on it. The rod was consistent with being a "push rod", which narcotics users use to put drugs in to a pipe and smoke them.

The glass pipe found underneath the seat field tested presumptive positive for the presence of cocaine. This pipe was found underneath the drivers seat and was only in the immediate area of Mr. Reeves.

I conducted a search of Mr. Reeves. During the search, I asked him to open his mouth. I observed a small white rock, consistent with crack cocaine on the bottom left side of his jaw line. I placed Mr. Reeves in to handcuff restraints, which were checked for proper fit and double locked. I then told him to open his mouth again. After he opened his mouth again and the item I originally observed was no longer there. Mr. Reeves advised that he did not have anything in his mouth and that it was likely a piece of his tooth that had come off. Mr. Reeves was then secured in the back of my patrol vehicle as he was now under arrest for Driving without a valid license.

NARRATIVE

On Monday, March 30, 2026, at approximately 0159 hours, I conducted a traffic enforcement stop on a white Chevrolet Impala (FL / CL7OMK) in the vicinity of US Highway 1 and 12th Street in Vero Beach, Florida.

I observed the above vehicle fail to make a complete stop behind the white stop bar prior to making a right turn on US Highway 1 South. I initiated a traffic stop and identified the driver as Mr. Brock Brickner (Arrestee) by the Florida driver's license he provided me.

While speaking with Brock, I noticed his eyes were watery, and he appeared nervous. He avoided eye contact with me while speaking to me. I could smell the distinct odor of an alcoholic beverage emitting from the vehicle and asked Brock to exit the vehicle. Once outside the vehicle, I continued to smell the odor emitting from Brock as he spoke.

I conducted a DUI investigation with Brock; however, he completed the Standard Field Sobriety Exercises (SFSE's) to standard.

Sergeant Thimmer approached on the passenger side of the vehicle, where he made contact with the front seat passenger, who was later identified as, Sherlyn Cazares. While Cazares was searching for her vehicle documents in the glove box, Sergeant Thimmer observed a package, which was pink-in-color, he knew to be a package individuals purchase from smoke shops, containing marijuana, due to his training and experience. Sergeant Thimmer asked Cazares if the package he observed contained marijuana and she stated it did. Sergeant Thimmer asked Cazares if she had a medical marijuana card, which she confirmed, she did not. Sergeant Thimmer asked Cazares to hand him the package and Cazares handed Sergeant Thimmer the pink-in-color package and a black-in-color box, which also contained loose green leafy substances, he knows to be marijuana.

Deputy Mims arrived on scene and Sergeant Thimmer requested for Deputy Mims to standby with Cazares, while he searched the vehicle. Before searching the vehicle, Sergeant Thimmer asked Cazares if there was anything else he would find inside the vehicle, to which, she explained we would find THC vape pens and an alcoholic mixed drink, she stated was her drink.

Sergeant Thimmer searched the vehicle and located two THC vape pens inside the center console arm rest, along with a clear plastic baggie, containing more green leafy substance, he knew to be marijuana. Sergeant Thimmer also located a cellphone case, contained in a clear zipper bag, containing more green leafy substance, which was confirmed to be marijuana. Sergeant Thimmer also located a styro-foam cup, containing pinkish liquid, on the floorboard on the passenger seat.

Sergeant Thimmer questioned Cazares about the items inside the vehicle. Cazares stated the THC vape pens are Brock's, but the marijuana was hers. Cazares explained the drink was hers as well and advised the drink was

Due to Cazares being 19-years-old, Sergeant Thimmer questioned her about how she possessed the alcohol, which at first, she stated Brock supplied the alcohol while they were at his house this evening. Cazares mentioned she and Brock went to eat at Grind and Grape, then headed to Dom's Bar, which are local establishments.

Sergeant Thimmer and I questioned Brock, post Miranda, about how Cazares became in possession of an alcoholic beverage. Brock said Cazares must have purchased it at Dom's Bar, but then after further questioning, he stated, he purchased the Tequila and cranberry drinks for Cazares, while they were at Dom's Bar.

Sergeant Thimmer had Brock face the patrol vehicle, and Sergeant Thimmer searched Brock's person. During the search, Sergeant Thimmer located a blue THC vape pen inside Brock's pant pocket.

A search of the manufacturers website (<https://partyboyzconcentrate.com/product/packman-x-partyboyz-3g-disposable-0-5g-infused-pre-roll-live-resin-liquid-diamonds/>) revealed the vape contained three (3) grams of live resin.

Brock ultimately stated he purchased drinks for his girlfriend, buying her tequila and cranberry mixed drinks so the bar staff would not know he was purchasing them for her.

I spoke with Cazares, and she initially denied Brock purchasing her drinks and when I asked if video from Dom's would support her story, she changed her story and stated Brock purchased her drinks using her credit card.

Brock was questioned about his license status, and he "suspected" because I was asking him, that it was suspended. Brock claimed that he did not know his license status was suspended, however a query of D.A.V.I.D. shows an extensive history of traffic infractions to include a culmination of over 24 points in 36 months. When Brock's mother arrived on scene to retrieve the vehicle and Cazares, she stated she was aware of his license status being suspended. D.A.V.I.D. shows Brock was provided notice of the pending suspension on September 11, 2025 and was effective October 01, 2025.

Brock was placed under arrest for possession of a controlled substance (THC Vape Pen is listed a Sch 1), giving alcohol to person under 21, and driving while license suspended with knowledge 1st offense.

Brock was transported to the Indian River County Jail Complex without further incident and held on a NO BOND status.

NARRATIVE

On Monday, March 30, 2026 at approximately 2016 hours I responded to [REDACTED] in reference to a suspicious incident; which was aired as a possible residential burglary in progress.

Upon my arrival I hastily made my way around the residence where I noted a large window or entrance to the property which was obviously large enough for a person to crawl through where a large piece of plywood was removed from the entrance. Further, as I rounded the North East portion of the residence I noted a large doorway which had a piece of plywood obviously removed as if individuals were using this as an entrance in to the property. I noted this plywood to be old, as if the house had been boarded up an extended period of time ago.

Once the house was contained, I made contact with the neighbor – who was the complaining party – who advised me of the following in summation:

The rightful owners of the property were currently in western Canada. The complainant, Mr. Richard Fatigate, advised me he has lived at [REDACTED] for several years and had never known any one to come and go other than lawn workers.

Mr. Fatigate advised me he had previously had issues in the past with homeless individuals breaking to the neighbor's residence. He further informed me he saw a white female enter the property earlier in the evening, around 2012 hours, and not seen anyone leave.

I, and several other deputies, made a good-faith effort, with the assistance of the Indian River County Sheriff's Office Real Time Crime Center (RTCC) to find contact information for the rightful owner of the property. All attempts were unsuccessful and are still continuing.

From a cursory view of the exterior of the residence, I noted several factors which led me to believe any occupant inside was not lawfully present, such as plywood boarded accesses, large quantities of miscellaneous trash on the floor of the residence – consistent with homeless encampments, no interior lights on, no vehicles present in the driveway, and no apparent means to secure the residence as the plywood door appeared to be damaged and removed from its placement.

K9 deputies gave loud, clear, and concise announcements at the door to the residence where we heard a female voice. After repeated announcements the female occupant finally came to an area just within view but also still within the residence. The female, later identified as Ms. Sheila Nichols, failed to comply with commands at the door until she was given a final warning that she would be bit by the k9 present; at which time she finally exited the residence where she was taken in to custody.

Now having established that a potential residential burglary had occurred; we entered the residence under exigent

circumstances to apprehend any other burglary suspects inside. Upon clearing the residence; the house was in a clear state of condemnation. A makeshift bed area was located, and trash was piled approximately 1 foot deep throughout the entirety of the main room of the residence. This further evidenced the likelihood this property was regularly being unlawfully inhabited by numerous individuals.

After clearing the residence, I informed Ms. Sheila Nichols of her constitutionally protected rights in the form of a "Miranda Warning". Ms. Nichols began speaking with me about just "being homeless" after I asked if she would like to talk about tonight's events, which I accepted as an affirmation she would engage in conversation and questioning. Ms. Nichols informed me of the following in effect:

Ms. Nichols never asked the owner of the property for permission to stay inside, nor had she any knowledge of the residence's owner. She, along with numerous other homeless individuals, had been using the residence as a shelter. Ms. Nichols denied being the one who damaged any property or removed the door way.

Being unable to substantiate that she had been the one to burglarize the residence, but having found probable cause for Trespass in a Structure and Resisting without Violence, Ms. Nichols was placed under arrest and transported to the Indian River County Sheriff's Office Jail Complex without incident.

I am attempting to contact the appropriate jurisdiction to notify the victim's in this case of the arrest.

My body worn camera was active.

This case is cleared by arrest - Closed.



NARRATIVE

On Monday, March 30th, 2026, at approximately 2143 hours, I was conducting speed enforcement around the 400 block of US Highway 1.

While traveling south bound, I observed a black motorcycle sitting stationary approximately three cars in front of me in my lane. The light cycled to green and shortly after leaving the intersection he changed lanes and began to create a significant space between the regular flow of traffic and was traveling at a high rate of speed. I estimated the vehicle's speed to be approximately 140 miles per hour; my calibrated Stalker DSR 2X radar indicated a speed of 143 miles per hour, which was clear and consistent with the Doppler tone. It is important to note that the posted speed limit for south bound traffic is 45 miles per hour. As I am observing the vehicle from a distance, it was traveling in the right lane and dangerously approached another vehicle at high speeds in the same lane, and made an improper lane change without signaling, to avoid a collision with the other vehicle. I initiated a traffic stop near the 900 block of South US Highway 1. Upon making contact with the driver, who was identified by his Florida driver's license as Matthew Louis Onate, I instructed him to exit the motorcycle and explained the reason for the traffic stop. I advised him that he was being detained for traveling 98 miles per hour over the posted speed limit. The driver was subsequently handcuffed and placed in the rear of my patrol vehicle.

Based on the facts and statements presented Mr. Onate is violation of FSS. 316.1922.(1)(A) Dangerous Excessive Speeding – 50mph or more. Mr. Onate was transported to the Indian River County Jail without issue.
