NARRATIVE

On October 27<sup>th</sup>, 2024, at approximately 2224 hours, I responded to the Wawa at 4495 U.S. Highway 1, Vero Beach, Florida, in reference to a trespass. While en route Public Safety Dispatch provided the description of a white male panhandling at the location.

Upon my arrival, I observed a white male later identified as James Thomas Helm, trying to flee at the sight of law enforcement. I then made contact with Helm who stated that he had been trespassed recently. I then conducted a query through Indian River County Public Safety Dispatch, and they advised that Helm had been trespassed from the location listed above. I placed Helm in handcuff restraints and placed him in my patrol vehicle.

I made contact with the caller, Wawa Manager Cassie P. Seuberling, who confirmed Helm was the suspect. Seuberling stated that Helm has been trespassed for panhandling and disrupting customers on the Wawa property and would like to pursue trespass charges.

I then read Helm His Miranda rights from my agency-issued card, Helm stated that he understood his rights and would speak with me. I asked Helm why he tried to run and he stated that he knew he was trespassed from the location and was trying to get away once law enforcement arrived.

Helm violates F.S.S. 810.08 (2)(a) trespass of a structure or conveyance.

I transported Helm to the Indian River County Jail without further incident.

NARRATIVE

On 10/27/2024 at approximately 2143 hours, I responded to [REDACTED] in reference to a disturbance which took place earlier in the day.

The reporting party, was a Danni Mcgre, who was working a dispatcher at the St. Lucie County Sheriff's Office, who was receiving text messages from her friend Lindsey Gryder. Lindsey advised her via text message [REDACTED] Dustin Andreas, [REDACTED] has "beaten" her in front of [REDACTED] and she has possible facial injuries.

Sergeant Avila, Deputy Mangel, Deputy Quaglia and I arrived on scene and made contact with Lindsey via telephone and requested her return to the area of the above location so we could speak with her and render aid for her allegations of injuries. Lindsey responded to the scene with Dustin's daughter from a previous relationship, Ava Andreas, and her son from a previous relationship, Gunner Harvey. Lindsey advised the following: she was returning from West Palm Beach after helping out with a mobile petting zoo. Once in the area of her home she past where Dustin park's/stages his 18 wheeler truck which is approximately 1 mile from where they reside, and did not stop to pick him up. She advised Dustin had to walk home, at which time she began packing her and the kids cloths so they could leave. She advised Dustin walked home faster than she anticipated and the two got into a verbal argument inside the home. Dustin then began slamming doors and yelling at her and eventually she went out to her car to leave with the kids. Dustin then went to the driver side door of the car and tells her she is not leaving with his daughter Ava and blocks her from getting into the car. She stated she then went to the passenger side of the car and entered the passenger side, at which time Dustin entered the driver side of the vehicle. She stated she then began "kicking and biting him" which caused Dustin to exit the vehicle, and Lindsey moved / slide over and gets into the driver seat. Dustin from outside the vehicle then grabs her (she was unable to say where and just advised her torso) and throws her to the ground. She gets up and attempts to get back in the car at which time Dustin grabs her (unable to say where and just advised her torso) and throws her to the ground again. Lindsey then advised she got up and got into the car and Dustin walked away. Lindsey then left the area with the kids. It should be noted Lindsey refused medical attention and she had no visible injuries.

Additionally, Lindsey provided the text message log of her and Dustin which showed following text she sent to Dustin: "Cops are coming don't answer the door Dani called them change your shirt of the Kids are gone Fuck you doing this fuck you You should have left me alone You should have left me and my kids alone you will never see my children again." Dustin responded with: "I didn't do anything I came here because you said you weren't I wanted to shower that is what I wanted shit and shower Ava wasn't even with you today that's cool More lies so where the fuck were you idc your such a liar it's sick after as much as I work to try to feed everyone this is my payback this is what I get you came after me you hit me you then chased me I'm literally bleeding out of my ear the cops can come here ill show them what you did you called Arianna right up and it's funny to make me walk home that's funny to you when I give you my last dollar.

Contact was made with Dustin who advised he came home earlier in the day from work and went to take a shower and sleep due to having to be back at work at 2:00 A.M. Dustin did not wish to speak to law enforcement about the altercation which took place earlier in the day. It should be noted Dustin had a gash on the right side his head which still had blood coming from it and scratch marks across the left side of his face and ear. Dustin refused medical attention.

No independent witnesses observed this altercation, however [REDACTED] Vidal Pena who resides at [REDACTED] which is across from [REDACTED] did hear Lindsey and Dustin in an altercation earlier in the day but did not witness it.

Based on Lindsey's statement of events, along with Dustin's visible injuries, Lindsey was placed under arrest for battery domestic violence, and transported to the Indian River County Jail for further processing.

NARRATIVE

On October 25, 2024 at approximately 2015 hours, I, Deputy Ramiro Doval responded to the 2600 block of 12<sup>th</sup> Street in regards to an auto accident leaving the scene.

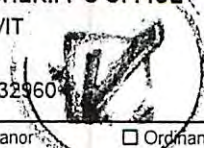

NARRATIVE

On Friday, 10/26/2024, at 2252 hours, I (Deputy Cody Scott) responded to 14415 US Highway 1, in reference to an auto accident.

Deputy Consalo stated he was on scene for a disturbance where two dogs attacked each other. The male identified by his Florida driver's license as, Braiden Eix (DOB: 09/29/1998), got into his truck at which point he backed up into a parked car and began to drive off. Due to Eix attempting to drive off and him being belligerent, he was detained. While Deputy Consalo was detaining Eix he could smell a strong odor of an alcoholic beverage emitting from his breath. Due to there being a crash involved, Deputy Consalo requested an additional unit for the sobriety investigation. Deputy Consalo's agency issued BWC captured Eix operating his motor vehicle, and exit the vehicle.

Upon my arrival, I met with Deputy Consalo who was completing crash investigation. Deputy Consalo completed his investigation, and turned Eix over to me for further investigation.

I read Eix his Miranda warning, at which point he stated he understood his rights and wished to continue talking to me.

As I interacted with Eix, I observed several physical signs of impairment: Bloodshot, watery eyes, Slurred speech, and a strong odor of an alcoholic beverage emitting from his breath.

I became concerned Eix was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Eix if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked Eix a series of medical questions to ensure he could participate in field sobriety exercises. Eix stated that he has a [redacted] from a few years back, and had no other physical defects. He was not sick or injured, did not have epilepsy or diabetes, did not wear contacts or glasses.

All field sobriety exercises were explained and demonstrated proficiently prior to Eix beginning each exercise and I confirmed he understood the instructions prior to the start of each exercise.

The following exercises were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed. Vertical Gaze Nystagmus was also present.
- 2.) WALK AND TURN - A straight line in the concrete was used for the exercise. When asked, Eix agreed with me that the line was straight, flat, and clear of debris. This exercise was explained, and demonstrated to Eix prior to him beginning the exercise, to which he stated he understood all instructions. During this exercise, Eix utilized his arms

to balance, missed heel-to-toe, conducted an improper turn, and stepped off the line.

3.) ONE LEG STAND – This exercise was explained, and demonstrated to Eix prior to him beginning the exercise, to which he stated he understood all instructions. Eix was instructed to count in the following manner: 1001, 1002, 1003, etc.. until instructed to stop. Eix chose his left foot for this exercise. I utilized my stop watch to time this exercise. I told Eix he may begin the exercise. Eix raised his left foot approximately one inch from the ground, utilized his arms to balance, put his foot down, when he got to 1018 while counting he put his foot down, and repeated 1018. Eix continued the exercise, however stopped counting and began to apologize. I instructed Eix he could stop the exercise.

Overall, Eix performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on 10/25/2024, Eix was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance, and was impaired beyond his normal faculties, and incapable of operating a vehicle safely.

Eix was arrested for DUI at 2333 hours and was advised of the charge. I took Eix into custody without incident and transported him to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Hiss advised me that Eix refused to provide a breath sample.

It is to be noted that post Miranda, Eix stated he knew he should not have been driving, and had consumed too much alcohol. This statement was captured on Cpl. Quaglia's agency issued patrol vehicle's fleet Axon prioner camera.

NARRATIVE

On 10/25/2024 at approximately 2231 hours, I responded to 5875 20th St in reference to a Miscellaneous

Upon arrival, I observed a male emptying and tossing Corona beer bottles into the bushes near where the vehicle. I approached the vehicle and made contact with both passengers and the driver who was later identified as Lori Jones.

I observed a Corona beer bottle spilling in the passenger seat next to a half-empty 750ML blueberry vodka bottle. The Corona bottle appeared sweaty and had condensation. I asked Lori if she had also consumed an alcoholic beverage that night, and she stated she had had three drinks earlier in the night.

I asked Lori to retrieve her driver's license, as she approached the vehicle she stated "I was not driving, I was traveling." I asked Lori what she meant by that and she stated "It means getting from one point to another". While speaking to Lori, I observed bloodshot glassy eyes, mumbled and slurred speech, and I could smell the strong and distinct odor of an alcoholic beverage emitting from her exhaled breath and person. Lori advised she had approximately three drinks earlier in the night prior to her dinner which consisted of Natural Ice beer, and a long-island-style drink, Lori advised she was a lightweight with alcoholic beverages.

I requested Lori to perform field sobriety exercises to determine if she was safe to operate a motor vehicle, Lori began to scream "Get me outta jail baby". I advised Lori she needed to stop screaming and provide a yes or no, Lori agreed to perform field sobriety exercises.

While conducting the Horizontal Gaze Nystagmus exercise I observed equal size pupils, resting Nystagmus, and equal tracking. I asked Lori if she was diabetic or epileptic and she advised [REDACTED] from a drunk driver. I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation, and onset of Nystagmus prior to the 45 degrees. Lori made multiple statements that she could feel herself swaying. She displayed a total of 3 clues during this exercise.

While explaining the walk-and-turn exercise, Lori started too soon, did not touch heel-to-toe multiple steps, and made an improper turn. She displayed a total of 3 clues during this exercise. Lori interrupted me during the instructional phase and when asked if she wanted to try the exercise again, she stated something to the effect "I'm going to get arrested so just arrest me." I asked if she wanted to continue with the exercises and she advised she did.

While explaining the one-leg stand, Lori swayed while balancing used her arms to balance (more than 6 in away from her body), and put her foot down before showing disinterest in wanting to continue with the exercises. She displayed a total of 3 clues during this exercise.

Lori was placed under arrest and handcuffed I asked Lori where she tossed the keys, she advised she tossed them somewhere in the truck, during a search incident to arrest the keys were located in the backseat wedged in between the seats, and multiple bottles of Corona Beer were lying in the vehicle to include the 750ML half-empty vodka bottle. the bottles were cool to the touch, there was also a bag in the backseat that was carrying ice. When asked where Lori's license was, she advised she did not have one, I confirmed on DAVID that her license was suspended as of 01/09/2023. Lori admitted to having tossed the keys in the back of the truck prior to the search.

Lori was transported to the county jail without further incident, where she later refused to provide a sample of her

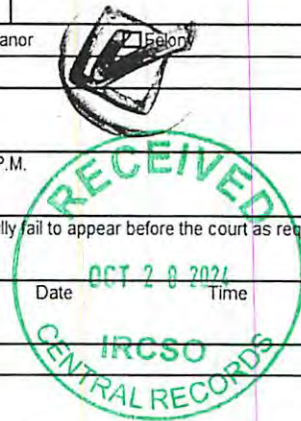

On 10/27/2024, at 08:20 hours, VBPD Officers responded to the intersection of 21st Street and 14th Avenue in reference to a large physical disturbance between a female and multiple males.

Upon arrival, the following involved parties were located:

- Kristea'yonna L. Troutman DOB: 07/24/2003 (defendant)
- Z'yhire J. Harris DOB: 04/13/2001 (primary victim/\_\_\_\_\_)
- Isaac Hunter DOB: 08/31/1990 (victim/witness)
- Brandon P. Birdow 04/07/1986 (victim/witness)
- Johnny L. Thomas DOB: 10/01/1990 (victim/witness)



Ms. Troutman was actively screaming and having a mental breakdown. Officer A. Gonzalez (#414) separated Ms. Troutman and tried to speak with her privately.

I was able to speak to Mr. Murphy (the complainant) who advised me that he resides at the apartments located at 2036 14th Avenue. Mr. Murphy informed me that while inside his apartment, he could he hear a loud disturbance coming from Pocahontas Park. Mr. Murphy noted that a female was yelling, and Mr. Murphy explained to me that exited his apartment to see where the disturbing yell was coming from. Mr. Murphy observed Ms. Troutman fighting with multiple males. Mr. Murphy observed that the males were teaming against Ms. Troutman, and Mr. Murphy called law enforcement to report the incident. I verified with Mr. Murphy that he did not see the fight start, nor did he witness any events that led to the altercation. Mr. Murphy only witnessed the ending where all the males were fighting the female.

I then spoke to the homeless males that were involved. I first spoke to Mr. Harris, \_\_\_\_\_ Ms. Troutman. Mr. Harris immediately made a comment that Ms. Troutman may have a kitchen knife in her possession, and all of the involved males stated that Ms. Troutman had been threatening people with the knife since the early morning hours, and that she was not mentally well. A subsequent search was conducted on Ms. Troutman and the surrounding area. Ms. Troutman acknowledged that she did previously possess a knife, but she denied having the knife at this time. Officers were unable to ever locate or recover the kitchen knife.

According to Mr. Harris, Ms. Troutman has been very emotional and causing arguments. Ms. Harris told me that he tried to remove himself from her presence, but Ms. Troutman continued to follow him throughout the downtown area. Ms. Troutman became aggressive and proceeded to chase Mr. Harris after they exchanged words. Ms. Troutman managed to strike Mr. Harris with her hand as he tried to evade her. The altercation moved towards the fountain located in front of Pocahontas Park. Mr. Hunter, Mr. Birdow, and Mr. Thomas were all standing by the fountain and observed Ms. Troutman pursuing after Mr. Harris. The males advised that Ms. Troutman carries a knife and recently has threatened them with the knife. As \_\_\_\_\_ approached the fountain, the homeless males made comments that Ms. Troutman was acting crazy. Ms. Troutman reacted to the comments and redirected her attention to the homeless males by the fountain. According to Mr. Hunter, Mr. Birdow, Mr. Thomas, and Mr. Harris, Ms. Troutman reached her hand into her handbag while making threats to the bystanders. The males told me that Ms. Troutman kept her hand concealed in the bag, giving the impression that she was retrieving her knife. Ms. Troutman then continued to threaten to kill the males. At this point, the males all defended themselves and tried to remove the bag from Ms. Troutman's possession. Ms. Troutman also engaged in the fight and blows were exchanged.

None of the involved parties were seriously injured, and all four males provided statements indicating that they did not wish to prosecute charges for the battery.

It should be noted that Ms. Troutman and Mr. Harris \_\_\_\_\_ Both subjects are homeless and \_\_\_\_\_

I then conducted a Post-Miranda interview with Ms. Troutman. Ms. Troutman admitted to being involved in a physical altercation because she did not like the way that people were talking to her. When I asked Ms. Troutman if she was chasing people with a knife, she claimed that she did not do that "today". She also mentioned that she did not have the knife on her. I asked her if she could tell me where the knife was located so I could ensure that no children would stumble across it. Ms. Troutman refused and told me that she would not provide me with that information because she did not want to receive another charge.

Based on the totality, I found that Ms. Troutman was the primary aggressor in this incident. Ms. Troutman willingly pursued after Mr. Harris with the intention of creating a confrontation with \_\_\_\_\_ While chasing after Mr. Harris through the downtown area, Ms. Troutman managed to strike Mr. Harris on his arm. Once near the fountain at Pocahontas Park, Ms. Troutman engaged with bystanders and began to yell loudly. Ms. Troutman proceeded to threatened the bystanders and reached into her bag (after she recently displayed that she had possession of a kitchen knife). Ms. Troutman's actions created a reasonable sense of fear, and the other involved parties reacted in self defense. Ms. Troutman instigated a physical altercation in a public park. This altercation disturbed the peace and quiet of persons that resided nearby (to include Mr. Murphy). This altercation also caused park patrons and local businesses to fear for their safety.

On 10/27/2024, at 22:02 (Specifically include facts constituting cause for arrest.)

On 10/27/24 at approximately 2202 hours, I, Ofc Aguilar, responded to 1200 block of 16th St. in reference to the report of a pickup truck that was stuck near the train tracks. On scene, I observed a white Chevy pickup truck bearing Florida tag (PDJV40) that appeared to have dented a D.O.T. median sign (\$500.00) and was now stuck in a grass median (\$500.00 damage to shrubbery).

I then made contact with the single occupant (driver) and registered owner of the vehicle, Sergio Ordaz who was seated in the driver's seat with the vehicle turned on. While speaking with Ordaz, I observed him to having water bloodshot eyes and he was unsteady on his feet. Ordaz advised that he was leaving a small gathering and had consumed two beers. Based on my observations and after the completion of crash investigation, I informed Ordaz that I was now going to be commencing a criminal DUI investigation.

I then requested that Ordaz complete a series of standardized filed sobriety exercises to ensure that he was capable of safely operating a motor vehicle. Ordaz agreed to complete the exercises and informed that he did not have any medical issues that would prevent the completion of the exercises. Ordaz was not wearing any glasses or contacts and advised that he was not a diabetic.

While explaining the exercises, I detected the strong odor of an alcoholic beverage emitting from his person. All exercises were explained (translated in Spanish) and demonstrated prior to Ordaz completing them. The results are as follows:  
Horizontal Gaze Nystagmus

- Lack of smooth pursuit in both eyes
- Distinct and sustained nystagmus at maximum deviation
- Onset of nystagmus prior to 45 degrees
- Followed stimulus with head movement

Walk and Turn

- Cannot keep balance while listening to instructions
- Starts too soon
- Stops while walking
- Improper turn
- Incorrect number of steps (10 steps on first set/ 12 steps on second set)
- Did not count steps

One leg stand (utilized left foot first and then transitioned to right foot)  
Sways while balancing

- Uses arms to balance
- Puts foot down

Based on the above-mentioned observations, Ordaz was placed under arrest for violation of F.S.S. 316.193 (3c1) DUI damage to property (citation # AFVKI3E). Ordaz was then transferred to the Indian River Cleveland Clinic for medical clearance and then the Indian River County Jail.

While at the Indian River County Jail, I conducted a 20-minute observation period and then requested that Ordaz provide a lawful sample of his breath to determine his breath alcohol content. Ordaz agreed and the following results were obtained (0.122 and 0.128). Ordaz was read his Miranda Warnings, which he understood and requested a lawyer prior to answering any questions. Ordaz was then transferred over to booking staff. Body camera video/photographs of the incident were submitted into a secure file at the Vero Beach Police Department.

On 10/27/2024 at 01:33 (Specifically include facts constituting cause for arrest.)

On October 27th, 2024, at approximately 0046 hours, I was dispatched to [redacted] in reference to a physical disturbance in progress. While en-route, dispatch advised the caller's [redacted] was being aggressive and two males began to hit each other.

Upon arrival, I made contact with a female at the front door, later identified as Desiree McCluskey. Desiree stated [redacted] and [redacted] were involved in a physical disturbance. Desiree informed that her and her husband were at a party and had been drinking prior to this incident.

Desiree led me inside the house which is where I made contact with her husband, identified as Kevin McCluskey. Upon making contact with Kevin, I immediately observed a small, fresh laceration on the right side of his head which was actively bleeding. Kevin also had a small cut on his right big toe. I asked Kevin multiple times if he needed EMS to which he refused. Kevin stated the following: Kevin and Desiree returned home from a party at a friend's house at which they were both drinking heavily. Upon returning home, [redacted] later identified as Dallas McCluskey, became upset due to the amount Kevin had been drinking. This is when a verbal altercation ensued. Kevin stated that at a certain point, the altercation between him and Dallas did become physical. Kevin was unable to describe to me how the physical altercation took place or details of the altercation. When I asked Kevin how he got the injury to his head, he stated he was unable to remember how it got there. However, he acknowledged that it was from the physical altercation that occurred between him and Dallas. While speaking with Kevin, I observed blood on the ground in the area in which the physical altercation occurred as well as broken items.

I once again made contact with Desiree and she stated the following: She and Kevin returned home from a party at a [redacted] at which they were both drinking. When Desiree returned home, she went straight to bed. While she was in bed, she heard a loud verbal altercation between Kevin and Dallas. Desiree did not immediately go see what was happening due to thinking it was normal for a [redacted] to fight. However, after a certain point, Desiree went out to see what was going on between the two. When doing so, Desiree stated she observed Kevin and Dallas grabbing each other against the wall. Desiree stated punches were being thrown however she was unable to remember by who. Desiree informed me that Dallas was being very aggressive and she did not understand why. According to Desiree, Kevin already had the laceration on his head by the time she exited her room to see what was going on. In an attempt to de-escalate the situation, Desiree told Kevin and Dallas she was [redacted] as a bluff. However, the altercation continued and Desiree decided to [redacted] out of fear for further escalation. The wall Desiree stated she observed Kevin and Dallas during the altercation was the same corner that I observed blood and broken items on the ground.

I then made contact with Dallas in his room. Immediately while speaking with Dallas, I observed marks and trace amounts of blood on both of his knuckles, consistent with landing closed fist strikes. I asked Dallas if he had any other injuries on his person which he stated he did not. I did not observe any other injuries to Dallas' person. When asked about what had happened between him and Kevin, Dallas refused to cooperate. According to Dallas, no disturbance ever took place between the two. Dallas stated Kevin came home from the party intoxicated and that was it. I asked Dallas how [redacted] got the laceration I observed on his head, to which he stated he "must have fell." I asked Dallas about the marks and blood on his knuckles, which he stated was from him falling in the corner of the room. It should be noted, what I observed on Dallas' knuckles was inconsistent with an injury from a fall and more consistent with an injury after landing a closed fist strike. Dallas refused to answer any more questions while on scene.

Based on the totality of the circumstances, the injuries I observed on both Dallas and Kevin [redacted] as well as statements from all parties on scene, I determined there was probable cause to place Dallas under arrest for violation of FSS 784.03(1A1) BATTERY (DV).


Dallas was transported to the Indian River County Jail without incident.
