#### NARRATIVE

On August 13<sup>th</sup>, 2025, at 2104 hours, I responded to 1805 19<sup>th</sup> Place #201, in reference to a search. Upon my arrival, I attempted to serve Mikhail Richard Pugh, DOB: 11/20/1992, with active Indian River County Sheriff's Office warrant # WR2025907, reference violating;

- FSS 817.61, Fraudlent Use of Credit Card
  - Bond: \$15,000.00
- FSS 810.02.3a, BURGL OCCUPIED DWELLING UNARMED
  - Bond: \$40,000.00
- FSS 812.014.2d, GRAND THEFT PROPERTY DWELLING/CURT 100-750 DOL
  - Bond: \$10,000.00.

Public Safety Dispatch (PSD) advised they received a call from the victim of Pugh's case which the warrant was active for (IRCSO OCA/ 2025-78185). The victim / complainant stated he believed Pugh was at the aforementioned residence due to observing Pugh's girlfriend's (Kacy Ellowitz) vehicle being parked in the parking lot outside the aforementioned address. The complainant advised Pugh frequently drives her gold Toyota bearing FL/ CI46YH. Upon my arrival, with the assistance from several other deputies, we located the aforementioned vehicle in the parking lot to the west of the apartment building. I confirmed with PSD by providing them with the attached FL tag that the vehicle was registered to Kacy Ellowitz.

Myself and addition deputies then located apartment number #201 and attempted to make contact at the front door of the apartment, by knocking and announcing our law enforcement presence. While knocking on the door and waiting for Pugh to answer, I heard a male subject speaking in a low tone of voice to a female subject behind the closed door. While keeping my hand on the front door of the residence, I felt a subject lean against the door shortly after making announcements. Myself and assisting deputies on scene knocked and announced multiple times, even going as far as addressing Pugh by his first name and stating that he had a warrant out for his arrest and that he needed to exit the apartment. It should be noted that while waiting for Pugh's cooperation, I heard a cell phone ring several times inside the aforementioned residence, as well as the male and female voices I previously heard, continue to conversate quietly.

It should be noted that the address listed on the warrant (warrant # WR2025907) was 1805 19th Place Apt #201. Prior to responding to the address, I utilized D.A.V.I.D and FCIC/NCIC databases and

learned that Pugh could be described as a white male 6' 3" in height, approximately 200 pounds in weight, covered in tattoos to include tattoos on his face and forearms, with a short blonde buzzcut hairstyle. After multiple knocking and announcement attempts for Pugh cooperation, assisting deputies and myself left the apartment complex and began surveillance on Ellowitz's apartment for an approximated 2 hours.

While sitting nearby, I utilized binoculars to watch the apartments windows, in hopes to positively identify Pugh inside the residence. Over the course of 2 hours, I observed a white male subject manipulate several curtains over the windows in the apartment, turn the interior lights on and off in the apartment, peak outside the windows of the apartment, and even go as far as standing on which appeared to the be windowsill of a window. After multiple sightings of the male subject on the inside of the apartment I was able to positively identify that the male subject in Ellowitz's apartment was a white male, approximately 6ft in height, roughly 200lbs, had several tattoos on his right forearm, (I observed the tattooed arm multiple times as the male subject manipulated the curtains and blinds to peak outside the window) and that the male subject had a very short haircut.

Due to the complainant (victim) leading us to the apartment, myself locating the suspect's girlfriend's vehicle in the parking lot, the address being confirmed on his warrant, hearing a male voice from behind the doorway, and several sightings of a male subject positively matching the suspect's description, I had reason to believe Pugh was inside the apartment. In accordance with FSS 901.19(1);

"If a peace officer fails to gain admittance after she or he has announced her or his authority and
purpose in order to make an arrest either by a warrant or when authorized to make an arrest for a
felony without a warrant, the officer may use all necessary and reasonable force to enter any
building or property where the person to be arrested is or is reasonably believed to be." (FSS Title
XLVII Chapter 901)

I relayed my findings to Sgt. Flores, who authorized forced entry into the aforementioned apartment complex, to take Pugh into custody.

It should be noted that for approximately 20 minutes, while I was still conducting surveillance, multiple assisting deputies on scene continuously knocked and announced their law enforcement presence at the apartment front door, and were met with unsuccessful attempts of contact.

Once the call to force entry was made, I went and made contact with the deputies on scene and forced entry into apartment #201. While clearing the apartment, I observed a wooden hutch placed in front of the door, which was consistent with when I observed the male subject appear to be standing on

the window sill. Once inside the apartment, I learned that the subject must have been standing on the couch that paralleled the north wall of the living room.

After clearing the entire apartment except for the most southern bedroom, assisting deputies and myself were met with a locked bedroom door. After continuous announcements and lawful orders for male and female subject heard conversating behind the closed door to exit the bedroom; Pugh eventually exiting the aforementioned bedroom. Once Pugh was removed from the hallway and was being placed into custody, I entered the final bedroom and located Ellowitz, lying in the bed. Both subjects were safely placed into custody.

Though my investigation, I found Kacy Leigh Ellowitz to be in violation of FSS 843.02, resisting arrest without violence.

learned that Pugh could be described as a white male 6' 3" in height, approximately 200 pounds in weight, covered in tattoos to include tattoos on his face and forearms, with a short blonde buzzcut hairstyle. After multiple knocking and announcement attempts for Pugh cooperation, assisting deputies and myself left the apartment complex and began surveillance on Ellowitz's apartment for an approximated 2 hours.

While sitting nearby, I utilized binoculars to watch the apartments windows, in hopes to positively identify Pugh inside the residence. Over the course of 2 hours, I observed a white male subject manipulate several curtains over the windows in the apartment, turn the interior lights on and off in the apartment, peak outside the windows of the apartment, and even go as far as standing on which appeared to the be windowsill of a window. After multiple sightings of the male subject on the inside of the apartment I was able to positively identify that the male subject in Ellowitz's apartment was a white male, approximately 6ft in height, roughly 200lbs, had several tattoos on his right forearm, (I observed the tattooed arm multiple times as the male subject manipulated the curtains and blinds to peak outside the window) and that the male subject had a very short haircut.

Due to the complainant (victim) leading us to the apartment, myself locating the suspect's girlfriend's vehicle in the parking lot, the address being confirmed on his warrant, hearing a male voice from behind the doorway, and several sightings of a male subject positively matching the suspect's description, I had reason to believe Pugh was inside the apartment. In accordance with FSS 901.19(1);

 "If a peace officer fails to gain admittance after she or he has announced her or his authority and purpose in order to make an arrest either by a warrant or when authorized to make an arrest for a felony without a warrant, the officer may use all necessary and reasonable force to enter any building or property where the person to be arrested is or is reasonably believed to be." (FSS Title XLVII Chapter 901)

I relayed my findings to Sgt. Flores, who authorized forced entry into the aforementioned apartment complex, to take Pugh into custody.

It should be noted that for approximately 20 minutes, while I was still conducting surveillance, multiple assisting deputies on scene continuously knocked and announced their law enforcement presence at the apartment front door, and were met with unsuccessful attempts of contact.

Once the call to force entry was made, I went and made contact with the deputies on scene and forced entry into apartment #201. While clearing the apartment, I observed a wooden hutch placed in front of the door, which was consistent with when I observed the male subject appear to be standing on

the window sill. Once inside the apartment, I learned that the subject must have been standing on the couch that paralleled the north wall of the living room.

After clearing the entire apartment except for the most southern bedroom, assisting deputies and myself were met with a locked bedroom door. After continuous announcements and lawful orders for male and female subject heard conversating behind the closed door to exit the bedroom; Pugh eventually exiting the aforementioned bedroom. Once Pugh was removed from the hallway and was being placed into custody, I entered the final bedroom and located Ellowitz, lying in the bed. Both subjects were safely placed into custody.

After Pugh's person was searched by assisting deputy A. Ballester, he placed Pugh into Deputy K. Matthews' agency issued patrol vehicle. Prior to closing the door, Deputy Ballester asked Pugh if he had missed any contraband on Pugh's person and informed him that if contraband were to be located on Pugh's person, interrupting the booking process, after being transported to the Indian River County Jail, Pugh would face additional charges for introduction of contraband into a secure corrections facility. Pugh responded by stating that he understood and that there was no contraband on his person.

After arriving at the IRCJ, correctional deputies located a small bag of what appeared to be loose marijuana in a clear plastic bag in Pugh's hand. I subsequently field tested the green leafy substance for the presence of THC by utilizing an agency issued field drug test kit. The drug test kit displayed a positive test result, indicating the presence of THC in the green leafy substance. After locating the substance, correctional personal then conducted a strip-search inside the IRCJ booking area where they located additional contraband to include, multiple pieces of tinfoil and a "loaded" syringe (a syringe containing a clear liquid, commonly identified and positively field tested as heroin). I unraveled one of the two pieces of tin foil and located a small clear plastic bag containing a pink powdery substance, commonly reference to as "pink cocaine." It should be noted that after reviewing deputy K. Matthews' in-car camera footage, I observed Pugh to appear to attempt to conceal something inside of his anus.

Per the DEA (United Stated Drug Enforcement Administration), "Pink cocaine is a powdered mixture of substances, which is dyed pink, may have a sweet smell, and typically produces mind-altering, hallucinogenic effects." "DEA laboratory testing has identified pink powders containing combinations such as:

- Ketamine and MDMA
- Methamphetamine, ketamine, and MDMA

# NARRATIVE

On August 14th, 2025, at 0205 hours, I responded to reference to a disturbance.	
Upon arrival, I heard yelling and screaming coming from the apartment. As I approached the door, a white male, later identified as Calvin Arduini, exited the apartment carrying two bags and holding later identified as	
Calvin was sweating and appeared agitated, consistent with being involved in an altercation. I observed a bloody scratch on his right knee. When asked what had occurred, Calvin stated he was involved in a verbal argument with his girlfriend, later identified as Jessica Lopez. He denied any physical contact and stated he fell while coming down the stairs with this arms, striking his head in the process. Calvin said may have also struck during the fall. He stated Lopez was downstairs at the time but was unsure due to hitting his head. Calvin confirmed he was holding throughout the argument with Lopez.	
While interviewing Calvin, stated, "They were yelling," pointed to forehead, and said it hurt. I observed a bump between eyebrows, another bump on the right side of forehead, and a bump or left cheek.	
I then made contact with Lopez, who confirmed the verbal argument but denied any physical contact. Inside the apartment, I observed broken items and several alcoholic beverages scattered around. I also observed a small bloody nail on her left pinky toe, along with small scratches on her left arm and left shoulder. Lopez stated she did not know how she sustained those injuries.	
Both Calvin and Lopez stated they do not live together but have been in an intimate relationship for over seven months.	
While exiting the apartment, a neighbor from Apartment reported hearing banging noises and yelling. She stated that she saw Lopez attempting to take bags from Calvin and put them back inside. She then saw Calvin aggressively push Lopez, causing her to fall and remain on the ground briefly before returning inside. This witness declined to provide her name.	
Deputy Ciofalo spoke with Hannia Naranjo, the resident of Apartment who reported hearing loud banging and arguing from Lopez's apartment. Naranjo stated she heard a baby crying outside, prompting her to look out. She observed Calvin sitting on the curb before standing up and "pushing the shit out of" Lopez, causing her to fall into bushes in front of the apartment.	
re-interviewed Lopez and informed her that there were witnesses to the incident. Lopez stated she could neither confirm nor deny the information and further stated she was not at the bottom of the stairs when Calvin fell, nor did she see him or fall.	
re-interviewed Calvin, advised him of his Miranda rights, and he stated he understood but refused to speak

Based on the totality of the circumstances—including injuries, the injuries to both Calvin and Lopez, and witness statements consistent with Lopez's injuries—I placed Calvin under arrest for battery (dating violence).

A search of drugs.com/pill_identification.html identified the pills as Acetaminophen and Oxycodone Hydrochloride, a Schedule II controlled substance.

#### NARRATIVE

On August 14, 2025 at 806 hours, I responded to the area of 85th Street and US Highway regarding a reckless driver.

While enroute to the area dispatch advised that the caller was following a Black Chevy pickup truck that the caller had observed being unable to maintain its lane of travel and he believed the driver of the Chevy to be intoxicated. The caller then stated that he almost hit another car and then the Chevy turned off of US Highway 1 on to 82<sup>nd</sup> Street and was west bound on 82<sup>nd</sup> Street where the Chevy stopped for approximately three minutes before continuing on to 45<sup>th</sup> Court before exiting out onto Old Dixie Highway where he continued south bound.

At this time dispatch also received a second call regarding an auto accident leaving the scene that occurred in front of the CVS located at 85th Street and US highway 1 where a black pickup truck with a Yamaha sales and service had struck another vehicle and failed to stop.

When contact was made with the Chevy in the 6500 Block of Old Highway it was observed to have a large Yamaha sales and service window on the back glass matching the description of the vehicle that left the scene of the crash. Based on this as well as the original callers statements a traffic stop was initiated by Deputy P. Newman.

When contact was made with the driver who I know through previous interactions to be Craig Sanders, I had him put the vehicle in park and step out. When Sanders responded his speech was slowed. As Sanders exited the vehicle, I detected the odor of fresh marijuana coming from the cab of the vehicle. I instructed Sanders to walk back to the hood of the patrol car directly behind his vehicle pointing to the vehicle I wanted Sanders to walk to.

Once at the hood of the patrol vehicle I radioed another unit to make contact with driver of the other vehicle involved in the auto accident. When Sanders heard this, he asked what. I informed him that we had received two calls involving his vehicle one was a reckless driver and the other was leaving the scene of an accident. Sanders stated he did not leave the scene of an accident he stated that he had a pretty good feeling that a tire kicked towards him. When speaking Sanders had difficulty maintaining his thoughts and his speech was staggered. Sanders said he was going down US1 and felt something like a tire hit his truck so he pulled over to the side of the road but there was no damage and no one stopped so he continued on.

The Real Time Crime Center was contacted and asked if they had traffic camera video for the area in which the incident took place. The advised they did and forwarded the video to me. Upon observing the video which shows the south side of US Highway 1 and 85th Street I observe Sanders's vehicle south bound through the intersection in the inside lane as it attempts to merge into the outside lane of travel that was also occupied by a white SUV. This action causes the right front of Sanders vehicle to impact the left side of the other vehicle. When the right front of Sanders truck was checked fresh white transfer was observed.

Deputy C. Luther who was at the crash scene interviewed the other driver and provided the following.

At 8:06 AM, IRCSO Public Safety Dispatch received a 911 call from Marjorie Etts. Marjorie stated at the intersection of US Highway 1 & CR 510 a black pickup truck with Yamaha Sales and Service on the back of hit impacted her white 2021 Toyota

Venza bearing Florida registration FA6JV. The black pickup truck failed to stop and continued southbound on US Highway 1.

At 8:09 AM, Deputy Patrick Newman then observed the described pickup truck, a black 2023 Chevrolet Silverado 2500 Super Duty bearing Florida registration B0A5G0D southbound from 69<sup>th</sup> Street on Old Dixie Highway. Deputy Newman conducted a traffic stop on the pickup truck at the 6500 block of Old Dixie Highway and made contact with its driver, Craig Glen Sanders. Deputy Newman would later tell me there was recent damage to the right front quarter panel of the pickup truck. That damage was consistent with the damage later described on Marjorie's vehicle.

I then made contact with Marjorie at the 8400 block of US Highway 1. Immediately I observed fresh damage to the left rear door and left rear quarter panel of her vehicle to include black transfer paint. Marjorie confirmed that was the area of impact. Marjorie continued to tell me while she was southbound on US Highway 1 occupying the outside travel lane and approaching the intersection of CR 510, she observed a black pickup truck traveling behind her. The pickup truck was failing to maintain a single lane as it neared her. As she entered the intersection of CR 510, the black pickup truck merged from the inside travel lane into her travel lane and impacted her in the aforementioned area. Marjorie stated the impact was hard enough for the Craig to have known impact was made. After impact, Marjorie pulled over to the side of the roadway assuming the Craig, the driver of the black pickup truck, do the same. Craig failed to do so and continued southbound on US Highway 1. Marjorie stated "Yamaha" in big letters was written across the rear windscreen of the pickup truck. Marjorie was unable to obtain a registration tag number, but stated the tag was green in color.

The estimated amount of damage of Marjorie's vehicle would cost \$2,000 to repair.

I was then informed by the IRCSO Real Time Crime Center; the crash was captured on video by the mounted traffic camera at the intersection of US Highway 1 & CR 510. Upon viewing the traffic camera recording, I observed both vehicles alongside entering the intersection. The black pickup truck then attempts to merge into the outside travel lane occupied by Margorie's vehicle. The impact is observed and Marjorie immediately veers off of the roadway and the black pickup truck continues southbound.

My investigation concluded Craig violated F.S. 316.061(1) - Leaving the scene of a crash resulting in property damage.

Based on Deputy Luther's investigation Sanders was placed into handcuffs where he was transported to the county jail for leaving the scene of an accident.

Based on my observations of Sanders and my believing him to be under the influence of an unknown substance once at the jail he was given the opportunity to dispel my fear by submitting to a series of field sobriety exercises. Post Miranda and with Sanders agreeing to perform the exercises he was asked if there were any medical conditions that would keep him from performing the exercises. Sanders stated that he has and operate a motor vehicle.

The first exercise Sanders was asked to perform was the Walk and Turn: After explaining the stance that the suspect was required to stand in, I asked if he understood, he advised he did. The suspect did not start prior to being instructed to. The

suspect did not lose balance during the instruction. After explaining the exercise, the suspect advised he did understand. The suspect then walked 10 out of 9 steps down, and 10 out of 9 steps back. He did not have to stop or pause to steady themselves and did not lose balance or step off the line. He did fail to walk heel to toe and did not use their arms for balance. The suspect did not lose balance while turning but executed an incorrect turn.

The second exercise Sanders was asked to perform was the One Leg Stand: While explaining the instructions to him the suspect appeared to fall asleep. After explaining the exercise to the suspect he advised he did understand the instruction. The suspect did not sway while balancing and did not use their arms for balance. He did not shuffle or hop on their base foot. The suspect did not lose balance or but put their foot down but did not lift his foot as instructed instead bending his knee lifting his foot behind him.

The Finale exercise Sanders was asked to perform was the The Finger To Nose Evaluation: After explaining the exercise to the suspect he advised they understood the instruction. While completing this exercise, the suspect's eyes did remain closed but he did not keep his head tilted back he did not sway back and forth or side to side. The suspect did not fail to return their arm to the down position. The suspect's finger did touch something other than the tip of the nose. The suspect did hesitate finger placement and did not attempt to, or use the wrong hand.

Based on the aforementioned, I had probable cause to believe that THE SUSPECT was driving or in actual physical control of a vehicle within this state; and under the influence of alcoholic beverages, a chemical substance set forth in FSS 877.111, or a substance controlled under Chapter 893, which effected THE SUSPECT to the extent that HIS normal faculties were impaired.

THE SUSPECT was arrested and transported to Indian River County Jail for booking, where he was turned over to Corrections Deputy. Corrections Deputy requested THE SUSPECT submitted to a chemical test of his breath but the results of which were 0.00.

Due to the results of the test of Sanders breath I requested a drug recognition expert, Corporal J. Chouinard to respond to the jail. Per Cpl. Chouinard, Sanders agreed to participate in a drug influence evaluation. At the conclusion of the evaluation, Cpl. Chouinard determined that Sanders was under the influence of a narcotic analgesic and was unable to operate a motor vehicle safely.

Cpl. Chouinard requested a urine sample from Sanders who refused. Cpl. Chouinard then read implied consent to Sanders. Sanders again refused to provide a urine sample.

On August 14th, 2025, at approximately 0955 hours, Sebastian Police Department Special Response Team (SRT) was executing a search warrant at 214 Harp Terrace, Sebastian, Florida 32958.

Upon their arrival, members from the SRT team made loud, clear verbal announcements that law enforcement was outside to execute a search warrant, and anyone who was inside the residence was to come outside and surrender. These commands were given over an intercom device multiple times, loud and clear. Due to nobody exiting the residence after multiple commands, Sebastian PD SRT team attempted to breach into the home to make forced entry. This was attempted three times.

Once the SRT team made a successful breached forced entry into the home, more loud clear verbal commands were given for anyone inside the residence to make themselves known. This was done multiple times to which no one came forward to surrender themselves. SRT then ultimately made contact with an adult female, identified as Jessica Hamel. Jessica was located by the SRT team even though she was given multiple opportunities and lawful commands to exit the residence and surrender herself to law enforcement. Jessica was taken into custody without incident.

Once in custody, Jessica was advised of her Miranda Rights which she understood. I asked Jessica if she was willing to speak with me to which she stated she wished to speak with her lawyer. No further questioning was done at this time.

Due to Jessica refusing to exit the residence after being given multiple opportunities and commands both before and after the SRT team breached into the home to make entry, obstructing the ability for the SRT team to properly and safely execute the search warrant which was being served, I found probable cause to place Jessica under arrest for violation of FSS 843.02 RESIST OFFICER WITHOUT VIOLENCE.

Jessica was transported to the Indian River County Jail without incident.



### NARRATIVE

On August 14, 2025, at approximately 1919 hours, I observed a red GMC pick-up truck traveling at a high rate of speed, north on Indian River Boulevard. I confirmed the speed to be 60-mph in a 45-mph zone with my STALKER DSR 2X SN: DB014914.

As I was attempting to catch up to the vehicle, I observed the vehicle run the red light at the intersection of Indian River Boulevard and 41<sup>st</sup> Street, northbound on Indian River Boulevard.

Prior to initiating the traffic stop, I ran an NCIC/FCIC query of the Florida tag on the red GMC, CP73RY. I learned the registered owner, Robert Presly did not have a valid Florida driver's license.

I initiated a traffic stop at the intersection of Indian River Boulevard and 45th Street, the vehicle came to a final stop at Orchard Grave Apartments, located at 1810 Woodland Circle, Vero Beach, Florida.

As I approached the vehicle, I observed the driver, Robert, jump into the back seat of the truck, and his girlfriend, Eileen Cuevas slide into the driver's seat from the front passenger seat.

I had Corporal Hatton take Eileen out of the driver's seat, and I removed Robert from the vehicle and placed him in handcuff restraints and checked for proper fit. I placed Robert in the rear of my patrol car. Robert asked why he was being placed in handcuff and in my patrol car. I informed Robert what I observed. He denied driving, and said Eileen was driving because he did not have a valid driver's license.

I asked Robert if he had a valid marijuana card, because I could smell the burnt marijuana, he stated there was no marijuana in the vehicle, only CBD flower.

K9 Deputy McKay conducted a free air sniff, with his K9 partner Tobi. K9 Deputy McKay's K9 partner Tobi alerted to the vehicle for odors he is trained to detect. A search of the vehicle was conducted, several small baggies consistent with the sale of illegal controlled substances were located, along with a green leafy substance scattered across the floor of the vehicle.

I reapproached Robert and explained to him, if he was honest, he would have just got a ticket. Robert admitted to driving the vehicle. I informed him about the green leafy substance on the floor, he advised he had a marijuana card.

I conducted a field test of the green leafy substance with an agency test kit, which can differentiate the difference between CBD and marijuana. The test of the green leafy substance revealed it was marijuana, and not CBD.

I contacted TELETYPE to confirm if Robert had a valid marijuana license. I was informed he did not.

I informed Robert he was being transported to County Jail for knowingly driving without a license.

This investigation was captured on my agency body worn camera, and the front dash camera of my agency patrol



### LONG CONTROL OF THE PROPERTY O

On Thursday, August 14, 2025, at approximately 1808 hours, I, Deputy M. Neill #6317 responded to Oslo Road (9<sup>th</sup> Street SW) and 43<sup>rd</sup> Avenue SW, Vero Beach, Indian River County, Florida, in reference to a single vehicle crash.

Deputy Estrella and I responded to the crash scene. Deputy Estrella spoke with the driver, Mr. Maximillian Bonilla while I spoke to a witness. The witness stated he was facing southbound at the intersection as he observed a gold Toyota passenger car heading north. The gold car approached the intersection at a high rate of speed. The vehicle then attempted to make a left turn at the intersection to proceed west. The vehicle was unable to make the turn due to the high speed. The witness stayed on scene and made contact with Mr. Bonilla. Mr. Bonilla stated to the witness that he was going to flee the scene. The witness advised him to go ahead, but the cops are already on the way. The driver appeared frantic and looking around. Law enforcement then arrived just minutes later. The witness positively identified Mr. Bonilla as the driver of the vehicle at the time of the crash.

Looking at the crash scene, damage to vehicle and property, as well as the tire marks, it does appear consistent that the Gold Toyota was traveling northbound at a high rate of speed, attempted to make a left turn too quickly, which resulted in the vehicle leaving the roadway, striking an Indian River Sheriff's Office FLOCK Camera, and then coming to a final rest off of the roadway.

Upon speaking to Mr. Bonilla, he advised he was the passenger in the crash and that his father was driving the vehicle. He provided the statement and was adamant he was in the passenger seat at the time of the crash. It should be noted that Mr. Bonilla had the keys in his hand upon speaking to law enforcement, and there was a large amount of property in the passenger seat, making it unlikely that there was a subject sitting in the passenger seat.

No other callers called in to report the crash or reported that they observed someone running from the crash. The traffic cameras were pointed in the wrong direction and did not capture the crash.

I changed from a crash investigation to a DUI investigation. Mr. Bonilla was advised of his constitutional rights. He advised he understood his rights and was willing to speak to us. He again denied driving the vehicle at the time of the crash and stated his father was driving. I attempted to call his father but was unable to make contact by phone. Both Mr. Bonilla and his father are from New York.

While speaking to Mr. Bonilla, he appeared to have droopy eyes, be on the nod, have constricted pupils, and have foam around his mouth. Due to the clues of impairment and his driving pattern, a DUI investigation was completed. Mr. Bonilla agreed to perform Standardized Field Sobriety Exercises. They go as follows:

Horizontal Gaze Nystagmus (0/6): Mr. Bonilla did not have a lack of smooth pursuit, did not have a distinct and sustained nystagmus at maximum deviation, and did not have an onset prior to a 45-degree angle. He did not have Vertical Gaze Nystagmus. He did move his head during the exercise.

Walk and Turn (5/8): Mr. Bonilla fell off line during the instructional stance, missed touching heel to toe on some steps, took too many steps, turned improperly, and stopped to steady himself.

### NARRATIVE (Continuation)

One Leg Stand (3/4): Mr. Bonilla hopped while attempting to balance himself and, swayed, used his arms for balance.

Based on my training and experience, I believed Mr. Bonilla was operating a vehicle while under the influence. I informed Mr. Bonilla to place his hands behind his back and Deputy Estrella and I grabbed his arms to place him under arrest. As we grabbed his arms, Mr. Bonilla tensed up. He actively resisted arrest and had to be taken to the ground. It took three deputies to place Mr. Bonilla in handcuff restraints.

During a search incident arrest of Mr. Bonilla's person, I located a glass smoking device which appeared to have methamphetamine residue within it. Additionally, 0.1 grams of field test presumptive positive methamphetamine was also located in the same left pants pocket.

Once in handcuff restraints, Mr. Bonilla continued to resist deputies by tensing his legs and bracing to avoid being placed in the patrol vehicle. Due to his high level of resistance and statements made, deputies attempted to secure Mr. Bonilla in further restraints to be able to safely transport him. Upon attempting to restrain him further, Mr. Bonilla grabbed Deputy Estrella's left thumb with his hand to prevent him from being able to use his hand. Mr. Bonilla was provided multiple chances to let go of Deputy Bonilla's hand. Force had to be used in efforts to free Deputy Estrella's hand from Mr. Bonilla.

Shortly after, Mr. Bonilla lunged his head forward to my left thigh. Mr. Bonilla placed his teeth on to my thigh, closing his mouth in attempts to bite me. Contact was made from his teeth to my thigh, but due to him being moved at the exact time, he was unable to successfully bite me to cause injury.

Later at the hospital, Mr. Bonilla apologies for attempting to bite me earlier. Upon asking him more questions about the crash, he advised a "unknown" subject was in the vehicle with him, but could not recall who. He confirmed that his father was in New York and no where around to be able to drive or operate the vehicle at the crash. He acknowledged the possession of the Methamphetamine and the drug paraphernalia. He advised he was going to smoke the methamphetamine later on today, but had not done so yet. He advised Amphetamines would be in his system if we completed a urine screen. He does not remember a lot of the crash or events which led up to his arrest earlier. He advised his head was foggy earlier and he was not thinking or acting right.

While at the jail, Mr. Bonilla refused to provided a breath sample.

Based on the above information, probable cause exists to arrest Mr. Maximillion Bonilla for two counts of Battery on Law Enforcement, pursuant to FSS 784.07(2)(b), possession of methamphetamine (Controlled Substance), pursuant to FSS 893.13, Driving Under the Influence, pursuant to FSS 316.193, DUI Property Damage, pursuant to FSS 316.193.3c1, and providing a false crash report, pursuant to FSS 316.067.

# NARRATIVE

On August 14, 2025, at approximately 1924 hours, I responded to Holiday Inn, 9400 19th Avenue, Vero Beach, regarding trespassing.

Before my arrival, the caller who is an employee of Holiday Inn, advised that a black female refused to leave the property. He said the female was walking around the lobby and did not have a room in the hotel. The caller said the female's manager had requested she leave, but she refused. After the manager threatened to call the police, the caller advised that the female had fled from the hotel towards Cracker Barrel.

Upon arrival, I made contact with the manager of the Holiday Inn. He advised the female left the scene. The manager described the black female as wearing a surgical mask, black jacket, short black spandex shorts, and flip flops. The manager advised that the female did not have a room in the hotel. His employee notified him about the female loitering in the lobby. Once he went downstairs, he made contact with the female who was near the elevators. He instructed the female to leave his property. The female refused to leave. He advised her that the police were being called. The manager advised that two males from another hotel came walking up. The female saw them and took off running toward the pool. After making it outside, the female jumped the fence towards the Cracker Barrel. The two men advised the manager that the female possibly took his phone. The manager advised them to wait for law enforcement to arrive.

While speaking with the manager, two white males walked up to my patrol vehicle. One of the males alleged that his phone had been stolen from the Hampton Inn. The males were identified as Larry Dasher (Victim) and Christopher (Chris) Gardner (Witness). Larry advised that his phone had been taken from the Hampton Inn.

I then spoke to Larry, who advised the following: Larry advised that he was checking into the Hampton Inn with his friend, Chris. Larry advised that while checking into the hotel, he observed a black female walking around the lobby. The female was described as black, wearing a blue surgical mask, a black jacket, short black spandex shorts, and flip flops. Larry said that he had finished what he was doing and had left the front desk. After grabbing his items, Larry noticed his cell phone wallet was missing. Larry could not remember if he left it in his vehicle or on the check-in counter. Larry advised that he looked in both locations and could not locate it. Larry advised that the phone wallet was black and it had his Black iPhone 15 Pro Max, with several credit and debit cards, and his Florida Identification card. The amount of the items taken was approximately \$1200.

Larry said he had walked outside and seen the same black female take off running towards the Holiday Inn. Larry advised that he had called his wife, who started tracking his phone. The phone was located and tracked to the Holiday Inn, where the female ran off. Larry advised they got into truck and responded to the area. At this time, the manager of the Holiday Inn advised the same female went around back to the pool area. Larry and the manager returned to the pool and observed the female jump the fence towards the Cracker Barrel. Larry advised that he had his wife look at the "find my phone" location again, and it was pinging in the area of the Cracker Barrel. After noticing that the female suspect had his phone, he waited until law enforcement arrived.

After getting all the information, I advised dispatch the information gathered and had other units respond to the scene. Deputy Wolf Shaw and Anthony Consalo responded to the scene for assistance. While waiting for units, I tracked Larry's phone through "Find my iPhone." The locations were all over the three parking lots: Holiday Inn, Stake n' Shake, and Cracker Barrel. I realized every time we moved closer to the phone ping, it would move away. This was possible due to the female suspect having it on her person.

After Deputy Shaw and Consalo arrived on scene, they assisted me with the search for the suspect and Larry's

phone. Also, Larry and Chris were helping us because they had the ping locations on Chris' phone. While walking the parking lot of Shake n' Steak, Chris looked over towards the Cracker Barrel parking lot and observed the same female walking behind the bushes. The female was wearing the same clothing and had a black duffel bag with her. As Chris pointed the female out, Deputy Shaw observed the female walk towards the bush line in our direction. Deputy Shaw advised that he follow her to the bush line. The female observed Chris and Larry yelling towards Deputy Consalo and me. The female initially started running inour direction, but noticed she would be in front of us. The female quickly turned around and ran towards Deputy Shaw's location.

Deputy Consalo and I lost sight of Deputy Shaw due to the bushes. We attempted to call Deputy Shaw over the radio, but could not reach him. We then heard the female screaming and ran in that direction. We located Deputy Shaw attempting to detain the female who was physically resisting him. Deputy Consalo and I assisted Deputy Shaw, who was trying to get the female's hands behind her back. After a few more seconds, we were all able to place the female into handcuffs and my patrol car.

After detaining the female, Deputy Shaw gave me a rundown of what happened when we lost sight of him. Deputy Shaw stated the following:

"Deputy Wolf advised he observed a black female matching the description (black t-shirt, short shorts, and wearing a mask) hiding in the brush approximately fifty (50) feet in front of his vehicle. Deputy Wolf advised that he move his vehicle to where the female was last seen. Deputy Shaw recognized the female had taken off running west from where she was last seen. The female turned around and began running towards Deputy Shaw; He was able to grab her and take her to the ground.

While on the ground, Deputy Shaw attempted to gain control of the suspect by grabbing her arms so she could stop kicking and screaming. It should be noted that the suspect was on her back when she grabbed Deputy Shaw's agency-issued taser. Deputy Shaw attempted to gain control and turn the suspect onto her stomach so she could be placed into mechanical restraints. Deputy Shaw was able to put the suspect on her stomach, and she managed to bite Deputy Shaw's left forearm. Deputy Shaw struck the suspect twice in the face near her left eye until she released, and he was able to gain control.

Deputy Shaw advised Corporal Thomas, and Deputy Consalo quickly responded to my location to assist with placing mechanical restraints on the suspect. The suspect was placed into Corporal Thomas' vehicle."

After speaking with Deputy Shaw, he had to be transported to the hospital due to the female's bite breaking his skin. Deputy Shaw sustained several lacerations on his left forearm from the female biting him. After speaking with Deputy Shaw, I asked the female if she needed any medical assistance due to a minor laceration on her head. The female stated, "No." I then secured the female duffle bag and flip flops on the ground near her feet. The bag was placed on my patrol vehicle.

I then spoke to the female and asked her for her name. The female gave me the name "Nick Capelton" and the date of birth, "07/26/1976." Due to the female looking younger, I informed her that providing a false name to law enforcement was an additional charge. The female advised, "That's my name." I asked for other identifiable information, and she would repeat, "I am not for certain." I ran the name via dispatch, but it did not come back to anyone. I then read her Miranda Warnings. The female advised that she understood her rights and wished to speak with me without her lawyer present. The female stated the following: I asked the female if the duffel bag belonged to her. She stated that everything in the bag belonged to her. I informed the female that she was being detained due

to the theft of a cell phone. The female advised that she had no idea what I was talking about. She denied taking the phone or knowing where it was located.

After speaking with the female, I searched her duffel bag. I located several items that were inside the main pocket. I located a loaded Glock 44 .22 caliber pistol, an airsoft gun, identification cards, four phones, one iPad, and Larry's phone case wallet with all his property. The only thing missing from Larry's items was his black iPhone 15 Max, which was now turned off. After finding the items, I ran the firearm through FCIC/NCIC, which was not stolen. I located a U.S. Passport, a Missouri identification card, and a Missouri Birth Certificate named "Londyn Salena Capelton." I ran Londyn through dispatch for a want/warrant and a criminal history check. The check revealed that Londyn was not a convicted felon or had any criminal history.

The photos on Londyn's identification cards looked similar to the female detained in my patrol vehicle. I asked the female if she was Londyn Capelton. She advised, "No, that is my family member." I asked the female if she knew which family member was to her. She replied, "I am not certain." I then contacted Agent Cesar, our resident United States Border Patrol Agent, for assistance verifying if the female was Londyn Capelton. Agent Cesar ran the female's photo and positively matched the female as Londyn Capelton.

After identifying Londyn, I asked her if everything in the bag belonged to her. Londyn stated, "Yes." I informed Londyn that I located a gun and Larry's property in her bag. Londyn advised that she had no idea who I was talking about and that the bag belonged to her. I attempted to find the location of Larry's phone, but Londyn refused to tell me where it was.

After speaking with Londyn, I returned to Larry and Chris, who identified Londyn as the female in the hotel lobby near Larry's missing items. Larry said he wanted to pursue criminal charges against Londyn for Grand Theft. The total amount of all the items was approximately \$1250. Larry's phone case wallet, credit, debit cards, and Florida Driver's License were the only items recovered. The property returned amount was approximately \$50. Londyn was also identified as the female trespassing in lobby of the Holiday Inn.

Based on the evidence gathered, I arrested Londyn for violations of F.S. 784.07 (2)(d) – Battery on Officer/Firefighter/EMT, F.S. 843.01 – Resisting Officer with Violence, F.S. 812.014 (2)(c)(1) – Grand Theft 750 less than 5K dollars, F.S. 810.08 (2)(a) – Trespassing Structure or Conveyance, F.S. 901.36(1) - Giving a False Name while Detained. Londyn was transported to the Cleveland Clinic for medical clearance. After being medically cleared, Londyn was transported to the Indian River County Jail.

### NARRATIVE

On August 14, 2025, at approximately 2333 hours, I responded to 760 8th Court, Speak Easy Bar, Vero Beach, Florida, in reference to a Disturbance.

While enroute Indian River County public safety dispatch advised that the suspect later identified as Christopher White was a black male with dreads and a white tank top.

Upon my arrival, I entered the bar and observed the Victim later identified as Hermenegildo Hernandez, on the floor on his back bleeding from his chin and the back of his head. Witnesses at the bar pointed to White as the suspect. I detained white and brought him to my patrol vehicle. While patting White down for weapons he stated that he did hit Hernandez one time because Hernandez "ran up on him".

I then spoke with the caller John Clements, who stated that Hernandez and White were arguing, they came face to face and White struck Hernandez causing him to fall on the floor unconscious.

I then read White his Miranda rights which he waived. Post Miranda White stated that Hernandez wanted to fight him and walked towards him aggressively causing him to defend himself and strike Hernandez on his chin. It should be noted that Hernandez never touched White. White also mentioned that his friend Charles Russel was in between them at one point and stated to Russel that he's not worried about Hernandez. White stated that the disagreement was because of twenty dollars owed to White.

I then spoke with Russel who stated that they are friends and were playing pool arguing over money. Russel stated that he walked away and that's when it all happened.

Hernandez was taken by EMS to Cleveland clinic for his injuries. Hernandez does not remember being hit and only remembers playing pool.

Based on the facts listed above, White intentionally struck Hernandez. I find probable cause to charge White with:

1. F.S.S. 784.03.1a1 - Battery touch or strike.
