## NARRATIVE

On May 5, 2024, at approximately 2346 hours, I responded to the area of **second second second** 

Upon arrival, a black Chevrolet Malibu (FL Tag: 07AYYD) was located in the driveway of the residence. Due to the allegations of a firearm, a felony traffic stop was conducted on the vehicle. All occupants of the vehicle were asked to step out and ultimately secured in handcuffs. The driver of the vehicle was identified as Ny'keed Mccray, the front passenger was identified as Marcello Gibson and the two rear passengers were identified as Tatyanna Morgan and Nakayla Williams. All of the subjects were placed into the back of marked patrol vehicles.

Upon clearing the vehicle, a black rifle was located in plain view in between the center console and front passenger seat. A grey and black handgun was also located on the floor board below the driver's seat. Both firearms were later found to be loaded with ammunition.

I then made contact with Jasmine Sartin who was inside of the house. Jasmine provided a sworn, verbal statement advising the following:

Jasmine said she was with her friends, Tatyana Morgan and Nakayla Williams, at her residence located at Jasmine said they invited two other males over, who were later identified as Marcello Gibson and Ny'Keed Mccray. Jasmine advised they were in her bedroom, smoking marijuana when Marcello started to argue and be disrespectful. Jasmine said she asked all of the subjects to leave, due to them being loud and her having roommates but the subjects refused and continued to talk loudly. Jasmine advised Ny'keed then became upset and pulled a grey or silver handgun from a white bag and started to waive it around the room. Jasmine said while Ny'keed was waiving the gun, he said he was going to "shoot the whole place up."

Jasmine said she asked the subjects approximately 4 times to leave the property. Jasmine advised the subjects eventually started to walk towards the front door of the residence when she heard Marcello say "I'm going to get the strap out of the car." Jasmine said she also heard one of the subjects say they were going to wait for her to come outside.

Jasmine advised Marcello, Nykeed, Nakayla, and Tatyana all exited the house and got into a dark colored sedan that was

Jasmine said she watched Ny'keed get into the driver's seat of the vehicle and she watched Marcello get into the front passenger seat of the vehicle.

Jasmine advised she wanted to prosecute and testify.

I then made contact with Marcello Gibson who was secured and in the back of a patrol vehicle. Marcello was read Miranda Rights from my agency Miranda Card. Marcello said he understood his rights and wished to speak with me at that time.

Marcello stated he came to the residence with Ny'keed to hang out with friends. Marcello said he never entered the residence and remained on the front porch. Marcello advised there was no altercation. He also stated there was another male at the address prior to Law Enforcements arrival but he had no further information to provide.

I then made contact with Ny'Keed who was secured in the back of a patrol vehicle. Ny'keed was read Miranda Rights from my agency Miranda Card. Ny'keed advised he understood his rights and wished to speak with me at that time.

Ny'keed said he picked up Marcello from West Palm Beach and they drove to **see Tatyana** and Nakayla. Ny'keed said when they arrived, they went inside and were hanging out before Jasmine started to get jealous due to her not getting attention. Ny'keed said they eventually left the residence and went to smoke marijuana in his vehicle that was parked in the driveway.

Ny'keed stated he did have a pistol on his person while he was inside the residence. Ny'keed denied pointing the firearm at anyone or displaying the firearm.

NARRATIVE

On Monday, May 6<sup>th</sup>, 2024 at approximately 1854 hours, I Deputy Ramiro Doval responded to the area of 40<sup>th</sup> Street and 43<sup>RD</sup> Avenue, Vero Beach, Florida in regards to a disturbance in progress.

While enroute to the above location, I learned the complainant was at a stop sign at the intersection of 43<sup>rd</sup> avenue and 40<sup>th</sup> street, when a male wearing blue shirt dark colored pants and wielding a skateboard was threatening the caller stating he was going to kill her. The male then threw an alcoholic beverage in her vehicle and the male was now walking away on 41<sup>st</sup> Street walking east bound.

While still enroute to the above location, I observed the male matching the description the complainant gave dispatch at the 3900 block 41<sup>st</sup> Street. Myself and Deputy Whisman stopped out with the subject. As soon as the male observed my patrol vehicle, he threw his hands up, with a skateboard in one hand and appeared to be irate and began to approach my vehicle in an aggressive manner. He was immediately detained, due to his behavior.

Once he was detained, Deputy Whisman made contact with the complainant, later identified as Jessica Gerard. I was able to retrieve Jessica's contact information and called her and asked her to tell me what happened prior to our arrival. Jessica stated she was at the intersection of 43<sup>rd</sup> avenue and 40<sup>th</sup> street awaiting traffic to slow down to enter 43<sup>rd</sup> avenue. A Hispanic male, later identified as Bryan De Paz Vazquez, was walking northbound on 43<sup>rd</sup> avenue and threw his hands up in the air and appeared to be upset. Jessica then threw her hands up, this made Bryan even more upset, Bryan then slapped her vehicles hood, causing no damage.

Bryan then began to approach Jessica's vehicle in an aggressive manner with the skateboard. This placed Jessica in fear, Bryan then stated "people have died here" and began using profanity towards Jessica, at one point Bryan told Jessica "I will fucking kill you and murder you. Do you see these colors"? Bryan then pulls out a blue bandana, this really placed Jessica in a well-founded fear that Bryan was going to harm her in some way. Jessica attempted to put her windows up, Bryan then threw an alcoholic beverage in her vehicle, spilling alcohol all over her seats and floor board staining them, causing her vehicle to reek of an alcoholic beverage.

I asked Jessica how much would it cost her to have her seats shampooed and cleaned, Jessica stated \$200.00 dollars. She stated she was on her way to pick her up her children and would have to roll the windows down to let it air out.

I spoke to Bryan, he was irate. Bryan stated he did throw beer in her vehicle but denied telling her he was going to kill Jessica or showing his bandana, but did state he did use profanity towards her because her vehicle was passed the stop bar and this made him upset. Bryan would speak to me in Spanish and English. It should be noted, Bryan did have odor of an alcoholic beverage emitting from his breath and did not wish to speak to me any further.

At this time, I placed Bryan under arrest for the following offenses;

## NARRATIVE

On the night of 05/06/24, I responded to the intersection of 27th Avenue and 9th Street SW in reference to a two vehicle crash. During the initial investigation, it was discovered that the driver of the at fault vehicle left the scene of the crash without rendering aid or providing information. My investigation revealed that after the collision, the driver later identified as the defendant Travis Drinkard driving a 2005 Dodge Ram 2500 pulled the vehicle in to the parking lot of Cumberland Farms (880 27th Ave SW). Once in the parking lot, the defendant crawled out of the vehicle through the passenger side door. A few moments later, he fled the area on foot traveling in a western direction. The driver was identified by the passenger/owner of the vehicle Antonio O'Neill-Dunham. A review of the store's video surveillance footage also showed the defendant exiting the truck then leaving the scene.

While on scene, contact was made with Travis via telephone at which time he was instructed he needed to return to the scene. Approximately 10 minutes later, Travis returned to the scene at which time I made contact with him. I advised Travis of his Miranda Rights from a pre-printed card, he stated he understood each of his rights and agreed to speak with me. Post Miranda, Travis stated he was driving the vehicle due to his friend Antonio "Tony" had been drinking. He also stated he didn't have his license, to which I asked if he had a license at all or if it was suspended. He stated he has never had a license issued. I asked him why he fled from the scene and he replied because all of his friends were there telling him to. Travis stated he was going to stay at the scene but everyone told him to leave.

A query of Travis' license via DAVID revealed he does not have a license issued and only has a valid ID card.

Travis was cooperative during the investigation upon his return to the scene. He was placed under arrest and transported to the Indian River County Jail where he was processed and held in lieu of a \$1,000 bond.



- During the course of driving a vehicle while under the influence of alcoholic beverages
- Did and was determined to have a breath alcohol .08 or more grams of alcohol
- per 210 liters of breath; to wit
- The Defendant provided samples of .120 & .123, respectively.

### DRIVING WITHOUT A LICENSE (NEVER ISSUED) in that the Defendant was:

- Knowingly and willfully;
- Driving/ Operating a motor vehicle;
- Upon a public road/ highway within of this state this state;
- Without a driver's license never issued.

On 05/06/24 at approximately 0100 hrs. I, Ofcr. S. Gonzalez (471), responded to the parking lot of the Sunshine Laundry located at 2020 6th Avenue, in Treasure Coast Plaza.

I was responding in response to a request from Ofcr. H. Hogue (468) for assistance.

Upon arrival, I was informed that the occupants of the vehicle she had stopped did not speak English and therefore she needed me to translate from English to Spanish and vice versa.

Ofcr. Hogue informed me that she was traveling west on 20th Street when she observed a white pick-up truck driving on east lanes of westbound 20th Street (the wrong way) right at her in the approaching 6th Avenue.

Upon stopping and making contact with the Defendant, Ofcr. Hogue informed me that she observed that the Defendant was the driver and in actual physical control of the vehicle. Ofcr. Hogue also informed me that she could smell the odor of an alcoholic beverage emanating from within the vehicle and that she also observed that Defendant's eyes were red.

While speaking with the Defendant, I observed that the Defendant's eyes were very red and that there was a strong odor of an alcoholic beverage emanating from his breath as he spoke.

The Defendant identified himself as JOSE MARIANO CASTILLO and was asked if he had a driver's license to which the Defendant stated that he did not. A subsequent driver's license check through dispatch confirmed that the Defendant did not have a driver's as there were no records for a driver's license for him.

When asked as to his whereabouts prior to being stopped, the Defendant stated that he's been out with the other passengers at a dance.

When asked about his alcohol consumption, the Defendant stated that he had consumed 5 beers with his last beer being consumed sometime between 7 p.m. and 8 p.m.

During my conversation I noted that, in addition to the red & glassy eyes and odor of an alcoholic beverage emanating from his breath, the Defendant's speed was slow and mumbled and further displayed an orbital sway while standing.

After speaking with Ofcr. Hogue, she requested that I conduct a DUI investigation at which point I became the primary officer and probable cause for the stop was transferred to me based on the Fellow Officer Rule.

I walked the Defendant over about 10 feet to the breeze way where I administered Field Sobriety Exercises ("FSE's") after informing the Defendant as to my observations and that based on his statements about his alcohol consumption as well as the fact that he had been driving on the wrong side of the road,

I, Ofc. Luna, was monitoring east and westbound traffic in the Rosewood school zone (16th St and 36th Ave-42nd Ave) when I observed a blue Toyota pickup entering the school zone eastbound at what appeared to be an excessive speed. Let it be noted the posted school speed limit in the school zone is 20 miles per hour. I visually estimated the speed to be 35 mph due to how fast the vehicle was approaching my vehicle. I activated my department issued radar unit (Stalker DSR2X) and received a Doppler tone which corresponded to my visual estimation, 37 miles per hour.

I got behind the vehicle without losing sight of it and initiated a traffic stop on the blue Toyota Pickup, bearing FL tag #BN73QQ. The driver, Dannyer J. Gonzalez-Rivas, was positively identified behind the driver seat of the Blue Toyota Pickup by providing his government issued work visa on scene. Citations for those summons are AHQYAKE and AHHG80E from Miami-Dade county.

Based on the information above I proceeded to arrest Gonzalez-Rivas for not having a valid license issued, FSS 322.03 (1). Gonzalez-Rivas was also issued a criminal citation for the above (citation# AJH060E) with a court date of 06/04/2024 at 0830 hours. The citation was also signed by Gonzalez-Rivas. The vehicle was turned over to a licensed driver, Josebert Jose Mendez Belmonte, who was in the passenger seat of the vehicle.

On May 6th, 2024, at approximately 1846 hours, I was dispatched to

in reference to a disturbance/fight.

Upon arrival, I made contact with the caller, identified as Marilyn Romero. Marilyn stated her ex-husband, Jesus, took her phone during an altercation. Marilyn stated the two were arguing over custody of their children which they have together. The argument began to escalate, resulting in Marilyn stating she threw plates of food Jesus was cooking on the ground in his direction. According to Marilyn, at some point during this altercation she and Jesus were by the couch which was when Jesus pushed her down and sat on her. Marilyn described this to me by saying Jesus was facing away from her and turned back in her direction. She fell on the couch and Jesus proceeded to sit on her, while attempting to grab her phone. Jesus was ultimately able to take her phone and not give it back to her. Marilyn repeatedly told Jesus to give her phone back to her in order for her to leave. Marilyn also informed me that Jesus went outside and threw all her clothes on the ground to which she did the same. Due to Jesus not giving Marilyn's phone back to her, she decided to call law enforcement.

I made contact with Jesus Romero. Immediately upon interviewing Jesus, I observed a fresh swollen wound below his left eye. Jesus stated the two began arguing over text about a man Marilyn recently began talking to. Jesus was cooking at home for the kids, which was when him and Marilyn began to argue more over custody over their children they have together. While Jesus was in the kitchen, Marilyn came over and threw most of the food off the counter in his direction. While speaking with Jesus I observed stains on his shorts consistent with food landing on clothing. Jesus took me inside the kitchen where I observed things to be in disarray. Jesus further informed after Marilyn did that, he felt her hit him in the face with an unknown object. Due to him not looking at her and only feeling the instant pain, he was unable to describe to me what he was hit with. After this occurred, Jesus took their children to the neighbor's home so they were not present for the remainder of this incident. Jesus also took a video after the incident inside of the kitchen, which shows his injury in a close up and he is saying in the video that he was hit by his wife.

I made contact with the neighbor was also present on scene, identified as Michael Carrano. Michael stated the following in a sworn written statement: "I was home and my bell rang, I answered the door and visibly saw my neighbor Jesus Romero bleeding from under his eye saying his wife hit him while she was yelling **stated be** took my phone.' My wife took her and the girls in the house and then **stated be** from her daughter's phone."

I also made contact with Jesus and Marilyn's 11 year old daughter, Anyssa Romero. Anyssa stated she did not see most of the altercation between her parents and mostly heard the yelling. Anyssa did state prior to the altercation, Jesus did not have any marks on his face. Anyssa also stated that at no point in time did she see the two of them next to the couch area.

I advised Marilyn of her Miranda Rights to which she agreed to speak to me. I asked her about the mark on Jesus's face. Marilyn stated she has no idea how he acquired that. Marilyn observed him go outside to throw her clothes everywhere and when Jesus came back the mark was suddenly there. It should be noted, the entire time I spoke to Marilyn while on scene I did not observe any marks or injuries to her person.

Due to what I observed on Jesus's face as well as his shorts, the statements of his neighbor Michael and Anyssa, not observing anything consistent to Mariiyn's person or on scene in correlation to what she said, I found probable cause to place Marilyn under arrest for violation of FSS 784.03(1A1) Battery (DV).

Marilyn was transported to the Indian River County Jail without incident.
