

NARRATIVE

On 11-18-2025, Suspect Lauren Elizabeth Endres did intentionally and unlawfully remove merchandise from the business of the Home Depot, located at 1885 58th Avenue, Vero Beach, without paying passing all points of sale. These actions were done with intent to deprive the business of their rights to the merchandise.

I made contact with Asset Protection Specialist Keith Weinberg, who stated that he observed Endres remove merchandise from the shelves and conceal it in a large bag that she had brought into the store with her. Weinberg observed her walk past all points of sale with the items concealed in her bag and a security system in her left hand and exit the store without paying for the merchandise.

NARRATIVE (Continuation)

I observed video from the business and observed Endres carrying a multicolored bag on her shoulder and a security system in her left hand as she walks past all point of sale and exits the business.

I made contact with Endres and advised her of her Miranda Rights. Post Miranda, Endres admitted to going to the Home Depot with the sole purpose of stealing items from the business and selling them. Endres stated that she is hard up for money and needed some cash to pay her bills. She got a call from a friend who told her a guy name John would pay her from some items from Home Depot. John told her what items to go get and she did. She does not know who John is but has met him a couple times. She does not know if John is his real name and she does not know where he lives. Endres admitted to placing the items in her bag to conceal them and walked out the store without paying.

Based on my investigation, I determined that there is Probable Cause to charge Lauren Elizabeth Endres with violation of Petit Retail Theft.

Endres was arrested and transported to the Indian River County Sheriff's Office County Jail without incident.

WALLES OF THE STATE OF THE STAT

On Tuesday, November 18, 2025, at approximately 1705 hours, I responded to the 1800 block of 58th Avenue, Vero Beach, FL, in reference to a retail theft in progress that occurred at Walmart located at 5555 20th Street.

Upon arrival, I made contact with Corporal Newberry, who had located the suspect, later identified as Christopher Dean Fultz. I took custody of Fultz and began coordinating my investigation with Deputy Hubbard, who was reviewing surveillance video in the Walmart Loss Prevention (LP) Office.

Deputy Hubbard advised that, upon reviewing the surveillance footage, he observed Fultz go to the self-checkout registers, scan items, and bag them. Fultz then attempted to pay for the items using a debit card; however, the transaction failed, and the items were not paid for. Fultz subsequently placed the bags into his shopping cart and proceeded to exit the store through the front doors. At the exit, Loss Prevention Specialist Jacob B. Parker intercepted Fultz and requested he return inside and go to the LP office. Fultz refused to comply, abandoned the shopping cart containing the unpaid merchandise, mounted his bicycle, and left the area, where he was ultimately apprehended by Cpl. Newberry. (See Deputy Hubbard's supplemental report for additional details.)

During my initial contact with Fultz as I escorted him to my patrol vehicle, he inquired why he was being detained. I informed him of the allegations, and he spontaneously stated, "I was going to go back and pay for the stuff," confirming the items had not been paid for. Fultz further stated that he attempted to pay by swiping his card, but it would not work. He then claimed he had purchased the items using the Walmart App "Shop & Go" function but was unsure if the transaction had been completed. He stated he attempted this at the register. This contradicted his earlier utterance that he intended to return to pay.

Cpl. Newberry contacted Deputy Hubbard by phone, and we discussed the incident. When I informed Deputy Hubbard of Fultz's claim that he used the Shop & Go feature, Deputy Hubbard re-reviewed the surveillance video and confirmed that although Fultz had his phone in his hand, he was not observed scanning any items. The Shop & Go process requires each item to be scanned individually before the sale can be finalized and payment completed. Fultz was not seen scanning any of the merchandise.

Due to this new information, I returned to my patrol vehicle and read Fultz his Miranda Warnings of Constitutional Rights. Fultz acknowledged understanding his rights and agreed to speak with me. When confronted about his earlier spontaneous utterance, he denied making it. When questioned further about his ability to pay, Fultz stated he had his mother on the phone trying to get her to send him money—again confirming the items had not been purchased.

Deputy Hubbard then responded to my location. He advised he had provided Jacob Parker with a link to upload the surveillance video using the Axon Community Request function. Deputy Hubbard provided me with a printed sales receipt and a written statement completed by Parker. The receipt indicated that 28 items were recovered, totaling \$144.43.

On 11/18/2025, at approximately 2032 hours, while on routine patrol stopped at the intersection of 12th Ave and 23rd St facing southbound. I observed a gold sedan exiting the parking lot of 7-Eleven (2296 US Hwy 1) approaching the intersection of 12th Ave and 23rd St. I then observe the vehicle run the stop sign.

While searching D1's purse, two empty syringes were located in a small zipper compartment inside the main purse compartment.

D1 was then placed under arrest for violation of F.S.S.893.147(1) Use Or Possession Of Drug Paraphernalia.

D1 was then transported to Indian River County Jail for processing and booking where she is held on a \$500 bond.

NARRATIVE

On Tuesday, November 18th 2025, I responded to 2335 Old Dixie Hwy SE, Vero Beach, FL, in reference to a suspicious person walking through backyards.

Upon my arrival, I made contact with Cathleen Craig who is the homeowner of the aforementioned address. Cathleen explained that a girl was walking around her front yard and was confronted by her son Dustin Craig and told to leave the property. Cathleen advised she observed the unidentified female later identified as Jessica Buffaloe looking through her window into her residence. Cathleen advised she was standing inside of her residence and was face to face with Buffaloe looking through the window at her. Cathleen advised she went out-front and told Buffaloe to leave her property. Cathleen advised the Buffaloe walked away into the dark and was located a few minutes later sitting in a chair on her back porch.

Cathleen and her son Dustin confronted Buffaloe again told her to leave multiple times. Cathleen also advised after telling Buffaloe to leave, she observed her looking through her window again before leaving her yard. Cathleen advised Buffaloe jumped the fence into her neighbor's yard and had to be told to leave that yard as well. I observed the video footage and confirmed the information provided by Cathleen as accurate. The video footage showed the female to be a white female wearing a white crop top and gray pants with dark hair. When asked directly Cathleen advised she does not know Buffaloe and has never seen her before. Cathleen advised Buffaloe was never invited to the residence and had no business being there.

I canvassed the area with Cpl. Quaglia and identified the residence of 2349 Old Dixie Hwy SE which had multiple dogs barking for an extended period of time. We made contact with Regina Kineaid who resides at this address. Cpl. Quaglia asked Kineaid if anyone should be in her fenced in backyard. Kineaid advised there should be no one in her backyard and gave us permission to search her back yard as the dogs continued to bark. At this time, we located Buffaloe who is a white female with dark hair wearing a white crop top with gray pants. Buffaloe was sitting in front of Regina shed inside of her fence in backyard. When asking Buffaloe what she was doing there, Jessica said I am tired. Buffaloe was placed into handcuffs and escorted outside of the closed gate of the fenced in backyard.

Cpl. Quaglia read Miranda Warnings from his agency issued pre-printed Miranda Warnings card to Buffaloe. Buffaloe acknowledged her rights and refused to speak with us. Due to Buffaloe being unable to dispel my fears or concerns of her reasons of being at the aforementioned addresses in the dark at the time of night that we found her inside of a closed fenced in-backyard of a residence where she does not know anyone who resides there. I took possession of her wallets and one lighter and a torch lighter which were all located inside of Buffaloe's pants. Jessica was placed under arrest and transported to
