

# NARRATIVE

On Tuesday, December 23<sup>rd</sup>, 2025, at approximately 1433 hours, I was contacted by Deputy C. Myers, in reference to a violation of injunction regarding case #2025-134560.

At approximately 2038 hours, I met with Deputy C. Myers in order to review audio recordings of phone calls, of Gabor Balogh, that were taken place at the Indian River County Jail. Deputy Myers advised the jail received an unknown phone call from a female subject asking if anyone at the jail has been trying to get a hold of Susanne Dunigan, who is the victim in case #2025-134560. He advised there were no records of the jail calling Dunigan. Deputy Myers advised he began reviewing the outgoing calls Balogh was making from the jail. Upon further review, Deputy Myers advised there were phone calls of Balogh asking a male subject to contact Dunigan.

Deputy Myers advised Balogh's First Appearance was 12/18/2025 at 8:30 A.M, where he was advised that he had an active No Contact Order with Dunigan. Approximately 48 minutes after First Appearance, at 0918 hours, Balogh called (646)-229-6614, which previous records indicated is Jonathan Coomes. Balogh explains to Coomes that Balogh was in jail because while he was drunk, he pushed Dunigan and she fell into a "wooden piece" and it cut her head open. He advised Coomes to call "her" and let her know that he loves her and he needs to talk. He referred to Dunigan as "Juicy Juicy". He advised Coomes to tell her "I'm crying. That I'm hysterical. That they charged me with the charges that I can get fucking up to 15 years, that my life would be over and ruined. And that we need to talk and that I love her and that I'm sorry. I was drunk and was out of control, it's not me. I'm fucking distraught. I'm crying on the phone to you. Can you go call her now please for me? And then I'll call you back in 15 minutes. And then let me know what she says. Please this is very important. We need to get her to uh, take care of it again, you know what I mean. And go down there...I'll go work on that part but you need to call and tell her I'm distraught, I'm hysterical on the phone. OK. Please. Be a little manipulative, alright." "If she don't drop the charges, I'm getting 10 years plus. Tell her. You hear me. Tell Big Juicy that. You hear me." He also advised Coomes to ask her if he is able to talk to her on the phone because he loves her and he is crying. He advised Coomes to "be a little convincing", and if she does not want to talk to him then to pack all his expensive belongings and send it to his mother.

Ten minutes later, at 0928, Balogh calls Coomes again. Balogh asked Coomes "What did Juicy say?", and Coomes responds "Absolutely not. She's going to do everything in her power to make sure you spend a good amount of time in jail. Adamant. Adamant. She's boxing up your stuff and as soon as your mother gets back to New York, she's sending it up to New York". The conversation continues for another few minutes, with both parties discussing Balogh's anger while he is drinking, and with Balogh asking Coomes to call her again to say sorry and that he loves her. Coomes advises that he will not be calling her again that day because he does not want to bother her.

I obtained copies of both recorded phone calls with the assistance from Deputy Myers, and uploaded them into Evidence.com.

I attempted to make contact with Dunigan, but was advised by a neighbor that Dunigan temporarily left town. Balogh using Coomes as a 3<sup>rd</sup> party to communicate with Dunigan caused Balogh to violate the active No Contact Order, therefore

BATTERY in that the Defendant did:

- Actually and intentionally;
- Touch or strike the Victim to wit a forceful slap; and
- Against the will of Victim;
- Contrary to Florida Statute 784.03(1).

On December 23, 2025, Officer E. Bannister (449) and I (Ofcr. S. Gonzalez, 471) responded to a reported disturbance at Vero Beach Marble & Tile, located at 2635 St. Lucie Avenue.

Upon arrival, I made contact with the Victim, identified by his Florida driver's license as Odelvis Castillo. Mr. Castillo stated that he and the Defendant had engaged in a heated verbal argument regarding a damaged stone slab. He alleged that during this dispute, the Defendant slapped him on the right side of his face without provocation. Mr. Castillo stated he then swung at the Defendant in self-defense. He further advised that the altercation was captured by an overhead security camera.

Upon physical inspection of the Victim, I observed a mark on the right side of his face consistent with being forcefully struck. Specifically, there was visible redness and a darker red mark situated between the cheekbone and the earlobe.

I then made contact with the Defendant, identified by his Florida driver's license as Liobel Perez Morejon. Mr. Morejon corroborated that a heated argument occurred regarding the damaged stone. However, he claimed the dispute began between the Victim and their boss, Felicio Pinto (Witness). The Defendant stated that when he attempted to intervene, the Victim forcefully shoved him in the stomach, prompting him to retaliate by slapping the Victim. When asked if the Victim had punched him, the Defendant stated he had not and demonstrated the alleged shoving motion.

Officer Bannister interviewed Mr. Pinto, who corroborated the Defendant's account of the events.

To resolve the conflicting statements, I requested to view the shop's security footage. My observations were as follows:

The verbal altercation initially began between the Victim and the Witness while the Defendant stood nearby. As the argument escalated, the Defendant became involved.

The video shows the Defendant slapping the Victim without provocation and there was no indication that it was an act of self-defense.

At no point in the footage did the Defendant flinch, stumble back, or move in a manner consistent with being shoved or struck.

Based on the totality of the circumstances and the video evidence, I determined the Defendant was the primary aggressor. He willfully and intentionally struck the Victim against his will and without legal provocation.

I placed the Defendant under arrest and transported him to the Indian River County Jail without incident, where he was turned over to corrections staff for processing. This incident occurred within the city limits of Vero Beach, Indian River County, Florida.

All interviews were recorded via my BWC and Officer Bannister's BWC; the footage has been uploaded to a secure server.

Also, although I recorded the security video in part with my BWC, the Witness agreed to email the original digital file to me.

On Tuesday December 23<sup>rd</sup> 2025, Cpl. Chouinard and I responded to 5555 20<sup>th</sup> street (Walmart) in reference to a shoplifting.

Upon my arrival, I made contact with Corporal A. Munni and Deputy T. Goodrich who already had the suspect Alexander Thomas in custody. Thomas was detained in handcuffs just outside of the doors to the "grocery" entrance to the store. Thomas was then escorted to the asset protection office. D/S Goodrich informed us that he already read Thomas his Miranda rights, to which he waived and agreed to speak with us.

I spoke with Asset Protection Investigator Brittany Dowdy. Dowdy provided the following written statement:

"I Brittany Dowdy on December 23, 2025 observed a black male subject wearing a blue shirt grey short and An ankle monitor on. I observed subject in jewelry selecting a watch. Subject opens the package and leaves it On the shelf subject selected sunglasses where he proceeded to the beer aisle where he selects a beer and Conceals the sunglasses and watch in his pocket subject proceeds to the next aisle where he conceals the beer Into his personal backpack subject, proceeded throughout the store selecting a backpack out of apparel and Putting his personal items inside the backpack. Subject then passes all point of sale not attempting to pay For items subject did not have permission to take these items Walmart wishes to prosecute. Which is contrary to the laws of the State of Florida, or contrary to local ordinances, and I will testify to these forms in a Court of Law."

Next, I separately interviewed Thomas. I asked Thomas why he passed all points of purchase. Thomas said "I walked around them went into subway and then the bathroom. I walked outside to smoke a cigarette. I was going to go back inside; I was not finished shopping yet". I then asked why did you not use a shopping cart? Thomas stated "I was not getting a lot of stuff I did not need one I used the backpack". The Steel Reserve Beer was partially consumed.

All items that were taken are as follows:

Analog watch \$15.98, JL earbuds \$24.88, Steel Res HG (Beer) \$2.36, MCNX DM 42ct \$28.76, Sunglasses \$22.97, Piranha \$13.88, Backpack \$36.00, Total: \$144.83. The watch was retrieved from Thomas's shorts pocket and the rest of the items were found concealed inside the backpack that Thomas selected.

Thomas was placed under arrest and transported to the Indian River County Jail for the following charge F.S.S. 812.015 retail theft.

#### NARRATIVE ....

On December 23, 2025, at approximately 1753 hours, Corporal Ballester and I responded to a reported shoplifting incident at the Walmart store located at 5555 20th Street in Vero Beach, Florida.

Upon arrival, I made contact with Walmart Asset Protection Officer Nathan Toliver, who provided a detailed briefing of the incident, and escorted me to review closed-circuit television (CCTV) surveillance footage from self-checkout register. The footage clearly depicted the suspect, later identified as Lisa AnnMarie Atwater, engaging in skip-scanning by holding two items in her hands while deliberately scanning only one of them. Atwater then placed both items into the bagging area, proceeded to bag the unscanned item along with the scanned one, and added them to her shopping cart. The video further showed additional merchandise, including large bags of pet food that was removed from shelves and concealed in the cart without ever approaching the scanning or bagging area, demonstrating clear intent to deprive the merchant of possession and full retail value.

Atwater completed the transaction by paying for a few items but failed to pay for 17 items with a combined retail value of \$76.10. After passing all points of sale, she was promptly detained by the Walmart Loss Prevention Team before exiting the premises.

During initial contact, Atwater told Deputies that her name was Lisa Marie Leonardo and refused to give a date of birth. Atwater was also asked for her social security number but stated that she doesn't know it. Atwater was then placed into custody for resisting an officer without violence to his or her person, FSS 843.02. During a pat down and a search of her purse, revealed a Florida Identification card with the name of Lisa Annmarie Atwater. I conducted an inquiry with Indian River County Sheriff's Office Dispatch and confirmed her name and date of birth which revealed that Atwater has an active warrant #: out of St. Lucie County for Failure to Appear refrence case number 562025CT000657AXXXSL.

Nathan requested Atwater to be trespassed from Walmart. A TAW was administered by Corporal Kaylee Kramer. Atwater was subsequently trespassed from Walmart and advised that if she returned, she was subject to arrest. Atwater stated she understood. Atwater was then read her Miranda Rights and Atwater acknowledged and understood her rights but refused to answer any questions.

Atwater was transported to the Indian River County jail for the following charges:

- Shoplifting/Retail Theft FSS 812.015
- 2. Resisting without Violence FSS 843.02
- 3. Give False Name While Detained FSS 901.36.1

#### NARRATIVE

On December 23, 2025, at 1951 hours, I responded to a reckless call later determined to be a DUI driver at the 6400 Block of 85th Street.

I made contact with K9 Deputy Le and the driver and sole occupant of the vehicle. The vehicle in question was a red Chevrolet Camaro bearing Florida tag NMGL80. The driver was identified as Marcus Ramos through his Florida ID card.

Prior to my arrival, the caller via dispatch notes stated the driver of the vehicle was driving like a "nut" driving aggressively.

K9 Deputy Le informed me the driver, Marcus Ramos, stated he had a couple of drinks tonight after having gone to Dom's Bar (1436 Old Dixie Hwy). The driver advised K9 Deputy Le he did not have a driver's license. K9 Deputy Le also informed me, he observed Ramos driving off the roadway into the grass shoulder and almost striking a traffic sign.

Ramos was made to step outside of the vehicle. A strong odor of an alcoholic beverage emitted from his person. Ramos was uneasy on his feet using his hands to grab onto the vehicle for support. Ramos was asked to walk towards the front of the patrol car, but walked to the back of the vehicle he was driving in. Ramos was told again to walk to the patrol car and swayed from side to side while doing so.

Ramos was read Miranda Warning advised he understood and would speak to me. Ramos stated he had four beers at Dom's Bar. He arrived at the bar at 6PM but was uncertain at what time he left the bar. He estimated he left the bar an hour ago. Ramos advised he did not have a valid driver's license and he was aware it was suspended from years ago. A check of D.A.V.I.D. revealed Ramos' license was suspended since 05/12/2012.

Ramos had glossy eyes, slowed motor skills, strong odor of an alcoholic beverage.

Ramos was asked to perform field sobriety exercises to which he advised he would. Ramos walked over to the white line painted on the roadway and was asked to stand heel to toe with his right foot in front of his left foot on the white line. Ramos was unable to maintain his balance on the white line and stepped off. He was asked to try again. Ramos attempted to stand heel to toe on more time and was unable to do so. Ramos then advised he couldn't do it and did not want to proceed.

Ramos was informed based on the totality of the circumstance; I was going to be placing him under arrest for driving while under the influence.

Ramos was placed under arrest for DUI and driving while license suspended with knowledge and transported to Indian River County Jail.

# NARRATIVE

On December 24, 2025, at approximately 0159 hours, I was stationary in the median on Interstate 95 facing south at approximately MM 150, when my STALKER DSR 2X SN: DB031280, alerted me with a high pitch audio doppler tone of a vehicle traveling north in my direction at a high rate of speed. I viewed the scene and observed 96 MPH in a 70 MPH zone.

I remained in the median, and when the white Chevrolet SUV passed me traveling north, I turned around onto 195 north and began to go after the vehicle.

When I got behind the white Chevrolet Equinox, bearing Florida tag 62FYHY, I initiated a traffic stop at MM 152 north bound by activating my overhead emergency lights for violation of Florida State Statute 316.183(2), Speeding.

I approached the passenger side of the vehicle, and made contact with the driver and sole occupant, Roderick Kirkland. I requested Roderick's driver's license, registration, and proof of insurance. Roderick handed me the rental agreement for the vehicle, along with his Florida driver's license, that had the corner cutoff. Based on my education and experience, I know that the corner removed from the driver's license, means it was expired or suspended.

I returned to my vehicle and ran an NCIC/FCIC query of Roderick, which I discovered his Florida driver's license was suspended. I conducted a query on the Driver and Vehicle Information Database (DAVID), and discovered Roderick's Florida driver's license has been suspended/ revoked since 05/08/2023. A query of Roderick's past convictions on DAVID, I discovered, Roderick was convicted on 03/03/2025 for driving while license suspended/ revoked. I queried another law enforcement database and discovered Roderick was convicted for driving without a license, in McIntosh County Georgia, reference McIntosh County Sheriff's Office case number 121614187.

I approached the driver's side of the vehicle and informed Roderick, that I needed him to look at something on the rear of the vehicle. When he exited and walked to the rear of the vehicle and faced it, I placed him in handcuff restraint's and checked for proper fit. I informed Roderick he was under arrest for driving while license suspended/ revoked.

I moved Roderick to the front of my patrol vehicle, and began a search of his person, prior to placing him in my patrol vehicle. I located \$194.00 in his front pocket, and a white plastic grocery bag in the front pocket of his hoodie, which contained a large sum of US currency. I continued to search Roderick and located a clear plastic bag in his underwear, which contained baggies of green leafy substance, and baggies of a white powdery substance.

I placed Roderick in the rear of my patrol car. I placed the white grocery bag with the large sum of US currency on the front seat of my patrol car.

I took the clear plastic bag that contained the baggies of green leafy substance, and baggies of a white powdery substance to the rear of my patrol car to field test and weigh the substances. The two (2) baggies of white powdery substance, field tested positive for cocaine. The first bag weighed 0.72 grams, and the second weighed 0.63 grams. The three (3) baggies of green leafy substance, field tested positive for marijuana. The first bag weighed 1.63 grams, the second weighed 1.73 grams, and the third weighed 1.47 grams.

I placed all weighed and tested items in the rear of my patrol car, and returned to my front seat and began a count of the US currency, located in the white grocery bag in the front pocket of Roderick's hoodie. The first bundle contained \$1000.00, which consisted of 40- \$20.00 bills, 2-\$50.00 bills, and 1- \$100.00 bill. The second buddle contained \$300.00, which

consisted of 10- \$1.00 bills, 10- \$5.00 bills, 6- \$10.00 bills, and 9- \$20.00 bills. The third buddle contained \$1020.00, which consisted of 6-\$5.00 bills, 8- \$10.00 bills, 33- \$20.00 bills, 1-\$50.00 bill, and 2- \$100.00 bills. The total US currency removed from Roderick's pockets was \$2,514.00. Which was later conformed at the county jail, by Deputy Burn ID# 6012.

While I was conducting the count of US currency, K9 Deputy Lee arrived on scene, and conducted a free air sniff of the vehicle, with his certified drug detection K9 partner. K9 Deputy Lee informed me his K9 Partner alerted to the vehicle, for drug odors he is trained to detect. See K9 Deputy Lee's supplement report for full detail.

K9 Deputy Lee conducted a search of the vehicle and found one bag of green leafy substance on the center consul, that later weighed 0.51 grams and field tested positive for marijuana.

I read Roderick his Miranda rights from my agency issued Miranda card, which he advised he understood and wish to talk. I asked Roderick about the drugs I located on his person, which he advised he smokes marijuana and sprinkles the cocaine on it. Roderick stated he was on his way to North Carolina to visit his kids, and the money recovered on his person was to buy them presents. Roderick advised there was some presents in the vehicle already. Roderick informed me to view the vehicle GPS to confirm, which I did. I confirmed Roderick was traveling to North Carolina and there were children's toys in the vehicle.

The rental vehicle that Roderick was driving was towed from the scene by Mike's Towing. A copy of the tow receipt was given to the tow truck driver, one was placed into Roderick's property at the jail, and one was placed into records.

I transported Roderick to the County Jail, and charged him accordingly.

This investigation was captured on my agency body worn camera, along with the dash camera on my marked patrol vehicle.

This investigation is cleared by arrest.

NARRATIVE NAME OF THE PROPERTY										
On Wednesday, December 24, 2025, at approximately 0746 hours, I responded to in reference to a disturbance in progress call for service.										
Upon arrival and while approaching the residence, I heard a loud verbal disturbance coming from inside the home. I advised dispatch of the situation and knocked on the front door. When the door was opened, I observed several individuals engaged in a verbal argument. After briefly determining the involved parties, a subject later identified as Lovens Pierre-Gilles advised that he and Areanna Chynel Atkins, the mother of his child and spouse, were the parties involved in the incident.										
I asked Lovens to step outside to speak with me. Lovens stated that Areanna arrived upset and began being disrespectful toward other family members residing in the residence. Lovens advised that he interjected himself and instructed Areanna to stop her behavior, at which point Areanna became more belligerent and the verbal argument escalated. Lovens stated the incident initially occurred in the living room. Due to the escalation, a family member stepped between them in an attempt to de-escalate the situation.										
Lovens advised that Areanna reached over the intervening family member and struck him in the face. Following this nitial strike. Lovens stated he grabbed Areanna with both hands underneath her armpits, picked her up, carried her to the and placed her inside. Lovens advised the argument continued in the again became physical. He stated that Areanna struck him several additional times. Lovens then stated he placed Areanna in a "headlock" in an attempt to make her stop.										
asked Lovens where he was struck, and he indicated his face and mouth. Upon observing the indicated areas, I did not observe any visible marks, injuries, or indicators consistent with the reported strikes. Lovens further stated that his "auntie" eventually separated them, and they went into separate rooms. Lovens admitted he made statements during the argument that he should not have made but initially refused to elaborate. It was later learned that Lovens welled that he would "kill" Areanna if she messed with his family.										
I then made contact with Corporal Baumann, who was speaking with Areanna. Corporal Baumann provided a brief synopsis of his conversation, which was consistent with Lovens' account. While Corporal Baumann was explaining how Areanna was placed in a headlock, Areanna interjected and stated, "That's how I got this." Areanna then pulled back her upper lip, revealing a small laceration and swelling near the corner of her mouth. (See Corporal Baumann's supplemental report for additional details regarding his interview with Areanna.)										
I also spoke with a family member later identified as Chantale Oniasse, who was the individual attempting to intervene during the altercation. Chantale corroborated the statements provided by both Lovens and Areanna and confirmed that Lovens placed Areanna in a headlock during the incident. Chantale adamantly informed that Areanna was belligerent and aggressive initially.										
Based on the totality of the investigation, I determined Lovens Pierre-Gilles to be the primary aggressor. Although Areanna was the first party to initiate physical contact by striking Lovens, Lovens continued the physical altercation by picking her up, moving her to the and restraining her in a headlock. On December 24, 2025, at approximately 1350 hours, I was dispatched to Walmart located at 2001 US Hwy I regarding a shoplifting.

Upon arrival, I made entry to the establishment through the north door, grocery side. I made contact with Christopher Matson, a loss prevention employee, who pointed out the male who was refusing to go back to the loss prevention office. I approached the male and placed him in mechanical restraints, double-locked, with a quick pat down. I asked the male for his name, to which he stated his name was Eric Machado. I explained to him that he was under arrest for retail theft. Christopher and I escorted Eric to the loss prevention office located in the back of the store.

While in the loss prevention office, I did a complete search of the suspect. I retrieved his wallet, which contained his FL DL. After the search, Eric was asked to take a seat, and I then read him his Miranda Rights, to which he stated he understood them. When asked why he did it, he stated that he was still inside the store when he was stopped. I explained to him that he had gone past all points of sale, which constituted retail theft.

Christopher pulled up the video of Eric trying to leave the store with a cart full of items. Christopher stated that Eric bagged some items but made no intent to pay for the items in the cart. The total amount of all the items was 848.71 dollars.

It was later discovered that on this same visit, before Eric started his shopping at the establishment, Eric went to the air freshener aisle and picked up two air fresheners. He then went to the customer service desk and asked for a refund. Eric was given 25.40 dollars in return. When asked, Eric admitted that it was a random receipt that he used to get cash back.

Eric was charged with grand theft, FSS 812.014(2C1), grand theft 750 but less than 5,000.

Eric was also charged with petit theft, FSS 812.014, for the \$25.40 that was taken from the cash refund.

Eric was placed in the back of the patrol unit and transported to the county jail without any further incidents.

Snipes was asked if he had anything other narcotic or weapons on him and he freely stated that he had weed in the front of his underwear. I located a clear plastic zip lock style baggie containing a green leafy substance which I immediately recognized as marijuana. Snipes is not currently prescribed a medical marijuana card.
Post Miranda, Snipes admitted that he found the cocaine and was trying to make some extra money. He also admitted that he knew about the trespass order, but was just trying to get his family.

#### NARRATIVE



On Wednesday, December 24, 2025, at approximately 2340 hours, I responded to reference to a disturbance with EMS needed. Communications advised that the call was activated by fall detection and a female and male were heard in the background. Communications further advised, the female stated, "stay away from me you scare me," meanwhile the male was heard stating, "let me take you to the hospital."

K9 Deputy Le and I arrived at the aforementioned location at which point I observed the female, Michelle Morgan, on the ground holding her wrist in the driveway, with Daniel Oleary crouching over her.

I asked Daniel what had happened to which he stated nothing, they are good. I informed Daniel that we were called her at which point he looked at Michelle and stated, "are you serious." I instructed Daniel to walk to the front of the truck that was in the driveway with Deputy Le, to which he looked again at Michelle and said, "Really?"

After Daniel finally complied, I spoke with Michelle regarding the incident. Michelle stated Daniel and her had gotten into an altercation after she discovered he was talking to other females. Michelle stated she went to leave, at which point Daniel told her she needed to stay, until such time as he began shoving her. Michelle stated Daniel followed her out to the driveway, and continued to shove her to the point that she fell to the ground and injured her wrist.

Michelle believed that her wrist was possibly broken from the fall, therefore EMS was requested to evaluate her for her injuries. EMS arrived at the aforementioned location, at which point Michelle declined to go with them stating if it gets any worse, she will self-transport to the hospital for evaluation as she just wanted to go home. Daniel stated Michelle became upset over him speaking with his female friend, and stated she was leaving at which point he was attempting to convince her to stay to talk it over. Daniel further stated that there was no physical altercation, and he did not at any point touch her. Daniel stated, "they were holding hands above their heads, at which point Michelle just fell." #### NARRATIVE

On 12-25-2025, I responded to 3958 Kennedy Court, Vero Beach, in reference to assisting Indian River County Fire and EMS with a medical call. Upon my arrival, I was advised by Fire and EMS that they responded to the residence in reference to a female who was having a seizure. The female was identified as Ashani Samuels Schulz.

As they attempted to assist her, she became agitated and battered Evyn Goodrich, Ryan Callahan, and Tristan Emsberger. Schulz told them to get out of her room and as EMT Emsberger went to walk away she shoved him in the back. EMT Goodrich attempted to step in between to prevent any other incident and she then shoved him in the back. They continued to exit the residence and Fire Captain Callahan was holding the front door for them to bring the stretcher out, she grabbed the door and slammed it against Callahan's shoulder.

These action occurred against the will of Emsberger, Callahan, and Goodrich.

Samuels Schulz was subsequently arrested and charged with Violation of FSS 784.07 (2d) Battery of Office/Firefighter/EMS. She was transported to Cleveland Clinic in reference to receiving medical clearance. While at the hospital, Samuels Schulz again became agitated and began to scream and yell. She then stated "Just shoot me, I don't want to go back to jail".

After receiving medical clearance, Samuels Schulz was again placed in my agency issued patrol vehicle to be transported to the jail. She then began to bang her head against the plexiglass partition in my patrol vehicle. She was restrained and transported to the Indian River County Jail without incident.

I (Ofc Amburgey #438) responded to the intersection of Indian River Blvd and Merrell P. Barber Bridge in reference to a traffic accident.

On scene I made contact with Kathleen Savage (Driver of V2 / FL TAG: RRA391). Savage stated that as she was waiting at the intersection of Indian River Blvd and Merrell P. Barber Bridge, the light turned green and as she began accelerating forward. While doing so, the rear bumper of V2 was struck by the front bumper of V1 (FL TAG: 53KSQ), resulting in minor damage.

While still on scene, I made contact with Richard Kohler (Defendant / Driver of V1). Kohler was sitting in the driver seat immediately following the accident and was the sole occupant of the vehicle. I asked Kohler to provide his drivers license and observed him making a deliberate, exaggerated effort to remove his wallet from his front right pocket. While doing so, Kohler paused for an unreasonable length of time, causing Ofc Mathews (#473) to approach the open driver side window. During Ofc Mathews (#473) conversation with Kohler, she detected what she believed to be the odor of alcohol on Kohler's breath, slurred speech, and glossy red eyes.

Ofc Mathews (#473) made me aware of her concerns while the EMS crew on scene asked if Kohler needed any medical assistance, which he repeatedly declined.

I continued asking Kohler basic informative questions ("Where are you coming from?", "Where are you heading?", to which Kohler appeared to pause for an exaggerated length of time before he could produce an answer while also continuing to have slurred speech. At that time, I approached the driver side door of V1, and instructed Kohler to exit the vehicle. While doing so, Kohler began exiting the vehicle in a slow and methodic manner. Once Kohler exited his vehicle, he immediately began leaning on the side of his vehicle while I instructed him to move towards the rear of his vehicle. Kohler started leaning so far forward that if I did not interfere he would have fallen onto the ground. I held Kohler by his right arm and assisted him as he stumbled to the rear of his vehicle. Ofc Mathews (#473) began talking to Kohler while I talked to the driver of V2.

While talking to the driver of V2, Ofc Mathews (#473) began calling for assistance because Kohler began falling towards the ground. I immediately assisted Ofc Mathews (#473) with standing Kohler upright, we (Ofc Mathews and I) grabbed each arm and relocated Kohler to the back passenger side of my marked patrol vehicle.

Based off of the totality of the circumstances on scene: slurred speech, glossy red eyes, delayed response prior to answering any and all questions on scene, his slow and methodic exit out of the vehicle, assisting Kohler to the rear of his vehicle to prevent him from falling, assisting Ofc Mathews (#473) with preventing him from falling, and carrying Kohler to my patrol vehicle, I believed that Kohler was inebriated to such an extent that he would have caused bodily harm to himself if he attempted any of the Standardized Field Sobriety Exercises on scene.

Based on the above-mentioned observations, I placed Kohler under arrest for DUI in violation of F.S.S. 316.193(1a) and transported him to the Cleveland Clinic Hospital for medical clearance. Kohler's vehicle was removed from the scene by Collison's Towing services and he also received a criminal citation (#ALZPNYE) with a court date of 01/27/2026. Once Kohler received medical clearance, I transported him to the Indian River County Jail for booking procedures.

While at the Indian River County Jail, a 20-minute observation period was conducted. Ofc. Aguilar (#437) then requested that Kohler provide a lawful sample to determine his breath-alchohol content. Kohler refused to provide a lawful sample. Kohler refused to conduct Standardized Field Sobriety Exercises. Kohler was read and understood implied consent, to which Kohler refused again. Ofc Aguilar (#437) read Kohler his Miranda Rights. Kohler refused to communicate post Miranda.

Kohler was then transferred to jail staff without further incident.

This incident was captured by my department issued Body Worn Camera (BWC).

#### NARRATIVE

On Wednesday, December 25, 2025 at approximately 1916 hours, I responded to the area near the intersection of Oslo Road and 27<sup>th</sup> Ave in reference to multiple reports of a reckless driver.

Ms. Denise Jorran (Complainant) reported a reckless driver, providing a detailed description of the vehicle as a silver Subaru SUV bearing Florida registration tag "RQVN48." Ms. Jorran further stated the vehicle was weaving in and out of traffic, stopped in the middle of the intersection, driving over curbs, ran a red light, and almost struck a pedestrian and a mailbox in separate events.

While sitting stationary on 27<sup>th</sup> Avenue, I observed a vehicle approaching from the North. I could tell the vehicle was failing to maintain its lane as it travelled South, I could see the headlights moving around the other traffic. As the vehicle passed my location, I positioned my patrol car behind the vehicle and verified the description of the vehicle and license plate matched the description provided by Ms. Jorran.

As the vehicle approached the intersection, it activated its left turn signal and began to maneuver towards the right into the bike lane before maneuvering into the left lane. The vehicle entered into the intersection and several safe opportunities passed for the vehicle to affect its turn. The vehicle slowly rolled forward and appeared to be making an attempt to go straight. The vehicle remained in the intersection for approximately forty-five (45) seconds until the light changed yellow, ultimately making a wide left turn onto Oslo Road heading East. The vehicle crossed over the solid white line travelled into the left lans and crossed back over into the right lane.

The vehicle continued to travel East at approximately thirty (30) miles per hour in a posted forty-five (45) mile per hour zone. The vehicle had difficulty maintain a straight bearing and weaved within its lane crossing over the solid white lane line. The vehicle came to a very slow crawl in the middle of the roadway. I activated my emergency lights and the vehicle pulled to the side of the road at 21st Court SW.

As I exited my patrol car, the vehicle drove over the curb began to drive forward. The vehicle stopped on the curb and I moved my car forward. As I exited my patrol car, the vehicle accelerated and entered the traffic lane heading East on Oslo Road.

Based on my training and experience, I attributed the driving pattern and behavior with an impaired driver and believed they demonstrated and immediate and continued threat to the general public.

I activated my siren and pursued the vehicle at speed of approximately forty (40) miles per hour, during which the vehicle continued to weave within its lane. I positioned my vehicle and attempted a Pursuit Immobilization Technique (PIT) at 32 Miles per hour near Oslo Road and 7th Court SW. The P.I.T. was unsuccessful and the vehicle recovered. The vehicle continued to drive for approximately 15 seconds before activating its turn signal and stopping in the near the driveway of a church.

#### NARRATIVE (Continuation)

A high-risk traffic stop was conducted. I gave loud, clear and concise verbal commands to the driver who complied with my commands. A female, later identified as Mrs. Jillian Harris (Arrestee) was directed out of the car. As Mrs. Harris was provided directions, she had difficulty concentrating on more than one task at a time. As she was given task direction to walk backwards, she would place her hands down. When she was given directions to place her hands in the air she would stop walking. Mrs. Harris was stumbling as she walked backwards and was rotating her hands in the air. Mrs. Harris was taken into custody without further incident.

When I approached the vehicle to clear for secondary passengers, I could smell the distinct odor of an alcoholic beverage emitting from inside the vehicle.

I spoke with Cpl. C. Moon (6015) who stated while securing Mrs. Harris in handcuffs, she could smell the distinct odor of alcohol.

Mrs. Harris was transferred into the back of my patrol car during which she lost her balance and almost fell. Requiring assistance to keep her from falling.

I advised Mrs. Harris of her Miranda rights which she stated she understood and declined to speak me. Mrs. Harris was not asked any questions pertaining to the incident. I advised Mrs. Harris she was under arrest for Driving Under the Influence and Fleeing / Eluding. In my brief interaction with Mrs. Harris, I could smell the distinct odor of an alcoholic beverage emitting from her breath, I observed her eyes were watery and she was slurring her speech.

During the transport, Mrs. Harris asked several times what her charges were and asked questions regarding the incident. I explained to her she refused to speak with out a lawyer present, and offered to read her Miranda again if she chose to speak with me regarding the incident.

Mrs. Harris repeated herself several times and asked me the same questions multiple times during transport. Her attitude seemed to be a carefree manor and was unable to appreciate the seriousness of the incident she was involved in. Mr. Harris asked a question regarding her charges, specifically the fleeing charge. I explained she ran from the traffic stop, and Mrs. Harris was unable to comprehend the explanation. She assumed she fled the traffic stop on foot and she asked how far she ran from the vehicle.

Upon arrival to the Indian River County Jail Complex, a twenty-minute observation period was initiated. During the DUI investigation, Mrs. Harris was provided the opportunity to Complete Standard Field Sobriety Exercises (SFSE's) which she willingly refused.



While on the Jail phones, she called her son and stated "You aren't going to fucking believe this, I had two drinks, I swerved, No accidents or nothing... I was in the wrong place at the wrong time!" She further explained to jail deputies that her daughter fiancée made her two (2) "white Russians" and that what caused all of this.

Mrs. Harris has a prior DUI conviction in Indian River County from 2023 under UTC: AIE08RE which she was adjudicated guilty for on February 14, 2024.

Mrs. Harris was ultimately charged with Flee / Elude a policer officer with lights and siren, driving under the influence and Refusal to Submit.

Mrs. Harris was issued the following citations: Flee / Elude (AMNZ21E), DUI (AM5W7YE), Refusal to Submit (AMNZ22E) and Fail to drive in single lane (AMNZ23E).
