PROBABLE CAUSE STATEMENT

I, Officer Bannister, responded to 1976 43rd Avenue, 7-Eleven, in reference to a shoplifting. Upon arrival, I made contact with the complainant, Sara Evans, who is the manager at the this location.

Evans stated that a white male, bald with a black beard, wearing a dark grey t-shirt and black shorts, had ran out of the store with a 12-pack of Modelo beer. I was also shown a picture of the suspect at this time, and was informed that the suspect went behind the building.

While walking around the back of the business, officers noticed a male sitting on the ground, on the northeast side of the building, the male seen in the photo, with a 12-pack of Modelo sitting next to him. When officers approached, the male, later identified as Joshua Sauls via his FL Identification card, stood up and attempted to walk away. Due to Sauls being the male from the photo and having the stolen product next to him, Sauls was immediately detained and placed in my patrol vehicle.

I then made again made contact with Evans, and viewed the video footage.

What is seen on the video surveillance footage is as follows, at 0639 hours, Sauls is seen walking towards the beer cooler and attempts to open them. Due to the coolers being locked, Sauls starts to walk towards exit at the front of the store. Prior to exiting the business, Sauls is seen grabbing a white case of beer, Modelo 12-pack valued at \$17.99, off of a display shelf and quickly exiting the business, passing all points of sale without paying for the product.

When officers located Sauls, the open 12-pack of Modelo and 2 empty Modelo cans were next to him on the ground.

Evans stated that 7-Eleven did wish to prosecute and also issue a Trespass for Sauls.

Sauls was officially taken into custody at this time, and transported to the Indian River County Jail without incident.

Sauls was charged with FSS 812.014(3A) Petit Theft, for the theft of the Modelo.

Sauls was trespassed from 7-Eleven at this time.





NARRATIVE

On April 19, 2026, the Indian River County Sheriff's Office began receiving tips through the Fortify app, which allows people to provide tips for possible threats, primarily towards schools. The tips contained IP addresses for the submitter of the tips, which lead deputies to 112 N Oleander St, Fellsmere, Florida based on a geolocation provided by T-Mobile.

Deputies conducted initial interviews with members of the residence, to include Antonio Mojica Castro, a Hispanic male October 27, 1971, Marisa Gamez Raya, a Hispanic female born July 19, 1971, Antonio Mojica, a Hispanic male born April 28, 2000 and Oscar Mojica, a Hispanic male born July 28, 2005.

During the interviews conducted by deputies on April 19, Antonio Jr stated their is not a functioning computer in the residence. All members of the family utilize Mint Mobile (which utilizes services of T-Mobile) for their cellular provider. Antonio stated Oscar is still in school at Sebastian High School and Antonio works in Palm Bay. Antonio further explained Oscar is still in school under a special needs program and has [REDACTED]

While on scene, deputies searched Oscar's phone, to which nothing of evidentiary value was noted. A search of his room was conducted and no weapons were located.

Due to continuous Fortify tips coming in, detectives responded to 112 N Oleander St on April 27, 2026 for follow up. It was discovered during the initial tips that the address was obtained via a cell phone number associated to an IP address on one of the tips obtained on April 19, 2026. The phone number was 772-400-1705, which was listed as Antonio Mojica's number on the initial report.

The Fortify tips obtained during the course of the investigation were as follows:

April 19, 2026 at 1717 hours: "Something's going to happen tomorrow so tell your officers to be careful tomorrow good luck"

April 19, 2026 at 1728 hours: "So I'm just going to happen to one of your officers tomorrow"

April 22, 2026 at 1104 hours: "I'm 23 years old cops watch your back I'm in palm bay good luck find me"

April 23, 2026 at 1818 hours: "Cops watch your back, Sebastian PD and palm bay I'm 26 years old I'm in palm bay rn I been waiting for you guys"

During a search of Oscar's phone, Fortify was located in his search history; however, Antonio explained Oscar's account is linked to his via Antonio's email.

Antonio again confirmed his phone number was 772-400-1705, which was the one associated to the tips by T-Mobile.

Based on the above facts, Antonio was taken into custody.

Detective Daugherty finds probable cause to arrest Antonio Mojica Jr for one count of written threats to kill.



