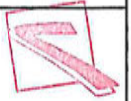




NARRATIVE

On Monday, May 11, 2026, at approximately 0046 hours, I conducted a traffic stop in the 6900 block of 66th Avenue in Vero Beach, FL.

While traveling northbound in the 5800 block of 66th Avenue, I observed a vehicle traveling west on 61st Street at a high rate of speed. The 2019 silver, Honda Civic bearing FL tag LYK21, then turned northbound in front of my patrol vehicle on 66th Avenue. The vehicle accelerated to what I estimated to be 80 mph in a 45 mph zone. I activated my vehicle-mounted Stalker DSR 2x radar's front antenna, which gave a readout of 85 mph. This was corroborated with an audio doppler tone.

I observed the vehicle's driving pattern for approximately eight blocks. During this time, speeds remained in excess of 30 mph above the posted speed limit. Additionally, the vehicle crossed over the lane markers no less than two times.

I activated my lights and siren, affecting a traffic stop in the 6900 block of 66th Avenue. I then made contact with the driver and sole occupant, Joseph Robert Scala DOB 07/15/1996, identified by his Florida Driver License. He had his driver license and registration ready to hand me as I walked up to his vehicle. Scala explained he was driving fast because he was just trying to get home from his friend's house in Sebastian.

I immediately noticed Scala's eyes were glassy and watery. As he spoke, I could also smell the odor of an alcoholic beverage coming from his mouth. Scala was initially unable to provide proof of insurance, so I returned to my vehicle to query his provided information through Indian River Public Safety Dispatch.

I then asked Scala to step out of his vehicle to speak with me. I explained to him I suspected he was operating his motor vehicle while under the influence of alcohol. I requested he tell me if and how many alcoholic beverages he had consumed this evening. Scala provided several versions of this narrative that varied the number of beverages he had consumed. He explained he met family at Hiram's, which I know to be a bar/restaurant, at about 4:30 PM where he consumed a vodka mixed drink and Fireball shot. He stated he then went to Earl's, which I know to be a bar, and consumed up to three Yuengling draft beers and three additional Fireball shots. Scala stated this occurred over the course of several hours. He stated he then went to Rack'm Billiards in Sebastian to play pool, where he denied drinking any alcohol. From there, Scala stated he left to go home. It should be noted Scala stated he was coming from the north to go home, had driven south past his residence, and then turned north to go home.

I asked Scala if he would be willing to participate in Standardized Field Sobriety Exercises. He initially stated he was uncomfortable with this and wanted to clarify his story regarding the quantity and timeline of his alcohol consumption. He explained this several times, changing the quantity and types of drinks each time. I asked Scala again if he'd be willing to perform the roadside SFSEs, which was completely voluntary. He agreed, after stating he "wasn't a fan" because he "hadn't drank in over four hours."

Scala denied any medical conditions or taking any medications. He stated he didn't wear glasses or contacts. I explained I'd first be checking his eyes. I observed Scala's pupils were round, equal, tracked appropriately, and reactive with no resting nystagmus. During the exercise, I observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees. Additionally, Scala had to be told several times to not move his head and to only

follow the stimulus with his eyes.

The next exercise explained was the Walk and Turn. During the instructions phase, Scala failed to maintain the heel to toe stance with his arms down by his side. Once the instructions were concluded and Scala stated he understood, I observed the following: Scala stepped off the line, missed heel to toe, used his arms to balance, and performed an improper turn.

The final exercise explained was the One Leg Stand. During the instructions phase, Scala failed to maintain the starting position with his heel/toes together and hand down by his side. Once the instructions were concluded and Scala stated he understood, I observed the following: Scala put his foot down several times, he used his arms to balance the entire time, and did not count as instructed.

Based on the above indicators of impairment, Mr. Scala was placed under arrest for Driving Under the Influence (DUI). Mr. Scala was secured in mechanical restraints and secured in the rear seat of my patrol vehicle.

Mr. Scala was transported to the Indian River County Jail Complex (IRCJC) without further incident. Upon arrival to the IRCJC, Deputy Rentas (6001) initiated a twenty (20) minute observation period at 0159 hours and requested Mr. Scala provide a sample of his breath to determine its alcohol content. Mr. Scala agreed and provided the following samples: 0.151 g/210 L and 0.158 g/210 L.

Scala was charged with the following:

1 Count – DUI with BAC of 0.15 or Higher (F.S.S. 316.193(4)), DUI UTC# AM5WE5E – Bond: \$1,000.00.

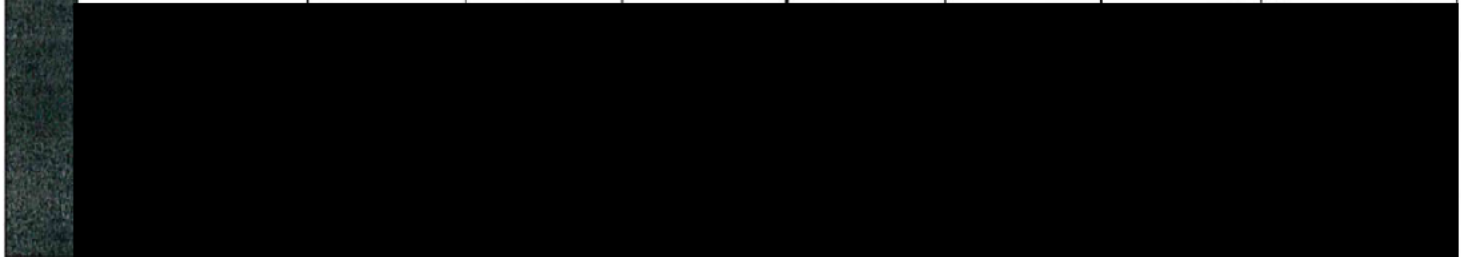

The windows of the vehicle were left open and there were no proper car restraints for the children in the vehicle. Vilama's wife stated she would not be able to meet with children for over an hour. NARRATIVE

On 05/11/2026 at approximately 1740 hours I was dispatched to 760 2nd Place SW in reference to a disturbance. Indian River County Public Safety Dispatch (Dispatch) advised that a female complainant, called dispatch and accused her of being intoxicated and hitting her vehicle at the residence. Deputy A. Binner arrived on scene first and advised that an unknown subject had left the scene of the disturbance. While still investigating on scene, Deputy A. Binner observed the unknown subject return to the scene driving a gray Dodge Ram bearing FL tag: 4728AU. Deputy A. Binner advised he observed an unknown subject, later identified as Ricky Williams as the sole occupant and driver of the vehicle. Deputy A. Binner observed Ricky, driving east down the street, pulling into the driveway of the residence and getting out of the vehicle to speak with him.

Upon arrival, I spoke with the driver of the vehicle, later identified as Ricky Williams. While speaking with Ricky I could smell a strong odor of an alcoholic beverage was emitting from his breath. It was observed that Ricky had bloodshot and watery eyes. Ricky spoke with slurred speech, and exhibited an orbital sway during my interaction with him. Based on my observations and this statement I asked Ricky to perform standard field sobriety exercises, to which he declined. A Taylor warning was given to Ricky and he continued to refuse my request. Based on my observations, Ricky Williams was arrested for DUI and was transported to the Indian River County Jail without incident.

It should be noted that in this same neighborhood, dispatch received a call on 05/11/2026 from a Tayreis Deleon at approximately 1655 hours. I followed up with Tayreis via cellphone where he advised the following:

He was outside when he observed a gray Dodge Ram 1500 driving recklessly throughout the neighborhood. It was raining out, and due to these conditions, the vehicle was speeding, doing burn outs and his tires were spinning due to not able to gain traction due to the conditions of the road. The male driving the vehicle was a black male with dreads, wearing a red shirt. It should be noted that the description of the vehicle, the male, and his clothing he was on scene in provided by Tayreis was accurate.

Upon arriving to the jail, Ricky was handed over to jail staff where they administered the states test. Jail staff advised that Rickey refused to submit a breath sample. Jail staff advised Ricky of implied consent, to which Ricky continued to decline providing a breath sample.

Due to the listed facts above I charged defendant Ricky Williams with F.S.S. 316.193.1a[8825] – DUI Influence of Alcohol or Drugs, and F.S.S. 316.1939.1[5388] – Refusal Submit to DUI Testing.

NARRATIVE

On Monday, 05/11/2026, at approximately 1913, I was dispatched to 4300 27th Avenue, Vero Beach, Florida 32967, in reference to a disturbance.

Upon arrival I made contact with the complainant, Tiffany Nasha Adair, who stated she was grabbed her hair and dragged on the road by Tiki Taujuan Cobbs. Adair also stated her vehicle mirror was damaged by Cobbs during the altercation. Adair declined medical attention.

Based on the statement I made contact with Cobbs outside of 4326 27th Avenue, Vero Beach, FL 32967, and asked him to explain what occurred between Adair and him. Cobbs stated that earlier in the day he agreed to change the oil of Adair's vehicle. Cobbs stated that he was previously in an intimate dating relationship with Adair. [REDACTED] had 3 children in common. Cobbs stated that he moved on from his relationship with Adair and she has been very angry about the situation. Cobbs stated that Adair pulled beside his vehicle outside of the residence, while he was inside his vehicle Adair began yelling at him to complete the work on her vehicle. Cobbs stated that he no longer wanted to work on Adair's vehicle and told Adair to have her boyfriend finish the work. Cobbs stated that made Adair upset, as a result she opened the passenger door of his vehicle and got into his vehicle where she bit his right shoulder and started to scratch him. Cobbs advised that Adair also threw his phone out of the vehicle into the roadway. Cobbs stated that while Adair was biting him, he pushed her head away from him to defend himself and get her out of his vehicle.

I observed a fresh bit mark on the upper right shoulder of Cobbs and took a picture of it using Axon Capture.

I made contact with Rachquel V Saunders, a witness to the event. Saunders stated she resides at 4326 27th Avenue and saw Cobbs in his vehicle outside of the residence. Saunders stated she then saw Adair's vehicle pull up to the residence and stop in the roadway. Saunders then heard Adair and Cobbs arguing about oil and Adair's vehicle. Saunders advised she saw Adair get into the passenger side of Cobb's vehicle and start to get physical with Cobb. Saunders stated she also saw Adair throw Cobb's cell phone out of the vehicle.

I then informed Adair of her Miranda rights, which she acknowledged and waived them voluntarily to speak with me. I asked Adair to explain what occurred between her and Cobbs. Adair stated that Cobbs told her to come to the residence to get the work done on her vehicle. Adair stated that when she approached Cobbs's vehicle, he was angry and told her to get her new boyfriend to do the work. Adair advised she was standing outside of the passenger door of the car, facing the vehicle, when Cobbs reached over from the driver's seat and grabbed her hair on the back of her head, pulling her into the vehicle. I told Adair that her story did not line up with what she told me originally and she stated that

NARRATIVE

On May 11, 2026, at 2030 hours, I responded to 5240 US Highway 1 (Davila's Pizza) in reference to a trespassing. Prior to arrival, I was informed via dispatch notes, a female subject is laying on the bench and will not leave. Caller, Kiyah Melendez, advising alcohol (bottles) dropped from female's purse. The female showed up to the business intoxicated, the business is about to close, and due to being the only person in the establishment (aside from employees) she is making employees uncomfortable.

Upon arrival, I located the only person in the establishment laying in one of the restaurant benches. Melendez confirmed the female was asked to leave prior to law enforcement arrival and refused to do so. I asked the female to leave the establishment to which she partially opened her eyes and closed them again. The female was removed from the bench and asked to leave. The female walked out the front door of the establishment and then tried to reentered through the adjacent door. The female was asked if she was aware she was trying to reenter the place she was asked to leave and advised yes. O'Toole pulled on the locked door to the establishment.

Though O'Toole would have the reasonable assumption to enter by belief of authorized, licensed, or invitation to enter or remain in the structure, the person authorized by the owner or lessee of the premises, Kiyah Melendez, warned O'Toole to depart. O'Toole refused to depart. O'Toole was placed under arrest and transported to Indian River County Jail for violation of Florida State Statute 810.08 for Trespassing in a structure.

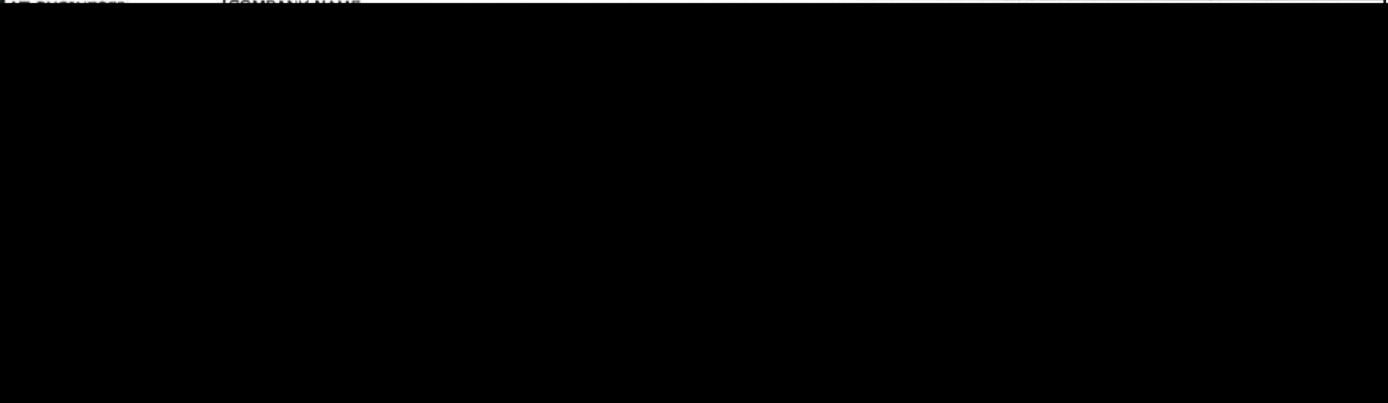

Jimell was placed under arrest for FSS 810.08 Trespass of a structure of conveyance and transported to the Indian River County Jail. While in route to the jail, Jimell made a statement stating he was outside when it began to rain and he attempted to seek shelter inside the residence.

Jimell's belongings were submitted into Evidence/Property to be held until his release.

PROBABLE CAUSE STATEMENT

On 11 May 2026 at approximately 2226 hours, I was traveling south on the 2000 block of Barber Street, in the city of Sebastian.

I contacted Lynette via phone and asked if she knew Justin had her vehicle. She stated no, that she was asleep. I then asked if she wanted to pursue theft charges, and she stated no. NARRATIVE

On May 11, 2026, at approximately 2325 hours, I Deputy B. Givens responded to [redacted] in reference to Disturbance.

Upon my arrival, I made contact with caller, Mario Bonner, who stated the following in substance: He came home from work when he was approached by his girlfriend, Alexis Teague. They began arguing over clean towels. Alexis grab the baby and walk away, attempting to go smoke while holding their child, Alizah Bonner. He grabs his daughter from her and Alexis began shouting to give her the baby back. He did not give the baby back and Alexis grabbed the diaper bag, and swung it towards him, striking him in the face and also making contact with Alizah. Alexis began to record him on her phone shouting at him. He then grabbed her phone from her hand, throwing it at the ground to stop Alexis from recording him. He went outside to avoid any further interaction but Alexis quickly grab his car keys and left to her mother's house. [redacted] waited outside for law enforcement.

I asked Mario how long have him and Alexis been together and he stated for 2 years and both parties have a child together. [redacted]

I made contact with Alexis who returned to the location. Alexis stated the following in substance: There isn't a problem. I just want my baby and he is refusing to give her to me. I took his keys because he tried to leave with my child.

Alexis went back into her residence but later came back and advised that Mario had smashed her phone. The broken item was a iPhone 12 pro max with a value of \$200-\$400 due to being used. She stated he grabbed it out of her hand and threw it at the ground. Alexis stated she did not want Mario to touch her and stated he's broken her things before.

Based on my investigation, and statements from both parties, Mario was placed in custody for the following charges: Battery Touch or Strike and Criminal Mischief.

A domestic violence lethality assessment was done for Alexis. Based on her answer she was not involved in a lethal relationship.

A domestic packet was completed and email to the appropriate parties and Alexis was giving a victim's rights brochure.

Alexis was also informed of the local domestic violence shelters available.

NARRATIVE

On May 12, 2026, at approximately 0216 hours, I observed a male who I believed to be Curtis Chambliss operating a gray Dodge truck bearing Florida tag CM21TX at WAWA, located at 9050 20th Street, Vero Beach, Florida.

Due to being familiar with Curtis, and knowing that he has had several warrants in the past, I conducted an NCIC/FCIC query to determine if Curtis had any outstanding warrants. My query was met with negative results. The query did reveal that Curtis did not have a valid Florida driver's license.

I conducted a query of the Driver and Vehicle Information Database (DAVID) to confirm the status of Curtis's Florida driver's license. My query of Curtis's Florida identification on DAVID revealed Curtis's Florida driver's license has been suspended since October 03, 2019. A further query revealed Curtis has never been issued a Florida driver's license.

After the above queries, when Curtis departed the Wawa, I initiated a traffic stop at 90th Avenue and 22nd Street, Vero Beach, Florida, on the aforementioned vehicle.

I approached the passenger side and made contact with Curtis, the sole occupant of the vehicle. I informed Curtis, I stopped him because I knew he did not have a valid Driver's license. Curtis handed me his Florida identification card.

I walked around to the driver's side and requested Curtis exit the vehicle, and stand in front of my vehicle.

When I got back into my vehicle to conduct the traffic stop, K9 Deputy McKay approached my window, I asked if he would utilize his K9 partner "Tobi" to conduct a free air sniff of the vehicle.

K9 Deputy McKay informed me that his K9 partner "Tobi" alerted to the vehicle. See K9 Deputy McKay's report for full detail.

I began to conduct a search of the vehicle; I opened the back door and saw a brand-new blue wallet on the back seat. I opened the blue wallet and discovered a small baggie with a crystal-like substance, next to a two (2) dollar bill, with writing on it, basically a love note to Curtis. I removed the two (2) dollar bill and held it up to Curtis and asked if his girlfriend wrote the note to him. Curtis advised his girlfriend had written the note on the two (2) dollar bill to him.

I removed the crystal-like substance and conducted a field test with an agency issued methamphetamine drug test kit, which yielded a positive result for methamphetamine.

I returned to the front of my vehicle, and began to secure Curtis in handcuff restraints, at which time he informed me he had something in his pocket. I removed a glass smoking pipe with residue and a lighter or torch, the pipe is commonly referred to as a bubble, which is utilized to ingest methamphetamine. The lighter or torch, is the common method to ignite the bubble to ingest the methamphetamine. It should be noted that the bubble was still warm to the touch.

A further search of Curtis revealed a bag of green leafy substance, which later tested positive for marijuana with an agency drug test kit, in his sock, Curtis informed me he had a medical marijuana card. I contacted TELETYPE and requested to see if Curtis had a valid medical marijuana card. TELETYPE informed me that Curtis did not possess a medical marijuana card.

Post Miranda, Curtis said he found the bubble and put it in his pocket.
