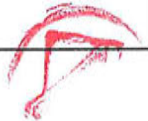

 On _____, at _____ (Specifically include facts constituting cause for arrest.)

On 4/9/26 at approximately 0200 hours, I Ofc. Kriegner, was sitting in the parking lot of Sunshine Pharmacy (1995 US1), when I observed a white SUV, traveling northbound, turn right onto 20th street before pulling into a parking space at the Palm Inn. The vehicle was observed to have an improper display of the license plate.

I observed the vehicle idling in the parking space for an extensive period of time (approximately 30 minutes). I observed two individuals loitering around the vehicle with the passenger door open before walking in the direction of the hotel without entering a room and return a short time later. The individuals re-entered the vehicle and remained idling in the parking spot. Ofc. Wickert and I approached the vehicle on foot to investigate the suspicious vehicle.

F.S 395.3025 (4), (7), & (8)HIPPA / Federal Law

Upon making contact with the vehicle, two individuals were inside, apparently sleeping. The passenger side window was down and it was beginning to drizzle at the time of the encounter; however, the passenger was unresponsive to outside stimuli. After a short period of time, the passenger (identified as Leigh Kennedy) awoke and stated the two had been waiting for a friend at the hotel but could not provide a full name or room number for the individual. While speaking with Leigh, in plain view, an open syringe with the presence of an unknown liquid, was located in the cup holder in the center console area. The syringe was recognized as being frequently used with the intervenious injection of narcotics and a probable cause search of the vehicle was conducted. Inside, a used syringe with pooled blood at the tip, was located in the center console area. In the rear of the vehicle, a bottle labeled "oral ipurophrn" and a white pill identified by Drugs.com as a muscle relaxer. Both individuals were asked to exit the vehicle and a search of their person was conducted. I located an unopened syringe and a clear vile containing 8.7 grams, a crystal-like substance believed to be methamphetamine, in the front pocket of her hooded sweatshirt. I advised Leigh of her Miranda Rights, to which she stated she understood and wanted to speak with me and admitted to the substance being Crystal Meth. Upon further questioning, it was discovered Leigh was not a guest at The Palm Inn and could not provide information about the friend they were going to meet.

Based on the totality of the circumstances, Leigh was placed under arrest for FSS 893.13 Possession of a controlled substance and transported to the Indian River County Jail without incident.

I observed two individuals loitering around the vehicle with the passenger door open before walking in the direction of the hotel without entering a room and return a short time later. The individuals re-entered the vehicle and remained idling in the parking spot. Ofc. Wickert and I approached the vehicle on foot to investigate the suspicious vehicle.

Upon making contact with the vehicle (white Chevrolet SUV Ohio tag# V281959). I spoke with the driver who identified himself As Allen Jackson with no middle name. When Vero Beach Communications advised there was no record of the individual, he was asked to provide his name again and he stated he had provided his name. When advised there was no information returning in regards to his record and he was advised it is a crime to provide a false identification to law enforcement, he stated that his middle name was Allen and his first name was Mike.

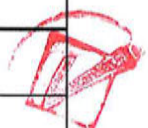





The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On **04/09/2026**, at **22:13** (Specifically include facts constituting cause for arrest.)

I conducted a traffic stop at the 600 block of Sebastian Boulevard on a red Dodge Charger for speeding. I made contact with the driver, Tirrell D. Baskin, spoke with him briefly, verified his registration and insurance, then went to my patrol vehicle to check his drivers license status.

While making my way to my patrol vehicle, approximately 20 feet behind the Charger, a black SUV pulled up behind me in the grassy median of Sebastian Boulevard. I turned my attention to that vehicle as that is highly unusual during a normal traffic stop. The driver immediately exited and I asked if I could help him. He began waling towards me saying I stopped his little brother. At this point I asked him to get back in his car. The male was wearing a hoodie with the hood on and said he was going to check on his brother. I told him several more times to get back in his car and that his brother was fine. He continued walking past me and I told him if he didn't get back in his car he was going to go to jail. The male continued to walk past me.

Since the male refused to stop or get back in his car I told him to come to me. He responded by saying "For what? I'm just checking on my brother." He did this as he continued to walk even closer to the back of my patrol vehicle. I grabbed a hold of his arm to stop him and he turned and pulled away and tried walking away. He kept repeating that he was just checking on his brother. When I told him to put his hands behind his back since he refused to stop interfering with the traffic stop, he responded by saying, "For what?"

I pushed him back towards his car and told him to leave. He turned back around with both hands just above waist level, balled his fists as if he were going to start fighting while saying "Don't tough me bro." Then he immediately began walking past me again, this time on the passenger side of my patrol car and into the roadway of Sebastian Boulevard. I grabbed a hold of him again, this time with slightly more force in order to keep him from reaching the vehicle I had stopped. He was yelling for his brother, Tirrell, to call someone. Once I got his hands behind his back he continued to say he did not do anything wrong. He was put in handcuffs and secured on Officer Sanchez's patrol vehicle without further issue.

During the entire encounter with the subject, my attention was completely diverted from the original traffic stop and the subject still in the car that was stopped. This is cause for major safety concerns from the unrelated, unknown subject exiting their car but also from the subject who I originally stopped.

Afterwards, the male was identified as Marquis L. Baskin. I spoke with Marquis again and he still maintained that he did not do anything wrong and he was just "protecting his brother." I tried to explain to Marquis that his brother was fine, I was nearly finished with the traffic stop and I was not even citing him for his speed so there was no need to "protect him".

I briefly spoke with Tirrell again who seemed disappointed in the way Marquis was acting. He said that Marquis has a bad attitude sometimes they try to help him control it. He agreed that he was fine during our original encounter and there was no reason for Marquis to check on him.

Marquis was arrested and transported to the Indian River County Jail. All interactions with him were captured on my agency issued body worn camera.

On 4/9/26 at approximately 2150 hours, I, Officer W. Brumley, responded to assist Cpl Dominguez on his traffic stop in the 2000 block of 18th ave in reference to a tag obstruction. The stopped vehicle was a green pickup truck bearing FL tag# QSIH89.

Upon approach, we made contact with the driver and sole occupant of the vehicle, identified as Michael Spence (defendant). The defendant was also a part of a BOLO from the Indian River County Sheriff Office (IRCSO), in reference to possible suicidal statements.

While waiting for the IRCSO and verifying the defendants license, he asked for his phone from the truck and gave me permission to enter the vehicle to get it for him. I entered the vehicle to look for his phone on the front passenger side of the vehicle. I observed a glass pipe containing white residue on the drivers side floor board, through my training and experience, I identified it to be a pipe usually used to smoke illegal narcotics from.

At 2216 hours, the IRCSO arrived on scene and advised they did not have enough information for the defendant to meet Baker Act criteria.

The defendant was then detained and placed in my patrol vehicle. Pre and post miranda, the defendant took ownership of the pipe located on the drivers side floor board. While talking with the defendant about the pipe, Cpl Dominguez and Ofc Kriegner located a white rock like substance under a rubber mat, in the center console area, just in front of the center arm rest. They also located a paper clip that was configured into a semi strait "push rod" typically used to push illegal narcotic down a glass pipe. The paper clip was found under a second rubber mat, under the radio area. The defendant stated he did not know what the white rock like substance was there, but if he did, he would have already smoked it.

Both the glass pipe and the rock like substance was field tested and had a positive reaction to the presence of cocaine.

Based on the foregoing the defendant was placed under arrest for violation of FSS. 893.13(6A) Possession Of A Controlled Substance, and 893.147(1) Possession Of Drug Paraphernalia.

The defendant was transported to the Indian River County Jail without incident.

It should be noted, while at the jail the defendant can be heard yelling on the phone to his wife, once he gets out he is going to "slap the taste out your mouth". The defendant can be heard a few minutes later yelling over the phone to his son, he doesn't know how to cut right and "to go suck your moms dick".

The defendants wife, Stephanie Spence, called the jail and asked to speak with me about that incident. She stated she felt in fear of her life that when the defendant is released he would drive home and cause her harm."

This event was captured on my BWC and uploaded to Evidence Library along with the drugs and paraphernalia being submitted into Evidence.

On 4/10/26 at approximately 2340 hours, I Ofc. Kriegner responded to 1646 24th Avenue, in reference to a disturbance.

Upon arrival, I spoke with Morgan McNulty (Victim 1) who advised _____ identified as Jesse Krauss, had followed her in his vehicle (blue Kia Forte tag#) from "Speakeasy" to her boyfriend's residence (address officers responded to) before continuing to follow her on foot towards the residence. She stated Jesse "forced his way" into the residence that he was not permitted to be at, by pulling open the closed, unlocked, front door. He proceeded into the residence and pepper sprayed Victim 1 in the face, at the entrance. He followed V1 into the residence, towards the bedroom (east side of the residence) and proceeded to pepper spray her again as well as pepper spraying the owner of the residence, Drew Fiske (Victim 2). I observed Victim 1 to have a red, puffy face, with red watery eyes. Based on my training and experience, I recognized the injuries to be consistent with someone being pepper sprayed; she declined to be evaluated by EMS. She stated she wished to press charges. Due to her and Jesse _____ a Domestic Violence Packet was issued. Florida Constitution, Article 1, Section 16 (b)(5)

I spoke with Victim 2, who stated he was asleep in bed when Victim 1 woke him up by arguing with Jesse at the front door. He stated Jesse entered his residence without his "permission, consent, or knowledge" and pepper sprayed him in the face and refused to leave the residence prior to Law Enforcement being contacted. I observed Victim 2 to have red watery eyes and red markings on his face and right arm, consistent with someone being sprayed; however, he declined EMS evaluation. Victim 2 stated he wished to press charges.

Jesse had fled the residence prior to Law Enforcement arrival and was believed to be traveling back to his residence (2824 6th Street SW). Officers arrived to the address in an attempt to locate Jesse for questioning. Jesse was present and was advised of his Miranda rights, to which he stated he understood and wished to speak. Post-Miranda he stated he had met Victim 1 at Dom's Bar () and planned to meet her at "Speakeasy" but got jealous of her texting another person he believed she was cheating on him with. He stated he followed her Uber to the residence and recognized it from previous incidents and was invited in by Victim 1. Once he was inside, she yelled to Victim 2. Jesse said he tried to convince her to come home with him and began arguing when she refused. When asked if he ever deployed pepper spray, he admitted he had during the argument. A container of pepper spray was located in his residence, in his bedroom.

Based on the totality of the circumstances, Jesse was placed under arrest for FSS 784.03 Battery, FSS 741.28 Battery Domestic Violence, and FSS 810.02 Burglary Of An Occupied Dwelling with Battery. He was transported to the Indian River County Jail without incident.

The pepper spray was collected and submitted into Evidence. Photographs were taken and submitted along with my BWC.
