PROBABLE CAUSE STATEMENT

I responded to a suspicious incident at 3416 Atlantic Boulevard in reference to an unknown male banging on the front door of the residence, asking for help. The complainant was the homeowner and was identified as Richard Otoole (W/M DOB: 01/15/1957).

On arrival, I observed a black male at the front door of the aforementioned address. The black male/defendant was later identified through his Florida drivers license as Alain Chavannes (DOB: 01/27/1995). As I approached the residence, I observed the defendant to be leaning forward, profusely sweating, which was more noticeable on his forehead. The defendant would not respond upon asking about his wellbeing and had a hard time standing up. The defendant then stated he may be having a panic attack to which EMS was called to respond to the scene.

The defendant had trouble maintaining his balance, was unable to keep his eyes open, and unable to maintain a conversation or respond to questions being asked. EMS arrived on scene but the defendant refused to be transported.

The defendant provided limited information on how he managed to walk onto the complainants property. The defendant stated he had left a gas station but was unable to provide a name or address. The defendant kept saying he was being chased and that something had bit his leg but was unable to tell me what exactly was following him. While speaking to the defendant he consented to a pat down of his person and then consented to a search of his green backpack.

While searching the backpack, I located a clear baggy containing a crystal-like substance. Due to an inconclusive field test of the substance, it will be sent to the lab for testing. A small black scale was also located in the front pocket of the backpack which contained a white powdery residue. The white powdery residue was field tested and tested positive for cocaine.

The defendant was read his Miranda Warning and agreed to speak with me. The defendant took ownership of the crystal-like substance, stating is was "bath salts" and that he took them from his mothers closet. The defendant stated he did not consume the bath salts but uses them to put them in his shoes to get rid of "negative energy." The defendant also took ownership of the small black scale and stated he use to use cocaine and "molly."

Based on the foregoing, the defendant was placed under arrest for Drug Paraphernalia F.S.S. 893.147(1) and transported to the indian River County Jail. The defendant is to be held on a \$500.00 bond.







NARRATIVE

On Tuesday, April 28th, 2026 at approximately 2221 hours, I responded to 5555 20th Street, Walmart, in reference to a shoplifting in progress. Prior to my arrival, [REDACTED] informed dispatch that a white male, wearing a red hoodie, sunglasses, blue jeans, and a yellow shirt underneath, was involved. The suspect left the Walmart premises heading north through the parking lot, then turned eastbound onto State Road 60 along the sidewalk. While attempting to locate the suspect, Sergeant D. Flores identified and detained him. Upon arriving at Walmart, I was shown video footage of the suspect within the store for identification purposes. I then relocated to Sergeant D. Flores's location and confirmed that the individual he detained was the suspect. Sergeant D. Flores discovered two magic trading card boxes in the front portion of the suspect's pants. The suspect was identified as Joseph Dwight Kirkland by his Florida ID card and was placed into hand restraints. Joseph was placed in the rear of my patrol vehicle and relocated to Walmart.

Upon my arrival, I spoke with Loss Prevention Officer Sara Ingo, who provided the following written statement:

"I, Sara Ingo, Asset protection for Walmart, witnessed on CCTV an unknown white male wearing a red hoodie, jeans, and black shoes enter the store. I had previously recognized the male from an event in our Walmart system where a theft occurrence was prevented by our Asset Protection team. I immediately follow the individual on the camera and see him select Magic Trading Cards next to our self-checkouts. Subject then places the selected merchandise into his basket and continues into our homeliness and then into our automotive area. Subject then selects an orange box, takes the item out of the box and places both into his shopping basket. Moments later, subject places the box and item from the box back on the shelf. Subject then heads over to the hardware section, scans the area, places down the basket, and conceals the Magic Trading Cards inside the front of his pants. Subject immediately leaves the area, heads over to sporting goods, and appeared to conceal more packs of the Magic Trading Cards as he was making movements to the front of his pants and pockets. Subject then exits sporting goods and makes his way towards the front of the store. He places the basket with the left-over merchandise he selected on top of one of our refrigerators next the register, and exited out of Grocery doors, passing all points of sale, at approximately 22:23hrs. The total loss is \$74.91. Walmart wishes to trespass and prosecute this individual."

I then spoke to Joseph, Joseph advised that he stole the magic trading cards for his son.

Walmart reported the following items stolen:

- Magic Trading Cards \$24.97
- Magic Trading Cards \$49.94

Walmart has a total loss of \$74.91

At the scene, I reviewed the store's surveillance footage, which corroborated the details provided in the written
